BRIGADE ORDER.

THE Perth Artillery, Fremantle Naval Artillery, Metropolitan, Fremantle, and Guildford Rifle Volunteers will parade for Brigade Drill in Review Order at Perth, with (25) twenty-five rounds of blank ammunition, on Tuesday, the 15th instant, at noon.

The respective Commands will fall in on their private parades, and be marched to the Recreation ground, where they will be formed up in column of companies (except the Artillery) facing East in the following order, viz .:-Metropolitan (1 and 2), Fremantle (3), Guildford (4) Rifles; and there await further instructions from the Inspecting Field Officer.

The Fremantle and Guildford companies respectively will be conveyed to and from Perth by train.

PROGRAMME FOR FIELD DAY.

FORCE .-

Naval Brigade with small arms only, to act as escort to the guns.

Perth Artillery with two guns horsed.

Infantry-four companies:

Metropolitan Rifles in two companies. ,, one Fremantle Guildford

To be drawn up in line in above order and in "open order" to receive the Governor. The order for the salute will be given by the Inspecting Field Officer.

After closing ranks the following evolutions will be performed :

- 1. March past (in column) and re-form line on original ground.
- 2. Advance in direct echelon of companies from the left, covered by the left flank company of the Rifles. Skirmishers com-mence firing. Halt. Cease firing.
- 3. Echelon will wheel to the right. Guns come into action right and commence firing. The escort retire to right flank. Skirmishers close on their left.
- 4. Rifles will form line on leading company and commence independent firing.
- 5. Guns will cease firing, limber up, and retire. The escort keeping always to their rear on the exposed flank. Then the Rifles will retire in direct echelon of companies from the right. Halt. Form company squares. Commence firing.
- 6. Cease firing. Re-form companies.
- 7. Line on No. 2 company Rifles.
- Change front to the left on the right company of Rifles covered by the left flank company of Rifles which will wheel to its left before extending and then extend from its centre. Skirmishers open fire. Close skirmishers and whole line open fire. Cease firing. Advance in review order.

IDEA.

The idea expressed in the programme, apart from the opening ceremonial "salute" and "march past," and the concluding "advance in review order," is as follows :-

A simple advance in direct echelon is made upon a supposed foe, the movement is of course covered by supposed foe, the movement is of course covered by light infantry, while the left flank is thrown forward and the right exposed. On coming into contact with the enemy he is supposed to attempt to turn the right flank, whereupon a change of front is made to the right by simply wheeling the companies which are in echelon to the right, and forming line to that flank. echelon to the right, and forming line to that hank. In spite of the flank attack being met, a retirement is found necessary, and during this retreat the enemy's cavalry press forward, which necessitates the forma-tion of company squares. The charge being repelled and the enemy trying now to force the left flank, a return to the original alignment is made by changing from to the left on a cartal company by throwing front to the left on a central company by throwing forward the right and back the left.
