#### Greeting:

KNOW YE that we have assigned you jointly and severally and every one of you Our Justices to keep Our Peace in Our Colony of Western Australia. And to keep and cause to be kept all Ordinances and Statutes for the good of the Peace and for the preservation of the same and for the quiet rule and government of Our People made in all and singular their articles in Our said Colony (as well within Liberties as without) according to the force form and effect of the same. And to chastise and punish all Persons that offend against the form of those Ordinances or Statutes or any one of them in the aforesaid Colony as it ought to be done according to the form of those Ordinances and Statutes. And to cause to come before you or any of you all those who to any one or more of Our People concerning their Bodies or the firing of their Houses have used threats to find sufficient security for the Peace or their good behaviour towards Us and Our People. And if they shall refuse to find such security then them in Our Prisons until they shall find such security to cause to be safely kept.

We have also assigned to you and every two or more of you (of whom any one of you the aforesaid George Walpole Leake, George Eliot, Rowley Crozier Loftie, Joseph Strelley Harris, Walkinshaw Cowan, John Gray Murray, John George Slade, William Pearce Clifton, Edward Hayes Laurence, Robert Fairbairn, John Crampern Rosselloty, Octavius Burt, and Charles Denroache Vaughan Foss, We will shall be one) Our Justices to inquire the truth more fully by the oath of good and lawful Men of the aforesaid Colony by whom the truth of the Matter shall be the better known of all and all manner of Felonies Poisonings Trespasses Forestallings Regratings Ingrossings and Extortions whatsoever. And of all and singular other Crimes and Offences of which the Justices of Our Peace may or ought lawfully to inquire by whomsoever and after what manner soever in the said Colony done or perpetrated or which shall happen to be there done And also of all those who in the aforesaid Colony in Companies against Our or attempted. Peace in disturbance of Our People with armed force have gone or rode or hereafter shall presume to go or ride. And also of all those who have there lain in wait or hereafter shall presume to lie in wait to maim or cut or kill Our People. And also of all Victuallers and all and singular other Persons who in the abuse of Weights or Measures or in selling victuals against the form of the Ordinances and Statutes or any of them therefore made or in force for the common benefit of the said Colony and Our People thereof have offended or attempted or hereafter shall presume in the said Colony to offend or attempt. And also of all Sheriffs Stewards Constables Keepers of Gaols and other Officers who in the execution of their offices about the premises or any of them have unduly behaved themselves or hereafter shall presume to behave themselves unduly or have been or shall happen hereafter to be careless remiss or negligent in Our aforesaid Colony. And of all and singular Articles and circumstances and all other things whatsoever that concerns the said Colony done or perpetrated or which hereafter shall there happen to be done or attempted in what manner And to inspect all Indictments and Informations whatsoever so before you or any soever. of you taken or to be taken or before others late Our Justices of the Peace in the aforesaid Colony made or taken and not yet determined. And to make and continue Processes thereon against all and singular the persons so indicted or informed against or who before you hereafter shall happen to be indicted or informed against until they can be taken surrender themselves or be outlawed. And to hear and determine all and singular Felonies Poisonings Trespasses Forestallings Regratings Ingrossings Extortions the Unlawful Assemblies Indictments and Informations aforesaid and all and singular other the premises according to the Laws and Ordinances of the said Colony as in the like case it has been accustomed or ought to be done. And the same Offenders and every of them for their Offences by Fines Ransoms Imprisonments Amerciaments Forfeitures and other means as according to the Law and Custom of the said Colony or form of the Ordinances and Statutes aforesaid it has been accustomed or ought to be done to chastise and punish. Provided always that if a case of difficulty upon the determination of any of the premises before you or any two or more of you shall happen to arise then let Judgment in no wise be given thereon before you or any two or more of you unless in the presence of Our Chief Justice of Our said Colony. And therefore We command you and every of you that in the keeping of the Peace Ordinances and Statutes and all and singular other the Premises you diligently apply yourselves and that at certain days and places appointed for these purposes into the Premises you make inquiries and all and singular the Premises hear and determine and perform and fulfil them in the aforesaid form doing therein what to Justice appertains according to the Law and Custom of the said Colony saving to Us the Fines and other things to us therefrom belonging.

And We command by the tenor of these Presents Our Sheriff of Western Australia that at certain days and places which you or any such two or more of you as is aforesaid shall make known to him he cause to come before you or such two or more of you as is aforesaid so many and such good and lawful Men of his Bailiwick by whom the truth of the matter in the Premises shall be better known and inquired into.

**Hn CRIINESS** whereof We have caused Our trusty and well-beloved FREDERICK NAPIER BROOME, Esquire, Companion of Our most distinguished Order of Saint Michael and Saint George, Our Governor and Commander-in-Chief of the Colony of Western Australia and its Dependencies, to sign these Presents and to affix hereto the Public Seal of Our said Colony, this nineteenth day of June, in the forty-sixth year of Our Reign and in the year of Our Lord One thousand eight hundred and eighty-three.

We may be permitted to draw the attention of Your Excellency to the fact that Fremantle is the most important seaport in the Colony, and also the terminus of the Eastern Railway; and therefore any improvements to the harbor, affording better accommodation to shipping, will benefit not the town only, but the district through which the railway passes.

#### GENTLEMEN,

I beg you to believe that both Lady Barker and myself much appreciate the cordial and sympathetic welcome offered to us by the town of Fremantle.

You lay stress on the loyalty and patriotism of the inhabitants of Western Australia, and, from what I have already seen and heard of this Colony, I can well believe that nowhere throughout the majestic Empire of England does there exist a community animated by a more heartfelt allegiance to our gracious and revered Sovereign.

I esteem myself particularly fortunate in that the direction of your affairs is committed to me at a period when a new era seems dawning for Western Australia, and when it is the general belief that a tide of success and progress is at last setting towards this side of the great island-continent.

You refer to possible changes in your political constitution. I can only say that should questions of this important nature arise, my attitude towards them will be regulated by an earnest regard for the welfare of the people of this Colony, and by no other policy or predilection whatever.

Convinced as I am of the vital importance of developing the resources of a country in process of colonisation by a bold and comprehensive scheme of Public Works, I shall be ready to join with the Legislative Council in carrying out such a policy fully as far as financial prudence will allow. Both Lady Barker and myself hope to see much of the people of Fremantle, and we trust that this formal introduction is but the beginning of an acquaintance which will ripen into friendship.

REPLY.

Yesterday was the fifty-fourth anniversary of the foundation of the Colony. It is my warmest wish that each recurring birthday of Western Australia which I may have the pleasure of celebrating with you may be kept with satisfaction by a happy and prospering community.

I am rejoiced to think that I assume the direction of your affairs at a season of general hope and united effort. A sudden development of your resources has attracted attention and capital. The important public works to which you refer have been set on foot or are under discussion, and Government, Legislature, Municipalities, and people seem to be taking "a long pull, a strong pull, and a pull all together," determined to lift the wheels out of the ruts, and to give the Colony a fair start on the highway of progress.

It will be my duty to add my best efforts to your own; and I cannot help feeling that, if I should be able to do this with any effect, it will be in a great degree owing to the well ordered condition in which your affairs have been left by your late able Governor, Sir William Robinson, whom I have had the advantage of consulting with at Adelaide, and who, while advancing your railways, your surveys, and other undertakings, has been careful to husband your resources, and has given me the satisfaction of finding that the Government has a handsome balance at its bankers.

Public expenditure, gentlemen, is a seductive thing, especially with cash in hand, but I hope the people of this Colony will agree with me in thinking that it would be unwise to reduce this balance below a certain point.

In conclusion, I assure the corporation of the city of Perth that their municipal rights will always be respected by me, and that I shall at all times be ready to receive their wishes and representations, as well as those of the municipalities of Fremantle and other towns of the Colony, with all the consideration and liberality compatible with the means of the Government and the votes of the Legislature, and due to the important part which municipal institutions have played, and must continue to play, in the development and progress of the Colony.

To His Excellency Frederick Napier Broome, Esquire, C.M.G., Governor and Commander-in-Chief of the Colony of Western Australia and its Dependencies.

We, the undersigned, Chairman and Members of the Standing Committee of the Synod of the Church of England in this Colony, desire, on behalf of the Members of the Church generally, to bid Your Excellency and Lady Barker a hearty welcome to our shores. The Diocese of which we are the Executive Body is coterminous with the Colony of Western Australia, and claims more than one-half of the whole population. To maintain effectively the work of the Church over so large an extent of territory and amidst a scattered people, the great bulk of whom are engaged in pastoral pursuits and are persons of comparatively small means, is no easy task. Until recently, indeed, the Church of England received substantial aid in this work, both from the Imperial Treasury and from the Colonial Government. The latter is still continued, and we trust will still for many years be continued to us; but the former is now in process of withdrawal, and will have ceased altogether in four years from the present date. Under these circumstances our efforts are necessarily directed in the first instance to the establishment throughout the Diocese of a system of regular contributions from all Members of the Church towards the stipends of the clergy, and in the next place to securing by means of an especial endowment fund, and by the acquisition of additional lands, at least the partial endowment of our several parishes in the future.

The extension of the ministrations of religion to outlying districts, including those now in process of settlement to the north and in the south-eastern portion of the Colony, is another object towards which something has already been done, and in which, as well as towards a sustentiation and endowment fund, we are receiving liberal, though temporary, assistance from three of the leading Church societies in England.

The religious instruction of the children attending the Government Schools of the Colony is another important object to which the attention of our Synod has been recently directed, and towards which something has been done by the formation of a Religious Education Committee, consisting not merely of clergy of the Church of England, but of ministers of other Protestant denominations also, and by the establishment under their direction, with the concurrence of the District Boards of Education and the hearty co-operation, in most instances, of the school teachers, of a system of annual examinations in the subjects of religious instruction taught under the provisions of our Education Act in the schools. The higher education of boys is in the main provided for at present by the Government; but for that of girls a diocesan provision has been made by the establishment, just four years since, of a girls' college in immediate connection with the cathedral in Perth.

The need of some further efforts amongst us to raise, both socially and spiritually, the condition of the aboriginal natives of the Colony, has also occupied the careful consideration of the Synod, and we trust that the plans determined on will ere long now take an active shape.

We may add that the erection of a new cathedral in Perth has within the past three years been taken in hand by the Members of our Church, that a handsome new church has been erected in Fremantle, and a smaller one at Roebourne, whilst there are five other similar buildings now in course of reection in the diocese.

This brief statement of the matters of special work in which the Church of England in this Colony is at present engaged will be sufficient, we are sure, to satisfy Your Excellency of the importance of that work to the highest interests and well-being of the Colony. We are indebted to Your Excellency's immediate predecessor for much valuable support in that work; we confidently anticipate no less valuable assistance and support from Your Excellency and Lady Barker; and it is our earnest hope that the period of Your Excellency's administration of the Government of this Colony may be marked by as real a progress in all that concerns the religious and social well-being of our people as in their material prosperity.
