CIRCULAR.

Downing Street, 18th January, 1883.

Sir,—I have had under my consideration the replies sent to the Earl of Carnarvon's Circular Despatch of the 7th of January, 1878, on the subject of public flogging of prisoners.

I am satisfied that the public flogging of prisoners is indefensible, and should be discontinued entirely.

If, therefore, the practice is still permitted by the Law of the Colony under your Government, I request you to take steps for the amendment of the Law, so as to provide that every sentence of flogging or whipping imposed by a Court or Magistrate shall be inflicted, except in the case of a person under the age of 14 years summarily convicted, in some prison; and that no person who is not officially con-nected with the prison shall be present at the punishment; and that, in the case of a person under 14 summarily convicted, it shall be inflicted privately, and further, that in every such sentence the instrument and the number of lashes or strokes shall be specified.

The Prison Regulations of the Colony should provide that corporal punishment for prison offences shall not be inflicted in the presence of other prisoners.

THE HONORABLE THE COLONIAL SECRETARY,-

This interesting and able Report should be printed for presentation to the Legislative Council.

2. The value of the work which the Admiralty Survey is accomplishing year by year upon the coast of this Colony cannot be over-estimated. It is a pity that the funds do not allow the "Meda" to be at sea for a somewhat longer period, in order that the work could be done during the Southern as well as the Northern seasons of the same year. Perhaps it may be possible in the future to make some arrangement which shall permit of this.

I desire to thank Staff Commander Coghlan for his Report, and to express my recognition of the thorough and excellent manner-entirely satisfactory to the Government of this Colony, as I have no doubt it also is to the Admiralty-in which he has conducted the Survey in his charge.

I have the honor to submit, for the information of His Excellency the Governor, the attached summary of the work carried out by the joint Admiralty and Colonial Marine Survey during the year 1883, and of that proposed to be undertaken during the year 1884.

To the Honorable Malcolm Fraser, C.M.G., &c., &c., &c., Colonial Secretary.

1. The surveying schooner "Meda" having sailed from head-quarters, in April 1883, after a somewhat tedious passage, owing to light winds, arrived in King Sound on 24th May, and proceeded to the Fitz-Roy River to survey the anchorage off the proposed townsite of Derby. A navigable channel communicating with the proposed anchorage (Amur Pool) was surveyed, and much additional information obtained relating to King Sound.

Owing to the difficulties experienced in procuring drinkable water, and working under a tropical sun in pulling boats, against strong tides, the work proved arduous. On one occasion in King Sound the "Meda" had a narrow escape from being wrecked, as, in consequence of the wind falling suddenly, she became unmanageable, while a very strong tide carried her nearly over a dangerous sunken ledge of rocks, the water being too deep (45 and 50 fathoms) for anchorage. The want of steam power was much felt while working amidst the strong tides of the Kimberley coast.

2. Some unknown dangers in the neighborhood of Swan Point and the Lacepede Islands were discovered and laid down in the charts.

3. A running survey was made of portions of the coast between King Sound and Roebuck Bay.

4. Roebuck Bay was examined and a plan made on the scale of four inches to the mile. Dampier Creek in the North-west portion of the bay (the port of the township of Broome) was found to be a good tidal harbor, the streams being scarcely felt, with a great range of tide, over a bottom of sand with patches of mud. A good harbor (Inner Anchorage) lies off the mouth of Dampier Creek, accessible at all times of tide.

While sounding the approaches to Roebuck Bay, the "Meda" struck upon a dangerous unknown rock lying  $8\frac{1}{2}$  miles and 16 miles respectively off the entrance points of the Bay; and she was compelled to return to headquarters for repairs at least a month sooner than anticipated. Owing to the strong tides and the great extent of shoal ground under examination, the want of a steam cutter was much felt during the survey of Roebuck Bay.

5. A running survey was made of portions of the coast between Roebuck Bay and the DeGrey River (including LaGrange Bay).

6. A running survey was made of the inshore channels between Dampier Archipelago and North-West Cape, including the islands fronting the Ashburton River.

7. A plan was made of the anchorage off the mouth of the Ashburton River, which should prove of service to the wool ships calling there for freight.

8. Additional information was obtained relating to Sharks Bay.

9. With a view of defining the bank of coast-soundings, deep-sea soundings were obtained as opportunities offered.

10. The necessary directions, furnishing detailed information, were drawn up, and published by command of His Excellency the Governor in the *Government Gazette* (30th October, 1883.)

11. In consequence of the Peninsular and Oriental Steam Navigation Company's steamship "Clyde" having taken the ground when in charge of the pilot while entering Princess Royal Harbor in October, 1883, His Excellency the Governor requested that an officer from this Survey should be sent to ascertain the cause thereof, and Lieutenant Dixon was detached for this service accordingly.

From the data submitted to me I arrived at the following conclusions :---

(a.) That the accident was due to the "Clyde" being out of her course, the leading marks not being in line from the position where the "Clyde" grounded.

(b.) That by keeping the leading marks in line, vessels of corresponding draught may continue, as hitherto, to enter and leave Princess Royal Harbor without risk.

Some anxiety was felt, and statements appeared in some of the local newspapers, that the mouth of Princess Royal Harbor was silting-up; but after a careful consideration of the question I was unable to arrive at that opinion myself, and informed His Excellency the Governor accordingly.

During all periods of the year Princess Royal Harbor receives and discharges a considerable volume of water, through a comparatively narrow mouth; and this strong tidal scour would of itself appear to negative any alarm as to mouth of the harbor silting-up.

Siltage might be expected where a current or tide carrying earthy matter in solution was too weak to overcome the resistance offered by the ocean swell (such as occurs at the mouths of several West Australian rivers at certain seasons of the year); or where solid structures joined to the shore (other than those specially intended to confine or deflect the current), such as masonry jetties, impeded the natural set. Neither of these conditions at present exist in the mouth of Princess Royal Harbor.

Some very slight alterations were ascertained to have taken place in the extent of the  $3\frac{1}{2}$  fathoms shoal off Possession Point. This was to be expected, as the limits of most banks and shoals—(other than those consisting of solid rock with no superstratum of sand and weed) with four fathoms and less water over them, adjoining the coast of Western Australia as is the case on many coasts—vary slightly according to the prevailing seasonal winds.

On our West coast, at the end of the season of strong Southerly winds, the edge of the shoal water (sand and weed) under the depth of 4 fathoms—will be found to have extended slightly to the Northward (though not sufficiently to affect navigation) and at the end of the season of North-West winds to have retroceded slightly to the Southward of the mean limit. Therefore the  $3\frac{1}{2}$  fathoms shoal off Possession Point would be expected to follow the same general law, and in due course resume its former limits; the alteration in both instances being one of shape and not of area.

To minutely determine alterations in depths of water (say to inches) there must be some fixed point of reference (such as an iron peg driven into an embankment or wall). If the soundings are reduced to a point called low-water spring-tides, and that point is known and stated to lie so many feet and inches below the iron peg before mentioned, we can detect minute alterations in the depths by referring the measurements to the said datum.

This bench-mark, or datum, is especially necessary where the sea-level varies appreciably at different seasons of the year, as is the case on the coast of Western Australia; because, in the absence of such fixed point of reference, a variable quantity would be introduced into the measurements by referring them to a variable sea-level. At King George Sound the difference of tidal level with a westerly wind and easterly wind blowing respectively, would be as much as five feet on some occasions.

The low-water of a spring-tide with a westerly wind blowing, would stand considerably higher than the low-water of a spring-tide with an easterly wind blowing, although the *range* of tide would in both instances be practically the same (about  $2\frac{1}{2}$  feet).

The recent examination of the mouth of Princess Royal Harbor was made at the beginning of November, 1883, or at the season when the lower sea-level, as stated by the Hydrographer of the Admiralty, is reached: and, therefore, soundings referred to a mean level of the sea,—obtained by meaning the high and low-waters of *one* spring-tide at that period of the year,—could not be expected to be other than less, by some 9 or more inches, than soundings referred to the mean-annual-sea-level obtained by meaning the high and low waters of the spring-tides of a *whole year*.

The mouth of Princess Royal Harbor may shoal or deepen—a few inches; but my own opinion is that practically these minute alterations in the depths will be found to be self-adjusting.

The only rigorous method for determining minute alterations in depths of water is by reference to a fixed point on the shore, and not to a variable sea-level.

Upon such data as soundings referred to a variable sea-level, to state that the harbor was siltingup, in my opinion, would be to arrive at an erroneous conclusion—and one likely to prove misleading, and detrimental to the character of the Inner harbor of Albany. The foregoing reasons have been submitted to the Hydrographer of the Admiralty in support of my opinion that there is no data at present for stating that the mouth of Princess Royal Harbor is silting-up.

I have requested, through the Hydrographer of the Admiralty, to be furnished with the position of the fixed mark on the shore or datum used by my predecessor during his survey, and upon obtaining it a further examination will be undertaken of the mouth of Princess Royal Harbor, as by measuring from that datum we shall be able to determine minutely if any alterations in the depths have occurred since the last survey.

Since furnishing this Report to His Excellency the Governor, a reply has been received from the Hydrographer of the Admiralty confirming my opinion.

12. The "Meda" returned to Fremantle on the 8th September, 1883, for repairs.

13. The tender of Mr. Howson, shipbuilder at Fremantle, having been accepted, the "Meda" was hove down in Careening Bay, Garden Island. Some twenty-six feet of the fore-part of her keel was removed and renewed; the vessel re-metalled; and the repairs in general carried out in a satisfactory manner by the contractor.

14. The cost of the repairs to the "Meda" having chiefly to be met by the annual survey vote, proved a great drain upon the funds of the Admiralty Survey, and necessitated the postponement of some contemplated surveys until after the end of the Imperial financial year (31st March, 1884).

15. His Excellency the Governor has recommended that the following Surveys should be made during the forthcoming season. (1.) Hampton Harbor. (2.) Esperance Bay. (3.) Deep River and its Roadstead. (4.) Point D'Entrecasteaux Roadstead. (5.) Dongarra. My own opinion coincides with that of His Excellency as to the necessity for these surveys being undertaken so soon as circumstances shall permit; but I have suggested to His Excellency that during the approaching season the services of the "Meda" could be advantageously employed chiefly upon our North-West Coast. Subject to His Excellency's and the Hydrographer of the Admiralty's approval, the following places appear to me to require surveys :—

- 1. Hampton Harbor: if the minerals reported to exist in that neighborhood should be developed, this harbor should prove a valuable port for shipping the ore.
- 2. A plan of the roadstead off the mouth of Fortescue River. This survey is needed in the interests of the settlers in that district; and would have been carried out last year, had not the "Meda" met with the accident before related.
- 3. An anchorage under Point Cloates, one of the places of disembarkation of the material for the overland telegraph to Roebourne, should be examined if circumstances permit. The correct astronomical position of Point Cloates requires to be determined, this headland being of even more importance to the coasting mail steamers and mariners in general than the North-west Cape, the opposite point of the peninsula forming the western shore of Exmouth Gulf.
- 4. A plan is required of Port Farquhar or "Boolbarley," which lies about sixty miles northward of Sharks Bay. The settlers in that district, I am informed, have at present to cart their wool by a circuitous route round a strip of waterless country, to the Gascoyne River for shipment.
- 5. Dongarra. A plan of this roadstead will be of service to the mail steamers and vessels trading between Dongarra and Fremantle.
- 6. The bank of coast soundings in the neighborhood of Champion Bay should, in the interests of navigation in general, be defined to the one-hundred-fathoms limit. The position of Mid Reef in the Geelvink Channel, at present only approximate, should also be accurately determined.
- 7. Deep River Entrance and Roadstead require examination with a view of determining if vessels can lie there at anchor in safety during a portion of the year. If it can be ascertained that it is practicable to ship timber at the Deep River, the vast Karri forests in that neighborhood will doubtless be utilised.
- 8. Point D'Entrecasteaux Roadstead is reported to afford shelter at certain seasons. The remarks relating to Deep River apply equally to Point D'Entrecasteaux.
- 9. Esperance Bay is an extensive sheet of water about fifteen miles long, with many islands, islets, and sunken dangers, belonging to the Western portion of the Archipelago of the Recherche, extending across its mouth. To survey it in detail would occupy probably a whole season. I beg, therefore, to suggest to His Excellency that the survey be deferred until the season of 1885.
- 10. The bank of coast soundings between Flinders Bay and King George Sound, if defined to the one-hundred-fathoms limit, should prove of great service to the mariners navigating our south coast in thick weather; and I would suggest that this work be carried out at the earliest opportunity.
- 11. The question of visiting Cambridge Gulf in the "Meda" during the forthcoming season is under consideration.

# A BILL to make provision for Bank Holidays, and respecting obligations to make payments and do other acts on such Bank Holidays.

HEREAS it is expedient to make provisions for rendering certain days Bank Holidays, and for enabling Bank Holidays to be appointed by the Governor: Be it enacted by His Excellency the Governor of Western Australia and its Dependencies, by and with the advice and consent of the Legislative Council thereof, as follows:---

Holidays to be pay-able on the following day.

Holidays.

Offices of Land Titles and of Registry of Deeds.

AFTER the passing of this Act the several days in the Schedule 1. Bills due on Bank to this Act mentioned (and which days are in this Act hereinafter referred to as Bank Holidays) shall be kept as close holidays in all banks in Western Australia, and all bills of exchange and promissory notes which are due and payable on any such Bank Holiday shall be payable and, in case of non-payment, may be noted and protested on the next following day and not on such Bank Holiday, and any such noting or protest shall be as valid as if made on the day on which the bill or note was made due and payable; and for all the purposes of this Act the day next following a Bank Holiday shall mean the next following day on which a bill of exchange may be lawfully noted and protested.

WHEN the day on which any notice of dishonor of an 2. Notice of dishonor unpaid bill of exchange or promissory note shall be given, or when the day on which a bill of exchange or promissory note should be presented or received for acceptance or accepted or forwarded to any referee or referees is a Bank Holiday, such notice of dishonor shall be given, and such bill of exchange or promissory note shall be presented or forwarded on the day next following such Bank Holiday.

NO person shall be compellable to make any payment or to 3. Payments on Bank do any act upon such Bank Holiday which he could not be compellable to do or make on Christmas Day or Good Friday; and the obligation to make such payment and do such act shall apply to the day following such Bank Holiday; and the making of such payment and doing such act on such following day shall be equivalent to payment of the money or performance of the act on the holiday.

> THE offices of Land Titles and of the Registry of Deeds shall be closed on all Bank Holidays, and if the day ordained or appointed as the last day for entry of any caveat, or for delivery of any memorial, or for the performance in either of the said offices of any act by any officer or by any person whatsoever shall fall upon any Bank Holiday, the obligation to enter such caveat, deliver such memorial, or perform such act shall apply to the day next following such Bank Holiday; and the entry of such caveat, or the delivery of

such memorial, or the performance of such act on such following day shall be equivalent to such entry or delivery or performance on the holiday.

IT shall be lawful for the Governor in Executive Council 5. from time to time, as to the Governor as aforesaid may seem fit, by Appointment of Special Bank Holi-proclamation to appoint a special day to be observed as a Bank days by Proclama-Holiday throughout the Colony, and any day so appointed shall be tion. kept as a close holiday in all banks within the Colony and in the said offices, and shall, as regards bills of exchange and promissory notes payable in the Colony, and as to all acts to be performed as aforesaid, be deemed to be a Bank Holiday for all purposes of this Act.

IT shall be lawful for the Governor in like manner from 6. time to time, when it is made to appear to the Governor in Council Day appointed for in any special case that in any year it is inexpedient that a day by this Act appointed for a Bank Holiday should be a Bank Holiday, <sup>Day appointed for Council</sup>. to declare that such day shall not in such year be a Bank Holiday, and to appoint such other day as to the Governor in Council may seem fit to be a Bank Holiday instead of such first mentioned day, and thereupon the day so specially appointed shall in such year be substituted for the day so appointed by this Act.

7. THIS Act may be cited for all purposes as "The Bank Short Title. Holidays Act, 1884."

rolled copies thereof said recited Acts or of either of them, and the said boundaries so adjusted as aforesaid shall differ from those contained in any grant of the boundaries of thereof from the Crown, issued previously to such adjustment, it shall be lawful for the Surveyor General to endorse or cause to be endorsed on the back or other convenient part of the deed or instrument of grant, if it shall be produced to him for that purpose, the true boundaries as so adjusted, and which he shall sign, and the said deed so endorsed and signed as aforesaid shall be forthwith given or forwarded by the Surveyor General to the Registrar of Deeds, and the said Registrar shall make and sign a memorandum of such endorsement in the margin or in some other convenient part of the enrolled copy of the said deed, and shall re-deliver the said deed to the person producing the same as aforesaid.

### BILL to Regulate the Punishment Α of Whipping.

HEREAS it is expedient to regulate the punishment of Whipping: Be it enacted by His Excellency the Governor of Western Australia and its Dependencies, by and with the advice and consent of the Legislative Council thereof, as follows:-

Short title.

Instrument and number of strokes to be specified in sentence.

Whipping to be inflicted in prison.

THIS Act may be cited as "The Regulation of Whipping 1. Act, 1884."

WHENEVER any person shall be sentenced by any Court 2. or Justice or other legal authority to be whipped, the number of strokes and the instrument with which they shall be inflicted shall be specified in the sentence.

EVERY such sentence of whipping, except in the case of a 3. person under the age of fourteen years summarily convicted, shall be inflicted in some gaol or prison, and no person who is not officially connected with the said gaol or prison shall be present at the infliction of the punishment.
