The Duke of Cambridge, K.G., &c., &c., &c. It having been pointed out that the great interest Sir Bartle Frere took in all matters relating to ties between the mother country and the British Colonies in general, and the devotion he showed in upholding the best interests of the Colonial Empire, were so notorious that many in the colonies other than those in the South African colonies, with which he was more intimately connected, would wish to join in the memorial to him if an opportunity were afforded, the Committee invite all who knew him in private life, or admired his public character, to take this opportunity of testifying their affection and esteem.

A sum not exceeding £3,000 is to be devoted to the erection of a Statue, and the surplus of all subscriptions received will be utilised, (1) in providing a permanent Fund to be conferred, as a testimony of admiration of Sir Bartle Frere, on his widow and family in life-rent; and (2) in per-

petuating his memory by settling the reversion on his family.

A sum of over £4,000 has already been collected in England.

WHEREAS by the "Cattle Diseases Ordinance, 1865," and the Act for the Prevention of the Importation of Diseased Stock, of 1879 (43 Victoria, No. 23), power is given to the Governor, with the advice of the Executive Council, to make such regulations as may be deemed expedient for the purposes in the said Acts specified: Now THEREFORE His Excellency the Governor directs the publication of the following Regulations, which have been made by him with the advice and under the powers aforesaid, and for the purpose of preventing the introduction of diseased stock into the Colony:—

Regulations under 29th Victoria, No. 3, and 43rd Victoria, No. 23, relating to the Importation of Live Stock into the Colony.

1. No horned cattle, sheep, or swine shall be introduced into the Colony of Western Australia by sea, unless the owner or person in charge of such stock shall have in his possession a certificate from an Inspector of Stock, or other officer duly qualified, or person performing similar duties, at the port or place where such horned cattle, sheep, or swine were shipped on board the ship or vessel bringing the same into the Colony, issued within seven days of the departure of such ship or vessel from the port or place of embarkation, and certifying that such horned cattle, sheep, or swine (as the case may be) are free from disease; and unless a duplicate of such certificate shall have been forwarded by post forthwith, after the shipment of such stock, to the Colonial Secretary, at Perth.

2. Any Inspector of Stock may in any case order such horned cattle, sheep, or swine on any vessel to be placed in quarantine in some suitable spot immediately on landing, and be kept there until such horned cattle, sheep, or swine shall have been examined by such Inspector, or by some duly qualified person appointed by the Governor to act for such Inspector, and shall have been certified, by such Inspector or other duly qualified person as aforesaid, to be free from disease; and the Inspector or other person as aforesaid may in any case direct the owner or consignee to disinfect any such stock.

3. If any person shall desire to introduce any such stock by sea into this Colony without the before-mentioned certificate, the Governor, or any other person appointed for the purpose by the Governor, may upon application permit such stock to be landed in quarantine. The duration of such quarantine to be for the term of ninety days.

Note.—The Statutes contain the following provisions for the Destruction of Diseased Imported Stock.

29 Victoria, No. 3.

3. All cattle imported or introduced into this Colony contrary to such Proclamation, restriction, or regulation as aforesaid, and all cattle removed contrary to any such restriction or regulation from any yard or place in the Colony in which cattle may, in accordance with any such restrictions or regulations, be secured, shall be forfeited, and the same may be seized by any Justice of the Peace, Officer of Customs, or Inspector of Stock, or by any Police Constable not being of a lower rank than Corporal of Police, who shall destroy the same, unless the Governor otherwise directs.

40th Victoria, No. 14.

8. If any imported stock on arrival, or within a month thereafter, be found on examination by an inspector to be infected, he shall immediately report the case to the Governor, and if after careful investigation the Governor shall decide that such stock are infected, the inspector shall serve the owner of such stock with a notice in the form of Schedule C hereto (by causing the same to be delivered to him personally or left at his usual place of business or abode), to destroy the same, together with all fodder, fittings, and effects infected or likely to be infected by such stock, within forty-eight hours from the time of receipt of such notice; and such stock, fodder, fittings, and effects shall be destroyed accordingly.

9. All imported stock, fodder, fittings, or effects landed contrary to any of the provisions of this Act, or of any regulations made hereunder, or taken or removed from any quarantine station, or any stock wilfully allowed to stray therefrom, or unlawfully outside such quarantine station, or any stock, fodder, fittings, or effects dealt with contrary to any of the provisions of this Act, may be seized by any person whosoever, and handed over to an inspector, to be disposed of as the Governor may direct. And all stock brought within the quarantine stations hereinbefore mentioned or straying within the same shall be taken and deemed to be stock duly placed in such quarantine in terms of this Act, and shall be subject to all the provisions affecting such stock; and any stock with which any imported stock may be brought in contact shall be held, taken, and deemed to be stock of the class with which they are so brought in contact, and shall be dealt with accordingly.

We trust Your Excellency and Lady Broome may long enjoy health and happiness, and that the affairs of the Colony, under your able administration, may continue to prosper.

In common with you all, I deeply desire the prosperity of Western Australia, and I really think we may say that the Colony has never had so bright and assured a future as that to which we may now look forward.
