Finding of the Board of Inquiry into the cause of the strand-ing and loss of the British brig "Greyhound" in Hamelin Bay, near Cape Leeuwin, at 10 p.m. on October 18th, 1884

WE, the undersigned, Principal Officer of Customs at the Port of Vasse, and Justice of the Peace of the Colony of Port of Vasse, and Justice of the Peace of the Colony of Western Australia, acting under the provisions of the 1st section of the 28th Victoria, No. 2, forming a Board of Inquiry into the loss of the brig "Greyhound" wrecked in Hamelin Bay at 10 p.m. on Saturday, 18th October, ultimo, are of opinion that the stranding and breaking up of the said vessel was unavoidable; and further, that every pre-caution, previous and subsequent to the casualty, was taken by the Master (Alfred Charles Prescott) to ensure the safety of his vessel in harbor, and in endeavoring to prevent her stranding upon the beach and we do not think it necesher stranding upon the beach; and we do not think it necessary to institute any formal charges in the matter aforesaid.

Revenue Schooner "Eloise,"

Cossack Creek, 28th October, 1884. I herewith have the honor to send in this report on the May River.

The Anchorage (which is a good one for a vessel of any size) is off its entrance, situated South bank of the Meda River bearing E.  $\frac{1}{2}$  N., distance  $4\frac{1}{2}$  miles, in 5 fathoms low water springs, sand and mud bottom; from this anchor-age the river takes a S.E. direction for about 16 miles, then turns sharply round to E. by N. for 4 miles, after which it runs to the Southward.

The Landing is right at the elbow of the two latter courses and is an excellent one, fit to land either stock or machinery, good high land (Pindan country), with a steep bank alongside of which a vessel (lighter) could lay, but would take the ground at low water, bottom coarse sand; there is good feed right at the landing, and water has already been found within 21 miles, but no doubt it could be found closer.

The May has an average width of about two miles, with a great many sandbanks in it; but by keeping to the West bank for the S.E. reach, and then the North bank for the rest of the way, an average depth of 2 fathoms can be carried right up by a vessel starting from the anchorage at the half-flood tide.

The river banks below the landing mentioned are extensive marshes, mud flats and mangroves.

Although there is a good depth of water, I would not advise a vessel of more than 5 feet draught to venture up the river, on account of the very strong tides that run.

From the landing, Yarralla Hill bore S. by E. 1 E., nearly 5 miles distance.

#### AUSTRALIA-SOUTH COAST.

FIXED LIGHT EXHIBITED AT CAPE NELSON.

With reference to Notice to Mariners, No. 253 (1), of 1st September, 1883, the Government of Victoria has given further notice, that on 7th July 1884, a light would be exhibited from a lighthouse erected on cape Nelson —

The light is *fixed white*, between the bearings E.  $\frac{1}{2}$  S., through east, north, and west, to W.  $\frac{1}{2}$  S., elevated 250 feet above the sea, and visible in clear weather from a distance of 19 miles.

A red sector is shown to the eastward over Lawrence rock, between the bearings W.  $\frac{1}{2}$  S. and W.S.W.; and a red sector is also shown to the westward over the southernmost point of cape Bridgewater, and one mile seaward of that point, or between the bearings E.  $\frac{1}{2}$  S. and E. by S.

The lighthouse, 79 feet high, is constructed of stone and painted white.

The illuminating apparatus is dioptric, or by lenses, of the first order

# AUSTRALIA-SOUTH COAST.

#### PORTLAND BAY.

(1) POETLAND HARBOR LIGHT-ALTERATION IN COLOR. The Government of Victoria has given notice that on 7th July 1884, the portion of Portland harbor light which previously showed red would be altered to green, it should be visible in clear weather from a distance of about 12 miles. The light now shows green between the bearings of N.W. through west, and S. by E., and white over the anchorage from S. by E. to the extremity of the jetty.

Note.—Vessels entering Portland Bay from the westward, must not, when nearing Lawrence rock, bring the light to bear northward of N.W. by W.  $\frac{1}{2}$  W.; having passed the rock, a course may be steered towards the light, keeping it on the port bow, and not standing into less than 6 fathoms. When abreast the anchorage, the jetty light (red) will be seen bearing about West.

(2) PORTLAND JETTY LIGHT-ALTERATION IN COLOR.

Also, that on 7th July 1884, Portland jetty light would be altered to a red light, which should be visible in clear weather from a distance of about 3 miles.

#### NEW ZEALAND-NORTH ISLAND.

(3) KAIPARA HARBOR-ALTERATION IN LEADING MARKS. (3) KATFARA HARBOK-ALTERATION IN LEADING MARKS. The Government of New Zealand has given notice, that on or about 20th May 1884, it was proposed to move the flagstaff on North Sand head, Kaipara harbor, about 150 feet E. by S. from its previous position, and it is therefore no longer a leading mark for crossing the bar. The lighthouse tower (when erected), the signalman's house, and the beacon in line will indicate the channel across the bar.

(The bearings are Magnetic. Variation 72° Easterly in 1884.)

A road one chain in width leaving the Telegraph Line of rad at a spot on it about 21 chains North-eastward from the 24th mile mark, and extending West to the East boundary of Sussex Location 9 at its intersection of the Busselton and Bunbury Road, surveyed by Gregory.

#### SUSSEX ROADS BOARD. MINOR ROAD.

The Duke of Cambridge, K.G., &c., It having been pointed out that the great &c., &c. interest Sir Bartle Frere took in all matters relating to ties between the mother country and the British Colonies in general, and the devotion he showed in upholding the best interests of the Colonial Empire, were so notorious that many in the colonies other than those in the South African colonies, with which he was more intimately connected, would wish to join in the memorial to him if an opportunity were afforded, the Committee invite all who knew him in private life, or admired his public character, to take this opportunity of testifying their affection and esteem.

A sum not exceeding £3,000 is to be devoted to the erection of a Statue, and the surplus of all subscriptions received will be utilised, (1) in providing a permanent Fund to be conferred, as a testimony of admiration of Sir Bartle Frere, on his widow and family in life-rent; and (2) in perpetuating his memory by settling the reversion on his family.

A sum of over £4,000 has already been collected in England.

T having been reported to the Government that Chinese Coolies recently imported from Singapore have in several instances proved to be crippled or in unsound health, His Excellency the Governor desires to draw the attention of Importers of Chinese labor into this Colony to the necessity of instructing the Agent they may employ in Singapore, or elsewhere, to exercise the utmost care in procuring proper Medical Certificates, after careful examination, that the persons engaged are in sound health, both mentally and physically.

To prevent Coolies interchanging or selling these Medical Certificates, the Agent should take especial care to satisfy himself that the man who actually embarks for Western Australia is the bond fide recipient of the Certificate, and the person originally engaged.

In reply to your Despatch No. 134, of the 11th July, respecting the proposed reduction of the charge of tele-grams on the Telegraph lines connecting Madras and Bombay with New South Wales, I have the honor to transmit to you, for communication to Your Lordship's Government, a copy of a letter from the India Office on the subject. I request that you will move your Gov-ernment to communicate the letter to the Governments of the other colonies which were represented at the Postal Conference at Sydney. 题

I am directed by the Secretary of State for India in Council to state, for the information of the Earl of Derby, that the copy of the resolution adopted by the Austrätan Postal Conference which was transmitted to this Office by Mr. Mead's letter dated 31st August, 1883, was commoni-cated to the Government of India in accordance with the request of that Conference.

The Government of India have now replied to the Secretary of State for India on the contents of that resolution, and after consideration of that reply, I am desired by His Lordship in Council to communicate with you in the following sense.

There is no disinclination on the part of the Govern-ment of India to meet the wishes of the Australian Postal Conference for a reduction in the rates charged for Press Messages on Indian lines, and so far as the Secretary of State for India is aware, no objection has been raised to such reduction by the Telegraph Companies who are interested in the matter; but it appears that Germany, as one of the Administrations interested in the telegram telegraphic route to India, objects to any considerable weduction in the mean demond reduction in the rates charged.

A meeting of the authorities representing the several A meeting of the authorites representing the several telegraph administrations is, however, arranged to take place at Berlin in May, 1885, when the subject will be dis-cussed; and, it is hoped, a satisfactory settlement in the direction of reduction of existing charges for Press Mes-sages may be arrived at. Pending the meeting of  $t_{\rm C}$ Conference, it appears to Lord Kimberley undesirable raise any discussion on the subject raise any discussion on the subject.

I am directed to request that you will move the Earl of Derby to cause a copy of this letter to be furnished to the proper authority for communication to the several Australian Colonies who were represented at the Sydney Conference.

Conditions of the Work to be performed and Rates to be charged by Contractor for Trucking.

1. The Contractor to perform all the trucking to and from the shore end of the Jettics, and to find labor for loading and discharging the trucks. Trucks will be found by the Government, and kept in repair except when damaged through carelessness.

2. The Contractor to be responsible for all loss or damage during transit, and in loading or discharging goods from the trucks.

3. The Contractor to place and stow all goods as directed by the Customs Officer in charge of the sea and shore end of the Jetty.

4. All the trucking to be charged per ton and be com-puted in accordance with the scale published in the *Govern-ment Gazette* of the 8th November, 1881.

5. When the trucking is ordered by the Principal Officer of Customs after the usual hours, during holidays, and on Sundays, the work must be performed by the Contractor.

6. Preference to be given to bonded goods so that none of such goods remain on the Jetties after 3 p.m. on all days except Saturdays, when they must be removed by noon.

7. The Contractor and his servants to be amenable to the existing Jetty Regulations.

S. The Contractor not to be compelled to load trucks with goods placed more than three yards from the rails, nor to place goods discharged from trucks more than three yards from the rails; if a further distance is required, a special arrangement may be made with the owner of the goods.

9. For performing the above services the Contractor will be permitted to charge one shilling and sixpence per ton, as per scale published in the *Government Gazette* of the 8th November, 1881, on all goods trucked to and from the sea and shore end of Jetties.




