That in each case of the Birth of every child in the said Colony the parent shall, within thirty days, and in the case of the Death of any person the tenant of the house or place shall, within fourteen days next thereafter, respec-tively inform the District Registrar of such Birth or Death, and of all the particulars concerning the same, according to the form of registration hereinbefore referred to.

Section 30.
