HEREAS under and by virtue of the provisions of "The Magisterial Districts Act, 1886," the Governor is empowered to alter the boundaries of any Magisterial District; Now THERE-FORE I, the said Governor, in pursuance of the powers vested in me by the said Act, do hereby declare that the districts named the "West Kimberley Magisterial District" and the "East Kimberley Magisterial District," respectively, shall hereafter embrace so much of the Colony as is comprised within the following boundaries :—

The "West Kimberley Magisterial District."— Bounded on the North by the 16th parallel of South Latitude; on the East by the 126th meridian of East Longitude; on the South by the parallel of 19° 30' South Latitude; and on the Westward by the sea coast, including the islands adjacent.

The "East Kimberley Magisterial District."— All that portion of the Colony North of the 16th parallel of South Latitude.

HEREAS under and by virtue of the provisions of "The Magisterial Districts Act, 1886," the Governor is empowered by proclamation to declare any portion of the Colony to be a Magisterial District, and to name the same and define the boundaries thereof; Now THEREFORE I, the said Governor, in pursuance of the powers vested in me by the said Act, do hereby declare that portion of the Colony within the following limits to be a Magisterial District, under the name of the "Kimberley Goldfield Magisterial District:"—

Bounded on the North by the 16th parallel of South Latitude; on the East by the Eastern boundary of the Colony (Longitude 129° East); on the South by the parallel of 19° 30' South Latitude; and on the West by the 126th meridian of East Longitude.

Gazette Notice No. 2479 C.S.O., of 8th March, 1886, is hereby cancelled.

7 HEREAS by an Ordinance of the Legislative Council of the said Colony, made and passed in the twenty-seventh year of the reign of Her Most Gracious Majesty Queen Victoria, No. 21, intituled "An Ordinance for the recovery of Small Debts and Demands," the Governor is empowered by Proclamation to constitute Local Courts for the recovery of Small Debts and Demands, to be holden at such times and places, and within such Districts throughout the said Colony as may be most fit and convenient : Now THEREFORE I, the said Governor, do hereby notify and proclaim, and do hereby constitute a Local Court for the recovery of Small Debts and Demands, to be holden on the second Thursday in each month, at the hour of eleven o'clock in the forenoon, at Wyndham, Cambridge Gulf, in the East Kimberley District.
