THE subjoined Final Report of the Commission appointed to promote the Representation of this Colony at the London Indian and Colonial Exhibition is published for general information, together with a Minute upon the Report by His Excellency the Governor.

MINUTE.

Read:—Report of the Commission of the “London Colonial and Indian Exhibition, Western Australia,” dated 26th November, and received 7th December, 1886.

This is the final report of the Commission.

It is signed by the Chairman, “on behalf of the Commission.” I draw attention to this because it is usual, and I think convenient, that the report of a Commission should be signed by all the members who have agreed to it. In the present case there are thirty-six Commissioners, and it would be advisable to know from how many of them the report proceeds. Several of the Commissioners resident in Perth state, as I understand, that they have not seen the report.

Though the report contains no reference to the member and late Deputy Chairman of the Commission who has been acting as Executive Commissioner for the Government in London, and to whose efforts the success of the Western Australian Court is so largely due, I nevertheless feel sure that his brother Commissioners are as ready as the Government of the Colony to acknowledge Mr. Fraser's services.

I observe it is stated in the report that the Commissioners “have not received any notice of the time of closing the Exhibition.” But I find that, in a letter addressed to the Chairman of the Commission on the 10th of June last, the Executive Commissioner in London adverted, among other matters, to the question of the disposal of the exhibits after the Exhibition, and mentioned the proximate date when the Exhibition would be closed. It is only twenty-eight days since the Exhibition closed, and the Executive Commissioner's official report of the actual closing has not yet, of course, reached the Colony. The Government possesses no other information on the subject than the telegrams which have appeared in the newspapers, and which were equally known to the Commission. The Commission was in direct official correspondence with the Executive Commissioner, and could at any time have communicated with Mr. Fraser, by telegram or by letter, asking for any information on any matter. I make these remarks because the passage in the report which I refer to may be interpreted to convey some reflection upon either the Government or the Executive Commissioner.

It seems right, also, that I should notice another passage of the report. The Chairman, writing for the Commissioners, observes that “we are not able to give Your Excellency any account of the progress of the Exhibition, not having received any.” I am at a loss to understand by what inadvertence this statement has found a place in the report, since, as a matter of fact, the Executive Commissioner in London has addressed to the Chairman many long and detailed accounts of the progress of the Exhibition in general, and of the Western Australian Court in particular. In order that it may be seen that this is the case, I will refer to these reports.

On the 2nd of February last, a few days after his arrival in London, Mr. Fraser wrote a long letter to the Chairman of the Local Commission, entering with much detail into the arrangements proposed for the West Australian Court, and trusting that what he was doing would meet with approval. In this letter, Mr. Fraser sends a copy also of a telegram which he had forwarded to the Government, requesting additional funds. I mention this because, in some papers before me, I notice an inquiry by the Chairman of the Commission as to whether the telegram in question had been communicated to the Commission, and an answer in the negative to that inquiry. The telegram was a request from Mr. Fraser to be allowed to expend an additional sum of £1,000 on the Court of this Colony. It did not rest with the Local Commission to give the authority to do this, but, after consulting the Finance Committee under the Audit Act, the authority was given by me, and the Chairman of the Commission was informed of what had been done, by letter from the Colonial Secretary, dated 20th of February, 1886.

On the 17th of February, 1886, the Executive Commissioner again wrote, at some length, reporting his proceedings, and adverting to the non-receipt of some necessary information. This letter reached the Local Commission on the 31st March.

The Executive Commissioner's next report was dated the 5th of March last, and is a lengthy account of his proceedings and of the arrangements he was making. It was forwarded to the Chairman of the Commission, to whom it was addressed, from the Colonial Secretary's Office, on the 8th of April.

On the 31st of March, Mr. Fraser again wrote to the Chairman of the Commission, reporting the arrival in London of Mr. Alpin Thomson, who had been appointed to assist the Executive Commissioner, and informing the Chairman that it was understood that Her Majesty would open the Exhibition in person on Tuesday, the 4th of May. In this letter to the Chairman, Mr. Fraser also entered into particulars of the progress of the Court in his charge.

On the 29th of April, the Executive Commissioner again addressed the Chairman of the West Australian Commission, sending a list of exhibits which had not yet reached London, and entering into other particulars. In this letter, Mr. Fraser informed the Chairman that His Royal Highness the Prince of Wales would visit the Western Australian Court on the 1st of May, “to make an official inspection,” and added that “the ceremony of opening by Her Majesty the Queen takes place at noon on Tuesday, the 4th of May.”

In Mr. Fraser's next letter to the Chairman of the Local Commission, dated the 14th of May last, the Executive Commissioner stated that His Royal Highness the Prince of Wales had inspected the West Australian Court, and had been very interested and pleased, also that our court had "been since visited by nearly all the members of the Royal Family and by crowds of other visitors." Mr. Fraser further officially informed the Chairman of the Local Commission that "the Exhibition was formally opened by Her Majesty the Queen on the 4th instant," and Mr. Fraser forwarded to the Chairman the account of the proceedings, as published in the *Times* newspaper of the 5th of May, and he also sent some Royal Commission printed papers relative to the Exhibition. Mr. Fraser further reported on the condition of our court, stated that some Kimberley gold had arrived and was attracting attention, and he forwarded copies of the official catalogue and guide to the Exhibition.

The Exhibition being now open and in full display, and Mr. Fraser's arrangements having been successfully completed, there was not much occasion for further reports, but on the 10th of June, as before mentioned, I find the Executive Commissioner again writing to the Chairman of the Local Commission respecting the disposal of the exhibits and other matters.

It may be remarked that, on the 15th of July, I addressed to the Acting Colonial Secretary a Minute, in which, referring to the Executive Commissioner's letter of the 10th of June, I intimated that I should be very glad to receive from the Commissioners any views they might wish to express respecting the disposal of the exhibits at the close of the Exhibition. In reply, the Chairman of the Commission, it seems without laying my minute before the Commission, stated that "apparently it rests with the Government to deal as they may think fit" with the exhibits at its disposal. Having received this answer from the Chairman of the Commission, I did not direct that a subsequent memorandum relative to the disposal of the exhibits, which was addressed to the Government by the Executive Commissioner on the 5th of August, should be referred to the Local Commission, but I consulted the Executive Council on the matter, and, having concurred with the advice tendered to me by the Executive Council, I directed Mr. Fraser to be instructed accordingly, which has been done.

I will also take this occasion to refer to the appointment of the Executive Commissioner in London, as I am led to believe that there has been some misunderstanding on the subject. What has been done will best be made clear if I state from the beginning the action taken by the Government.

On the 12th November, 1884, before embarking at Albany for England, I addressed the following Minute to the Honorable the Colonial Secretary, for the information and guidance of the officer who was to administer the Government of the Colony during my absence.

"To the Honorable the Colonial Secretary,

"I believe it to be the general desire that this Colony should take part in the Colonial Exhibition to be held in London in 1886.

"2. No official intimation of the Exhibition has yet reached this Government. I communicated with the Governor of South Australia on the subject some time ago, when His Excellency informed me that nothing had yet been settled in the Eastern Colonies, but that it was expected that an invitation would shortly be received from His Royal Highness the Prince of Wales.

"3. I am of opinion that, immediately the proper official communication respecting the Exhibition reaches this Colony, active steps should be taken, by the appointment of Commissioners, and of sub-committees or agents in different parts of the Colony, etc., in order that Western Australia may make a really complete and creditable show.

"4. The necessary funds should be obtained by consulting the Finance Committee under the Audit Act; but, if the Committee feel unable to recommend any expenditure, I am of opinion that the Administrator would be justified in taking the responsibility upon himself, rather than imperilling the timeliness of the action and the proper appearance of the Colony at the Exhibition. But I think the Committee will agree.

"5. I recommend that no efforts be spared to make a really excellent show of Western Australian products. The opportunity is one which should not be lost, and its seizure may result in great good to the Colony at the present juncture, when we are trying to assert, wherever we can, and in every way we can, that this country offers advantages to capitalists and immigrants.

The requisite steps having been taken by the officer administering the Government, a Commission was in due course issued, on the 12th of February, 1885, appointing a number of representative gentlemen, with the officer administering the Government himself as Chairman, to be Commissioners "to promote the representation of the products, manufactures, and resources of the Colony of Western Australia at the Colonial and Indian Exhibition;" and it was declared that the Commission "should continue in force until the close of the said Exhibition." The terms of the Commission, including the limitation of its existence to the close of the Exhibition, having been settled by the Chairman, it must be presumed that they were satisfactory to the Commission.

The Commission went to work in a practical manner, and had accomplished a good deal by the date of my return to the Colony in June, 1885, when I added the names of Mr. Steere and of a few other gentlemen to the Commission, which continued its duties.

Shortly after the appointment of the Commission the Administrator of the Government and Chairman of the Commission transmitted and recommended, for the Secretary of State's approval, the application of a member of the Commission to be appointed Executive Commissioner in London. The Administrator acted, in my opinion, rightly and in accordance with precedent in not consulting the Commission respecting this appointment, which, here, as in Victoria, New South Wales, and the other

Colonies of this part of the Empire, was intended to be made, and was made, solely by the Executive Government. Being asked for my view on the matter while in London, I recommended that Mr. Fraser, who, I was aware, was a candidate for the appointment, should be the Executive Commissioner. As Mr. Fraser was the Deputy Chairman and senior member of the Commission next to the Chairman, his selection appeared the more considerate to the Commission, while his official position and personal qualifications had also to be given weight. I think that Mr. Fraser's appointment has been justified, and that it is due to his unwearied exertions, and to his skilful management of materials, that the Western Australian Court has been the success it undoubtedly has been. I may mention that I requested the Commission to nominate a gentleman as Assistant to the Executive Commissioner. The Commission recommended Mr. Alpin Thomson, whom I appointed. I gave the patronage of this appointment to the Commission as a mark of my consideration for that body. I doubt if similar appointments have been placed at the disposal of the Local Commissions of the other Colonies.

The labours of the Commission have, as they deserved to be, been recognised by the Government. Printed papers, containing two preliminary reports of the Commission, were laid by me before the Legislative Council last session. These papers (No. 36 of the Session) can be referred to. They contain a Minute, dated the 5th of December, 1885, in which I offered "my best thanks to the Commissioners for their disinterested, and, I trust, successful labours." The papers also contain the instructions issued to the Executive Commissioner in London. A copy of these instructions was communicated to the Local Commission, on the day of their issue to Mr. Fraser. The Local Commissioners were placed in "direct official communication" with the Executive Commissioner, and Mr. Fraser was informed that it would be his "duty to pay great attention to the views and wishes expressed by the Commissioners." It was added, as was obviously required, that as Mr. Fraser would be upon the spot, and would be acting with no other object than the promotion of the interests of this Colony, I did not desire to debar him from exercising his own judgment and discretion in any matter which might arise. This saving clause had reference not only to communications Mr. Fraser might receive from the Commission, but to his instructions from the Government.

Every request which the Government has received from the Commission has been promptly complied with, and I trust that what I have written will make it clear that the Government has treated the Commission with every consideration in every possible way.

It is because the passages which I have quoted from the final report of the Commission may possibly give rise to a contrary impression, that I have thought it right that the report should be accompanied by a record of the facts of the case, and I feel sure that this will meet the wishes of the Commissioners themselves, whom I again cordially thank for their labours.

We, the Commissioners appointed to arrange the products, &c., of this Colony for the London Colonial and Indian Exhibition, beg to report

That the existence of this Commission being limited to "the closing of the Exhibition in London," it has terminated by efflux of time. For, although we have not received any notice of the time of the closing the Exhibition, we are assured that it was so closed on the 10th inst.

We have therefore, supplementing our last Report of Progress, to inform Your Excellency

That the accounts of this Commission have been made up from the 30th of January last to the 11th inst., and, with their vouchers, sent in to the Colonial Treasury, and found correct.

The accounts of the preceding period cannot be closed, as there are some discrepancies which Mr. Thomson only can explain.

Therefore it is not possible to present a final balance sheet—but

All funds in the hands of the Commission have been paid into the Treasury.

We are not able to give Your Excellency any account of the progress of the Exhibition, not having received any.

In conclusion, we have again to express our regret that our labors have not been so successful as we could desire, but it is unnecessary to say more as we have already alluded to the causes of this in our last report. We trust, however, that what we have done will meet with Your Excellency's approval.
