CIRCULAR.

Downing Street,
21st December, 1886.

SIR,—My attention having been directed to the practice which has recently been adopted in some Colonies, of granting leave of absence with half salary to Officers who remain in the Colony during such leave, I have the honor to point out to you that Chapter V. § 11 of the Colonial Regulations plainly contemplates that such leave should be spent out of the Colony.

2. I request you to make it known that no Civil Servant has any claim to spend his half-pay leave of absence in the Colony without special sanction from the Governor, which should not be given except in very special circumstances.

3. A special case forming an exception to the rule might occur if the Officer should propose to employ his leave for the public advantage with the approval of the Colonial Government, or should have urgent need of occupying himself with private affairs which had been neglected in the discharge of public duties. But in no case should an Officer on leave be allowed to accept private employment in the Colony of which he is a public Servant.

SIR,

Warden's Camp, Kimberley, December 10th, 1886.

I have the honor to submit, for the information of His Excellency the Governor, the following Report on the present condition of this field:—

At the date of my last, I estimated the population at about 1,500, now I think 1,000 is the outside number. I purpose having this ascertained as closely as possible when men are available to undertake the work; latterly, circumstances have arisen requiring the services of the Police on other important duties, and at the present time there is only one Trooper, with the exception of my orderly, in camp.

There is nothing fresh to report with regard to alluvial workings, no new or deeper ground having been opened, the same scratching in the ravines obtaining, with about the same results; rumours are continually circulated of something good having been struck, when numbers rush off to the locality only to find no truth in them.

The opening of the Prospector's claim on Jackson's Reef at Hall's Creek, of which I informed you, was the signal for numbers of others to be taken up on the supposed line, and acted as an incentive to others to abandon "gully raking" and prospect for reefs, with the result that one showing good prospects was opened at the head of Hall's Creek (probably a continuation of Jackson's), since abandoned by the original holders but taken up subsequently by another party. Another on the Brockman, registered as "The Lady Margaret," in reality only a leader, but very rich, showing splendid specimens, and the rubble casing permeated with fine gold; by following this they will in all probability strike the main reef, it may be some depth, but should repay them; this claim is "declared payable" and at only a depth of 20 feet. Of course the striking of this led to a number of claims being pegged off on the line, none so far having cut the reef.

At the 3-mile Gully from McPhee's a good leader has been worked for some time past with good results, and another in "Spear Gully," near McPhee's, shows good indications. No doubt in a short time many more will be opened up.

The utter absence of blasting material and suitable tools for this work is a bar to its being energetically prosecuted in these claims. "Dolly Crushing," a very tedious and primitive method of extracting gold from the stone, is the only method which can be adopted here, and this is done to pay ordinary expenses, which I learn they do and more. With the aid of machinery these claims should prove very rich should the stone continue to carry gold as at present.

The population on the Brockman and vicinity number some 400. On the "Lady Margaret" line being struck, about 10 claims (quartz) were applied for; now only 4 are working, employing about 20 men; very shortly probably more will be taken up; so far only the Prospector's claim is on payable stone. The remainder of the population are working in the gullies and ravines, some are doing fairly well, many not earning food, as far as I can learn, but very few of the alluvial miners are earning more than fair wages. There are 2 stores, 2 wayside houses, and a butchery on the creek.

At Hall's Creek are about 120 men, about 30 of these are working the six quartz claims on "Jackson's Line." Here also the only one that has hit the main reef carrying a good body of stone—rich stone—is the Prospector's, now a depth of 40 feet, every foot sunk showing richer stone; they have to "dolly crush" to pay expenses. Those working alluvial in this Creek are only going over old ground, from which much cannot be expected. There are 4 stores and 2 wayside houses, in conjunction with them 2 butchering establishments.

On the "Old Main Camp on the Elvire" there are some 60 men; a few of these have, I hear, done very well, the remainder not making food. I have myself watched several pannings off here with miserable results. Hall's Gully employs about 60, all on old workings and doing very little.

McPhee's Gully, 130, all working old ground which has been worked and re-worked at least three times, so much cannot be expected from this; it is probable payable reefs will be struck in this locality. One store and slaughter yard here.

On the "Mary Fall," as it is termed, are about 130 men. I learn some good gold has been got here, and that some men have done fairly well; this and the Brockman appear the most remunerative of the field. No permanent store, but several packers.

There are a few parties on the "Panton." I have not visited them yet but am on the point of doing so. Reports from there say they can only get "color." It is in this direction and that of the Mary where most attention to alluvial workings is being turned now, with a view to opening new and deeper ground.

The population at these places as given is what is at the present time; in three or four days it may be very different, it is a very floating one, and only those who are on good wages ground stay more than a day or two in one place.

Thunderstorms, the precursors of the wet season, are of daily occurrence, consequently many well equipped parties are preparing to start (some have done so already) in various directions, prospecting. Mr. McPhee, a pioneer miner and general benefactor to the field (which latter will be borne out by everyone), who opened the Gully bearing his name,—perhaps one of the richest so far,—is about starting out with a strong party thoroughly found in everything (I learn he takes about 50 pack horses with him). He is reported to be going south, and should he be fortunate enough to strike anything payable will at once report it. It is rumoured that about 100 men purpose following him under the impression that he knows of some good ground, but he assured me he is purely prospecting.

Parties are arriving every day with numbers of pack horses from Wyndham, who had gone down to procure supplies to last them through the wet season. They have been travelling slowly up or camped on good feed awaiting the first rains. I hope after these have fairly set in to be able to report a large increase in the yield of gold, but I am firmly of opinion that if it be so it must be from entirely new ground. The most of the present workings have been worked several times over, and must be almost if not quite exhausted, an occasional patch of a few ounces all in a little pocket or on a bar which has been missed in the former rakings being found. I regret, but at the same time I dare not even hazard a conjecture as to the yield of gold or average takings. I do believe more is being obtained than any one knows of, there being no bank. The men only produce enough to pay for their rations, and the majority plead utter poverty, and I know of my own knowledge that there are numbers only making sufficient to procure flour and tea; meat or other proper food is almost unknown to them now. I will endeavor to elicit some more definite information before my next report, before which I shall have been all round the different workings again, and when we are sure to have had some heavy rains.

If the prospects of the alluvial workings are not very good, those of the reefs so far opened are, and augur well for the future of this as a reefing district.

I mentioned in my last that the miners, or the majority, were very averse to taking out their "Rights," but that by letting them have time they would come for them of their own accord, and it is turning out as I anticipated.

There is a great deal of sickness on the field, and a number of deaths have occurred lately. Fever, dysentery, scurvy, and general debility, the latter from an insufficiency of proper food being the cause; indeed I may say the whole of them arise from this cause, with the exception of fever.

The thunderstorms have left water in many places, sufficient for personal use but not for mining.

In conclusion, I must say this is the most orderly field I have known. I attribute it to two causes, first that the greater number of the men on the field at the present time are old miners, who are, as is well known, the most law-abiding of communities, standing by "The Regulations" to the last, and second to the poverty of the field. Until quite recently there was not a "Shanty" or even a bottle of intoxicating liquor on the field. Now, had it been very rich, "Shanties" would have been here with the first of the men; and even now that liquors are obtainable but little abuse of them is seen, the majority of the men plainly saying they cannot "get enough gold to buy meat, let alone grog."

I trust, on my return from my visit round the field, to be able to report more favorably as to its future.
