By His Excellency SIR FREDERICK NAPIER BROOME, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commanderin-Chief in and over the Territory of Western Australia and its Dependencies, &c., &c., &c.

HEREAS it is provided by "The Sandalwood Act, 1881," that it shall be lawful for the Governor-in-Council from time to time to proclaim and define one or more area or areas of Waste Lands of the Crown within which no live or growing Sandalwood tree shall be cut or grubbed up for the period to be named by the Governor in such proclamation:

Now THEREFORE I, the said Governor, with the advice of the Executive Council, do hereby proclaim and define the Waste Lands of the Crown contained and being within the following areas to be areas within which no live or growing Sandalwood tree shall be cut or grubbed up during the period of three years from the date hereof:—

1. All that portion of Crown land, included within an area bounded on two sides by lines drawn on each side of and parallel to the railway being constructed under the contract entered into between the Government and Anthony Hordern, on the 25th day of October, 1884, at a distance not exceeding 40 miles therefrom; and on the North and South by lines produced East and West through the terminus of the railway at Beverley and at Albany.

2. All that portion of Crown land, included within an

2. All that portion of Crown land, included within an area bounded on two sides by lines drawn on each side of and parallel to the railway being constructed under the contract entered into between the Government and John Waddington, on the 27th day of February, 1886, at a distance not exceeding 40 miles therefrom; and on the North and South by lines produced East and West through the terminus of the railway at Guildford and at Walkaway, Greenough Flats.
