pursuance of the provisions of an Act passed in the fiftieth year of our Lady the Queen, and intituled "An Act for the management of Goldfields," I, the said Governor, do hereby proclaim the portion of Crown Land bounded on the North and West by lines extending East 100 miles and South 100 miles from a point situate 30 miles North and 20 miles West from Ennuing Well, the opposite boundaries being parallel and equal, to be a Goldfield, and to be known and called by the name of "The Yilgarn Goldfield."

N pursuance of the provisions of an Act passed in the fiftieth year of Our Lady the Queen, and intituled "An Act for the Management of Goldfields," I, the said Governor, do hereby proclaim the portion of Crown Lands bounded on the West by a line extending South from a spot on the Sea Coast East by South from Depuch Island, and passing through the summit of Mount Negri, continuing South till it meets a due West line from Trigonometrical Station B 3; on the South by the due West line aforesaid; on the East by a North line to the Sea Coast; and on the Northward by the Coast aforesaid to the starting point, to be a Goldfield, and to be known and called by the name of "The Pilbarra Goldfield."
