Perth, 6th November, 1888. IIS Excellency the Governor, acting in this behalf by virtue of "The Quarantine Ordinance, 1868," Section 2, has been pleased to order and direct that the area hereinafter defined shall be a place for the performance of Quarantine in the Port of Carnarvon, viz. :—

Babbage Island and the adjacent space or anchorage ground hereinafter defined.

Northern limit.—Anchor Hill, on Whitmore Point, or the North entrance of Whitmore Island, bearing East magnetic.

Southern limit.—Site of proposed beacon on Babbage Island, being the highest of the low hills in about centre of island, bearing East magnetic.

Eastern limit.—A line parallel to, and eight cables from, a line joining the above two points.

Western limit.—A line parallel to, and eight cables to the Westward of this line, or sixteen cables from the line joining the two points named.

The depths over this quarantine anchorage ground are from two and a-half to three fathoms and three-quarters (sand).

Additional Amended Regulation for the management of Goldfields.

Any Protection Area granted under the Regulations of 2nd February, 1888, which after the date of the grant thereof shall have come or shall come within the limits of a proclaimed goldfield, may, notwithstanding the proclamation of such goldfield, continue to be held under the terms of the said regulations, until the expiration of one year from the date of such grant or until the discovery of payable gold on such area, whichever shall first happen; in which latter case the Goldfields Regulations will immediately apply—provided that if the labor conditions requiring two men for each protection area, as provided by the Regulations of 2nd February, 1888, are not fully complied with, the above extension of time will cease and determine, and the protection area will be forfeited.

This Regulation is substituted for the Additional Regulation gazetted on October 1st, 1888, which is hereby cancelled.

Notice.—The attention of holders of Protection Areas is called to the above Regulation intended for their benefit, but they are warned that the Wardens of Goldfields are instructed not to grant any exemption from the labor conditions to persons availing themselves of this Regulation.

NOTICE.

W HEREAS it has been frequently found when lands have been fenced, or in enclosures, that the Boundary Marks have been destroyed or removed, Persons are hereby cautioned not to destroy or remove, under any pretext whatever, any posts, pegs, or other marks placed for the purpose of defining the boundaries of any lands. Any person found so doing will be prosecuted, and upon conviction will be liable to a penalty of from £10 to £50, or to imprisonment for six calendar months.

## PERTH LOCAL BOARD OF HEALTH.

I N pursuance of the Public Health Act, 1886 (50 Vic., No. 19), notice is hereby given that the Bye-laws for the Municipality of Perth, dated 12th day of April, 1888, and published in the *Government Gazette* of the same date, are hereby repealed, and that the following Rules, Orders, and Bye-laws having been confirmed by the Central Board of Health, shall come into operation and take effect from the date of publication in the *Government Gazette*.

#### BYE-LAWS.

1. The Board shall meet for general business in the Town Hall, on the first Friday in each month at 4 p.m., and special meetings may be called at any time by the Chairman or any two Members of the Board.

2. All monies shall be placed in the Bank to the credit of the Board, and none shall be drawn therefrom except by cheque, signed by the Chairman or any two Members of the Board, and countersigned by the Secretary.

3. The duties of the Secretary and Inspector of Nuisances shall be: to make himself thoroughly acquainted with the provisions of "The Public Health Act, 1886," and carry out its provisions under instructions from the Board.

To visit occasionally, at uncertain times, the several quarters of the City, and if necessary give his advice to the occupiers of premises as to the prevention of nuisances and deodorising offensive matter.

To keep a monthly record of all notices issued to abate nuisances, and the result thereof.

To keep constantly hung up, outside the office door, the names and abodes of all licensed nightmen, for the information of the Public.

To summons, attend, and take minutes of all meetings of the Board, keep accounts, and perform such other clerical duties as may be necessary.

4. The dry earth or pail system shall be used in an area comprising, for the present, both sides of St. George's Terrace, and Hay and Howick Streets from William Street to Pier Street. The names of the nightmen for this area may be seen on the notice board or obtained from the Inspector.

5. Should any nightman neglect or refuse, without reasonable excuse, to properly clean any cesspool, water closet, or earth closet, or to remove any other offensive matter for 24 hours after demand from the Inspector, or any occupier of premises within the city, he shall be subject to a penalty not exceeding 5s., and the Inspector or occupier may engage any other nightman for the service.

6. No nightsoil, or other offensive matter, shall be removed before 11 p.m. or after 5 a.m.; any person guilty of a breach of this Bye-law shall be subject, on conviction, to a penalty of not more than Five pounds.

7. Any person who shall deposit broken glass, bottles, empty tins, or other rubbish, in any street, or other public place within the City, or other than the places set apart for that purpose, shall, on conviction thereof, in addition to the expense of removing the same, be subject also to a penalty of not more than Two pounds. 8. No person shall exercise or practise the business of a nightman, or drive any nightcart within the limits of the city of Perth, unless and until he shall have obtained a license to do so from the Inspector, subject to the approval of the Board.

9. Nightmen's licenses shall be in the form contained in the Schedule hereto annexed marked A, or to the like effect, and shall be numbered in such manner as shall be approved by the Board.

10. Nightmen's licenses, at whatever period of the year they may be granted, shall remain in force only until the 31st day of December then next ensuing; provided that apart from any penalty which may be inflicted under the provisions hereof, it shall be lawful for the Board, upon being satisfied of the misconduct of any licensed nightman, whilst engaged in the business for which he shall be so licensed, to cancel any such license, or to suspend the operation thereof for any such time as to the Board shall seem fit; and if any such nightman shall, after such cancellation, or during the period of such suspension, practise such business as if under the authority of such license, he shall be subject, upon conviction thereof, to a penalty not exceeding Two pounds.

11. Every licensed nightman, whenever or so long as he shall be engaged in removing any nightsoil or other offensive matter or thing, or in driving any nightcart, or otherwise in conducting the said business, shall carry with and about him his license, and shall produce and show the same whenever required by any person to do so; and such license he shall, on no pretence whatever, lend or part with to any other person.

12. Every licensed nightman shall, whilst using any cart or other carriage as a nightcart, have painted, and kept at all times conspicuous on the right or off side thereof, white upon a black ground, his name, together with the words "Licensed Nightman" in letters not less than two inches in length and of proportionate breadth, and the number assigned to such nightcart in figures not less than four inches in length and of proportionate breadth.

13. For the purpose of these Bye-laws the word "nightman" shall be understood to mean any person who for remuneration shall remove, or assist to remove, any nightsoil, or other foul or offensive matter or thing whatever; and the word nightcart shall mean any cart or other carriage of any description whatsoever, used by nightmen for the conveyance of any nightsoil, ammoniacal liquor, or other offensive liquid or substance.

14. Each house shall be provided with a dustbin, or other suitable receptacle, of a size to be approved by the Inspector, and shall be kept clean and free from offensive smell, and shall be cleaned at least once every month, or as often as the Inspector may direct.

15. Any licensed nightman who shall ask or demand or receive from any person or persons, for work done by him, any sum greater than that fixed by Schedule B. of these Bye-laws, shall be guilty of an offence against these Bye-laws.

16. Every bucket or pan kept for the reception of nightsoil shall be of iron, and shall be of a shape and size suitable for the purpose.

17. Every privy or closet shall be built in such a position that the same may be emptied without the contents being carried through any dwelling-house; and every person having or building a closet contrary to this Bye-law shall be liable to a penalty of not less than One pound nor more than Five pounds.

18. All penalties recoverable under these Byelaws shall be applied in the manner directed by Sec-

tion 129 of the Ordinance 50 Victoriæ, No. 19. Wherever in these Bye-laws the word Inspector is used, it shall be taken to mean the Inspector for the time being of the said Local Board, or any one duly appointed to act in his place.
