NOTICE TO MARINERS.

BEACONS AT ROEBUCK BAY, N.W.
COAST OF AUSTRALIA.

NOTICE is hereby given that two pole beacons painted white, and having triangles at the tops, have been erected to mark the passage between the Channel Rock and the point of Middle Ground into the Inner Anchorage in Roebuck Bay.

The two beacons in line bearing N. 12° 24' E., magnetic, will lead into the Inner Anchorage, between Channel Rock and the Middle Ground. Vessels going in should keep them in line until Entrance Point bears S.W. by W. $\frac{1}{2}$ W., and then steer for the anchorage.

Report of H.M.S. "Rambler" for Season 1889.

SIR,

H.M.S. "Rambler," Albany, 18th December, 1889.

I have the honor to inform Your Excellency regarding the progress made in the Hydrographic Surveys of the N. W. Coasts of Australia during the season 1889.

A narrative report seems the most fitting method of combining past movements of the "Rambler," with future suggestions as to the Coast Survey.

Port Darwin has been the head-quarters throughout, and the entrance and approach to the Cambridge Gulf the chief scene of the "Rambler's" labors.

A chart, on a scale of one inch to the Geographical mile, is in course of construction, the surveys being completed extending from Cape St. Lambert on the north to "Position Doubtful Islet" on the south, of the old chart, embracing La Crosse Island and the entrance of the Cambridge Gulf as far as Adolphus Island: thus joining the work accomplished in the "Myrmidon" by my predecessor, Captain the Honorable Foley Vereker, during the season 1888.

Lines of deep sounding have also been run between Port Darwin and Cambridge Gulf, and between the latter and Roebuck Bay. These soundings would have been continued had the severity of the Southerly wind and sea met with not put an end to all attempts at further sounding.

When at Roebuck Bay, coal was replenished, and a few corrections made to the chart. I also advised the Inspector of Pearl Fisheries, with reference to the most appropriate positions to be adopted for the beacons sent up from Fremantle, to be erected as a leading mark for the guidance of vessels entering the anchorage off Broome, inside Roebuck Bay.

I took the opportunity, while at Shark Bay, to amend the chart of Gascoyne Roads, adding the considerable jetty which has been built, and noting the condition of the bar of the river; the deepening of which by dredging would allow steamers of 15 feet draught to go alongside the jetty in smooth water, and discharge or take in cargo.

Having gathered from the captain of one of the Adelaide Steam Navigation Company's steamers, the "Flinders," the practicability of a vessel of 14 feet draught taking the passage inside Dirk Hartog Island, across what are known as the Inner and Outer bars, and the Southerly wind continuing to blow fiercely, I resolved to make the attempt in the "Rambler," thus saving some 90 miles of open sea work.

On a draught of 13ft. 3in. the "Rambler" successfully passed each of the bars mentioned. The Outer bar has 4 fathoms over it at low water, and with Southerly winds the sea over it is quite smooth, and navigation easy. The passage across it has been recently simplified, by the erection of two wooden beacons on the shore with triangular discs, which when kept in line serve as a leading mark for the best channel.

About the centre of the inner bar into Shark Bay, and marking the best channel, a black buoy has been placed. This bar is of soft sand and weed, and here, again, a steam hopper dredge might be usefully employed.

It has been reported to me, and I see no cause to doubt the report, that the steamers of the company I have alluded to cross this bar drawing as much as 15 feet, the sand being soft preventing the vessels losing their way through the water. Here the sea is invariably smooth.

Bad weather prevented my complying, to the letter, with the request contained in Your Excellency's telegram of 30th October, received by me at Roebuck Bay, as to an examination of Maud reported anchorage in about latitude 23° 5' S., longitude 113° 52' E. In passing this part of the coast the weather was bad, and a decidedly adverse current and in-draught towards the shore were experienced.

As far as I could judge, the line of heavy breakers appeared continuous: if anchorage there be inside the reef, such anchorage must be confined and hazardous, and should, I would suggest, be surveyed by an officer and boat approaching by road from the land side—opportunity of wind and sea being taken advantage of.

After some doubts as to the shortness of fuel, making it probable that the "Rambler" might have to call at Geraldton, Fremantle was arrived at November 15th.

The vessel was secured to the jetty on a draught of 14 feet, taking in coal with greater facility than from a hulk.

The spring piles of which the jetty is built seem to act admirably, but I would again respectfully suggest, that here there is room for the employment of a steam hopper dredge, to deepen the ship's berths near the jetty, as well as the area to the Northward towards the mouth, and in the entrance of the Swan River.

A favorable run was experienced round the Leeuwin, quickly followed by very heavy westerly weather, which caused me to congratulate myself that I had not attempted the exposed roadstead of Hamlin. Here I must express my regret at not having followed more than the spirit of Your Excellency's wishes, as expressed in the Despatch of 26th November, 1889, regarding our calling at Hamlin.

After consultation with Captain Russell, R.N., the Chief Harbor Master, who proceeded in the "Rambler" from Fremantle to Albany, the barometrical symptoms, exceptionally late season, and more importance to be attached to what lay before us at Albany, outweighed the apparent necessity for immediate action at Hamlin.

At Hamlin again, the opportunity offers for the employment of a single naval surveying officer, with boat, proceeding by road with hired crew to make a large plan of the improvements reported by the local owner, working from the shore as opportunity offers.

And now I come to Princess Royal Harbor, or Albany, which the "Rambler" reached November 29th.

The last Admiralty chart of the port and entrance to Albany was made in 1877, by Staff-Commander Archdeacon. Since then the Railway jetty has been constructed, and a large scale plan on about 30 inches to the geographical mile executed in July, 1888, under other than sea-going auspices.

This plan showed that a marked change had taken place in the depths in the entrance of and approach to the harbor. The "Rambler's" time for retention on these coasts was running short, as I had instructions to proceed to Hobart for refit and completion of charts, and then to Sydney for docking and other details. The officers and men, too, were to a certain extent jaded by the season's labors on the North-West coast. Nevertheless, after consultation with the various authorities, I saw that the opinions being so divided and documents contradictory on the question of silt, or no silt, at the harbor entrance, that the best and only plan, in spite of the continuous unfavorable weather, was to make a new and independent chart of the whole of Princess Royal Harbor, on a scale of six inches, and of the entrance on twelve inches to the geographical mile.

This has been accomplished, with the result of showing—

- (1). That neither the entrance to, nor the anchorage area of the Port of Albany has decreased materially since 1877, or the date of Staff Commander Archdeacon's Survey.
- (2). That the area of the most desirable channel and anchorage consisting of sand, that it is probable that a steam hopper dredge could speedily deepen the bar at the entrance to a depth of 29 or 30 feet, at low water.

Having entered the port, there is no obstruction or tidal difficulty to be encountered in berthing vessels alongside the outer part of the Railway Jetty, which, with the heavy moorings for hauling vessels off to, does not deserve the detractions I have heard levelled against it—but, as it stands, offers excellent accommodation for the steam ships of 24 feet draught which occasionally enter the Port.

Tracings of the plans made will shortly be in the hands of Your Excellency, and new Admiralty published charts of the parts surveyed will probably be available for public disposal before long.

The chart of the entrance to Cambridge Gulf shows anchorages and deep channels into the Gulf, on the route leading up to Wyndham, not before known, and which effect a considerable saving in time, distance, and anxiety to those engaged in the navigation of those parts.

The captains of the steamers calling at Wyndham have been supplied with approximate tracings from the Staff of the "Rambler," to aid them in navigation prior to the availability of the published Admiralty charts.

In conclusion, I would respectfully offer two suggestions which occur to me for the improvement of the Hydrography, and the easier accomplishment of the immediate small surveys called for on the coast of West Australia:

- (1.) That out of the £3,000 annually voted by the Colony towards the expenses of the surveying ship of war nominated by the Admiralty for this work, £1,000 should be devoted to the upkeep and expenses of a Naval Surveying Officer resident in the Colony, and in the position, regarding the Government authorities, similar to what was formerly allotted to officers such as Staff-Commander Archdeacon or Coghlan, who formerly conducted these surveys.
- (2.) That a steam hopper dredge (I say a hopper dredge, because such a craft is seaworthy, more economical, and can steam from port to port) should be purchased, or hired, for the deepening of the various sand-obstructed channels to navigation of West Australian ports. I have already pointed out in the course of this report the great value such a dredge would be in deepening the approaches, &c., of such places as Albany, Fremantle, Carnarvon (Gascoyne River), Inner Bar in Southern Passage to Shark Bay, and I would add the approach to Broome in Roebuck Bay, the channel to Roebourne, and the landing at Wyndham.

If the finances of the Colony are judged too small to meet such an expense, a small extra tollage on port dues might meet the case and serve to pay off the interest of any money borrowed for the undertaking. Failing that, private enterprise, if guaranteed by Government, might step in and carry the matter out. Such contractors as those who recently constructed the Railway between Port Darwin and Pine Creek in the Northern Territory, as also that between Perth and Albany in this Colony, being of the type alluded to.

An offer of £10,000 for the deepening of the channel into the port of Albany to a depth of 30 feet, I would respectfully suggest, might speedily see that most desirable undertaking in a fair way towards effective and rapid completion.

I have reason to expect that H.M.S. "Rambler" will not return to N.W. Australia, but that either H.M.S. "Penguin" or H.M.S. "Egeria" may be detailed for a continuation of the coast survey, commencing at the Holothuria bank, and working westward to King Sound and Derby, in about the month of April next. If the former vessel, which is just about to leave England, is selected, I consider it probable that she may call at Albany or Fremantle first, proceeding northward from thence to the scene of the Survey. The Lords Commissioners of the Admiralty will, no doubt, inform Your Excellency, through the customary official channels, as to what has been decided on, in due course.

85. All ground held under a mining lease shall be worked by not less than one man for every three acres or part of three acres, unless exemption or partial exemption from work has been granted. Provided that no lease shall be worked by less than two men.

2. The purchases will be made in Calcutta, Madras and Bombay, by Remount Agents under the orders of the Director, Army Remount Department.

3. The Calcutta Remount Depot will be open for the reception of horses from the 1st of October, 1890, to the end of the purchasing season. Purchasing to commence as soon after arrival of the shipment as the Remount Agent may direct.

4. Horses and mares of all breeds will be received, but they must be within the prescribed age, 4 to 6 years, and in the case of Australian horses 14 hands 3 inches to 16 hands high.

5. Greys will not be purchased for Horse and Field Artillery.

6. The average price for an Australian or Cape remount has been fixed at Rs. 650, which will be paid at the Indian port of purchase. The average price for Arabs and Persians is Rs. 550, but every horse presented for purchase will be valued separately, and higher or lower prices may be given provided the averages fixed above are not exceeded.

Explanatory Notes on Clauses 46, 47, 48, 49, 54, and 55 of the Land Regulations of 1887.

*Crown Lands' Office,
Perth, December 20th, 1889.*

APPLICANTS for land should be careful to ascertain which clause of the Land Regulations is most advantageous in their particular case, and should always state clearly, when applying for land, the Clause of the Regulations they wish to come under. In order that the above Conditional Purchase Clauses may be clearly understood, the following explanations have been prepared for general information:—

Clause 46.—This clause is only to be used in applying for land within a surveyed agricultural area.

2. An applicant must not be under 18 years of age, and must reside upon a portion of the land taken up.

3. The area held by one person must not be less than 100 acres nor more than 1,000 acres, and may be in three blocks but no more.

4. The rent is 6d. an acre for 20 years, payable on 1st March in each year.

5. The improvements required are, that within 2 years one-tenth of the land shall be fenced, and the whole within 5 years—and, within the 20 years, ten shillings an acre has to be expended on the land.

6. At any time after 5 years, if all the improvements are completed and the full 20 years rent paid, the title deed will issue.

Clause 47.—This clause is intended for those who possess land under former Regulations, and reside upon a portion of such land, and is applicable either within an agricultural area or outside of it.

2. By this clause a person can take up from 100 to 1,000 acres anywhere within 10 miles of his homestead.

3. The rent is 6d. an acre for 20 years, and the conditions, excepting residence, exactly the same as under Clause 46.

Clause 48.—This clause is intended for those who wish to apply for land outside an agricultural area.

2. An applicant must reside upon a portion of the land within 6 months from the date of survey.

3. The rent and all other conditions are exactly the same as under Clause 46; the only difference being that Clause 46 is intended for a surveyed agricultural area, and Clause 48 for land outside of an agricultural area.

Clause 49.—This clause is intended for those who do not reside upon their own land, and who do not wish to reside upon the land taken up, or by those who reside upon their own land and wish to take land situated more than 10 miles from their residence, without residing upon it.

2. This clause is equally available for land within an agricultural area and land outside of an area.

3. Under this clause the annual rent is one shilling an acre, and the conditions, excepting residence, the same as under Clause 46.

Clause 54.—This clause is intended for those who wish to pay ten per cent. of the purchase money (viz., 10s. an acre) on application, and the balance within one month after the application has been approved.

2. This clause is equally available for land within an agricultural area and land outside of an area.

3. Residence is not required under this clause. From 100 to 5,000 acres, in not more than 3 blocks, can be obtained.

4. The improvements required are, that the land shall be fenced in within 3 years from the date of survey, and 5s. an acre expended upon it in improvements within 7 years from such date.

Clause 55.—This clause is intended for those persons who require land for vineyards, orchards, and gardens in small blocks of from 5 acres to 20 acres, either within an agricultural area if small blocks have been surveyed in it, or outside of an area.

2. Residence is not required.

3. Not more than 20 acres can be obtained under this clause by any one person.

4. The price per acre must not be less than £1.

5. The improvements required are that the land shall be fenced, and one-tenth part shall be planted with vines or fruit trees, within 3 years from the date of survey.

6. If the land required is outside the South-West Division, it must be within a special area or within 10 miles of a townsite.
