By His Excellency SIR MALCOLM FRASER, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Administrator of the Government in and over the Colony of Western Australia and its Dependencies, &c., åc., åc.

HEREAS a certain Townsite has been duly proclaimed a Townsite under the name and style of Knutsford Townsite, such Townsite con-
