THEREAS under the provisions of "The Constitution Act, 1889," it is made lawful for the Governor of Western Australia for the time being to fix the place and time for holding the first and every other Session of the Legislative Council and Legislative Assembly: Now THEREFORE I, SIR WILLIAM CLEAVER FRANCIS ROBINSON, G.C.M.G., being Governor as aforesaid, in exercise of the powers so in me vested as aforesaid and of all other powers me enabling in that behalf, do by this my Proclamation announce and proclaim that THE FIRST SESSION OF THE LEGISLATIVE COUNCIL AND THE LEGISLATIVE ASSEMBLY, to be holden under the provisions of the said Act, shall be holden, for the despatch of business, on TUESDAY, THE THIRTIETH DAY OF DECEMBER INSTANT, at the hour of twelve of the clock AT NOON: the session of the Legislative Council to be holden in the Building lately known and used as the General Post Office, in St. George's Terrace, in the CITY OF PERTH, in the said Colony; and the session of the Legislative Assembly to be holden in the Chambers heretofore used by the late Legislative Council, in the CITY OF PERTH, in the said Colony; and the Members of the Legislative Council and the Members of the Legislative Assembly are hereby required to give their attendance at the said time and places accordingly.

My LORD.

Government House, Perth, 23rd December, 1890.

The Press is at present engaged in discussing the alleged irregular proceedings of the Executive Council with regard to the appointment of the Legislative Council, and in case your attention should be called to the discussion, it may be well that I should offer a few remarks on the subject.

2. The fact that the Members of the Executive Council are sworn to secrecy should of itself be sufficient to show the public that the statements as to our proceedings are unfounded, or at all events unauthorised; and I confess it seems to me a pity that the early days of Responsible Government should be disturbed by any lengthened controversy, based on an erroneous impression of the character to which I have referred.

3. I need scarcely assure Your Lordship that the ballot-if by ballot secret voting be understood—was not resorted to in any shape or form. It is true that before the Council met, the Members were furnished by me with comprehensive lists of the names which would be submitted for consideration, in order that they might have ample time to consider beforehand to whom they would give deliberate preference. As each name was read out by myself, members declared freely and openly whether they supported the nomination or not, and, wherever it was necessary to do so, the merits and claims of the persons whose names were before us were fully and frankly discussed.

The personal responsibility thrown on the Governor was exercised in a perfectly regular and constitutional manner, and for the appointments made, after receiving the advice of the Council as required by law, I recognise that I am personally and constitutionally responsible. I say this with the more satisfaction inasmuch as there was a remarkable agreement of opinion between the Council and myself with regard to the gentlemen nominated, and I believe that when the country shall have had some practical experience of the proper functions and attributes of the Upper House, the selections which we have made will be found to vindicate our choice.

5. I left two vacancies to be filled on the advice of the incoming ministry, in case they should require to use them in connection with the formation of the Government.

Scriptural instruction is given, out of school hours, to boys whose parents or guardians wish them to receive it.

Fees.

The present scale of fees is as follows :----

- For each boy over 12 years of age on the first day of the term, £3 6s. 8d. per term.
- For each boy under 12 years of age on the first day of the term, £2 13s. 4d. per term.
- In the case of two or more brothers attending the school, a reduction of 10 per cent. will be allowed in the fees for tuition.
- The fees for each resident boarder are at the rate of £60 per annum for a boy over 12 years of age, and £50 per annum under 12 years, inclusive of the tuition fee.

Boys are received from the age of eight years and upwards.

Scholarships.

There are two High School Scholarships of the annual value of £50, open to competition by boys from any of the Elementary Schools.

Terms and Vacations.

The year is divided into 3 terms, with vacations of 6 weeks at Christmas; 1 week at Easter, during which it is optional for boarders to remain at the School without additional charge; and 5 weeks at Midwinter.

The present term at the High School will end on Wednesday, the 17th instant, and the next term will begin on Saturday morning, January 31st, 1891, at 9 o'clock.

New boys will be expected to attend for the purpose of examination at 2 p.m. the preceding day.
