By His Excellency SIR WILLIAM CLEAVER FRANCIS ROBINSON, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Colony of Western Australia and its Dependencies, &c., &c.

HEREAS the Parliament of Western Australia now stands prorogued until Tuesday, the 30th day of June; AND WHEREAS it is expedient further to prorogue the same: Now THEREFORE I, the said Governor, in exercise of the powers in me vested, do by this my Proclamation further prorogue the said Parliament from Tuesday, the 30th day of June, to Wednesday, the 2nd day of September next ensuing.

Given at Perth, under my hand and the Public Seal of the said Colony, this 16th day of June, 1891.
