IS Excellency the Administrator in Executive Council has been pleased, on the recom-mendation of the Perth Roads Board, to approve of the following deviation in the road from Perth to Wanneroo, viz.:-That portion from the North boundary of Location K to the Western boundary of Location 132 is closed, and the following line of road substituted therefor: the West side being a line starting from a spot situate 51 chains 98 links West, from the South-West corner of Swan Location I, and extending 9 degrees 46 minutes, 28 chains 20 links, 350 degrees 1 minute, 69 chains 86 links, 42 minutes, 11 chains 57 links, along the East boundary of Swan Location 741; then 356 degrees 8 minutes, 50 chains, 355 degrees 22 minutes, 13 chains 3 links, 360 degrees 36 minutes, 20 chains 2 links, 355 degrees 34 minutes, 58 chains 58 links, to the North-East corner of Perthshire Location 114, and the South-East corner of Perthshire Location 103, and along its Eastern boundary 336 degrees 57 minutes, 154 chains 28 links, to the Southern corner of Perthshire Location 102, and along its South-East boundary 21 degrees 47 minutes, 62 chains 92 links, to its Eastern corner; then 239 degrees 52 minutes, 73 chains 68 links, 331 degrees 59 minutes, 84 chains 42 links, through the North-East corner of Swan Location 839; then 332 degrees 53 minutes, 136 chains 37 links, to the Eastern boundary of Swan Location 132, and North 5 minutes East, 7 chains 77 links, to its North-East corner.

HIS Excellency the Governor in Executive Council has been pleased to direct that on and after the 1st November next, the following portions of the Sharks Bay Pearling Grounds shall be closed until further notice :—

No. 1.—All that portion of Denham Sound lying between the shore of Dirk Hartog Island and a line drawn from Quoin Bluff to a headland lying South by West half South from Cape Bellefin.

No. 2.—All that portion of Useless Inlet and Freyeinet Reach which lies inshore of a line extending Northwards from Cape Bellefin to the edge of the Three-fathom Bank on the 26th parallel South latitude, and along it East to a point about $1\frac{1}{2}$ miles North-North-East from Cape Heirisson, and thence about South-South-East half South in direction of Lefevre Island to a spot $1\frac{1}{2}$ miles East from a headland lying about 5 miles North-Westerly from said island, and thence West to that headland.

No. 3.- All that portion of Denham Sound lying inshore of a line extending West from Cape Lesueur 2 miles, then South-South-Easterly to a spot 2 miles West from Lagoon Point, and then East to said Point.

No. 4.—All that portion of Hopeless Reach, Sharks Bay, lying between the shores of Faure Island, Peron Peninsula, and lines drawn from the North-Eastern shore of Faure Island to Cape Peron, and from the South end of Faure Island to the end of the Cliffs about 1½ miles South from Dubaut Point.

With reference to my Circular Despatch of the 9th of May last, I have the honor to transmit to you, for publication in the Colony under your Government, a copy of the Imperial Act 54 and 55 Vict., cap. 31, "to enable Her Majesty in Council to carry into effect Conventions which may be made with "Foreign Countries respecting Ships engaged in Postal Service."

An Act to enable Her Majesty in Council to carry into effect Conventions which may be made with Foreign Countries respecting Ships engaged A.D. 1891. in Postal Service.

[21st July, 1891.]

B E it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal and Commons in the of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows :--

1.-(1.) Where Her Majesty the Queen has made a Convention with a Foreign State respecting the postal service between such Foreign State and the United Kingdom, or respect-Act by Order in ing the privileges of mail ships, that is to say, ships engaged in any postal service of such Council. Foreign State or of any part of Her Majesty's dominions, it shall be lawful for Her Majesty in Council to Order that this Act shall, and this Act shall accordingly, subject to any con-ditions, exceptions, and qualifications contained in the Order, apply, during the continuance of the Order, as regards such Convention and Foreign State, and the postal service and mail ships described in the Convention; and where by virtue of any such Order this Act or any section thereof applies as regards any Convention, Foreign State, postal service, or mail ship, the same is in this Act referred to as a Convention, Foreign State, postal service, or mail ship to which this Act or section applies.

(2.) The Order shall recite or embody the terms of the Convention, and may be varied or revoked by Order in Council, but shall not continue in force for any longer period than the Convention.

(3.) Every Order in Council under this Act shall be laid before both Houses of Parliament forthwith after it is made, or, if Parliament be not then sitting, after the then next meeting of Parliament, and shall also be notified in the London Gazette and published under the authority of Her Majesty's Stationery Office.

2.-(1.) Where this section applies to a Convention with a Foreign State, the master of 2.—(1.) Where this section applies to a Convention with a Foreign State, the matter of Conveyance of a British mail ship to which this section applies when carrying mails to or from any port of letters by crew the Foreign State, and the master of a mail ship of the Foreign State to which this section or passengers of applies when carrying mails to or from any port of the United Kingdom, shall not, nor shall bidden. appress when carrying mains to or from any port of the United Kingdom, shall hot, hot shall any person on board the ship, whether a passenger or belonging to the ship or any other person, convey in the ship for delivery to another person in the Foreign State or United Kingdom, as the case may be, any letter, other than the letters contained in mail bags entrusted to the master by a postal officer of the United Kingdom or of any Foreign State, or than the despatches sent by the Government either of the United Kingdom or of any Foreign State.

(2.) If a person on board such ship acts in contravention of this section, or refuses or fails on demand to give up to a postal officer, or, if such person is not the master, to the master, any letter so conveyed by him, he shall be liable, on summary conviction, to a fine not exceeding five pounds.

(8.) It shall be the duty of the master of the ship to secure the observance of this section by all persons on board the ship, and to inform the proper authorities at the port at which the ship arrives of any breach of this section by any of those persons, and if he wilfully fails to perform that duty he shall be liable to a fine not exceeding five pounds.

(4.) Provided that a person shall not be liable under this section to a fine for any offence for which he has been punished by the law of the Foreign State.

(5.) Nothing in this section shall apply to any letters which if sent from the United Kingdom would be exempted from the exclusive privilege of the Postmaster General under the Act of the session of the seventh year of King William the Fourth and the first of Her 7 Will. IV. present Majesty, chapter thirty-three, initialed "An Act for the management of the Post & 1 Vict., c. 33. Office."

3.-(1.) Where the owner of any ships, British or foreign, applies to the High Court in England, and

- (a.) produces a certificate of a Secretary of State that such owner is subsidised for the execution of any postal service within the meaning of a Convention with a Foreign State to which this Act applies, by reason of receiving from the Foreign State, or from the Government of the United Kingdom or of a British possession, a bonâ fide subsidy for the postal service mentioned in the certificate, and
- (b.) produces sufficient evidence of the nature of the said service and the number of and the prescribed particulars respecting the ships engaged therein, and
- (c.) gives notice of the application to the Board of Trade,

the High Court, after hearing the owner, and the Board of Trade if they wish to be heard, shall fix the nature and amount of the security which the owner ought to place under the control of the court for the purposes of this Act as respects the ships engaged in that postal service, and fix the maximum number and tonnage of the ships to which the security is to apply.

- (2.) The security shall be the bond of the owner guaranteed either-
 - (a.) by the personal security of a surety, accompanied by an adequate real security given by the surety; or,
 - (b.) by the payment or transfer into court of cash, or of securities of the Government of the United Kingdom.

(3.) If the owner gives such security to the satisfaction of the High Court, then so long as the security is maintained and is sufficient to the satisfaction of the Court, and the number and tonnage of the ships for the time being actually engaged in carrying mails for the postal service in respect of which the security is given does not exceed the number and tonnage of the ships to which the security applies, the ships actually engaged in carrying mails for the said service shall be deemed to be exempted mail ships, and be entitled to the exemptions and privileges given by this Act to exempted mail ships; and the Board of Trade shall give the prescribed notices for informing the arresting authorities that the ships actually engaged in carrying the mails for the said postal service are exempted mail ships.

(4.) Notice of every application respecting any security given in pursuance of this section shall be given to the Board of Trade.

(5.) If at any time it appears to the Board of Trade that a security given as respects ships engaged in any postal service is from any cause (whether pending claims, variation of the conditions of the service, or otherwise) insufficient, the Board of Trade shall apply to the High Court, and that Court, if satisfied of such insufficiency, shall require the security to be made sufficient to the satisfaction of the Court within a reasonable time, and direct that in default the ships engaged in the postal service shall cease to be exempted mail ships, and that the Board of Trade shall give the prescribed notices for informing the arresting authorities of such cesser.

(6.) The amount and nature of the security may be varied and the whole security may be withdrawn, and the income of the security may be disposed of, by order of the High Court from time to time on such application either of the shipowners, or of the Board of Trade, or of any person appearing to be interested, and in such manner, and after such notice, and upon such terms and conditions as may be prescribed by rules of court, or, so far as the rules do not extend, as the Court may think just.

(7.) Provided that before the security is actually withdrawn, the High Court shall be satisfied-

- (a.) that the prescribed notice of the order for withdrawal has been given to the arresting authorities; and
- (b.) that there is no pending claim for the purposes of which the security may be required;

and upon the prescribed notice of the order for withdrawal being given to an arresting authority, the ships shall, as respects that authority, cease, after the date specified in the notice, to be exempted ships.

(8.) Rules of court may be made for carrying this section into effect, and in particular for regulating the nature, amount, and value of the security to be given, and the mode of giving security, and of giving notices to the arresting authorities, and for providing for the evidence of the exemption of ships under this section, and for the information to be given from time to time to the High Court respecting the ships to which the security applies, and for the jurisdiction of the High Court under this Act being exercised in chambers.

Arrest and exships.

4.-(1.) Where this section applies to a convention with a foreign state, and an ecution of pro-ecution of pro-ecution of pro-exempted mail ship to which this section applies is in a port in the United Kingdom, no exempted mail person shall be arrested without warrant on board such ship, and before any process civil or exempted mail ship to which this section applies is in a port in the United Kingdom, no

criminal authorising the arrest of any person who is on board such ship is executed against that person the following provisions of this section shall be observed; that is to say,

- (a.) written notice of the intention to arrest a person who is, or is suspected to be, on board the ship, stating the hour at which, if necessary, the ship will be searched, shall, if it is a ship of a Foreign State and there is at the port a consulate of that State, be left at the consulate, addressed to the consular officer;
- (b.) it shall be the duty of the master upon demand, if the said person is on board his ship, to enable the proper officer to arrest him;
- (c.) if the officer is unable to arrest the said person he may, but if it is a foreign ship only after the expiration of such time after notice was left at the consulate as is specified in the convention, search the ship for such person, and if he is found may arrest him.

(2.) The ship may be delayed for the purposes of this section for the time specified in the Convention, but not for any longer time.

(3.) If the master of a ship refuses to permit a search of the ship in accordance with this section, any officer of Customs may detain the ship, and such master shall be liable to a fine of five hundred pounds.

(4) This section shall apply to the arrest of the master in like manner as in the case of any other person.

5.—(1.) An exempted mail ship to which this section applies shall not, subject as in this Act mentioned, be liable to be arrested or detained by any arresting authority either for the purpose of founding jurisdiction in any Court of Admiralty, or of enforcing the payment of any damages, fine, debt, or other claim or sum, or enforcing any forfeiture, whether arising from the misconduct of the master or any of the crew or otherwise, but every court of the United Kingdom by the process of which the ship could have been under the circumstances arrested or detained shall have the same jurisdiction as if the ship had been so arrested or detained, and any legal proceeding in relation to any such matter as aforesaid may be com-menced by such service in the United Kingdom of any writ or process as may be prescribed by rules of court, and the High Court, on application, shall, in accordance with rules of court, cause the security to be applied in discharge of any such damages, fine, debt, claim, sum, or forfeiture.

(2.) Provided that nothing in this section shall render invalid the arrest or detention of a ship before the prescribed notice has been given to the arresting authority, but such authority, on proof that the ship is an exempted mail ship, shall release the ship. Where the Commissioners of Customs in pursuance of any Act or as a condition of waiving any forfeiture, require a deposit to be made by any exempted mail ship to which this section applies, the amount of such deposit shall, on notice from the Commissioners of Customs, and without any further proceeding, be set apart out of the security as money belonging to the said Commissioners, and shall be paid and applied as they direct, and any rules of court relating to such notice, payment, or application shall be made with the consent of the Treasury.

6.-(1.) Where the convention with a Foreign State provides that any provisions of the convention similar to those contained in this Act shall in any cases apply to a public ship of a Foreign State when employed as a mail ship, it shall be lawful for Her Majesty the Queen to agree that the like provisions shall apply to a public ship of Her Majesty in the like cases when employed as a mail ship, and to give effect to such agreement.

(2.) An Order in Council applying this Act as regards a Convention with a Foreign State may, if it seems to Her Majesty in Council to be consistent with the Convention so to do, apply this Act as regards a public ship of that Foreign State when employed as a mail ship in the cases authorised by the Convention, and this Act shall apply accordingly, as if such ship were an exempted mail ship belonging to a private owner, and any person may be arrested on board such ship accordingly.

7.—(1.) Every fine under this Act, if exceeding fifty pounds, may be recovered by action in the High Court in England or Ireland or in the Court of Session in Scotland, and the court in which it is recovered may reduce the amount of such fine, and a fine under this Act not exceeding fifty pounds may be recovered on summary conviction, provided that every offence for which a fine exceeding fifty pounds can be imposed under this Act may be prose-cuted on summary conviction, but the fine imposed on such conviction shall not exceed fifty pounds.

(2.) In the case of a summary conviction, any person who thinks himself aggrieved by such conviction may appeal to quarter sessions. In Scotland such person may appeal in $^{33 \& 39}_{c, 62}$, $^{30 Vict.}_{c, 62}$. manner provided by the Summary Prosecutions Appeals (Scotland) Act, 1875.

(3.) Service of any summons or other matter in any legal proceeding under this Act shall be good service if made by leaving the summons for the person to be served on board the ship to which he belongs with the person being or appearing to be master of the ship.

(4.) If a fine under this Act imposed on the master of a ship is not paid, and cannot be recovered out of any security given in pursuance of this Act, the Court may, in addition to any other power for enforcing payment of the fine, direct the amount to be levied by distress or poinding and sale of the ship, her tackle, furniture, or apparel. An officer of Customs in

detaining a ship or releasing a ship after detention in pursuance of this Act shall act upon such requisition or authority and under such regulations as the Commissioners of Customs may make with the consent of the Treasury.

Application of Act to British Possessions. 8.—(1.) An Order in Council may for the purpose of a Convention with a Foreign State apply this Act, subject to any exceptions or modifications not inconsistent with the provisions of this Act, to any British Possession, and this Act when so applied shall, subject to those exceptions and modifications, and subject as hereinafter mentioned, have effect as if it were re-enacted with the substitution of such British Possession for the United Kingdom;

Provided that before it is applied to any British Possession named in the schedule to this Act the Government of such possession shall have adhered to the Convention.

(2.) Where this Act applies to a British possession, it shall not be necessary for the owner of any mail ship to give security in any court in that possession, and the provisions of this Act with respect to the jurisdiction of any court of the United Kingdom, other than any jurisdiction relating to the application of the security, shall apply as if a court in the British Possession were substituted for a court of the United Kingdom.

(3.) It shall be lawful for Her Majesty in Council to make rules for carrying into effect, as respects British Possessions, the provisions of this Act with respect to the security given by mail ships, and in particular with respect to the commencement of a legal proceeding by service of a writ or process in the Possession, and to the notices to be given to arresting authorities in the Possession, and the evidence to be receivable by such authorities of the security having been given or withdrawn, and the application of the security in discharge of any damages, fine, debt, claim, sum, or forfeiture, where the same are or is recovered or payable either in the British Possession, or under proceedings pending concurrently in that British Possession and in any other British Possession or the United Kingdom.

(4.) If by any law made either before or after the passing of this Act by the Legislature of any British Possession provision is made for carrying into effect within such Possession any convention to which this Act applies, Her Majesty in Council may suspend the operation within such Possession of this Act or of any part thereof so far as it relates to such convention, and so long as such law continues in force there, or direct that such law or any part thereof shall have effect in such British Possession with or without modifications and alterations as if it were part of this Act.

9.—In this Act—

The expression "mail bag" means a mail of letters, or a box, or parcel, or any other envelope in which post letters within the meaning of the Acts relating to the Post Office, are conveyed;

The expression "subsidy" includes a payment for the performance of a contract;

The expression "master of a ship" includes any person in charge of a ship, whether commander, mate, or any other person;

The expression "ship of a Foreign State" means a ship entitled to sail under the flag of a Foreign State;

The expression "arresting authority" means any court, authority, or officer having power to arrest or detain a ship, or to arrest a person on board a ship, or to order such arrest or detention, or to order the execution of any process, civil or criminal, for the arrest of a person on board any ship;

The expression "postal officer" means any person employed in the business of the Post Office of the United Kingdom or a British Possession or Foreign State, as the case may be, whether employed by the Postmaster General, or the chief of the Post Office of the British Possession, or the chief of the Post Office of the Foreign State, or by any person under him, or on behalf of any such Post Office.

The rock marked awash in latitude 14° 00′ 30″ S., longitude 125° 35′ 00″ E. does not exist.

The following dangers have been found in the track of ships bound from Roebuck Bay or Derby to Wyndham or Port Darwin around Cape Bougainville:—

OUTER ROUTE.

Oliver Rock is a coral head with 9 feet of water over it and 25 fathoms close around, in latitude 13° 58′ 29″ S., longitude 125° 33′ 23″ E. From it the South extreme of Cassini Island bears N. 80° E., distant 4.3 miles. The water has never been seen to break over it. H.M.S. "Penguin" passed over this rock without discovering any sign of shoal water.

Bassett-Smith Shoal is about one mile in diameter, and has a general depth of 5 to 6 fathoms with 50 fathoms around. The shallowest part, which is near the Western edge of the shoal, has 20 feet of water over it. It is in latitude $13^{\circ} 17' 56''$ S., longitude $125^{\circ} 44' 54''$ E. The water over this shoal has never been seen to break, and there is nothing in the appearance of the sea to indicate danger.

Penguin Shoal reported last year in latitude 13° 07' S., longitude 125° 59' E., has 6 fathoms over it on the shallowest part.

Warn Rock is a small coral head with 6 fathoms over it, situated at the Northern edge of the Holothuria banks, in latitude 13° 09' 18" S., longitude 126° 06' 00" E.

INNER ROUTE.

Lee Rock.—In the fairway of the smooth-water channel between the Montesquieu Islets and Long Reef, a coral pinnacle has been found which has 3 feet of water over it, and 10 to 17 fathoms close around. It is in latitude 14° 03′ 30″ S., longitude 125° 46′ 28″ E. From it Oyster Rock bears S. 9° W., distant 8 cables; Pascal Island summit S. 83° W., distant 7.2 miles; Low Rocks, highest part S. 89° E., distant 5.9 miles; Bird Islet, S. 63° W., distant 4 miles. When over the rock, the summit of Baudin Island shows just to the right of Bird Islet, which latter is in line with the next islet to the W.S.W. of it. There is a ship channel 1.8 miles broad between Lee Rock and Long Reef. H.M.S. "Penguin" has passed twice within a few feet of this rock, sounding rapidly, and seen nothing to indicate danger.

Tancred Shoal is a coral bank, 7 cables in diameter, in latitude 14° 05' 11'' S., longitude 125° 54' 15'' E. The general depth over it is 3 to 7 fathoms, with 16 to 22 fathoms around. From the Western part of the bank, where there is 18 feet of water, the highest part of Low Rocks bears N. 56° W., distant 2 miles.

Fury Rock.—The extensive reef of rocks, marked in the existing published chart North of Gibson Point and also North of Hat Point, does not exist; but there is a rock awash at high water, from which the island North of Gibson Point bears East, distant 1.2 miles. From this rock, a reef dry at low water extends to the North-West for a distance of 4 cables, and North of this again there is foul ground, one patch of 5 fathoms being situated 1.2 miles N. $\frac{1}{2}$ E. from Fury Rock.

Bougainville Reef is a coral patch off Cape Bougainville about 300 yards in diameter, in latitude 13° 52′ 04″ S., longitude 126° 04′ 12″ E., with 4 feet of water over it. From it the conspicuous hill upon Hat Point bears S. 42° W., distance 4.9 miles, and the South Point of Troughton Island bears N. 34° E., distant 8.1 miles. It has never been seen to break. There is a large reef to the East of it.

Bishop Rocks are a small group of coral heads in latitude 13° 44' 18" S., longitude 126° 06' 50" E., which show 2 feet above low water springs. From these rocks the North extreme of Troughton Island bears S. 75° E., distant 2.1 miles, and the reef North of Troughton is distant 7 cables.

Guichen Reef.—No reef exists in the position assigned to this danger on the published chart; but there is a large detached coral reef, the nearest part of which is 1.3 miles North-West of Troughton Island. It dries at half-tide. Probably it was upon this reef that the "Guichen" struck. Vessels passing through the channel North of Troughton should not approach the island nearer than 3 miles.

A Coral Bank with 2 fathoms over it has been found N. 50° W., distant 6.9 miles from the North Point of Troughton Island; separated by a deep channel from the South Point of the East Holothuria Reef; and in the fairway of vessels making for the passage North of Troughton Island from the North end of Long Reef. It is in latitude $13^{\circ} 40' \ 00''$ S., longitude $126^{\circ} 03' \ 45'' \text{ E}$.

Branch Banks consist of 2 coral shoals with 6 and 7 fathoms over them, situated N.N.E. of Troughton Island, in the fairway of vessels making a course out from the passage North of Troughton Island. From the nearest 6 fathoms the North Point of the Island bears S. 18° W., distant 8.1 miles; and is in latitude 13° 37' 10" S., longitude 126° 11' 50" E. Soundings of 6 fathoms were obtained for a distance of one mile East of this position.

Caution.—The water around Cape Bougainville for a radius of 50 miles is thickly impregnated with lime, apparently washed off the decaying portions of the coral reefs, which are exposed for many hours at spring tides. Great caution is required in navigating, as there is nothing in the appearance of the sea which indicates danger when approaching the shoals and rocks. The water is usually smooth, the lead gives no warning; and the tidal streams run at times with a velocity of 2 to 3 knots an hour. The accidental manner in which some of the above dangers have been discovered points to the probability that, owing to the thickness of the water, others have escaped detection, notwithstanding a careful examination extending over ten months.

HYDROGRAPHIC INFORMATION.

H.M.S. "PENGUIN," 1891.

The area of magnetic disturbance near Cossack has been again examined. It exhibits the characteristics of red magnetism, as if there was a congestion or concentration of the magnetic elements due to the Southern Hemisphere. It seems appropriate, therefore, to call it a "magnetic shoal," and to treat it graphically as if it were an elevation of the bottom of the sea or area of "shoal water," the "soundings" being the deflections of the compass needle.

Worked out thus it was found that the magnetic shoal developed the following features :----

An area 4 miles long, North-East and South-West, by 2 miles broad, with a depth of 8 to 9 fathoms at low-water spring-tide; bottom quartz sand, over which compasses are deflected more than one degree.

Within the above,—An area 3 miles long North-East and South-West by half-a-mile to $1\frac{1}{2}$ miles broad, over which compasses are disturbed half-a-point or more.

Within the above,---

- (1.) A line of maximum Easterly repulsion about $2\frac{1}{4}$ miles long, over which the North-seeking end of the needle is violently repelled to the East—in several places as much as 40° ; in one place 56° .
- (2.) A line of maximum Westerly repulsion about $2\frac{1}{4}$ miles long, over which the North-seeking end of the needle is repelled to the West to the extent of about one-half the Easterly repulsion.
- (3.) Between these two lines—which lie one to three cables apart—a line of no repulsion $2\frac{1}{4}$ miles long, over which the magnetic needle points to the true North, and where the directive force is very small. This is called the "Axis," or "Line of vanished repulsion."
- (4.) A point on this line, about one mile from the South-West end of the magnetic shoal, where the "intensity," or "total force," is greatest, which is called the "Focus."

The axis, or line of vanished repulsion, is inclined to the true meridian, at an angle of 56° , in the neighborhood of the Focus. This angle coincides with the angle of maximum Easterly repulsion.

A vessel passing, in a straight line, across the magnetic shoal, at the Focus, on a North-Westerly course, would find the North-seeking end of the needle behave in the following manner:—When about one mile from the Focus, a slight disturbance would be observed, the North-seeking end of the needle being repelled to the East; but this disturbance would not amount to more than half-a-point until she had run to within two and a-half cables of the Focus. The needle would then be more and more repelled until 300 feet from the Focus, when it would be deflected as much as 56° from the true North. It would then quickly resume its correct position, and over the Focus, the needle would "be repelled to the West; and at 200 feet from it would be deflected as much as 26°. It would now begin to return again to its proper position, and at three cables from the Focus, on the North-West side, would not deviate

from the normal more than half-a-point. At one mile from the Focus all signs of disturbance would disappear.

Crossing the shoal rectangularly elsewhere than at the Focus, similar but less powerful repulsion would be observed. The distance between the largest East and the largest West repulsion would be greater.

In a wooden ship, or composite vessel, such as the "Penguin," the compasses would act as usual after leaving the shoal; and it is believed that no induction would take place in iron vessels. At present there is no evidence that any danger accrues to navigation except that a vessel steering by compass across the shoal would be set out of her course, more or less, according as to whether she cut across it at the narrowest part or obliquely.

The Focus is in latitude $20^{\circ} 32' 35''$ S., longitude $117^{\circ} 13' 2''$ E. From it Bezout Island summit bears S. 78° 49' W., distant 2.17 miles.

The greatest range in deflection of the compass needle was 82° , after applying the deviation for the apparent position of the ship's head. The actual traverse of the Penguin's compass card was 86° .

The greatest inclination or dip of the needle found on this occasion was $81^{\circ} 10'$.

The greatest intensity or total force was 18.808 (British units), or nearly double the intensity which, in this locality, is due to the earth considered as a magnet—*i.e.*, the force of magnetic attraction is such as to draw a weight of one grain 18.808 feet, in one second, in opposition to the force of gravity. This is the greatest known intensity generated by an invisible cause. The largest recorded intensity in the world, due to the earth considered as a magnet, is 15.2 (B.U.), in the neighborhood of the South Magnetic Pole.

The statement made to the Royal Society by Captain E. Creak, R.N., F.R.S., Superintendent of Admiralty Compasses, that, in cases of local magnetic disturbance in the Southern Hemisphere, the Northseeking end of the magnetic needle is repelled from the disturbing cause, is fully borne out by this investigation.

It is requested that the precise positions of all places where local magnetic disturbance is observed be forwarded to the Hydrographer of the Admiralty.

Affecting Chart No. 1047, VIII., 90.

CAPE FORD TO BUCCANEER ARCHIPELAGO.

(Bearings given are Magnetic. Depths given are reduced to Low-water Spring Tide.)

Ingram Reef.—Owing to information received from Captain Henry Lee, of the Adelaide Steamship Company's vessel "Rob Roy," who discovered it, a reef has been fixed by the officers of the "Penguin," which is in the track of ships bound from Roebuck Bay or Derby to Wyndham or Port Darwin. It is one mile long North-West and South-East, and 3 cables broad, with a depth of 28 to 30 fathoms close around. The shallowest part, which is a coral patch at the North-West end of the reef, is awash at lowwater spring tide, and is 3 cables long by one cable broad. The centre of this patch is in latitude 14° 7' 32" S. longitude 125° 16' 0" E. From it the flat-topped summit of Condillac bears N. 84° E., distant 17 miles, and the highest bushes to the right of the centre of the top of the West Montalivet Island bear S. 11° W., distant 11 miles.

As a rule, the sea does not break upon this reef except near low water. The "Penguin" has passed within a mile of this reef on two occasions when engaged in special search for new dangers; and though the weather was favorable, nothing was seen to indicate her proximity to shallow water. The water is thick with lime washings from the reefs. The lead gives no warning.

Albert Reef, marked on the existing published chart West of the West Montalivet Island, appears to be detached from the island; but vessels should not attempt to pass between. The North-West part of this reef is dry at low-water spring tide. The outer edge is in latitude 14° 15′ 30″ S., longitude 125° 9′ 45″ E. From it the highest bushes to the right of the centre of the summit of West Montalivet Island bear S. 52° E., distant $4\frac{1}{2}$ miles; and the North breaker of the Rob Roy Reefs bears S. 59° W., distant $19\frac{1}{2}$ miles.

Rob Roy Reefs, marked on the existing published chart to the North of a group of five islands, are dry in parts at low-water spring tide. The Western breakers of these reefs are in longitude 124° 50′ 35″ E. The Northern breaker is in latitude 14° 24′ 45″ S., longitude 124° 52′ 0″ E. About half-amile South-East of this Northern breaker, there is a sand cay which is awash at half-tide. The Northern breaker is 4 or 5 miles to the North-West of the nearest Maret Islands.

Adele Island is 4 miles to the West and 1 mile to the North of the position assigned to it on the existing published chart.

## TELEPHONE REGULATIONS.

#### I.—TELEPHONE EXCHANGE.

1. Persons may become members of the Telephone Exchange, at Perth or Fremantle, on payment of the following annual subscriptions, viz. :---

COMMERCIAL SUBSCRIBERS, INCLUDING ALL PLACES OF BUSINESS, AND LEGAL PRACTITIONERS, &C.

2. Each Subscriber will be provided with one complete set of instruments connected by a special wire with the Telephone Exchange to which he subscribes. An extra charge will be made for extension bells, switches, and any additional instruments at rates to be fixed by the Postmaster General.

3. If a Subscriber wishes to connect a second office or residence with the Telephone Exchange, under the same Exchange number, he will have to pay (in addition to the ordinary subscription) a yearly rental for any extension of wire exceeding one mile, of 20s. for every quarter of a mile or fraction thereof of wire required for such additional connection, besides the annual charge for extra instruments, switches, &c. If, however, no additional wire is required, or if the total length of wire from the Exchange does not exceed one mile, then the Subscriber shall only be required to pay the workmen's time, or such other sum for effecting the connection as the Postmaster General may determine, besides the annual rental of additional instruments, &c.

4. Persons occupying offices in the same building can jointly subscribe to the Telephone Exchange under the same Exchange number, on paying, in addition to one ordinary subscription, £3 a year for each additional set of instruments fixed in the several offices of the said joint Subscribers, who will have to provide an attendant for their own local switchboard.

5. A Subscriber to the Perth or Fremantle Telephone Exchange will be able to communicate with any other Subscriber to the same or other Exchange, or with any person attending at the Telephone Offices.

6. The use of a wire between the Perth and Fremantle Exchanges must not, as a rule, exceed five minutes at any one time, and may be limited in the aggregate to one hour in any one day.

7. Subscribers will be liable for all damage to instruments, beyond ordinary wear and tear.

8. The Perth and Fremantle Telephone Exchanges will be open from 8 a.m. to 11 p.m. every day. 9. Should a Subscriber change his residence, or wish the instruments to be shifted, he will be required to pay the cost or such proportion of the cost of the work as the Postmaster General may determine. The subscription to be adjusted according to altered length of line.

10. All telephones, instruments, batteries, &c., are the exclusive property of the Postmaster General, and may be removed by him upon the determination of the contract, for which purpose he or his officers are to have free access to the premises of the Subscriber or lessee. The Postmaster General or any officer appointed by him is also to have free access for inspection purposes whenever required.

11. The first year's rent to be paid in advance, and all subsequent subscriptions to be paid half-yearly in advance.

12. Should any Subscriber or lessee be six months or more in arrears with his subscription or rent, and fail to pay the same on being required to do so, the Postmaster General shall have power to cancel the agreement, remove the name of the Subscriber from the list, and enter upon the premises for the purpose of removing all instruments, wires, &c., without prejudice to the right of the Postmaster General to claim the subscription and rent due.

#### II.—PRIVATE LINES.

13. Any person can be supplied with a private line on the following terms and conditions :—

14. Instruments and batteries will be supplied and maintained in working order by the Post and Telegraph Department on payment of yearly rental, as under:—

- For a set comprising two telephone receivers, one transmitter, one call-bell and battery, £2 10s.; or outside the twenty-mile radius £3 per set, or such other sum as may be fixed by the Postmaster General.
- An extra charge will be made for Berthon-Ader, Berliner telephone sets, extension bells, switches, and any additional instruments, at rates to be fixed by the Postmaster General.

15. The lessee of any private line will not be allowed to permit the use of such line for any other than his own business. Any breach of this rule may involve the removal of the line and instruments, without prejudice to the right of the Postmaster General to claim the rent for the remainder of the term.

16. Should a lessee of a private line change his residence or office, he will be required to pay such proportion of the cost of altering the line, &c., as may be determined by the Postmaster General: the annual rental will be adjusted to altered length of line.

17. The lessee will be required to pay for all damage to instruments beyond ordinary wear and tear.

18. All telephones, instruments, batteries, &c., are the exclusive property of the Postmaster General, and may be removed by him upon the determination of the contract, for which purpose he or his officers are to have free access to the premises of the lessee. The Postmaster General, or any officer appointed by him, is also to have free access for inspection purposes whenever required.

19. The first year's rent to be paid in advance, and all subsequent rentals to be paid half-yearly in advance.

20. Should any lessee be six months or more in arrears with his rent, and fail to pay the same on being required to do so, the Postmaster General shall have power to cancel the agreement, and enter upon the premises for the purpose of removing all instruments, wires, &c., without prejudice to the right of the Postmaster General to claim the rent due.

21. Except where a shorter term is specially arranged for, the agreement to be for a period of one year; but the Postmaster General may, in special cases, determine the agreement before the one year has expired.
