WHEREAS under the provisions of "The Constitution Act, 1889," it is made lawful for the Governor of Western Australia for the time being to fix the place and time for holding the first and every other Session of the Legislative Council and Legislative Assembly: NOW THEREFORE I, ALEXANDER CAMPBELL ONSLOW, being Administrator as aforesaid, in exercise of the powers so in me vested as aforesaid and of all other powers me enabling in that behalf, do by this my Proclamation announce and proclaim that THE SECOND SESSION OF THE LEGISLATIVE COUNCIL AND THE LEGISLATIVE ASSEMBLY, to be holden under the provisions of the said Act, shall be holden, for the despatch of business, on MONDAY, THE SEVENTH DAY OF DECEMBER NEXT, at the hour of three of the clock, p.m.: the session of the Legislative Council to be holden in the Legislative Council Chambers, in St. George's Terrace, in the CITY OF PERTH, in the said Colony; and the session of the Legislative Assembly to be holden in the Legislative Assembly Chambers, in Howick Street, in the CITY OF PERTH, in the said Colony; and the Members of the Legislative Council and the Members of the Legislative Assembly are hereby required to give their attendance at the said time and places accordingly.

Proclamation by His Excellency the RIGHT HONORABLE ALGERNON HAWKINS THOMOND, EARL OF KINTORE, LORD FALCONER OF HALKERTON, LORD KEITH OF INVERURIE, a Member of Her Majesty's Most Honorable Privy Council, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Province of South Australia and the Dependencies thereof, &c., &c., &c.

BY virtue of the provisions of "The Stock Diseases Act, 1888," I, the Governor, with the advice and consent of the Executive Council, do hereby proclaim and direct that the proclamation dated the 21st day of January, 1891, and published in the *Government Gazette* on the 22nd day of January, 1891, by which the importation or introduction of horses, cattle, swine, and dogs from the colony of Western Australia into the said province was from the date of the said proclamation, and until further order therein, prohibited, shall, from the date hereof, be varied by striking out in such proclamation the words "horses," "cattle," and "dogs"; and I declare that horses, cattle, and dogs may hereafter be imported or introduced from the said colony of Western Australia into the said province, subject to the provisions of the said "The Stock Diseases Act, 1888," and the regulations for the time being thereunder.

Given under my hand and the public seal of the said province, at Adelaide, this fourteenth day of October, in the year of our Lord one thousand eight hundred and ninety-one, and in the fifty-fifth year of Her Majesty's reign.

ROADS BOARD DISTRICT.

Bounded on the *West* by the sea coast; on the *South* by a line extending East therefrom and passing along the South boundary of Rockingham townsite and East as far as the Perth-Albany Road; and on the *East* and *North* by a line extending from said point North-Westward towards the South-East corner of Canning Location 26 to the South-

BRIDGETOWN COMMONAGE REGULATIONS.

1. No person to depasture stock on Commonage without license.
2. License to be issued by Chairman of Commonage Board.
3. Cattle above 12 months, not exceeding 10 head, 2s. 6d. per head; under 12 months old, 1s. 3d. per head per annum.
4. Cattle above 10 head in number, over 12 months old, 5s. per head; under 12 months old, 2s. 6d. per head per annum.
5. The same Rules and Regulations for cattle to apply to horses.
6. Sheep depasturing on the Commonage, for the purpose of being killed for use in the town, to be kept on South side of river, not to exceed 100 in number, to be charged threepence a head per annum.
7. No stock to be kept on the Commonage unless the property of persons residing within it.
8. All sheep travelling not to stay on Commonage more than one night without permission from Chairman.
9. Fees collected to be expended in improving the town by the body having the management.
10. Stray cattle or sheep from adjoining runs to be allowed to occupy the Commonage without paying any fees, if shown to be accidentally upon it, and if steps are taken at once for their removal.

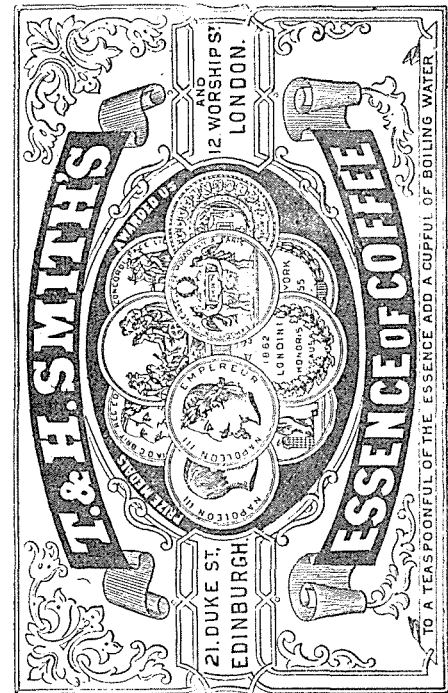

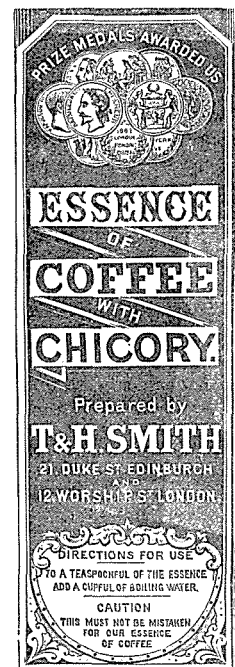
