WHEREAS by an Act passed in the 52nd year of the reign of Her present Majesty, No. 14, intituled "An Act to amend an Ordinance intituled 'An Ordinance to provide for the establishment of Proper Places for the Burial of the Dead'" (10th Vict., No. 12), it is enacted that it shall be lawful for the Governor in Executive Council to declare the closure of any cemetery or burial place: Now THEREFORE I, the Administrator, in Executive Council, by and with the advice of the Executive Council, in pursuance of the power vested in me by the said Act, do hereby declare the closure, on and after the 1st of April next ensuing, of all Cemeteries now existing within the Guildford Municipality.

#### The Bankruptcy Act, 1871.

IN THE SUPREME COURT, WESTERN AUSTRALIA.

In the matter of J. Dawson, senr., William Dawson, and James Dawson, of Perth, boatbuilders, bankrupts.

**TERBERT** Hemsley Holman, of Perth, Accountant, has been appointed trustee of the property of the bankrupts. The Court has appointed the public examination of the bankrupts to take place at the Supreme Court House, Perth, on the 18th day of March instant, at 11 o'clock in the forenoon.

All persons having in their possession any of the effects of the bankrupts must deliver them to the trustee, and all debts due to the bankrupts must be paid to the trustee.

Creditors who have not yet proved their debts must forward their proofs of debt to the trustee.
