THE following additional Regulations made under “The Sharks Bay Pearl Shell Fishery Act, 1892,” are published for general information.

Regulations under “The Sharks Bay Pearl Shell Fishery Act, 1892.”

WHEREAS under the powers conferred upon him by “The Sharks Bay Pearl Shell Fishery Act, 1892,” His Excellency the Governor in Council did, on the 7th day of June, 1893, make certain Regulations, which were published in the *Government Gazette* on the 8th day of June, 1893; AND WHEREAS it has been determined to make the following additional Regulations: NOW THEREFORE His Excellency Sir WILLIAM CLEAVER FRANCIS ROBINSON, G.C.M.G., Governor of the Colony of

Western Australia, acting with the advice of the Executive Council, doth hereby make the following Regulations under the authority of the said Act:—

1. The Inspector or other Officer may seize and remove any young or immature shell found in the possession of any person.

2. No person shall have or carry on board any boat or use a dredge without the permission of the Inspector, and the Inspector or other Officer may seize and remove any dredge found on board any boat or used contrary to this regulation.

3. The Inspector may authorise persons to collect mature shell on any portion of the waters of Sharks Bay which shall have been closed under the provisions of Section 12 of the said Act, but such shall not be collected except in deep water and by means of diving apparatus.

Any person offending against the provisions of any of these Regulations shall be liable, on conviction, to a penalty not exceeding the sum of £50.

THE attention of Bankers and the public generally is particularly requested to the provisions of "The Gold Declaration Act, 1888," which are as follows.

JOHN FORREST,
Colonial Treasurer.

1. ANY banker or other person exporting from the Colony any gold, gold ore, gold dust, or gold bullion, if such gold, gold ore, or gold dust, shall have been found in or procured from the soil of the Colony, or if the gold contained in such bullion shall have been found in or procured from the soil of the Colony, shall at the Customs declare the weight or value of the same at the time of export.

2. ANY person failing to comply with the provisions of this Act may, on summary conviction before two Justices, be fined any sum not exceeding Ten pounds, or any sum not exceeding an amount equal to Five per cent. on the value of the undeclared articles, whichever sum shall be the greater.

3. NO person exporting from the Colony articles manufactured of gold, although such gold shall have been found in or procured from the soil of the Colony, shall be bound to declare the weight or value of such articles.

"The Constitution Act Amendment Act, 1893," and "The Electoral Acts 1889 and 1893."

THE special attention of Returning Officers, Resident, Police, and other Magistrates, Electoral Registrars, District Registrars of Births, Deaths, and Marriages, Clerks of Municipal Councils and District Roads Boards, Inspectors, Sub-Inspectors, and Sergeants of Police, Officers in charge of Police Stations, Postmasters, and Headmasters of Government Schools is drawn to the duties imposed upon them, respectively, by the above mentioned Acts, and also to the Notices appearing in the *Government Gazette Extraordinary* of the 13th November, 1893.

Persons desiring to be registered as Electors for Members to serve in the Legislative Council and Legislative Assembly are required to claim, in writing, in the prescribed form.

For a shaft to be sunk from below the depth of 100 feet to a depth of 200 feet, @ £2 10s. per foot.

For a shaft to be sunk from below the depth of 200 feet to a depth of 300 feet, @ £5 per foot.

CONDITIONS.

Each shaft to be vertical throughout, with a superficial area of not less than 27 feet in the clear when completed, and a minimum width of not less than 3 feet, to be sunk and timbered where necessary, to the satisfaction of the Warden or his Deputy.

Provided, that if any shaft has been already sunk of a less superficial area than 27 feet, the bonus shall be paid in proportion; but in no case shall any bonus be paid for a shaft having a less area than 20 feet, or less than 3 feet in width.

No payment will be made in respect of the first 100 feet from the surface.

With regard to existing shafts, no payment will be made in respect of work done before the date hereof.

Any person intending to deepen any existing shaft of or exceeding the depth of 100 feet shall give notice in writing to the Warden or his Deputy of the depth of the said shaft, and of his intention to deepen the same.

The Warden or his Deputy shall ascertain and certify the depth of such shaft, and payment shall be made only in respect of the work done beyond the depth certified by the Warden or his Deputy.

Any person intending to sink a new shaft with the intention of claiming a bonus shall give notice in writing of such intention before the commencement of the work, or before the shaft is down 100 feet.

No company or person shall receive assistance for more than one shaft on the same mining property.

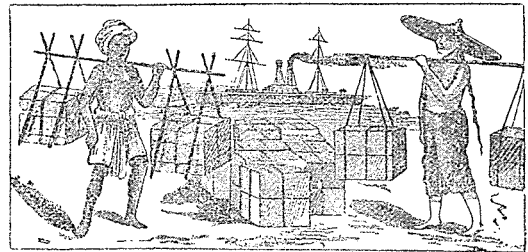
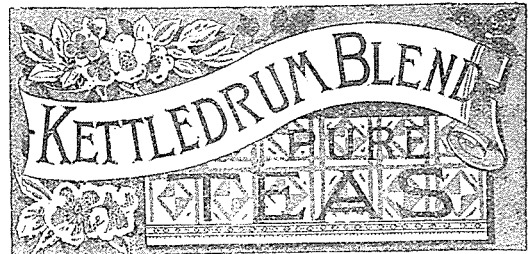
