THE said Governor, by virtue of the Ordinance 21 Victoria, No. 12, intituled "An Ordinance "to extend and enlarge the provisions of an Ordin-"ance passed in the twelfth year of the reign of "Her present Majesty, intituled 'An Ordinance "for the Regulation of Gaols, Prisons, and Houses of "Correction in the Colony of Western Australia, "and for other purposes relating thereto," do hereby, with the advice and consent of the Executive Council, direct that the buildings and premises, bounded on the West-North-West and South-South-West by lines extending 18° 2 chains 25 links, and 108° 2 chains from a spot situate about 25 chains 30 links East, and about 30 links South from the Easternmost corner of Kimberley Goldmining Lease No. 1 "Lady Broome," the opposite boundaries being parallel and equal, now used and occupied at Hall's Creek in the Kimberley Goldfield District for the confinement and reception of prisoners, shall henceforth be a Legal Public Gaol and Prison of and belonging to the said Colony, for the purposes mentioned in the said Ordinance.

HEREAS by an Ordinance of the Legislature of the said Colony, made and passed in the twenty-seventh year of the reign of Her Most Gracious Majesty Queen Victoria, No. 21, entitled "An Ordinance for the Recovery of Small Debts and "Demands," the Governor is empowered by Procla-mation to constitute Local Courts for the recovery of Small Debts and Demands, to be holden at such times and places, and within such Districts throughout the said Colony, as may be most fit and convenient, and likewise, by Proclamation, to alter the time or place or manner of holding any such Courts : AND WHEREAS it has been deemed expedient to alter the time for holding the Local Court for the District of Broome: Now THEREFORE I, the said Governor, with the advice and consent of the Executive Council, do hereby notify and proclaim that the day for holding a Local Court for the recovery of Small Debts and Demands for the said District shall, after the day of the date hereof and thenceforth, be the first Tuesday in each and every month at Broome, in lieu of once a quarter as heretofore.

Pearling Banks in Sharks Bay Opened.

The Treasury, Perth, April 4th, 1894.

II IS Excellency the Governor in Council, under the powers conferred upon him by "The Sharks Bay Pearl Shell Fishery Act" (55 Vic., No. 9), notifies, for general information, that the Pearling Banks in Sharks Bay, closed by *Gazette* notice on 26th March, 1892, and numbered 3, will be opened for Pearl Shelling from the 1st of April to the 30th June, 1894.

The Area comprised on No. 3 is as follows :----

All that portion of Denham Sound lying inshore of a line extending West from Cape Lesueur 3 miles, then South-South-Easterly to a spot 3 miles West from Lagoon Point, and then East to the said Point.

No dredging will be allowed on any "pick-up" banks within the area, except on the edges of the shallow banks where it is impossible to pick up by hand at low tides, but permission in writing may be issued by the Inspector to use a dredge on such other portions of the area as he may approve of.

The Inspector shall have power to stop the work of collection or of dredging at any time, if in his opinion the industry is being injured.

EXTRADITION TREATY WITH PORTUGAL.

THE following copy of an Order of Her Majesty the Queen in Council, for giving effect to the Treaty between Her Majesty and His Majesty the King of Portugal for the Mutual Extradition of Fugitive Criminals, is published for general information.

THE QUEEN'S MOST EXCELLENT MAJESTY.

Lord President. Mr. Gladstone. Marquess of Ripon. Earl Spencer.

Sir William Vernon Harcourt.

WHEREAS by the Extradition Acts, 1870 and 1873, it was amongst other things enacted that, where an arrangement has been made with any Foreign State with respect to the surrender to such State of any fugitive criminals, Her Majesty may, by Order in Council, direct that the said Acts shall apply in the case of such Foreign State; and that Her Majesty may, by the same or any subsequent Order, limit the operation of the Order, and restrict the same to fugitive criminals who are in or suspected of being in the part of Her Majesty's dominions specified in the Order, and render the operation thereof subject to such conditions, exceptions, and qualifications as may be deemed expedient; and that if, by any law made after the passing of the Act of 1870 by the Legislature of any British possession, provision is made for carrying into effect within such possession the surrender in Council applying the said Acts in the case of any Foreign State, or by any subsequent Order, suspend the operation within any such British possession of the said Acts, or of any part thereof, so far as it relates to such Foreign State, and so long as such law continues in force there and no longer:

And whereas by an Act of the Parliament of Canada passed in one thousand eight hundred and eighty-six, and entitled "An Act respecting the Extradition of Fugitive Criminals," provision is made for carrying into effect within the dominion the surrender of fugitive criminals: And whereas by an Order of Her Majesty the Queen in Council, dated the seventeenth day of November, one thousand eight hundred and eighty-eight, it was directed that the operation of the Extraditions Acts, 1870 and 1873, should be suspended within the Dominion of Canada so long as the provision of the said Act of the Parliament of Canada of 1886 should continue in force and no longer:

And whereas a Treaty was concluded on the seventeenth day of October, one thousand eight hundred and ninety-two, between Her Majesty and His Majesty the King of Portugal for the mutual extradition of fugitive criminals, which Treaty is in the terms following :---

Her Majesty the Queen of the United Kingdom of Great Britain and Ireland, Empress of India, Sir George Glynn Petre, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Companion of the Most Honourable Order of the Bath, Her Majesty's Envoy Extra-ordinary and Minister Plenipotentiary at the Court of His Most Faithful Majesty, &c.; and

His Most Faithful Majesty the King of Portugal and of the Algarves, Dom Antonio Ayres de Gouvéa, Councillor of His Majesty, Peer of the Realm, Bishop of Bethsaida, retired Professor of the University of Coimbra, His Majesty's Minister and Secretary of State for Foreign Affairs, &c.;

Who, having communicated to each other their respective Full Powers, found in good and due form, have agreed upon and concluded the following Articles :--

ARTICLE I.

The High Contracting Parties engage to deliver up to each other those persons who, being accused or convicted of a crime or offence committed in the territory of the one Party, shall be found within the territory of the other party, under the circumstances and conditions stated in the present Treaty.

ARTICLE II.

The crimes or offences for which the extradition is to be granted are the following :—

1. Murder (including assassination, infanticide, and poisoning), or attempt, or conspiracy to murder.

2. Manslaughter.

3. Maliciously wounding or inflicting grevious bodily harm.

4. Assault occasioning actual bodily harm.

5. Counterfeiting or altering money, either metallic or of any other kind representing the first named, or uttering counterfeit or altered money of any of those kinds.

6. Knowingly making any instrument, tool, or engine adapted and intended for counterfeiting coin.

7. Forgery, counterfeiting, or altering or uttering what is forged, or counterfeited, or altered.

8. Embezzlement or larceny.

9. Malicious injury to property, if the offence be indictable.

10. Obtaining money, goods, or valuable securities by false pretences.

11. Receiving money, valuable security, or other property, knowing the same to have been stolen, embezzled, or unlawfully obtained.

12. Crimes against bankruptcy law.

13 Fraud by a bailee, banker, agent, factor, trustee, or director or member or public officer of any Company, made criminal by any law for the time being in force.

14. Perjury, or subornation of perjury.

15. Rape.

16. Carnal knowledge, or any attempt to have carnal knowledge, of a girl under 16 years of age.

17. Indecent assault.

18. Administering drugs, or using instruments, with intent to pro-cure the miscarriage of a woman.

19. Abduction.

20. Bigamy.

21. Child stealing.

22. Abandoning children, exposing or unlawfully detaining them.

23. Kidnapping and false imprisonment.

24. Burglary or Housebreaking.

25. Arson.

26. Robbery with violence.

27. Any malicious act done with intent to endanger the safety of any person in a railway train.

28. Threats by letter or otherwise, with intent to extort.

29. Piracy by law of nations.

30. Sinking or destroying a vessel at sea, or attempting or conspiring to do so.

31. Assaults on board a ship on the high seas, with intent to destroy life, or to do grievous bodily harm.

32. Revolt, or conspiracy to revolt, by two or more persons on board a ship on the high seas, against the authority of the master.

33. Dealing in slaves in such a manner as to constitute a criminal offence against the laws of both States.

Extradition is also to be granted for participation in any of the aforesaid crimes, provided such participation be punishable by the laws of both the Contracting Parties.

Extradition may also be granted at the discretion of the State applied to in respect of any other crime for which, according to the laws of both the Contracting Parties for the time being in force, the grant can be made.

The Portuguese Government will not deliver up any person either guilty or accused of any crime punishable with death.

ARTICLE 111.

The Portuguese Government will not grant the extradition of any Portuguese subject, and Her Britaunic Majesty's Government will not grant the extradition of any British subject; but in the case of a natu-ralized subject, this Article shall only be applicable if the naturalization was obtained previous to the commission of the crime giving rise to the application for extradition.

ARTICLE IV.

The extradition shall not take place if the person claimed on the part of the British Government, or the person claimed on the part of the Portuguese Government, has already been tried and discharged or punished, or is still under trial, within the territories of the two High Contracting Parties respectively, for the crime for which his extradition is demanded.

If the person claimed on the part of the British Government, or if the person claimed on the part of the Portuguese Government, should be under examination, or is undergoing sentence under a conviction, for any other erime within the territories of the two High Contracting Parties respectively, his extradition shall be deferred until after he has been discharged, whether by acquittal, or on expiration of his sentence, or otherwise. or otherwise.

ARTICLE V.

The extradition shall not take place if, subsequently to the com-mission of the crime, or the institution of the penal prosecution, or the conviction thereon, exemption from prosecution or punishment has been acquired by lapse of time, according to the laws of the State applied to.

ARTICLE VI.

A fugitive criminal shall not be surrendered if the offence in respect of which his surrender is demanded is one of a political character, or if he prove that the requisition for his surrender has in fact been made with a view to try or punish him for an offence of a political character.

ARTICLE VIL

A person surrendered can in no case be kept in prison, or be brought to trial in the State to which the surrender has been made, for any other crime or on account of any other matters than those for which the extradition shall have taken place, until he has been restored or had an opportunity of returning to the State by which he has been surrendered.

This stipulation does not apply to crimes committed after the extradition

ARTICLE VIII.

The requisition for extradition shall be made through the Diplomatic Agents of the High Contracting Parties respectively.

The requisition for the extradition of an accused person must be accompanied by a warrant of arrest issued by the competent authority of the State requiring the extradition, and by such evidence as, according to the laws of the place where the accused is found, would justify his arrest if the crime had been committed there.

If the requisition relates to a person already convicted, it must be accompanied by the sentence of condemnation passed against the convicted person by the competent Court of the State that makes the requisition for extradition.

A sentence passed in contumaciam is not to be deemed a conviction, but circumstances may cause a person so sentenced in contumaciam to be dealt with as an accused person.

ARTICLE IX.

If the requisition for extradition be in accordance with the foregoing stipulations, the competent authorities of the State applied to shall proceed to the arrest of the fugitive.

ARTICLE X.

If the fugitive has been arrested in the British dominions he shall forthwith be brought before a competent Magistrate, who is to examine him and to conduct the preliminary investigation of the case, just as if the apprehension had taken place for a crime committed in the British dominions.

In the examinations which they have to make in accordance with the foregoing stipulations, the authorities of the British dominions shall admit as valid evidence the sworn depositions or the affirmations of likewise the warrants and sentences issued therein, and certificates of, or judicial documents stating the fact of, a conviction, provided the same are authenticated as follows:—

1. A warrant must purport to be signed by a Portuguese Judge, Magistrate, or officer.

2. Depositions or affirmations, or the copies thereof, must purport to be certified under the hand of a Portuguese Judge, Magistrate, or officer to be the original depositions or affirmations, or to be the true copies thereof, as the case may require.

3. A certificate of or judicial document stating the fact of a conviction must purport to be certified by a Portuguese Judge, Magistrate, or officer.

4. In every case such warrant, deposition, affirmation, copy, certificate, or judicial document must be authenticated either by the oath of some witness, or by being sealed with the official seal of the Minister of Justice, or some other Portuguese Minister; but any other mode of authentication for the time being permitted by the law in that part of the British dominions where the examination is taken may be substituted for the foregoing.

ARTICLE XI.

If the fugitive has been arrested in the dominions of Portugal, his surrender shall be granted if, upon examination by a competent authority, it appears that the documents furnished by the British Government contain sufficient primá facie evidence to justify the extradition.

The Portuguese authorities shall admit as valid evidence records drawn up by the British authorities of the depositions of witnesses, or copies thereof, and records of conviction or other judicial documents, or copies thereof, provided that the said documents be signed or authenticated by an authority whose competence shall be certified by the seal of a Minister of State of Her Britannic Majesty.

ARTICLE XII.

The extradition shall not take place unless the evidence be found sufficient, according to the laws of the State applied to, either to justify the committal of the prisoner for trial, in case the crime had been com-mitted in the territory of the said State, or to prove that the prisoner

is the identical person convicted by the Courts of the State which makes the requisition, and that the crime of which he has been convicted is one in respect of which extradition could, at the time of such conviction, have been granted by the State applied to. In Her Britannic Majesty's dominions the fugitive criminal shall not be surrendered until the expiration of fifteen days from the date of his being committed to prison to await his surrender.

ARTICLE XIII.

If the individual claimed by one of the two High Contracting Parties in pursuance of the present Treaty should be also claimed by one or several other Powers, on account of other crimes or offences committed upon their respective territories, his extradition shall be granted to that State whose demand is earliest in date.

ARTICLE XIV.

If sufficient evidence for the extradition be not produced within two months from the date of the apprehension of the fugitive, or within such further time as the State applied to, or the proper Tribunal thereof, shall direct, the fugitive shall be set at liberty.

ARTICLE XV.

All articles seized which were in the possession of the person to be surrendered, at the time of his apprehension, shall, if the competent authority of the State applied to for the extradition has ordered the delivery thereof, be given up when the extradition takes place, and the said delivery shall extend not merely to the stolen articles, but to every-thing that may serve as a proof of the crime.

ARTICLE XVI.

All expenses connected with extradition shall be borne by the demanding State.

ARTICLE XVII.

The stipulations of the present Treaty shall be applicable to the Colonies and foreign possessions of both of the High Contracting Parties, so far as the laws for the time being in force in such Colonies and foreign possessions respectively will allow.

The requisition for the surrender of a fugitive criminal who has taken refuge in any of such Colonies or foreign possessions may be made to the Governor or chief authority of such Colony or possession by the Chief Consular authority of the other State in such Colony or possession.

Such requisitions may be disposed of, subject always, as nearly as may be, and so far as the law of such Colony or foreign possession will allow, to the provisions of this Treaty, by the said Governor or chief authority, who, however, shall be at liberty either to grant the surrender, or to refer the matter to his Government.

The High Contracting Parties shall, however, be at liberty to make special arrangements in their respective Colonies and foreign possessions for the surrender of oriminals who may take refuge therein, on the basis, as nearly as may be, and so far as the law of such Colony or foreign possession will allow, of the provisions of the present Treaty.

Requisitions for the surrender of a fugitive criminal emanating from any Colony or foreign possession of either of the High Contracting Partics shall be governed by the rules laid down in the preceding Articles of the present Treaty.

ARTICLE XVIII.

The present Treaty shall come into force ten days after its publica-tion, in conformity with the forms prescribed by the laws of the High Contracting Parties. It may be terminated by either of the High Contracting Parties at any time on giving to the other six months' notice of its intention to do so.

The Treaty shall be ratified, and the ratifications shall be exchanged at Lisbon as soon as possible.

In witness whereof, the respective Plenipotentiaries have signed the same, and have affixed thereto the seal of their arms.

Done in duplicate at Lisbon, the seventeenth day of October, in the year of our Lord one thousand eight hundred and ninety-two.

And whereas a Protocol relative to the said Treaty was signed at Lisbon on the thirtieth day of November, one thousand eight hundred and ninety-two, which Protocol is in the terms following :---

The stipulations of the present Treaty do not apply to extradition between British and Portuguese India, which is reserved for ulterior negotiation.

Done in duplicate at Lisbon, the thirtieth day of November, in the year of our Lord one thousand eight hundred and ninety-two.

Her Britannic Majesty's Envoy Extraordinary and Minister Plenipotentiary, GEORGE G. PETRE.

O Ministro e Secretario de Estado dos Negocios Extrangerios de Sua Magestade Fidelissima,

A. AYRES DE GOUVEA.

And whereas the ratifications of the said Treaty and Protocol were exchanged at Lisbon on the thirteenth day of November, one thousand eight hundred and ninety-three:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council and in virtue of the authority committed to her by the said recited Acts, doth order, and it is hereby ordered, that from and after the nineteenth day of March, one thousand eight hundred and ninety-four, the said Acts shall apply in the case of Portugal and of the said Treaty and Protocol with His Majesty the King of Portugal.

Provided always, and it is hereby further ordered, that the operation of the said Extradition Acts, 1870 and 1873, shall be suspended within the Dominion of Canada so far as relates to Portugal and to the said Treaty and Protocol, and so long as the provisions of the Canadian Act aforesaid of 1886 continue in force, and no longer. 


