Line 32.—Strike out "and N3" after the reference letter "R1." Alter the word "cause" to "causes," and strike out the words "the arm N and" immediately following it.

Line 33.—Strike out the word "their" after the word "resume," and insert the word "its." Also strike out the words "in addition to providing a."

Strike out Lines 34 and 35.

Page 5.

Strike out Lines 6 and 7.

After claim 3 insert fresh claim—"4. In seed and manure drills, a device for adjusting the pressure for keeping each tine independently in the ground."

Page 6.

Insert fresh claim—"5. In seed and manure drills the combination with a bar carrying the tine to which pressure is applied by means of an upright piece and spiral spring of a device by which the pressure upon the spiral spring (such as N3) can be adjusted at will consisting of a collar (such as O) provided with a jointed lever (such as P) substantially as herein described."

Alter "Claim 4" to read "Claim 6."

Alter "Claim 5" to read "Claim 7," and strike out the word "supplementary" appearing therein.
