**W**HEREAS by Clause 14 of the Letters Patent, passed under the Great Seal of the United Kingdom, constituting the Office of Governor and Commander-in-Chief of the Colony of Western Australia and its Dependencies, bearing date the 25th August, 1890, it is provided that in the event of the Governor having occasion to be temporarily absent for a short period from the seat of Government or from the Colony, he may in every such case, by an Instrument under the Public Seal of the Colony, constitute and appoint our Lieutenant-Governor, or if there be no such officer, then any other person, to be his Deputy during such temporary absence, and in that capacity to exercise, perform, and execute for and on behalf of the Governor during such absence, but no longer, all such powers and authorities vested in the Governor by these Our Letters Patent, as shall in and by such Instrument be specified and limited, but no others: Provided, nevertheless, that by the appointment of a Deputy as aforesaid, the power and authority of the Governor shall not be abridged, altered, or in any way affected otherwise than We may at any time hereafter think proper to direct;

AND WHEREAS I, the said Governor, purpose to absent myself temporarily from the said seat of Government as authorised;

AND WHEREAS there is no Lieutenant-Governor of the said Colony:

NOW THEREFORE I, the said Governor, by virtue and in exercise of the powers vested in me as aforesaid, do by this Instrument, under the Public Seal of the Colony, constitute and appoint you, Sir ALEXANDER CAMPBELL ONSLOW, Knight, from the date of my departure upon the said absence from the said seat of Government, and during such absence, to exercise, perform, and execute for and on my behalf as such Governor all such powers and authorities vested in me by the said Letters Patent as you may from time to time be requested or advised by a Responsible Minister or by the Executive Council to discharge.

SIR,—I have the honour to transmit to you, for publication in the Colony under your Government, a copy of an Order of Her Majesty the Queen in Council, dated the 2nd of February, 1899, for giving effect to the Treaty between Her Majesty and the Queen of the Netherlands for the mutual extradition of Fugitive criminals, signed at London on the 26th of September, 1898, the ratifications of which were exchanged at London on the 14th of December, 1898.

**ORDER IN COUNCIL.****EXTRADITION TREATY.—NETHERLANDS.***Osborne House, Isle of Wight, 2nd February, 1899.*

AT THE COURT AT OSBORNE HOUSE, ISLE OF WIGHT,  
the 2nd day of February, 1899.

Present:

THE QUEEN'S MOST EXCELLENT MAJESTY.

WHEREAS by the Extradition Acts, 1870 to 1895, it was amongst other things enacted that, where an arrangement has been made with any foreign State with respect to the surrender to such State of any fugitive criminals, Her Majesty may, by Order in Council, direct that the said Acts shall apply in the case of such foreign State; and that Her Majesty may, by the same or any subsequent Order, limit the operation of the Order, and restrict the same to fugitive criminals who are in, or suspected of being in the part of Her Majesty's dominions specified in the Order, and render the operation thereof subject to such conditions, exceptions, and qualifications as may be deemed expedient.

And whereas a Treaty was concluded on the 26th day of September, one thousand eight hundred and ninety-eight, between Her Majesty and the Queen of the Netherlands for the mutual extradition of fugitive criminals, which Treaty is in the terms following:—

Her Majesty the Queen of the United Kingdom of Great Britain and Ireland, Empress of India, and Her Majesty the Queen of the Netherlands, having mutually resolved to conclude a new Treaty for the extradition of criminals, the said High Contracting Parties have named as Their Plenipotentiaries to conclude a Treaty for this purpose, that is to say:

Her Majesty the Queen of the United Kingdom of Great Britain and Ireland, Empress of India, the Most Honourable Robert Arthur Talbot Gascoyne Cecil, Marquess of Salisbury, Earl of Salisbury, Viscount Cranborne, Baron Cecil, Peer of the United Kingdom, Knight of the Most Noble Order of the Garter, Member of Her Majesty's Most Honourable Privy Council, Her Majesty's Principal Secretary of State for Foreign Affairs, &c., &c.,

And Her Majesty the Queen of the Netherlands, Alexander William Baron Schimmelpenninck van der Oye, Chargé d'Affaires, *ad interim*, of the Netherlands in London, Knight of the Order of Orange Nassau, &c., &c.;

Who, having communicated to each other their respective full powers, found in good and due form, have agreed upon and concluded the following Articles:—

**ARTICLE I.**

The High Contracting Parties engage to deliver up to each other those persons who, being accused or convicted of a crime or offence committed in the territory of the one Party, shall be found within the territory of the other Party, under the circumstances and conditions stated in the present Treaty.

**ARTICLE II.**

The crimes or offences for which the extradition is to be granted are the following:—

1. Murder, including infanticide, or attempt, or conspiracy to murder, including such crimes when directed against the Sovereign, his heir, or any other person whomsoever, provided that the crime is not of a political character.
2. Manslaughter, including the manslaughter of a child.
3. Assault occasioning actual bodily harm.
4. Maliciously wounding or inflicting grievous bodily harm.
5. Counterfeiting or altering money, or uttering counterfeit or altered money.
6. Forgery, counterfeiting or altering, or uttering what is forged counterfeited or altered.

7. Embezzlement; fraud by a bailee, banker, agent, factor, trustee, or director or member or public officer of any Company, made criminal by any law for the time being in force; or larceny.

8. Malicious injury to property if the offence be indictable.

9. Obtaining money, goods, or valuable securities by false pretences.

10. Crimes against bankruptcy law.

11. Perjury, or subornation of perjury.

12. Rape.

13. Carnal knowledge, or any attempt to have carnal knowledge, of a girl under 16 years of age.

14. Indecent assault.

15. Administering drugs, or using instruments with intent to procure the miscarriage of a woman.

16. Abduction.

17. Child stealing.

18. Kidnapping of minors and their false imprisonment.

19. Burglary or house-breaking.

20. Arson.

21. Robbery with violence.

22. Any malicious act done with intent to endanger the safety of a railway train.

23. Threats by letter or otherwise, with intent to extort.

24. Piracy by law of nations.

25. Sinking or destroying a vessel at sea, or attempting to do so.

26. Assaults on board a ship on the high seas, with intent to destroy life, or to do grievous bodily harm.

27. Revolt by two or more persons on board a ship on the high seas, against the authority of the master.

28. Dealing in slaves in such a manner as to constitute a criminal offence against the laws of both States.

Extradition is also to be granted for participation in any of the aforesaid crimes, provided such participation be an extradition crime by the laws of the State applied to.

In the foregoing cases extradition shall take place only when the crime, if committed within the jurisdiction of the country on which the claim for surrender is made, would constitute an extradition crime by the laws of that country.

Extradition may also be granted, at the discretion of the State applied to, in respect of any other crime for which, according to the laws of both the Contracting Parties for the time being in force, the grant can be made.

**ARTICLE III.**

Either Government may, in its absolute discretion, refuse to surrender its own subjects to the other Government.

**ARTICLE IV.**

The extradition shall not take place if the person claimed on the part of the British Government, or the person claimed on the part of the Netherlands Government, has already been tried and discharged or punished, or is actually upon his trial, within the territory of the other of the two High Contracting Parties, for the crime for which his extradition is demanded.

If the person claimed on the part of the British Government, or if the person claimed on the part of the Netherlands Government, should be under examination, or is undergoing sentence under a conviction, for any other crime within the territories of the two High Contracting Parties respectively, his extradition shall be deferred until after he has been discharged, whether by acquittal or on expiration of his sentence, or otherwise.

**ARTICLE V.**

The extradition shall not take place if, subsequently to the commission of the crime, or the institution of the penal prosecution, or the conviction thereon, exemption from prosecution or punishment has been acquired by lapse of time, according to the laws of the State applied to.

**ARTICLE VI.**

A fugitive offender shall not be surrendered if the offence in respect of which his surrender is demanded is one of a political character, or if he prove that the requisition for his surrender has in fact been made with a view to try or punish him for an offence of a political character.

**ARTICLE VII.**

A person surrendered may in no case be kept in prison, or be brought to trial in the State to which the surrender has been made, for any other crime or on account of any other matters than those for which the extradition shall have taken place, until he has been restored or had an opportunity during one month of returning to the State by which he has been surrendered.

This stipulation does not apply to crimes committed after the extradition.

**ARTICLE VIII.**

The requisition for extradition shall be made through the Diplomatic Agents of the High Contracting Parties respectively.

The requisition for the extradition of an accused person must be accompanied by a warrant of arrest issued by the competent authority of the State requiring the extradition, and by such evidence as, according to the laws of the place where the accused is found, would justify his arrest if the crime had been committed there.

If the requisition relates to a person already convicted, it must be accompanied by the sentence of condemnation passed against the convicted person by the competent Court of the State that makes the requisition for extradition.

A sentence passed *in contumaciam* is not to be deemed a conviction, but a person so sentenced may be dealt with as an accused person.

**ARTICLE IX.**

If the requisition for extradition be in accordance with the foregoing stipulations, the competent authorities of the State applied to shall proceed to the arrest of the fugitive.

**ARTICLE X.**

Pending the presentation of the demand for extradition through the Diplomatic channel, a fugitive criminal may be apprehended under a warrant issued by any Police Magistrate, Justice of the Peace, or other competent authority in either country, on such information or complaint, and such evidence, or after such proceedings as would, in the opinion of the authority issuing the warrant, justify the issue of a warrant if the crime had been committed or the person convicted

in that part of the dominions of the two Contracting Parties in which the Magistrate, Justice of the Peace, or other competent authority exercises jurisdiction; provided, however, that in the United Kingdom the accused shall, in such case, be sent as speedily as possible before a Magistrate. He shall, in accordance with this Article, be discharged, as well in the Netherlands as in the United Kingdom, if within the term of twenty days a requisition for extradition shall not have been made by the Diplomatic Agent of the demanding country in accordance with the stipulations of this Treaty. The same rule shall apply to the cases of persons accused or convicted of any of the crimes or offences specified in this Treaty, and committed on the high seas on board any vessel of either country which may come into a port of the other.

#### ARTICLE XI.

If the fugitive have been arrested in the British dominions he shall forthwith be brought before a competent Magistrate, who is to examine him, and to conduct the preliminary investigation of the case, just as if the apprehension had taken place for a crime committed in the British dominions.

In the examinations which they have to make in accordance with the foregoing stipulations, the authorities of the British dominions shall admit as valid evidence depositions or statements on oath or the affirmations of witnesses taken in the Netherlands, or copies thereof, and likewise the warrants and sentences issued therein, and certificates of, or judicial documents stating the fact of, a conviction, provided the same are authenticated as follows:—

1. A warrant must purport to be signed by a Judge, Magistrate, or officer of the Netherlands.
2. Depositions or affirmations, or the copies thereof, must purport to be certified under the hand of a Judge, Magistrate, or officer of the Netherlands, to be the original depositions or affirmations, or to be the true copies thereof, as the case may require.
3. A certificate of, or judicial document stating the fact of a conviction must purport to be certified by a Judge, Magistrate, or officer of the Netherlands.
4. In every case such warrant, deposition, affirmation, copy, certificate, or judicial document must be authenticated either by the oath of some witness, or by being sealed with the official seal of the Minister of Justice, or some other Minister of State of the Netherlands; but any other mode of authentication for the time being permitted by the law in that part of the British dominions where the examination is taken may be substituted for the foregoing.

#### ARTICLE XII.

If the fugitive have been arrested in the dominions of the Netherlands the officer of justice shall prefer a requisition within three days after the arrest, or, if the arrest have not taken place, or if it have taken place prior to the application for extradition, then within three days after the receipt of authority for that purpose from the Netherlands Government, in order that the person claimed may be interrogated by the Court, and that it may express its opinion as to the grant or refusal of extradition.

Within fourteen days after the interrogatory the Court shall forward its opinion and its decision, with the papers in the case, to the Minister of Justice.

The extradition shall only be granted on the production, either in original or in authenticated copy:—

1. Of a conviction; or,
- 2.—(a) Of a warrant of arrest (which, by the law of the British dominions, is the only document which is granted when it is adjudged upon evidence taken on oath that the accused ought to be taken into custody), issued in the form prescribed by British law, and indicating the offence in question sufficiently to enable the Netherlands Government to decide whether it constitutes, in contemplation of Netherlands law, a case provided for by the present Treaty; and,
- (b.) Of the evidence.

In the examinations which they have to make in accordance with the foregoing stipulations, the authorities of the Netherlands dominions shall admit as valid evidence depositions or statements on oath, or the affirmations of witnesses taken in the British dominions, or copies thereof, and likewise the warrants and sentences issued therein, and certificates of, or judicial documents stating the fact of, a conviction, provided the same are authenticated as follows:—

1. A warrant must purport to be signed by a Judge, Magistrate, or officer of the British dominions.
2. Depositions or affirmations, or the copies thereof, must purport to be certified under the hand of a Judge, Magistrate, or officer of the British dominions, to be the original depositions or affirmations, or to be true copies thereof, as the case may require.
3. A certificate of, or judicial document stating the fact of a conviction, must purport to be certified by a Judge, Magistrate, or officer of the British dominions.
4. In every case such warrant, deposition, affirmation, copy certificate, or judicial document must be authenticated either by the oath of some witness, or by being sealed with the official seal of one of the Principal Secretaries of State, or some other Minister of State of the British dominions; but any other mode of authentication for the time being permitted by law in that part of the dominions of the Netherlands where the examination is taken may be substituted for the foregoing.

#### ARTICLE XIII.

The extradition shall not take place unless the evidence be found sufficient, according to the laws of the State applied to, either to justify the committal of the prisoner for trial, if the crime had been committed in the territory of the said State, or to prove that the prisoner is the identical person convicted by the Courts of the State which makes the requisition, and that the crime of which he has been convicted is one in respect of which extradition could, at the time of such conviction, have been granted by the State applied to. The fugitive criminal shall not be surrendered until the expiration of fifteen days from the date of his being committed to prison to await his surrender.

#### ARTICLE XIV.

If the individual claimed by one of the two High Contracting Parties, in pursuance of the present Treaty, should be also claimed by one or several other Powers, on account of other crimes or offences committed upon their respective territories, his extradition shall be granted to that State whose demand is earliest in date.

#### ARTICLE XV.

All articles seized which were in the possession of the person to be surrendered, at the time of his apprehension, shall, if the competent authority of the State applied to for the extradition has ordered the delivery thereof, be given up when the extradition takes place, and the said delivery shall extend not merely to the stolen articles but to everything that may serve as a proof of the crime.

#### ARTICLE XVI.

The respective Governments mutually renounce all claim for the repayment of expenses incurred by them in the arrest and maintenance and transport of the person to be surrendered, and all other expenses which may be incurred within the limits of their respective territories until the person to be surrendered is placed on board ship, together with the expenses of giving up and returning all seized articles and of sending and returning the papers containing proof of the crime, or other document, and they reciprocally agree to bear all such expenses themselves.

The above stipulations, however, shall not apply to extradition to and from Canada, as regards which Colony all the expenses shall be borne by the demanding State.

The person to be extradited shall be sent to the port which the Diplomatic or Consular Agent of the demanding State shall indicate.

#### ARTICLE XVII.

If in any criminal matter pending in any Court or Tribunal of one of the two countries it is thought desirable to take the evidence of any witness in the other, such evidence may be taken by the judicial authorities in accordance with the laws in force on this subject in the country where the witness may be; and any expenses incurred in taking such evidence shall be defrayed by the country in which it is taken.

#### ARTICLE XVIII.

The stipulations of the present Treaty shall apply to the Colonies and foreign possessions of the two High Contracting Parties, but being based upon the legislation of the mother country, shall only be observed on either side so far as they may be compatible with the laws in force in those Colonies or possessions.

The demand for the extradition of an offender who has taken refuge in a Colony or foreign possession of either Contracting Party may also be made directly to the Governor or principal functionary of that Colony or possession by the Governor or principal functionary of a Colony or possession of the other Contracting Party when the two Colonies or foreign possessions are situated in Asia, Australia (including New Zealand and Tasmania), the Pacific and Indian Oceans, or South or East Africa.

The same rule shall be followed if the two Colonies or foreign possessions are situated in America (including the West India Islands).

The said Governors or principal functionaries shall have the power either of granting the extradition or of referring the question to their Government.

In all other cases, the demand for extradition shall be made through the Diplomatic channel.

The period of provisional arrest provided for in Article X. shall for the purposes of this Article be extended to sixty days.

#### ARTICLE XIX.

From the day when the present Treaty shall come into force the Treaty of Extradition between the two countries of the 19th June, 1874, shall cease to have effect; but the present Treaty shall apply to all crimes within the Treaty, whether committed before or after the day when it comes into force.

#### ARTICLE XX.

The present treaty shall be ratified, and the ratifications shall be exchanged as soon as possible.

The Treaty shall come into force three months after the exchange of the ratifications. It may be terminated by either of the High Contracting Parties at any time on giving to the other six months' notice of its intention to do so.

In witness whereof the respective Plenipotentiaries have signed the same, and have affixed thereto the seal of their arms.

Done in duplicate at London, this 26th day of September, 1898.

SCHIMMELPENNINCK v. D. OYE.

And whereas the ratifications of the said Treaty were exchanged at London on the fourteenth day of December, one thousand eight hundred and ninety-eight:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, and in virtue of the authority committed to her by the said recited Acts, doth order, and it is hereby ordered, that from and after the fourteenth day of March, one thousand eight hundred and ninety-nine, the said Acts shall apply in the case of the Netherlands, and of the said Treaty with the Queen of the Netherlands.

Provided always, that the operation of the said Acts shall be and remain suspended within the Dominion of Canada so long as an Act of the Parliament of Canada passed in one thousand eight hundred and eighty-six, and entitled "An Act respecting the extradition of Fugitive Criminals," shall continue in force there, and no longer.

WHEREAS by Section six of "The Fishery Act, 1889," it is enacted that it shall be lawful for the Governor in Council from time to time, by Regulations to be published in the *Government Gazette*, amongst other things—

1. "To prescribe limits in or about the mouth of, or within any river, creek, stream, estuary, or other inlet of the sea within which it shall not be lawful for any person to fish by means of any net or fixed engine."
2. "To determine the times and seasons at which the taking of any species of fish shall commence and cease."

"And to impose such reasonable penalties, not exceeding Twenty pounds (£20) and forfeitures, as the Governor in Council may think fit, for any breach of such Regulations."

His Excellency the Governor in Council does, by this Regulation, declare it to be unlawful for any person to fish by means of any net or fixed engine, during a period of four calendar months in each and every year, commencing on the first day of March, in that portion of Peel's Inlet described hereunder:—

## No. 3 Bank.

Bounded by lines starting from the South-East corner of Murray Location 5, and extending East-South-Easterly about 330 chains to the South-West corner of Bank No. 2, thence North to the North shore of Peel's Inlet, and along it Westerly to the East end of Creery Island, and along its South coast Westerly to its Southernmost point, and West to the starting point (as coloured red on plan on exhibit at Court House, Pinjarrah, and Post Office, Mandurah, respectively).

HIS Excellency the Governor in Executive Council has been pleased to approve of the following Regulations under Sections 153 and 161 of "The Land Act, 1898," for the leasing of any Town or Suburban Lands which may be declared open for selection as Residential Lots:—

1. An application for a lease of town or suburban land declared open for selection as a Residential Lot shall be made in the form of Schedule "A."

2. The applicant shall be a male person above the age of 18 years, not being an Asiatic or African alien.

3. Applications shall be made to the Minister for Lands, but shall be lodged at the office of the Land Agent of the District within which the land is situate, or in case the land is situate within a Goldfield, then at the office of the Warden of such Goldfield, and shall be transmitted to the Minister by the Land Agent or Warden with his recommendation thereon.

4. Applications shall take priority in accordance with the provisions of Sections 17 and 18 of "The Land Act, 1898."

5. Every application shall set forth the number, position, and area of the Lot applied for, and shall be accompanied by a statutory declaration in the form of Schedule "B."

6. A fee of 10s. shall be payable with every application.

7. The Land Agent or Warden shall forward the application, with his recommendation thereon, to the Minister forthwith after the receipt thereof; and the Land Agent or Warden may, if he shall think fit under special circumstances, give to the applicant a conditional approval in the form of Schedule "C," which shall entitle the applicant to occupy the lot applied for, subject to these Regulations, pending the granting or refusal of the lease.

8. On an application being approved by the Minister, a lease shall be granted in the form of Schedule "D."

9. Every lease shall be limited to the natural surface of the land demised, and of so much of the land below the natural surface to a depth of 40 feet.

10. Every lease shall be granted for a term not to exceed 21 years, at the rent of 10s. per annum, payable in advance, the first payment to be made with the application, and every subsequent payment to become due on the 1st day of January in each succeeding year, and if default in payment thereof shall continue after the 1st day of March in any year the lease shall thereupon become forfeited.

Any Residential Lot leased, or agreed to be leased, under these Regulations, or any portion thereof, may be resumed by the Governor for mining purposes or for any public purpose, at three months' notice to the lessee, published in the *Government Gazette*; and immediately after the expiration of such three months, all the estate and interest of the lessee in the land demised, or the portion resumed, as the case may be, shall cease and determine as if the lease had never been granted: Provided that, on any such resumption, the lessee shall be entitled to receive from the Minister for Lands the fair value of any improvements existing on the said land, to be ascertained, in the absence of agreement, by one competent person to be appointed by the lessee and one by the

Minister for Lands; any difference of opinion between the said valuers to be determined by the Resident Magistrate of the District or Warden of the Goldfield within which the land is situate acting as umpire.

13. In case of the refusal by the Minister of any application, notice thereof shall be given to the applicant by letter sent by post to the address given in the application, and the fee paid on the application and the deposit of rent shall thereupon be returned to the applicant on demand.

14. No person shall hold any Residential Lot within the distance of two miles from any other Residential Lot held by him.

15. No lessee shall transfer or underlet the premises demised by any lease, or any part thereof, except with the consent of the Minister in writing first obtained, after production by the lessee of the lease, and a statutory declaration by the transferee in the form of Schedule "B," and on payment of a fee of 5s.

16. The Governor may, at any time, by notice in the *Government Gazette*, exempt from the operation of these Regulations any portion of any Town or Suburban Lands which may have been declared open for selection.

**H**IS Excellency the Governor has been pleased to make the following additional Regulations under "The Stock Diseases Act, 1895."

GEO. THROSSELL,  
Commissioner of Crown Lands.

1. No cattle shall be allowed to leave the East Kimberley Quarantine Area except at the Port of Wyndham.

2. All cattle leaving the East Kimberley Quarantine Area for any other part of the Colony of Western Australia shall be shipped direct to a spot opposite to Reserve 6320, Owen's Anchorage, situated 12 chains South-Eastward from Robb's Jetty, where, on landing, they shall be deemed to be quarantined until slaughtered or otherwise disposed of as directed, in writing, by an Inspector of Stock.

3. Vessels engaged in the shipment of cattle from the East Kimberley Quarantine Area to the spot opposite to Reserve 6320, Owen's Anchorage, shall be thoroughly disinfected with steam immediately after the landing of the cattle.

4. Cattle may only be removed from Reserve 6320, Owen's Anchorage, on the written permit of an Inspector of Stock that such cattle are apparently clean, and such cattle shall be forwarded in trucks by rail direct to such place on the Eastern Goldfields as shall be specified in the permit, where they shall remain in quarantine until slaughtered, and the trucks used for the carriage of such stock shall be thoroughly disinfected with steam immediately after use.

5. All expenses in connection with the disinfection of vessels and railway trucks used in the conveyance of cattle from the East Kimberley Quarantine Area and Reserve 6320, Owen's Anchorage, or any other temporarily-proclaimed quarantine areas and all expenses incidental to the quarantining of such cattle shall be borne by the owners of such cattle, and all disinfections shall be carried out to the satisfaction of an Inspector of Stock.

6. All hides and skins removed from cattle slaughtered within the East Kimberley Quarantine Area Reserve 6320, Owen's Anchorage, or any other temporarily-proclaimed quarantine area to which East Kimberley cattle may be removed, on the permit of an Inspector of Stock, shall not be removed from any of the said quarantine areas unless the said hides or skins have been treated and disinfected, as follows:—

- (1.) The hides or skins shall be fully opened out and laid down one on top of the other with the hair or outer side lowermost on a properly prepared floor of concrete or other impervious substance on which a layer of salt has been spread.
- (2.) The inside of the hides or skins shall be covered with strong, coarse, dry salt, to the extent on an average of not less than 12lb. to each hide, and they shall be built up and salted in this way till a stack is formed from which the brine is allowed to drain freely off.
- (3.) The hides or skins shall remain in the stack for not less than seven days.

- (4.) When salted each of the hides or skins shall be turned in from the head, then from the butt, and then folded up so as that the salt shall be retained and every part of them shall come in contact with it

The hides or skins shall remain on the salting-floor until an Inspector of Stock has certified in writing that the above requirements have been complied with.

7. All imported stock carried in vessels which at any time after these Regulations shall come into force shall have been employed during the next preceding three months in the East Kimberley cattle trade shall be subject to the Regulations applicable to cattle shipped from the East Kimberley Quarantine Area, in lieu of the declaration and certificate required under Sections 12 and 13 under "The Stock Diseases Act, 1895."

8. Every person committing a breach of any of these Regulations shall be liable to a penalty not exceeding £500.

### Interpretation Clauses.

"East Kimberley Quarantine Area" shall mean all that portion of the Kimberley District East of the 127th meridian of longitude.

"Inspector of Stock" shall mean the Chief Inspector of Stock, and every Inspector appointed under the provisions of this Act or any person authorised by the Government to act as an Inspector.

"Quarantine" shall mean the complete isolation of cattle from all other stock.

"Owner" shall mean any owner or consignee, whether joint or sole, superintendent, or person in possession or charge of stock, or any agent or any such owner.

"Vessel" shall mean all steam or sailing boats

"Cattle" shall mean any bull, cow, ox, steer, heifer, or calf, or the carcase, or any portion of the carcase thereof, respectively.

**I**T is hereby notified, for general information, that His Excellency the Governor in Executive Council has been pleased to approve of the following Regulations in connection with the Land Surveyors Licensing Board, appointed under the above Act, and of the cancellation of those approved on 19th February, 1896.

1. The Board shall meet for the despatch of business on the first Wednesday of every January, April, July, and October, and shall have power to adjourn to any intermediate period; provided that, if the first Wednesday be a public holiday, the Board shall meet on the following Wednesday.

2. At the first meeting of the Board, which shall be held in the month of January in each year, the members present shall choose one of their number to be the Chairman for the ensuing year, but the omission to choose a Chairman at such meeting shall not invalidate any act done by the Board.

3. The Chairman shall have power to call a special meeting for the consideration of any business which he may wish to submit to the Board.

4. The Chairman, or, in his absence, the Secretary, shall convene a special meeting of the Board, upon the written requisition of three members setting forth the objects for which the meeting shall be called, within three days after the receipt of the requisition.

5. Twenty-four hours' notice in writing, at least, shall be given of any special meeting of the Board to every member of the same, and shall be sent by post to, or delivered at, the address of such member.

6. At every meeting of the Board the Chairman, if present, shall preside, and, in his absence, a Chairman shall be chosen by a majority of the members present.

7. Any member of the Board shall be entitled to receive a fee of one guinea for attendance at any meeting convened in accordance with these Regulations, and for each day or part of a day engaged in conducting any examination.

8. Any member who shall not be present at any Board within fifteen minutes of the time appointed for the meeting of the same shall not be entitled to any remuneration for his attendance.

9. All questions which shall be proposed or considered at any meeting of the Board shall be determined by a majority of the votes of the members present; each member to have one vote, and in case of an equal division of the votes the Chairman shall have a casting vote besides his ordinary vote.

10. All proceedings of the Board shall be entered in a journal to be kept for the purpose, and at each meeting of the Board the minutes of the preceding meeting shall be read and confirmed or amended, and the presiding Chairman shall sign them as confirmed or amended.

11. All moneys received by the Board shall be placed to its credit at such bank as the members may from time to time direct, and all payments shall be made by cheques on such account, signed by one member of the Board and countersigned by the Secretary for the time being.

12. The Secretary shall attend every meeting and enter minutes of all the proceedings of the Board, and keep all the books and accounts, conduct the correspondence under the direction of the Chairman, and transact any other business the Board may require. He shall keep a register in which he shall enter the names of all Licensed Surveyors, with the particulars of their certificates, and shall cause such register to be revised forthwith after the issue, cancellation, or suspension of any license. The summer appears to have broken up rather early this year. The prevailing impression seems to be that it has been a remarkably mild one, but the figures hardly support this view.

November was unusually cool, December slightly above the average, January very slightly below, February was below, as was also this month. So, on the whole, the summer has been a cool one, but not by any means exceptional.

We have once again to record a very heavy storm in the North-West district. This appeared first at Port Darwin (South Australia) on the 12th. Next day Wyndham and Turkey Creek experienced it, and on Wednesday morning, the 15th, Turkey Creek reported a further downpour of 256 points. During this day it extended to Derby, which station recorded 107 points on Thursday morning. By Friday morning the rain had reached Condon, and it was overcast down to Onslow. On Sunday it was raining at Condon and Cossack, and the barometer at the latter place fell to 29.38, with a strong South-East gale. Next morning (20th) it had fallen to 29.27, and very heavy rains were recorded all through that district as far South as Fortescue. The lowest barometer, 28.941, was reached during the 20th. It seems then to have recurved and travelled inland, causing very heavy floods through the North-West districts. Owing to the absence of observing stations we are unable to trace it further, but it seems probable that it travelled across the desert to South Australia, for rain fell at Menzies and Mount Malcolm, in the upper Coolgardie district, on the 23rd, and on the next day a heavy downpour was recorded throughout the Northern portions of South Australia.

The steamer "Albany," trying to reach Cossack from Onslow, encountered the storm at sea. The Captain reports that a strong Easterly gale was blowing on the morning of the 19th, but at 2 p.m., when off Skoll Island, the wind suddenly backed to the South-East and blew with terrific force, the barometer reading 28.90. At 4 p.m. the wind increased to hurricane force, the ship lost part of her steering gear and drifted before the wind till 4 a.m. on the 21st, when the wind, having backed from the South-East to the South-West, blew itself out in a West-South-West direction. This all tends to show that the storm passed nearly over, or perhaps rather to the North of Cossack, and travelled inland in an Easterly or South-Easterly direction.
