## PROCLAMATION

Mestern Anstralia, ) to wit.

By His Excellency Lieut.-Colonel Sir GERARD SMITH, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Colony of Western Australia and its Dependencies, &c., &c., &c.

HEREAS under and by virtue of the provisions of "The Municipal Institutions Act, 1895." the Governor is empowered, with the advice of the Executive Council, amongst other things to alter the boundaries of any Municipality: Now THEREFORE I, the Governor of the said Colony, with the advice aforesaid, in pursuance of the power vested in me by the said Act, do hereby alter the boundaries of the Municipality of Kalgoorlie, and declare them to be as follows :-

Bounded by lines starting from the intersection of the centre of Ward Street with the centre of the Kalgoorlie-Menzies railway line and extending 223° 28' about 54 chains to the South-West side of Cassidy Street; thence 133° 28' 12 chains 75 links along said side of Cassidy Street; thence 223° 28' 15 chains along the North-West side of Campbell Street; thence 133° 28' 20 chains 70 links along the South-West side of Russell Street; thence 223° 28' 71 chains 50 links along the North-West side of Bourke Street; thence by a line bearing 133° 28' about 62 chains along the South-West boundaries of Kalgoorlie Town Lots 290 and 293 by a fine bearing 133–23 about 52 chains along the South-West boundaries of Kalgoorlie Town Lots 399 and 398, and along the South-West side of Throssell Street to the South-East side of Egan Street; thence 43° 28′ 23 chains 50 links along part of the South-East side of Egan Street; thence 109° 28′ about 26 chains 70 links; thence 45° 28′ about 46 chains and 60 links; thence 39° 48′ about 29 chains 55 links parallel to and at the distance of 75 links south East halo for the South East bound at the distance of 75 links South-Easterly from the South-Eastern boundaries of Kalgoorlie Town Lots R713 to R719 inclusive to the centre of the Kalgoerlie-Boulder railway line, and thence North-Westward along the said centre and the centre of the aforesaid Kalgoorlie-Menzies railway line to the starting point.

The boundaries set forth in the Proclamation published in the Government Gazette of the 22nd October, 1897, are hereby cancelled.

### CIRCULAR.

#### Downing Street, 21st July, 1899.

SIR,—With reference to my Circular despatches of the 23rd February and 15th May, 1897, forwarding Regulations as to Naval Cadetships, I have the honour to transmit to you a copy of a letter from the Admiralty with enclosures [Admiralty, 19th June], respecting a proposed modification of the present system of conducting the Examination on Stations abroad of certain Colonial Candidates for these Cadatehing. Cadetships.

2. In order to meet the wish expressed by their Lordships that the names of Colonial Candidates may be forwarded to them by the 1st January in each year, it will be necessary that the Secretary of State shall in future consider all applications for nominations for the ensuing year in the preceding December, and I shall therefore be obliged if you will forward all such applications, together with your recommendation and the prescribed documents, in time to reach this Department by the 30th November in each year, instead of the 31st December as requested in my Circular despatch above referred to.

You will have the goodness to acquaint all applicants for nominations who may elect to be examined abroad, that the local Examinations will no longer be held in March, July, and December as heretofore, but some weeks earlier according to the distance of the particular Station from the United Kingdom,

4. I take this opportunity to forward to you copies of the latest Regulations which have been issued by the Admiralty in connection with this matter. I have, etc.,
