BY virtue of The Commonwealth of Australia Constitution Act, I, Sir Alexander CAMPBELL ONSLOW, Knight, Administrator of the Government of Western Australia, hereby command you that you cause election to be made, according to law, of Six Members for the State of Western Australia to serve in the Senate; and I appoint the following dates for the purposes of the said Election :-
