And We command by the tenor of these Presents Our Sheriff of Western Australia that at certain days and places which you or any such two or more of you as is aforesaid shall make known to him he cause to come before you or such two or more of you as is aforesaid so many and such good and lawful Men of his Bailiwick by whom the truth of the matter in the Premises shall be better known and inquired into
