CITY OF PERTH.

By-LAW No. 1.

Standing Orders.

In pursuance of the powers in that behalf contained in "The Municipal Institutions Act, 1900," the Mayor and Councillors of the Municipality of Perth do hereby repeal all By-laws heretofore made by the Council of the said Municipality with reference to the matters hereinaft r provided for, and do order as follows :

1. The proceedings and business of the Council shall be conducted according to the following Regulations, which shall be called the "Standing Orders."

2. In the construction of this By-law, unless the con-text otherwise requires, the word "Mayor" shall include the Councillor chosen to preside at any meeting of the Council.

The business of the Council shall be conducted with 3 open doors except upon such occasions as the Council shall, by resolution, otherwise decide, which resolution may be moved without notice.

4. At any meeting of the Council a quorum shall consist of not less than five Councillors in addition to the Mayor. Every meeting shall proceed to business so soon after the time stated in the summons as there shall be a sufficient number of Councillors in attendance to constitute a quorum.

5. If at any meeting a quorum be not present within a quarter of an hour after the time appointed for such meeting, the majority of the Councillors present, or any one Councillor if only one be present, or the Town Clerk if no Councillor be present, may adjourn such meeting to any date not later than seven days from the date of such adjournment.

The Mayor, if present, shall preside at all meetings of the Council, and in his absence, or if, after being present, he retires, one of the Councillors chosen by the Councillors present shall preside.

7. At all meetings at which there are not present five Councillors and the Mayor, or six Councillors, as the case may be, or at which the Council is counted out for want of a quorum, the names of the Councillors then present shall be recorded in the minute book.

8. Any Councillor may count out a meeting at any time

8. Any council or may count out a meeting at any time when there shall not be a quorum present. 9. The minutes of any preceding meeting, whether ordinary or special, not previously confirmed, shall be sub-mitted as the first business at all meetings of the Council in order to their confirmation; and no discussion shall be be the proceedings, and the said minutes shall then be signed by the Mayor as by Section 162 of the Act required. 10. After the signing of the minutes as aforesaid, the

order of business of an ordinary meeting shall be as follows, or as near thereto as shall be practicable; but for the greater convenience of the Council at any particular meet-ing thereof, it may be altered, by resolution to that effect :-

- (1.) Announcements by the Mayor, without discussion.
- Questions by Council, without discussion. (2.)
- Correspondence. (3.)
- (4.) Petitions and memorials.
- (5.) Tenders.
 (6.) Reports of Committees. Orders of the Day, including considering and ordering upon reports previously presented, business left over from the preceding meeting, (7.)and any business the Mayor may think desirable to bring under the notice of the Council, and may have directed to be entered as an order of the day.

- (8.) Motions of which previous notices have been given
- Notices of motions for consideration at the fol-(0.)lowing meeting, if given during the meeting.

The order of business at any special meeting of the 11. Council shall be the order in which such business stands in the notice thereof.

12. Any Councillor may bring forward such business as he may consider advisable in the form of a motion, of which notice shall be given in writing to the Town Clerk, either at the meeting previous to the meeting at which it is intended to move the same, or at any time thereafter, being not less than three clear days before such last mentioned meeting. 13. Every such motion shall lapse unless the Councillor

who gave the notice thereof, or some other Councillor authorised by him in writing, be present to move the same when such motion shall be called on.

Order of Debate.

14. Any Councillor moving a motion or amendment, or taking part in the discussion thereon, shall rise and address the Mayor, and shall not be interrupted unless upon a p int of order, when he shall resume his seat until the Councillor raising the point of order has been heard there-on and the question of order has been disposed of, when the Councillor in possession of the chair may proceed.

15. Any Councillor desirous of proposing an original motion or amendment shall state the nature of the same before he addresses the Council thereon, and, if so required by the Mayor, shall put the same in writing.

16. No motion or amendment shall be withdrawn without the leave of the Council.

17. No motion or amendment shall be discussed or put to the vote of the Council unless it be seconded, but a Councillor may require the enforcement of any standing order of the Council by directing the Mayor's attention to the infraction thereof.

18. At meetings of the Council, speakers, in referring to others present thereat shall designate them by their respective titles of Mayor or Councillor, as the case may be.

19. If two or more Councillors rise to speak at the same time, the Mayor shall decide which is entitled to priority.

20. No Councillor shall speak twice on the same question except by way of explanation or in reply upon any original motion of which he may be the mover, or as the mover of the amendment last carried. And no Councillor shall speak to any question after the mover shall have been permitted to reply.

21. The Mayor shall, without waiting for the inter-position of the Council, call to order any Councillor proceeding to speak a second time on the same question.

22. A Councillor moving or seconding a motion or amendment shall be held to have spoken thereon.

23. In cases of urgent necessity any Standing Order or Orders of the Council may be suspended on motion duly made and seconded without notice, provided that such motion has the concurrence of the majority of the Councillors present, provided also that such majority be not less than seven.

24. Any Councillor moving the suspension of any Stand-ing Order shall state the object of such motion, but no discussions shall take place thereon.

25. Any Councillor may, of right, require the production of any of the documents of the Council relating to the questions or matter under discussion.

26. One amendment only shall be discussed at one time, but, if lost, another may be moved before the original question is put to the vote; but upon any amendment being carried, it shall be competent for any Councillor to move one other amendment thereon, but no more.

Upon the adoption of any amendment, such amend-27 ment shall be held to have quashed the original motion, and for all purposes of subsequent discussion the amendment so carried shall, subject to the last preceding clause, be treated as an original motion.

28. The Mayor shall, in taking the vote on any motion or amendment, put the question first in the affirmative, and then in the negative, and he may do so as often as it is necessary to enable him to form and declare his opinion from the show of hands as to which party has the majority.

29.The Council shall vote by a show of hands, but any Councillor may call for a division upon any question, in which case the Councillors voting in the attirmative shall, until the vote is recorded, stand up, and those in the negative retain their seats; all division lists shall be entered on the minutes.

No Councillor shall reflect upon any vote of the Council, except for the purpose of moving that such vote be rescinded.

31. No discussion shall be allowed on any motion for adjournment of the Council, but if, on the question being put, the motion be negatived, the subject then under consideration or the next on the notice paper, or any other that may be allowed precedence, shall be discussed before any subsequent motion for adjournment shall be entertained.

32. No resolution of any meeting of the Council shall be revoked, rescinded, or altered, except in manner provided in Sec. 150 of the Act.

33. No motion for revoking, rescinding, or altering any resolution of the Council which shall have been negatived by the Council shall again be entertained during the same municipal year, unless with the consent of at least 10 members of the Council.

34. A debate may be adjourned to a later hour of the same day or to any other day by motion duly seconded without previous notice. No discussion shall be allowed upon a motion for the adjournment of a debate.

35. The Councillor upon whose motion any debate shall be adjourned by the Council shall be entitled to preaudience on the resumption of the debate.

36. If a debate on any motion moved and seconded be interrupted by the Council being counted out, such debate may be resumed, at the next meeting, at the point where it was so interrupted, on motion with notice.

37. At all meetings of the Council, save where the Act otherwise provides, all the Councillors present shall vote. If there be an equal division of votes upon any question, the Mayor shall, in addition to his own vote, have a second or casting vote.

38. The Council may determine that any question shall be considered in committee of the whole, and a motion to that effect may be moved without previous notices.

39. Such committee shall consider such matters only as shall have been referred to it by the Council.

40. In committee of the whole the Standing Orders of the Council shall apply, except that Councillors may speak more than once to the same question.

41. The Mayor shall report the resolutions arrived at in committee of the whole to the Council at its next ordinary meeting, or upon the resumption of the Council, as the case may require, and such resolutions shall be dealt with as the Council may think fit.

42. No Councillor shall digress from the subject matter of the question under discussion, nor impute improper motives to any other Councillor, and all personal reflections upon any Councillor shall be considered highly disorderly.

43. Any Councillor may require the Town Clerk to take down any particular words used by a Councillor immediately upon the same being used.

44. The Mayor, when called upon to decide a point of order or practice, shall give his decision, and no argument or comment shall be permitted thereon; and his decision shall be final in that particular case.

45. Any Councillor who shall use any expression which, in the opinion of the Mayor, reflects offensively on any member of the Council shall, when required by the Mayor, withdraw such expression, and make a satisfactory apology to the Council; and if he refuse or neglect to do so before the close of the meeting, he shall be deemed guilty of an offence against this By-law.

46. No Councillor shall make any noise or disturbance, or, except to raise a point of order, converse aloud whilst any other Councillor is speaking, or whilst any matter is being read or opened; and, in case any such noise or disturbance is persisted in after the Mayor has called the offender to order, such offender shall be deemed guilty of an offence against this By-law.

47. When the Mayor is putting any question, no Councillor shall walk out of or across the chamber, nor shall any Councillor, whilst any other Councillor is speaking, pass between the speaker and the chair.

48. The Mayor may, on his own motion, call any Councillor to order whenever, in his opinion, there shall be cause for so doing.

49. Every Councillor shall be entitled to direct the attention of the Mayor to any infraction of the Standing Orders by any other Councillor.

50. Whenever it shall have been decided by the Mayor that any motion, amendment, or other matter before the Council is out of order, the same shall be rejected, and whenever anything said or done in Council by any Councillor shall be similarly decided to be out of order, such Councillor shall be called upon by the Mayor to make such explanation, retraction, or apology as the case may require. 51. Any Councillor who shall have been called to order, and who shall persist in any line of conduct which shall have been decided to be disorderly, or who shall refuse to make such explanation, retraction, or apology as aforesaid when required so to do, shall be deemed guilty of an offence against this By-law.

Committees.

52. In addition to such special committees as may from time to time be appointed, there shall be three standing committees appointed from among the Councillors—namely, a Works Committee, a Finance Committee, and a General Purpose Committee—each of which shall consist of not less than four members. Such committees shall be appointed each year at the first meeting of the Council which shall be held after the annual election.

53. The members of the said committees shall, in default of agreement, be elected by ballot; and in the event of an equality of votes for two or more Councillors, the Mayor shall have a casting vote.

54. The Works Committee shall have the general direction of all works ordered or sanctioned by the Council, and of all streets, roads, ways, drains, bridges, and other public places under the care and management of the Council, the management and general direction of street lighting, sweeping, and watering, and the general administration of the building By-law. Such committee shall inquire into and report to the Council from time to time upon such improvements and repairs as they may think necessary, or which the Council may, by resolution, direct them to inquire into and report upon.

55. The Finance Committee shall examine and check all accounts and generally supervise the collection and expenditure of the municipal revenue. Such committee shall inquire into and report to the Council from time to time upon all matters which they may consider to affect, or be likely to affect, the finances of the municipality, or which the Council may, by resolution, direct them to inquire into and report upon. Such committee shall also have control of all matters affecting the staff of the Council.

56. The General Purpose Committee shall prepare drafts of all such By-laws as may from time to time be required for the good government of the municipality. They shall also have the control of all parks, reserves, and tree-planting, and of the Town Hall and other municipal buildings, and the administration of all the municipal By-laws, except such as shall be specially placed under the control of any other committee. So far as concerns the administration of the By-laws in reference to licensed vehicles, the proceedings of the General Purpose Committee shall not require the approval of the Council.

57. Special committees may consist of any number of members, and may be appointed for the performance of any duty which may be lawfully entrusted to a committee, and for the performance of which, in the opinion of the Council, a special committee ought to be appointed. No standing committee shall interfere with any matters which may for the time being have been entrusted to any special committee. The appointment of a special committee shall be made by resolution, after due notice; such resolution shall state the duties proposed to be entrusted to such special committee, and may either state the number of Councillors to be elected by ballot or shall name the Councillors whom it is proposed shall constitute such committee. In the event of a ballot being taken and an equality of votes being recorded in favour of any two or more Councillors, the Mayor shall have a casting vote.

58. The Town Clerk shall call a meeting of any committee when requested so to do by the Mayor or any two members of such committee.

59. Each standing committee shall keep a book, to be called the minute book, in which shall be entered minutes of all its proceedings and transactions. The minutes of each meeting shall be confirmed at the following meeting and signed by the chairman thereof.

60. Any Councillor who shall be guilty of an offence against this By-law shall be liable, on conviction before a court of summary jurisdiction, to a penalty not exceeding $\pounds 220$.

61. Whenever any Councillor shall have committed an offence under this By-law, the Mayor may forthwith lay or cause to be laid an information before a Justice of the Peace, for the purpose of summoning the offending Councillor, and shall afterwards appear and prosecute the charge.

BY-LAWS.

Perth. 17th December. 1902.

UNDER the provisions of "The Parks and Reserves Act, 1895," the Board appointed to control and manage Caves' Reserves Nos. 8427, 8428, 8429, 8430, 8431, 8432, 8433, 8434, 8435, 8436, 8437, and 8438 has, with the approval of His Excellency the Administrator, made the following By-laws.

ADAM JAMESON, Minister for Lands.

CAVES TO BE OPEN.

1. The caves within these reserves will be open for inspection daily between 8 a.m. and 10 p.m., provided visitors give the caretakers reasonable notice of the time they intend to visit them.

VISITORS TO BE ACCOMPANIED BY CARETAKER

2. No person or persons shall enter any cave unless accompanied by the Caretaker.

Admision Fee.

3. Every person entering a cave shall pay to the caretaker an admission fee of 1s.

INJURING OR DESTROYING TREES.

4. No person shall injure, cut, break, deface, pull up, pick, remove, or destroy any tree, shrub, plant, or flower growing on the said Reserves.

INJURING OR DISFIGURING CAVES.

No person shall break, remove, injure, or deface by writing or marking, or in any way damage any rock, stalactite, or stalagmite, or remove any rock, stalactite, or stalagmite, or is an agrinte, or remove any rock, stalactice, or stalagmite, or in any way injure, damage, or disfigure the stairways, ladders, cave gates, railings, seats, fences, build-ings, machinery, lighting appliances, or other structures or improvements within any cave or upon any cave reserve.

INJURING THE SOIL OR SURFACE, OR DESTROYING BIRDS OR ANIMALS.

No person shall cut up, damage, or disfigure, or 6. interfere with the soil, or rocks, or turf, or surface of the caves reserves, or the roads or footways across, around, or over the same, or pollute or interfere with any water thereon, interfere with or destroy any birds or animals thereon in any manner whatsoever.

VISITORS TO ACT IN OBEDIENCE TO INSTRUCTIONS OF CARETAKER.

7. Every visitor to the reserves or caves therein shall act in obedience to the instructions of the Caretaker, whilst being shown through or over any cave or caves.

PERSONS MISCONDUCTING THEMSELVES.

8. No person or persons shall misconduct themselves in any way by indulging in riotous or indecent conduct, or make use of any indecent or improper language, or commit any nuisance on or within the said reserves and caves.

CARETAKER MAY REMOVE ANY PERSON GUILTY OF IMPROPER CONDUCT.

9. Any caretaker or servant of the Board may exclude or remove from the reserves or caves any person or persons guilty of a breach of these By-laws.

POSTING BILLS.

10.
