AMENDMENT TO REGULATION No. 107.

WHARFAGE.
No. 107.

Inwards Manifests to be supplied and certified to.—The master of every vessel arriving at the Port of Fremantle shall, in order to enable the amount of wharfage dues payable in respect of cargo carried by such vessel, deliver at the office of the Trust, prior to commencing to discharge such cargo, a true, legible, and complete copy of the manifest of the said vessel, certified to by himself as being true and complete in accordance with the form set forth in Schedule A, and shall also furnish within a reasonable time a certified statement of all alterations (if any) which may be made in such manifest by reason of re-measurement of goods included therein or otherwise. Should the master of any such vessel fail to furnish such information within the time specified, or should he furnish the Trust with any information which is inaccurate in any material particular, or is not duly certified to as being true and complete, the said master, or, in his absence from the port, the owner or agent of the vessel, shall be liable to a fine not exceeding One hundred pounds (£100).

SANTOPILLI LIGHT—CHARACTER ALTERED.

With reference to Notices to Mariners, Nos. 4 and 31 of 1903, it is hereby notified that, from and after the 16th November, 1903, the character of Santopilli light will be altered from a white fixed to a group flashing white light giving two flashes every ten seconds; it will show a group of two flashes of about one-ninth second, separated by eclipses of about 2½ seconds and followed by an eclipse of about 7½ seconds duration; also that the building on which this light will be exhibited is a cement tower situated S. 48° E. mag., distant 1,800 feet from the present lighthouse.

WITH the object of encouraging *bona fide* prospectors, free assays for gold, silver, copper, etc., and determinations of mineral samples and rocks will be made at the School of Mines, Coolgardie, under the following circumstances:—

- (a.) The sender must satisfy the Director that he is a *bona fide* prospector, or acting on behalf of such, and that the sample forwarded is one genuinely complying with the following conditions under which free assays will be made.

SCHEDULE.

Conditions on which Ledger Accounts are opened with customers by the Railway Department for the carriage of goods:—

1. A bank cheque or a bank draft in favour of the Colonial Treasurer must accompany application, the amount of which will be placed at fixed deposit at current bank rate of interest for the period mentioned

in application. No amount will be deposited bearing interest for a less period than six months. Such deposit will be renewed from time to time for like periods, unless notice to the contrary is given not less than seven days prior to deposit maturing.

2. Interest accruing on deposits will be forwarded direct to ledger account holder, or paid to his credit at any bank, as may be desired.

3. Deposits may be withdrawn at any time upon notice (in writing) being given to the Chief Accountant, and ledger accounts closed, but interest will be allowed only on deposits which have matured, and not for any broken periods.

4. Credit will not be given beyond the amount of deposit.

5. Accounts will be rendered at least monthly, and must be paid in full within seven days of delivery of same. In the event of payment not being so made, it will be optional with the Department to summarily close the account and apply the amount of deposit, or so much of it as may be necessary, in payment of such account, and should there be a deficiency, detain goods on any part of the railway premises as lien. Accounts will be rendered more frequently than monthly if desired by the ledger account holder, and if convenient to the Commissioner. No money will be received in part payment of an account.

6. Errors, when found to exist, must at once be brought to the notice of the Chief Traffic Manager, who will have such rectified as soon as possible.

7. Claims for loss or damage will not, under any circumstances, be allowed as a set-off against an account. Any attempt at evasion of this nature, if persisted in, will be treated as an infringement of these conditions.

8. Credit will only be given at the station mentioned in the original request for a ledger account. Fresh application on a proper form must be made for credit at any additional stations.

9. Ledger accounts are opened subject to the observance of the By-laws, Rules, and Regulations appertaining to the Department.

10. The Commissioner of Railways shall, with respect to all goods, have the same right of detainer and power of sales for all moneys due to him as is given by the Railway Acts of Western Australia and the Regulations made thereunder.

11. In the event of a ledger account holder desiring to increase or reduce the amount of deposit or of any change in the style of the account, fresh application must be made.

REGULATIONS FOR CONDUCT OF DRIVERS OF PASSENGER OR GOODS VEHICLES PLYING FOR HIRE WITHIN THE GOVERNMENT RAILWAY PREMISES.

(To operate from the 1st January, 1904.)

1. No cab, carriage, cart, trolley, or other wheeled vehicle will be allowed to enter upon the railway premises for the purpose of plying for hire, unless the person in charge thereof has been duly licensed for that purpose by the Commissioner.

2. Applications for licenses must be made to the Commissioner (in the form of Schedule A hereto) and forwarded through the Station Master or other official in charge of the place for which the license is required.

3. Applicants for licenses must forward, with their application, certificates of character from at least two persons of repute, or one certificate from the Police authorities of the district wherein the applicant resides or plies his calling.

4. A half-yearly fee of 10s. (Ten shillings) shall be paid on every license issued. Every license shall terminate on the 30th June and 31st December in each year, and the Commissioner may, subject to the regulations in force for the time being, renew such license on payment of the prescribed fee of 10s.

5. The holder of a license shall not solicit custom or hire, or in any wise interfere with or obstruct any passenger or servant of the Commissioner upon any railway premises or any approach thereto (*vide* By-laws 20 and 21).

6. Licenses are not transferable. They must be delivered up to the Commissioner when required.

7. Should the person in charge of any vehicle plying for hire on any railway premises be found in possession of, and using a license which has not been issued to him, he will be liable to prosecution.

8. The Commissioner may cancel any license the holder of which,—

- (a.) Has been convicted of a breach of the By-laws; or
- (b.) Has been proved to the satisfaction of the Commissioner to have been guilty of any disorderly conduct; or
- (c.) Of making use of threatening, abusive, indecent, or offensive language; or
- (d.) Is guilty of any breach of these regulations.

9. The Commissioner may, without giving any reason, cancel any license issued under these regulations.

10. All previous regulations are hereby cancelled.

YILGARN DISTRICT ROADS BOARD.

By-Law.

WHEREAS under Section 117 of "The Roads Act, 1902," power is given to Roads Boards to make By-Laws: the undermentioned By-Law is hereby declared, under sub-section 9, for the Yilgarn District:—

Mode of Harnessing Horses.

All teams consisting of more than two horses, drawing vehicles of any description, shall be harnessed two abreast, and not in single file. When the number of horses in any team is more than two, but not a multiple of that number, the odd horse may be harnessed singly.

Any person offending against this By-law shall be liable to a penalty for each offence of a sum not exceeding £20 on conviction before any two (2) Justices of the Peace.

BY-LAWS OF THE CUBALLING ROADS BOARD.

THE Cuballing Roads Board, in pursuance of the powers vested in the said Board, under and by virtue of the said Act, doth hereby make and publish the following By-laws:—

WHEREAS by "The Roads Act, 1902," the Board of any district is empowered to make By-laws for all or any purposes in the said Act mentioned: It is hereby resolved by the Board of the Cuballing district, by and with the approval of His Excellency the Administrator in Council, that the following By-laws shall be in force within the said district from the date of the publication thereof in the *Government Gazette*:—

Interpretation.

In these By-laws the following terms shall, unless the context otherwise indicates, bear the meanings set against them respectively, that is to say:—

"The Act," the Roads Act of 1902, and all amendments thereto considered necessary which may come into force hereafter as far as the Act allows.

"District," the Cuballing Roads Board District.

"Board," the Cuballing Roads Board.

"Secretary," the Secretary of the Board.

"Road or Reserve," a public road or reserve, as the case may be, under the control of the Board.

"Footpath or Footway" shall include any part of a street set apart for the sole use of foot passengers, and whether the same be made or kerbed or otherwise.

"Cycle," a bicycle, tricycle, or other velocipede.

"Cyclist," a person riding, impelling, or otherwise using or having the management or control of any cycle.

"Person" shall include the plural and also the body corporate.

"Permission of the Board," the consent of the Board given in writing.

"Vehicle," any cart, dray, carriage, van, omnibus, trap, or other conveyance (not being a handcart), with or without springs.

Other interpretations are as defined in Interpretation Clause 4 of "The Roads Act, 1902."

Appointments.

1. No permanent appointment shall be made to an office under the Board until an advertisement has been published in one or more local newspapers calling for applications from persons competent to fill such an appointment. All appointments shall be made by resolution passed by the Board.

Duties of Secretary.

2. (a.) To attend all Board meetings.
- (b.) To attend committees when considered necessary.
- (c.) To take notes of all minutes and prepare reports of committees.
- (d.) To conduct all correspondence, and to give the other officers instructions as directed by the minutes.
- (e.) To answer all the questions on the Board's business.
- (f.) To supervise the preparation of the rate books and Board's electoral lists, examine proofs of latter, and arrange for the distribution of copies prior to elections; also to attend all Courts of Revision or Repeal, making the necessary arrangements for the elections, and preparing papers, etc., for the clerks.
- (g.) To summon the members to Board and Committee meetings other than the regular meetings.
- (h.) The Secretary shall keep the cash book, as well as any and all other books issued by Minister for Works in accordance with instructions inserted therein, and those required to show the receipts and expenditure made by the Board. The said books shall be kept written up every fortnight ready for the inspection of the Board or any member of the Board who may at any time during office hours desire to see them.
- (i.) He shall check all accounts sent in to the Board, and see that all accounts for works (exceeding five pounds in amount) have stated on them the authority under which such works have been done, and shall check all returns made by the collectors or other of the Board's officers, and shall see that, with all returns made, the heels of the receipt books accompany the returns; he shall supervise and attend to the due payment of all money coming through the hands of the Board's officers and payable to the credit of the Board; he shall report to the Board at their next meeting any officer neglecting to make his returns, as provided, with the necessary vouchers attached thereto.
- (j.) He shall pay into the bank as soon as possible after the receipt, to the credit of the Board, any sum or sums of money that may be received by him on behalf of the Board.
- (k.) He shall have the cash book and bank pass book made up in readiness for the meetings of the Board, and shall produce them at each meeting thereof; should any member of the Board desire to see them at any time during office hours the Secretary shall produce them for his inspection. No money shall be paid into the bank to the credit of the Board by any officer of the Board, except by or through the Secretary. The Secretary shall give all receipts on printed forms. The Secretary shall readily and cheerfully obey all lawful commands or orders of the Board, and shall attend to all other matters affecting the finances of the Board and not herein specified.
- (l.) At each ordinary meeting of the Board an approximate balance sheet shall be produced, showing as nearly as possible the financial position of the Board as regards payments already made, its present assets and liabilities, which latter shall specify and include moneys voted for special purposes which have not yet been undertaken or contracted for; and no further expenditure of any nature shall be incurred unless the balance sheet shall be then produced.

Duties of Collector.

3. (a.) To send out all rate notices.
- (b.) To collect all moneys due to the Board for rates and licenses.
- (c.) To report to the Board at every meeting the business he has transacted for the Board, the amount of money collected and paid over to the Secretary.

Meetings and Proceedings.

4. (a.) Notice shall be given by the Chairman or Secretary of ordinary or special meetings at least three days before such meeting, and "notice in writing" of every meeting adjourned for a term exceeding two days.

- (b.) The Chairman, if present, shall preside at all meetings of ratepayers and of the Board, and in his absence, or, if after being present, he shall retire, one of the members of the Board chosen by the ratepayers or members present (as the case may be) shall preside for remainder of meeting.
- (c.) Meetings of the Board shall be of two kinds, "Ordinary" and "Special."
- (d.) It shall rest with any three members of the Board to exclude the public when, in their opinion, it is expedient so to do.
- (e.) A special meeting may, on the requisition of three members of the Board, be called at any time and in the manner prescribed by Section 81 of the Act, but the Chairman may call a meeting of the Board as soon as he may think proper.
- (f.) No business shall be transacted at a special meeting other than that for which the special meeting was called.
- (g.) At all meetings of the Board, when there is no quorum present, or when the Board is counted out, which counting out shall take place whenever there shall be less than a quorum present, such circumstances, together with the names of the members then present, shall be recorded in the minute book.

Order of Business.

5. The ordinary business at all ordinary meetings shall be as follows, that is to say:—

- (a.) Reading and confirmation of minutes of last ordinary and of special meetings, if any.
- (b.) Consideration of business arising out of minutes.
- (c.) Reading of correspondence (received and despatched) and taking such immediate action as may be deemed expedient in regard thereto.
- (d.) Passing of accounts for payment.
- (e.) Presentation of petitions or memorials and Committee reports, and consideration thereof.
- (f.) Consideration of tenders and ratification of contracts.
- (g.) Ordinary business of the Board.
- (h.) No discussion shall take place upon the minutes except as to their accuracy, or for the ratification of any clerical error.
- (i.) Immediately after the confirmation of the minutes the Chairman may make any communication to the Board which he may deem advisable, or bring under consideration any business he may think necessary; and it shall be competent for any member of the Board to ask a question or questions, but he shall confine himself to the question simply, and no debate shall ensue thereon at the time.

Petitions.

6. Every petition or memorial must be couched in respectful and temperate language and shall be presented by a member only, such member shall affix his signature thereon.

Tenders.

7. Tenders for work shall be opened and dealt with when the subject matter of the tenders come on to be considered at the meeting of the Board, or by a Committee appointed for the purpose. Deposit—Up to £10, nil; £10 to £20, 10s.; £20 to £50, 7½ per cent.; over £50, 5 per cent.

Speaker must not digress.

8. Every member addressing Chairman must stand on his feet.

- (a.) A member having audience shall not digress from the subject of debate, and speak for not more than ten minutes, unless by permission of the Board.
- (b.) A motion once moved at a meeting cannot be withdrawn unless by the consent of the Board.
- (c.) One or more amendments may be proposed on a motion before the Board.
- (d.) When more than one amendment is moved the question shall first be put on the last amendment, then on the next in succession, and then on the original motion, in the reverse order in which they are moved.

- (e.) A motion or amendment not seconded cannot be discussed by any member except the mover nor put by the Chairman.
- (f.) In submitting a motion or amendment, the Chairman must put the question, first in the affirmative and then in the negative.
- (g.) When an amendment is carried the motion as amended thereby becomes a substantive motion, upon which further amendment may be moved before it is finally dealt with.
- (h.) All notices of motion shall be in writing, and shall be lodged with the secretary seven clear days before regular meeting of the Board.
- (i.) Notices of expenditure must be given one month previous, with power for the Chairman to accept same, with the consent of the Board, without notice, in case of urgent matter.
- (j.) No motion shall be brought forward for discussion except given notice of or permission being granted by members and Chairman of the Board present.

Committee.

9. No committee shall incur any financial liability or in any way commit the Board to any responsibility whatever, without express and specific authority conferred by the By-laws or by a resolution of the Board.

Finance Accounts.

10. All accounts, bills, and vouchers shall be submitted to the Board by the Chairman at the ordinary meetings, and after being certified correct shall be so initialled by him and paid by cheque.

Unauthorised expenditure.

11. Every item of expenditure, and every liability incurred by any committee or member of the Board, otherwise than under the authority of the Act or these By-laws, shall be deemed unlawful expenditure.

Offences, omissions, or neglects.

12. Any person guilty of any of the following offences, omissions, or neglects shall, on conviction, pay a penalty not exceeding £10.

- (a.) Riding or driving a horse, cattle, or other animals, or wheeling any barrow or driving any carriage upon or along any footpath.
- (b.) Placing any timber, bricks, or other building material upon any footpath, channel, surface drain, or carriage road without the permission of the Board having first been obtained.
- (c.) Placing any advertisement board, placard, on property under the control of the Board without having first obtained the permission of the Board.
- (d.) Opening any drain or sewer or removing the surface of any road or carriage road without the permission of the Board having first been obtained.
- (e.) Rolling any cask, breaking in any horse, flying any kite, using any bows and arrows, football, catapult, air-gun, or firearms, or playing at any game to the annoyance or damage of any person, or obstructing any road, whether by allowing any cart or animal to remain across such road or by placing goods thereon or otherwise.
- (f.) Having any awning, verandah, or blind on any road not being of the full width of ten feet and eight feet clear above the footway, or hanging any goods on or under such awning, verandah, or blind over the road, or erecting any sign-board, sign-awning, blind, over-hanging lamp, or other thing over or near any road without first having obtained permission of the Board.
- (g.) Blasting any rock, stone, or timber in or near any public road without permission of the Board, and not attending to any directions in regard thereto given by such Board.
- (h.) Furiously or negligently riding or driving on any road.
- (i.) Making a cellar door or other opening from any road without the consent of the Board.

General Regulation of Traffic.

13. Every person having the care or conduct of any vehicle shall keep the same on the left or near side of the road, except in case of actual necessity or other sufficient reason for deviation, and shall not interrupt or interfere with any person or vehicle passing or attempting to pass his vehicle.

No person, between sunset and the following sunrise, shall, in, upon, or along any of the public roads within the district, drive any vehicle without having a lamp or lantern securely fixed and lighted on the off side of the front of such vehicle.

No person shall ride or drive any horse or other animal along any road at a speed exceeding eight miles per hour.

The driver of every vehicle or the rider of any horse or other animal turning for the purpose of proceeding in an opposite direction, or turning the corner of any road in the district, shall bring the horse or other animal to a walking pace before commencing to turn.

Cycles.

14. Every cyclist within the district shall observe the rules of the road laid down for vehicular traffic.

No cyclist shall ride or impel a cycle upon any footpath within the district.

No cyclist shall, between the hours of sunset and the following sunrise, ride a cycle within the district unless there is attached to such cycle a lamp, which shall exhibit a white light in the direction in which he is proceeding.

Every cyclist shall carry a bell, which shall be rung as a signal whenever any person on foot or on horseback or any vehicle is being approached or passed.

No person shall pass, at a speed exceeding eight miles an hour, any person who shall be riding or driving any horse or any animal.

When a cyclist meets or overtakes any horse or other animal, and such horse or animal becomes restless or appears likely to get beyond the control of the person in charge thereof, such cyclist shall dismount, and shall remain dismounted as long as necessary to avoid accident.

No person shall ride any cycle round the corner formed by the junction of any roads in the District, or across the intersection of any road, at a pace exceeding three miles an hour.

Obstruction on Roads.

15. Nothing of any kind whatever may be allowed to remain on any part of any road within the District after sunset, nor in any case longer than is absolutely necessary, without the permission of the Board.

Preservation of Trees, etc.

16. No person shall injure, cut, break, deface, pull up, pick, remove, or destroy any tree, shrub, plant, etc., growing on any reserve. In case of any offence such person, on conviction, shall forfeit the sum of £10.

Throwing Dangerous Substances.

17. Any person who shall throw vegetable substances or any offensive, noxious, or dangerous substances upon any road or reserve shall be liable to remove same at own cost and to a fine of £2, in addition to amount of damages caused thereby.

Reserves and Recreation Grounds.

All reserves and recreation grounds under the control of the Board shall be open to the public daily for recreation purposes.

Exclusive right to use and occupy any such recreation reserve for holding public sports or amusements by any responsible person or persons may be granted by the Board, providing a fee to be fixed for admission be paid to the Board.

Penalties.

19. Where any person or persons by the foregoing bye laws or any of them are required to do or perform any act or thing, and any such act or thing remains undone, the Board may cause the same to be performed, and charge the costs and expenses against such person or persons, and the amount thereof may be recovered summarily.

Every person who does, permits, or suffers any act or thing contrary to any of these By-laws shall, on conviction, for every offence, breach, or neglect, be liable to a penalty not exceeding (except when otherwise provided) the sum of £20.

No person shall damage or destroy by means of horse, team, wagon, dray, or any other means any road or portion of road under construction or repair. Any person found guilty of such damage or destruction shall be liable to a penalty not exceeding £20.

All penalties and other sums recovered under the provisions of these By-laws shall, unless otherwise provided, be paid to the Board, and shall become the property of and form part of the ordinary income of the District, except so much as may be payable to any informer.

License Fees.

All license fees due under the Act shall be paid to the Secretary not later than the last day of June in each year.

BY-LAWS OF THE CUE ROADS BOARD.

WHEREAS by virtue of the provisions of "The Roads Act, 1902," 2 Edward VII., No. 48, the Roads Board of every District is empowered to make, publish, alter, modify, amend or repeal By-laws for any of the purposes of the said Act mentioned: It is therefore ordered by the Cue Roads Board that, from and after the publication thereof in the *Government Gazette*, the following By-laws shall be in force within the Cue Roads Board District.

Rules of Debate.

1. At all meetings the ordinary rules of debate shall be observed.

For regulating the duties of Secretary of the Board.

2. (a.) To attend all Board meetings.
- (b.) To take notes of all minutes.
- (c.) Conduct all correspondence and give instructions to the other officers, as directed by the minutes.
- (d.) To see that the accounts are audited once a year, and the balance-sheet prepared.
- (e.) To see to the gazetting of all By-laws and advertisements.
- (f.) To summon the members of the Board to meetings.
- (g.) To collect all licensing fees.
- (h.) To keep an account of all moneys received and expended on behalf of the Board in books issued by the Minister, and in accordance with the instructions inserted therein.

For the General Regulation of Traffic upon Roads.

3. Every driver of any vehicle within the Cue Roads Board District shall observe the rules of the road by keeping to the left side of the road in the direction in which he is travelling.

To prevent the danger arising from the driving of vehicles at night without lights.

4. No person shall, between sunset and sunrise, in, upon, or along any road within the Board's District, except two days before and two days after full moon, drive any vehicle constructed or used for the conveyance of goods, wares, or merchandise without having a lamp or lantern securely fixed and lighted at the off-side; nor any vehicle constructed or used for the conveyance of persons as well as goods, wares, merchandise, or of persons only, without having a lamp or lantern securely fixed and lighted on each side of the front of the said vehicle.

To prevent accidents from the riding or propelling of bicycles, tricycles, and other velocipedes.

5. (a.) Throughout this By-law the expression "bicycle" means bicycle, tricycle, or other velocipede; the expression "cyclist" means a person riding, impelling or otherwise using or having the management or control of a bicycle, tricycle, or other velocipede on any road or track within the Board's District.
- (b.) Every cyclist within the Cue Roads Board District shall observe the rule of the road by keeping on left side of road in the direction in which he is travelling.
- (c.) Every bicyclist who rides a bicycle between the hours of sunset and sunrise shall carry attached to his or her bicycle a lamp, which shall be so constructed as to exhibit a white light in the direction in which he or she is proceeding, and shall be so lighted and kept lighted.
- (d.) No cyclist shall pass at a speed exceeding eight miles an hour any person who shall be riding or driving.
- (e.) Every cyclist shall carry a bell.

Registration of Camels and the Licensing of Drivers.

6. (a.) No person shall own, keep, or use within the Cue Roads Board District (hereinafter referred to as "the District") any unregistered camel.
- (b.) Registration shall be effected annually under these By-laws, unless the camel is registered for the time being under the By-laws of another Road District.
- (c.) Application for registration shall be made in the form "A" in the Schedule, addressed to the Secretary of the Board.
- (d.) The fee payable on registration, except in respect of camels used by prospectors for prospecting purposes, shall be:—

For every cow or gelded camel over the age of three (3) years, 2s. 6d. per annum.

For every bull camel over the age of three (3) years, £1 per annum.
- (e.) A certificate of registration will be granted in the form "B" in the Schedule.
- (f.) Every registration shall expire on the 31st day of December next following the date thereof.
- (g.) Every person in charge of any camel shall produce the certificate of registration of each camel whenever required so to do by any officer or other person acting with the authority of the Board.
- (h.) Every unregistered camel found within the District may be seized and sold or destroyed by any person acting under the authority of the Board.
- (i.) No person shall drive camels within the District unless he is the holder of a camel driver's license issued by the Board of the said District or of another Road District.
- (j.) A camel-driver's license may be in the form (C) in the Schedule.
- (k.) Every camel-driver's license shall expire on the 31st day of December next following the issue thereof.
- (l.) The fee payable for a camel driver's license shall be Ten shillings.
- (m.) The number of draught or pack camels driven by any one driver shall not exceed eleven.
- (n.) A camel-driver's license shall be transferable at the office of the Board on payment of a fee of One shilling.
- (o.) Every camel-driver shall produce his license for inspection whenever required so to do by any officer or other person acting with the authority of the Board.

Regulation of camel traffic upon roads.

7. Every camel-driver within the Cue Roads Board District shall observe the rules of the road, and shall at all times make way for vehicular traffic.

To prevent and prohibit animals suffering from any infectious or contagious disease from polluting water.

8. Any owner of an animal suffering from any infectious or contagious disease, and allowing such animal to water at any public watering place, shall be liable to a penalty not exceeding Two pounds (£2).

To provide for the licensing of bicycles.

9. (a.) No person shall ride any bicycle within the Cue Roads Board District without having first obtained a license.
- (b.) Licensing fee for bicycles, 2s. 6d. per annum.
- (c.) Every rider of a bicycle shall have his license number affixed on some conspicuous part of his bicycle.

Requiring all licensed vehicles to have a number affixed to such vehicles.

10. Every owner of a licensed vehicle shall attach a number to some conspicuous part of such vehicle.

Penalties.

For every offence against the provisions of these By-laws to which no penalty is attached, the offender shall, upon conviction before any one or more Justices of the Peace, forfeit and pay a penalty not exceeding Ten pounds (£10).

The above By-laws were passed at a special meeting of the Cue Roads Board, held on the 11th February, 1903.

The climate map shows that the summer is making itself felt in the tropics, 100 degrees or over being recorded at all stations there, but the rainy season has not yet set in.

South of the tropics both the day and night temperatures were considerably below the average for previous years, and the atmospheric pressure throughout the State below normal.

A good rainfall was again experienced in the agricultural districts, being especially heavy between Katanning and Bridgetown towards the end of the month. Very little fell North of Geraldton, and slightly above the average inland over the goldfields.

Two storms of rather a rare type are worth noting. The first made its appearance off the West coast on the 16th; working its way down the coast as far as Bunbury, it passed inland on the following day. Light to heavy rain was recorded from Sharks Bay Southwards, and very rough weather experienced along the Bight on the 18th. The second storm, at the end of the month, was of a similar type. It was preceded by warm and sultry weather, and accompanied by thunderstorms and general rains throughout the State South of the latitude of Geraldton, being especially heavy in the extreme South-West.

A fall of snow was recorded at a few places in the South-West on the 10th of the month.
