Claims:—

1. In totalisators the combination with a press of a horizontal rocking shaft having cranked arms one of which is connected to the press and the other to the recording apparatus substantially as described and for the purposes indicated.

2. In totalisators the combination with a series of presses of a horizontal swinging shaft arranged across the front of the said series of presses, said shaft being connected to a recording apparatus for recording the total number of operations of such series of presses substantially as described and for the purposes indicated.

3. In totalisators the combination with a press having a punch operating with a recess in the bed plate of the recess of a receptacle for collecting the pieces of ticket punched out substantially as described and for the purposes indicated.

4. In totalisators the combination of a press (such as B) a horizontal rocking shaft (such as D) cranked arms (such as D and D²) one connecting to the press and the other to the recording apparatus, a horizontal swinging shaft (such as E) arranged across the front of the series of presses and connected to a recording apparatus, a punch (such as J) and a tray or receptacle (such as M) substantially as described and for the purposes indicated.

2. In a gas furnace the combination of a concaved floor, a domed roof, a circular inner wall and an outer wall separated therefrom by a mass of suitable packing, with a chimney having the flue thereto adjoining and on the same plane as the gas intake.


