BY MEANS OF ANY NET OR FIXED ENGINE, FOR
THREE YEARS.

WHEREAS by "The Fishery Act, 1889" (53rd Vict., No. 4), and "The Fisheries Act, 1899" (63rd Vict., No. 47), the Governor is empowered, by Proclamation in the *Government Gazette*, to prescribe limits within which it shall not be lawful to fish by means of any net or fixed engine, and to determine the times and seasons at which the taking of any species of fish shall commence and cease: AND WHEREAS it is deemed expedient that it shall not be lawful to fish by means of any net or fixed engine within any portion of Leschenault Estuary for a period of three years: NOW THEREFORE I, the said Governor, with the advice and consent of the Executive Council, do by this my Proclamation declare that it shall not be lawful for any person to fish by means of any net or fixed engine within any portion of Leschenault Estuary for a period of three years, commencing from and inclusive of 1st day of July, 1904.

Every person committing a breach of this regulation shall be liable, on conviction, to a penalty of not more than Twenty pounds sterling (£20), and shall forfeit the instruments used and all fish taken.

WHEREAS by the 17th Section of "The Health Act, 1898," as amended by Section 10 of "The Health Act Amendment Act, 1900," the area of any district defined for the purpose of a Local Board of Health may, from time

to time, be extended or contracted or abolished by the Governor by Order in Council: NOW, THEREFORE, His Excellency the Governor of Western Australia does hereby extend the area at present under the control of the Midland Junction Local Board of Health so as to include all lands bounded on the North by the North-Eastern boundaries of subdivisional lots 23 to 33, inclusive of Swan Location 16 (Bayley's Reward Estate); on the South by the North side of Ford Street; on the East by the Western side of Harper Street; and on the West by the Western boundaries of Lots 14, 15, and the South-South-Western boundary of Lot 33 in aforesaid subdivision.

WHEREAS by "The Land Act, 1898," the Governor is empowered to reserve to His Majesty, or to dispose of in such manner as for the public interest may seem best, any lands vested in the Crown that may be required, *inter alia*, for magazines for explosives, and by Order in Council to direct that any such reserve shall vest and be held by any person with power of leasing for any term not exceeding twenty-one years: AND WHEREAS the reserves mentioned in the Schedule have been duly made for sites for magazines for explosives: AND WHEREAS it is desired to vest the said reserves in the Minister for Mines: NOW, THEREFORE, His Excellency the Governor, with the advice of the Executive Council, does hereby vest the reserves mentioned in the Schedule in the Honourable Henry Gregory, M.L.A., Minister for Mines, and his successors in office, to secure the use thereof for the purpose for which the reserves were made, with power of leasing the same for any term not exceeding twenty-one years, but subject, nevertheless, to all existing leases lawfully granted prior to this date.

HIS Excellency the Governor in Council, by his Deputy, under the powers conferred upon him by "The Sharks Bay Pearl Shell Fishery Act, 1892" (55th Vict., No. 9) has been pleased to make the following Regulations for the control and management of the Oyster Pearling Bank contained in the Government Reserve, on the East side of Useless Inlet, Sharks Bay.

REGULATIONS.

1. The period during which the said reserve shall be thrown open, as aforesaid, shall commence from the 1st day of July, and shall terminate upon such date as the Inspector of Fisheries, Sharks Bay, shall by notice declare; such notice shall be posted on the notice board at the office of the said Inspector at Sharks Bay at least seven days before the termination of the before-mentioned period.

2. Every person being the holder of one or more exclusive licenses under "The Sharks Bay Pearl Shell Fishery Act, 1892" (55th Vict., No. 9), shall be entitled, on the payment to the Inspector of Fisheries, Sharks Bay, of the sum of £1, to one special permit to gather, collect, or remove pearls or pearl shells from the said Government Reserve in Useless Inlet; such permit shall extend over the period of one week from the date thereof, and may be renewed from week to week during the continuance of the period during which the reserve shall be so thrown open as aforesaid, on payment of the sum of £1 per week, in advance, to the said Inspector.

3. The holder of such special permit shall not be entitled to work more than one boat for the purposes aforesaid, either by himself or by any agent or agents, assistant or assistants, whom he may appoint or employ.

4. All pearls or pearl shells gathered, collected, or removed under the provisions of any special permit to be granted as aforesaid shall be gathered, collected, or removed subject to the provisions and restrictions contained in Clauses Nos. 6 and 13 of the Regulations for the control and management of the Pearl Shell Fishery at Sharks Bay, published in the *Government Gazette* of the 16th May, 1898.

Such Regulations to come into force throughout the State on the first day of July, 1904.

REGULATIONS.

PROSPECTING AREAS.

Dimensions of Prospecting Areas for Gold.

3. The maximum area which any miner who desires to prospect for gold on Crown Land may mark off and hold for that purpose shall be as follows:—

- (a.) Outside the limits of a proclaimed Goldfield, forty-eight acres.
- (b.) Within the limits of a proclaimed Goldfield, eighteen acres.

And every such area shall be marked in the prescribed manner. Every such area shall be called a Prospecting Area.

The Warden may, in his discretion, refuse to register any Prospecting Area, or he may register any Prospecting Area of such less extent than forty-eight or eighteen acres, as the case may be, as to him shall seem fit.

Prospecting Areas to be marked.

4. Every Prospecting Area shall be, as nearly as possible, in the form of a rectangular parallelogram, the length of which shall, in no case, exceed twice the width, and shall be marked at each corner by a substantial post or a cairn of stones projecting above the surface of the ground not less than three feet, and set in the angle of an "L" trench, the arms of which shall not be less than four feet in length and six inches in depth, cut in the general direction of the boundary lines. When the nature of the ground will not permit of trenches being cut, rows of stones of similar dimensions shall be substituted. The boundary lines shall be cleared from post to post. On one of such posts shall be firmly affixed at the time of marking a notice, in writing, under the hand of the miner, setting forth the name of such miner, the number and date of his Miner's Right, and the date on which the area was marked off. Such marking off and notice shall be deemed a sufficient title to such Prospecting Area for ten days if the same is situated within twenty miles of the nearest Warden's Office, and for fourteen days in any other case, and at the expiration of either of such periods, as the case may be, every Prospecting Area shall be registered as provided in Regulation 5.

Registration of Prospecting Area.

5. Any miner desirous of registering any Prospecting Area shall, before the expiration of the period in any case provided, make application for registration thereof in duplicate, in the form of Schedule 9, by lodging the same at the Mining Registrar's Office, and at the same time shall deposit the fee for registration at the rate prescribed; and on receipt thereof the Mining Registrar shall deliver to the applicant a Certificate of Application, in duplicate, in the form of Schedule 10, one of which shall forthwith be posted by the applicant on the Notice Board at the Mining Registrar's Office; and the other shall, as soon as conveniently may be, be posted on one of the posts of the area. Provided that the Mining Registrar may, if no prior right or public interest is thereby affected, register such Prospecting Area upon receipt of the application therefor, and the fees for registration thereof, without issue of Schedule 10 or posting thereof. And provided, further, that the Mining Registrar may require the applicant to comply with the provisions hereof with regard to posting of such notice; and in such case such notice shall be posted as provided and kept legible and intact for a period of six clear days; and if, at the expiration of such period, no objection shall have been lodged, he may register such area, subject to the provisions of Regulation 3, or he may refer the application to the Warden, and in that case shall be guided by his decision. If any objection shall have been lodged, the Mining Registrar shall defer registration until such objection has been heard and determined by the Warden, and shall be guided by the decision thereon.

GOVERNMENT ASSAYS.

ASSAYS, Analyses, and Determinations of any Western Australian Ore or Rock will be made by the Assayer to the Geological Survey, when not unduly interfering with official work, subject to the following conditions:—

1. Each sample must weigh at least 6oz., but not more than 2lbs.
2. Each sample must be enclosed in a separate canvas bag or strong paper wrapper, with a slip of paper bearing the name and address of the sender, together with a private mark by which it may be readily identified.
3. The parcel must be forwarded *prepaid* to:—

The Mineralogist and Assayer,
Geological Survey Office,
Perth.

4. A letter must be sent at the same time to the same address, stating for what metals the samples are to be assayed, or containing other instructions, as the case may be.

(N.B.—It is always advisable to keep duplicate samples of those submitted.)

5. Before any assay is made the prescribed fee must be paid to the Mineralogist and Assayer or sufficient reasons, in accordance with Section 7 below, be furnished for having the samples treated free of cost.

TENDERS (indorsed "Tender for Shoeing Police Horses," will be received at the Office of the Tender Board Perth, until noon of Thursday, the 24th June, 1904, from persons willing to contract for the above service, at the places mentioned on the attached list, during the twelve months from 1st July, 1904, to 30th June, 1905.

CONDITIONS.

The material and workmanship to be of the best description and subject to the approval of the Officer of Police in charge of the Station.

The work to be performed on the requisition of the Officer in Charge, and in the event of the contractor failing to attend to the order the work will be otherwise performed, and any extra expense charged to the contractor.

A set of shoes to last at least one month. If required oftener, or shoes slipped, they are to be replaced at the contractor's expense.

Payments of accounts to be made monthly.

This contract to be terminable upon one month's notice from either party, but it may be cancelled without notice from the Commissioner of Police for bad workmanship.

INSTRUCTIONS.

The following instructions are to be observed by all Farriers shoeing Police horses:—

The shoes for the fore-feet should be of an uniform width from toe to heel, averaging from seven-eighths to one inch, and of an uniform thickness from toe to heel of about three-eighths of an inch, but in the case of horses which travel exclusively on bush roads the shoe may be made narrower and thicker in proportion. The heel of the shoe should on no account be thicker than any other portion of it. There should be seven nails in each shoe—four on the outside and three on the inside, and the last nail on the inside should not be further back or nearer to the heel than about midway between the toe and the heel of the shoe.

The heel of the hind shoe may be a little thicker than any other portion of the shoe, but in other respects the same remarks apply as to the fore shoes.

Calkins are never to be allowed on the fore shoes except where the horse has to travel over mountainous districts and cannot do without them, as they are inconvenient for the horse to travel in, and by the undue pressure they cause on the heels of the feet they produce bruises and corns, and frequently in a very short time render the animal quite useless.

The shoe, when fitted to the foot, should present, from toe to heel, a perfectly plane or flat surface on that part which rests on the crust or wall of the foot, and should in every instance follow the natural shape of the foot, more especially from the quarters to the heels.

The feet should be prepared by carefully removing the dead or shelly portions with the rasp and knife, but on no account should the sole of the foot be pared to admit of its being sprung by the thumb of the smith, as is too frequently the case, for the sensitive foot, when thus denuded of its horny cover, is very liable to become bruised by the animal's treading on a stone or some other hard substance.

The heels should not be cut open, as it is termed, nor should the bars, which act as buttresses to prevent the heels contracting, be removed. The wall or crust should be levelled from heel to toe to receive the shoe. The heel of the fore foot, for about half an inch from the extreme point, may be about one-sixteenth part of an inch lower than the quarters, so that when the shoe is on a thin knife may be passed between it and the foot at the heel.

Unless in exceptional cases, which will seldom occur, the frog should not be pared, but should be left to itself. Nature will remove the superfluous horn, and the rags can do no harm, and if left alone will soon disappear altogether.

The foot should never be rasped above the clinches of the nails, as it only weakens the foot, and leaves less horn to nail to when it grows down.

CONDITIONS OF TENDER FOR THE SUPPLY OF FIREWOOD.

1. A separate tender must be made for delivery at each place. Tenders must be on printed form, which must be without alteration or erasure, and tenders for any quantities, except as quoted in the schedules, will not be considered.

2. The quantities specified in the schedules are approximate only, and the Commissioner reserves the right to order smaller or larger quantities than those tendered for, at the price named in the tender, and to vary the rate of delivery if it be found necessary to do so.

3. For the purposes of this tender the cord is equal to 128 cubic feet of firewood, loaded in trucks or stacked by the contractor in such place as shall be directed by the officer receiving the wood. The billets are all to lie the same way, viz., crossways, in the form of a cord, and are to be laid as closely and solidly as possible in the trucks or stacks for measurement. If the firewood is not fairly loaded or stacked the contractor shall re-load or re-stack the same at his own expense prior to receiving acknowledgment of receipt of same. The Commissioner shall, however, be at liberty to weigh any or all of the firewood, and each cord shall be of a minimum weight of 30cwt. Should the weight be less than 30cwt. per cord, a proportionate price only may be paid by the Commissioner, or the wood may be rejected, as he may deem fit. The Commissioner shall have the power to order firewood by the cord of 128 cubic feet or by the ton of 2,240lbs. In the latter case the contractor shall accept the weight as taken at places where railway facilities for weighing exist.

4. The firewood shall consist of jarrah (from which the bark must be removed), gum, raspberry jam, sheoak, gimlet wood, or other wood approved by the Commissioner. It shall be straight, sound, seasoned, and split into billets not more than six inches nor less than two inches in diameter, and in lengths as shown in the schedules. For items Nos. 37, 38, and 39 sawn mill edgings or waste will be accepted. The tenders shall show the description of firewood offered, and, if mixed, the proportion of each kind.

5. The Commissioner may reject any firewood which, in his opinion, is not in accordance with these conditions, and the contractor shall not be deemed to have delivered any firewood so rejected. Firewood so rejected shall be removed by the contractor from the premises of the Commissioner within seven days of a notice in writing being sent to him of such rejection, and, failing such removal, the firewood shall become the property of the Commissioner without any payment or compensation whatsoever.

6. The contractor will not be allowed to transfer, assign, sub-let, or abandon his contract, except with consent of the Commissioner in writing.

7. As security for the performance of the contract, payment for the first quantity ordered will not be certified to until the second quantity ordered shall have been delivered and accepted, and so forth throughout the contract until the final delivery is completed, when all moneys due will be paid within reasonable time. In the event of the non-fulfilment of any order, any moneys due to the contractor shall be absolutely forfeited to the Commissioner.

8. Quantities of firewood ordered must be delivered within seven days from the sending of the order, and in the event of orders not being so fulfilled, a penalty of 2s. per cord, or 1s. 4d. per ton, may be imposed for each and every day's delay beyond the time specified. Alternately the Commissioner shall be at liberty to supply himself elsewhere with firewood, and may deduct the amount of the penalty, or of any loss which he may sustain in consequence of his obtaining firewood elsewhere, from any moneys due, or which may thereafter become due, to the contractor. The Commissioner may terminate the contract forthwith should the contractor fail to carry out the conditions or obligations of his contract, and, except for the purpose of enforcing any right which may have accrued to him thereunder, the contract shall thereupon absolutely cease and determine.

9. All notices and orders to be served upon the contractor may be deemed duly served if sent by post in the ordinary way to the address given in the tender, and all notices or orders signed by a duly authorised servant or agent of the Commissioner shall be of the same effect as if signed personally by the Commissioner.

10. The term of the contract will be from 1st July, 1904 to the 30th June, 1905, inclusive.

ORDER 52A.

PROCEEDINGS UNDER "THE TRUSTEES ACT, 1900."

1. All applications under "The Trustees Act, 1900" (in this Order called "the Act"), may be made by petition, except as otherwise provided under Rule 4 of this Order.

2. (1.) Where a trustee desires to make a lodgment in Court, under Section 46 of the Act, he shall make and file an affidavit intituled in the matter of the trust (described so as to be distinguishable) and of the Act, and setting forth,—

- (a.) A short description of the trust and of the instrument creating it.
- (b.) The names of the persons interested in and entitled to the money or securities, and their places of residence, to the best of his knowledge and belief.
- (c.) His submission to answer all such inquiries relating to the application of the money or securities paid into Court, as the Court or Judge may make or direct.
- (d.) The place where he is to be served with any petition, summons, or order or notice of any proceedings relating to the money or securities. Provided that if the fund consists of money or securities being or being part of, or representing a legacy or residue to which an infant or person beyond seas is absolutely entitled, and on which the trustee has paid the legacy duty, or on which no duty is chargeable, the trustee may make the lodgment (without an affidavit) on production of the official receipt for such duty, or a certificate from the proper officer, of the payment thereof, or that no such duty is payable.

(2.) Where the lodgment in Court is made on affidavit—

- (a.) The person who has made the lodgment shall forthwith give notice thereof, by prepaid letter through the post, to the several persons whose names and places of residence are stated in his affidavit as interested in or entitled to the money or securities lodged in Court.
- (b.) No petition or summons relating to the money or securities shall be answered or issued unless the petitioner or applicant has named therein a place where he may be served with any petition or summons, or notice of any proceeding or order relating to the money or securities, or the dividends thereof.
- (c.) Service of any application in respect of the money or securities shall be made on such persons as the Court or Judge may direct.

3. Applications to deal with funds lodged in Court under the Act shall be intituled in the same manner as the affidavit or request on which the funds were lodged. All other applications under the Act not made in any pending cause shall be intituled in the matter of the trust (described so as to be distinguishable) and of the Act. Every petition or summons for a vesting order, or the appointment of a person to convey, shall state the section or sections of the Act under which it is proposed that the order shall be made.

4. Any of the following applications may be made by summons:—

- (a.) An application for the appointment of a new trustee, with or without a vesting or other consequential order.
- (b.) An application for a vesting order or other order consequential on the appointment of a new trustee, whether the appointment is made by the Court or a Judge or out of Court.
- (c.) An application for a vesting or other consequential order in any case where a judgment or order has been given or made for the sale, conveyance, or transfer of any land or stock, or the suing for or recovering any chose in action.
- (d.) An application relating to a fund paid into Court in any case coming within the provisions of Order 52, Rule 3.

5. The following Rules are hereby repealed:—

Order 49, Rules 18, 19, 20, 21.
Order 52, Rule 3, (4), (6).

6. These Rules may be cited as the "Rules of the Supreme Court (Trustees Act, 1900)" and each Rule may be cited separately according to the heading thereof, with reference to the Rules of the Supreme Court, 1888.

They shall come into operation on the first day of July, 1904.
