ANNEXATION TO CUE MUNICIPALITY.

PROCLAMATION 799

WESTERN AUSTRALIA,

WHEREAS by "The Municipal Institutions Act, 1900," the Governor may by Proclamation annex any land forming, with the municipal district of some municipality, one continuous area to such municipality: AND WHEREAS a petition was duly presented to His Excellency the Governor praying that the area described hereunder be annexed to the Municipality of Cue, signed by not less than 20 resident householders or owners of rateable land within the area proposed to be annexed: AND WHEREAS the said petition was publicly advertised in the Government Gazette on the 29th day of August, 1902: AND WHEREAS, pursuant to the said petition, by a Proclamation dated the 23rd day of March, 1904, certain lands therein described were annexed to the said Municipality : AND WHEREAS it is desirable to give further effect to the prayer of the said petition: Now THEREFORE I, the said Governor, with the advice of the Executive Council, in pursuance of the

powers vested in me by the said Act, do hereby annex to the Municipality of Cue the area contained within the following boundaries :-

The area lying between the North-East side of Living-stone Street, Cue, the Southern boundaries of G.M.Ls. 203 and 1221, the North-East boundary of Lot 322, the North-East side of Hicks Street and its prolongation, and the Cuc-Nannine Railway Line.

The area bounded on the Westward by the Western side of Simpson Street, and the Western boundaries of Lots 303 to 306 inclusive; on the Southward by the North side of Victoria Street; on the Eastward by the Eastern boundaries of Lots 311 to 318 inclusive and part of the Western boundary of G.M.L. 203; and on the Northward by the Southern boundary of G.M.L. 1265; excluding, how-ever, tl e surface rights of G.M.L. 1274.

The area bounded by lines starting from the East corner of Lot 271, and extending along the North-Western side of Stewart Street to the Southern side of Robinson Street's thence by said Southern side of Robinson Street North-Westward to the East corner of Lot 396; thence by the South-East boundary of Lot 396 and its prolongation 25 links South-Westward; thence by the South-Western side of a wight of way to a wint in prolongation of the North of a right-of-way to a point in prolongation of the North-West boundary of Lot 391; thence by the latter's North-West boundary and prolongation to the North-Western boundary of the Townsite, and along it North-Easterly about 3 chains; thence South-Easterly parallel to and at a distance of 25 links from the North-Eastern boundaries of Lots 379 to 390 inclusive for a distance of about 18 chains Lots 379 to 390 inclusive for a distance of about 18 chains 50 links; thence North-Eastward parallel to and at a dis-tance of 25 links from the North-West boundaries of Lots 271 to 280 inclusive to the South-Western side of Road No. 848, and along it South-Easterly to the starting point.

SCHOOL OF MINES OF W.A.

GENERAL REGULATIONS FOR SCHOLARSHIPS.

1. The examinations will be held during November in each year, at times to be duly announced.

Applications from candidates, together with satisfactory proof of age and a fee of ten shillings, must reach the Secretary of the School of Mines, Kalgoorlie, not later han October 20th.

The scholarships will be awarded on the reports of the Examiners to those candidates who obtain the highest aggregate of marks and comply with the conditions.

4. No scholarship will be awarded any candidate unless he passes in each subject of the examination and obtains at least 60 per cent. of the aggregate marks.

No person will be allowed to hold two of these scholarships concurrently.

Successful candidates must produce certificates of good character and of bon i fide residence for six months in Western Australia.

7. The Minister for Mines reserves the right of cancelling any scholarship should the holder be reported for irregular attendance, idleness, or bad conduct.

8. As a condition of holding a School of Mines scholar-ship, successful candidates must regularly attend the classes and pass the annual examinations in the subjects specified for each scholarship.

9. The interpretation of these and the following regulations, together with the decision of all matters not specifically provided for, shall rest with the Director of the School of Mines, who shall also have full control of the conduct of the examinations.

10. There will be offered annually the following scholarships:-

(a.) One Junior and one Entrance Scholarship for youths residing within the Eastern Division. Land

These scholarships will be tenable at the School of Mines, Kalgoorlie.

- (b.) One Senior Scholarship open to all youths com-pleting the first year's course for an Associate-ship of the School of Mines. Students of the Perth Technical School will be eligible to compete, and if successful may obtain permission from the Hon. the Minister for Mines to continue their studies in Perth.
- (c.) Two other Junior Scholarships for separate competition, one in the South and Eucla Divisions, and one in the Western, North-West, and Kimberley Divisions.
- (d.) A second Entrance Scholarship for competition outside the Eastern Division.

The last four scholarships, viz., the Senior, the two Juniors, and the Entrance, by permission to be granted in each case by the Minister for Mines, may be held at the Perth Technical School.

SPECIAL REGULATIONS.

Junior Scholarships.

Junior Scholarships will be offered annually for com-1. petition, open to youths who are at least 15 years of age on the 1st of March following the examination, and have been bona fide residents of Western Australia for six months immediately prior to the examination.

2. The scholarships will be offered for separate compe-tition in the following land divisions, viz.:--One in the Eastern Division, one in the South-West and Eucla Divisions, and one in the Western, North-West, and Kimberley Divisions.

3. Each successful candidate must at once enter upon classes in Preparatory Mathematics, Chemistry, and Physics, as laid down in the School of Mines syllabus, and by the end of his second year must complete the first course for the Associateship.

4. The sch larships will have an annual value of £40 for three years, with remission of class fees, and will be tenable for a fourth year if the holder completes the second year's work of the Associateship course at the end of his third year

5. The Junior Scholarship examinations will be held in the following subjects :-

- (a.) ENGLISH.—Grammar, dictation, and composition, as laid down for Standard VII. of the State Primary Schools.
- (b.) ARITHMETIC. Notation, numeration, tables, weights and measures, the simple and com-pound rules, square root, fractions, proportion, practice, and the mensuration of simple surfaces and solids.
- (c.) ALGEBRA.—The elementary r brackets and simple equations. elementary rules, including
- (d.) GEOMETRY.-The definitions, axioms, and postulates of Euclid, Book I., and propositions 1 to 26.
- (e.) PHYSIOGRAPHY.—Elementary principles. The atmosphere and oceans, circulation and action of water, the composition and movements of the earth's crust.

SCHOOL OF MINES ENTRANCE SCHOLARSHIPS.

1. Entrance Scholarships will be offered annually for competition to youths who are at least 15 years of age, on the first of March following the examination, and have been bona fide residents of Western Australia for six months immediately prior to the examination

Each successful candidate must at once enter upon 2 an Associate course in mining or metallurgy, as laid down in the School of Mines syllabus, and must pass the examinations for the first and second years' Associateship course at the end of his first and second year respectively, as a condition of retaining the scholarship.

The scholarships will have an annual value of £60 for three years, with remission of class fees.

The Entrance Scholarship examinations will be held in the following subjects:

- (a.) ARITHMETIC.-The whole subject, with mensuration of simple surfaces and solids.
- (b.) ALGEBRA.—The elements up to easy quadratics.
- (c.) GEOMETRY.—The first three books of Euclid.
- (d.) CHEMISTRY.-The elementary principles, including gen, and carbon, and simple calculations.
- (e.) PHYSICS. The elementary principles of sound, light, heat, magnetism, and electricity.

5. All candidates who pass in the mathematics portion of this examination will be entitled, without further examination, to enrolment as Associateship students of the School of Mines of Western Australia.

SCHOOL OF MINES SENIOR SCHOLARSHIP.

1 One Senior Scholarship will be offered annually for competition to students who are registered Associateship students and are completing the first year's work of an Associateship course in either Mining or Metallurgy.

2. The successful candidate must at once enter upon the second year's work of the Associateship course and pass the terminal examinations at the end of his first year as a condition of holding the scholarship

The Senior Scholarship will have an annual value of £75 for two years with remission of class fees

The Senior Scholarship Examination will be identical with the annual examinations for the first year of the School of Mines Associateship course held in the following subjects

- (a.) MATHEMATICS.—First course.
- (b.) CHEMISTRY.-First course.
- (c.) GEOLOGY.
- (d.) PHYSICS.—First course.
- (e.) Assaying.—First course.

GOVERNMENT ASSAYS.

A SSAYS, Analyses, and Determinations of any Western Australian Ore or Rock will be made by the Assayer to the Geological Survey, when not unduly interfering with official work, subject to the following conditions :--

1. Each sample must weigh at least 6oz., but not more than 21bs.

2. Each sample must be enclosed in a separate canvas bag or strong paper wrapper, with a slip of paper bearing the name and address of the sender, together with a private mark by which it may be readily identified.

3. The parcel must be forwarded prepaid to :-

The Mineralogist and Assayer,

Geological Survey Office, Perth.

4. A letter must be sent at the same time to the same address, stating for what metals the samples are to be assayed, or containing other instructions, as the case may be.

(N.B.—It is always advisable to keep duplicate samples of those submitted.)

5. Before any assay is made the prescribed fee must be paid to the Mineralogist and Assayer or sufficient reasons, in accordance with Section 7 below, be furnished for having the samples treated free of cost.

- (c.) The sample must be of sufficient promise to warrant an assay being made at the expense of the State.
- (d.) Free assays will not be made of samples showing free gold, or of tailings or other metallurgical products, or of umpire samples.

8. The Department reserves to itself the right of refusing to make any particular assay, and also the right of publishing at any time the results of an assay made at the public expense.

* Averages for three years only. This month was characterised by severe storms in Southern portions, and especially over the ocean between Cape Leeuwin and Tasmania during the middle of the month. Three distinct stormy periods occurred in our W. and S.W. districts, viz., on the 8th to 9th, 14th to 20th, and 25th to 27th, with mostly fine bright weather in between. During the middle period remarkably wintry weather prevailed. The S.W. coast was visited by a succession of heavy gales, accompanied by unusually intense thunderstorms, and terrific seas swept along repeatedly from the Leeuwin Eastwards. Many fine vessels were unable to progress against the fury of the storm, and were compelled to heave-to for periods of 12 to 30 hours. The s.s. "Kyarra," which left Adelaide for Fremantle on the 18th, encountered a hurricane from the Westward on the 20th, and at noon on that day recorded a barometer reading of 28 62, rising to 30 00 (nearly an inch and a half) during the next 36 hours. During the fine periods frosts occurred in places, especially at the commencement of the month, the lowest surface temperature recorded being 23deg., at Katanning, on the 2nd and 3rd. Turning now to the general climatic conditions, we find that pressure was about or slightly below the normal throughout; temperature was unusually low in the tropics, the mean maximum at Wyndham, in the extreme North, being nearly 6deg. below that for previous years. Elsewhere it was about or slightly below in central latitudes, but unusually heavy throughout S.W. districts, and above the average generally in Southern districts, the maximum being just South of Perth, where the average for the square degree was 10.75 inches. On the Coolgardie Fields it was about or slightly above the normal in Southern portions, but defective in Northern.
