WHEREAS by "The Transfer of Land Act, 1903, Amendment Act, 1896" (60 Vict., No. 22), the Governor was empowered, by Proclamation in the *Government Gazette*, to revest in Her late Majesty, her heirs or successors, as of her or their former estate, all or any lands whereof Her Majesty then was, or Her Majesty, or her heirs or successors might thereafter become the registered proprietor or proprietors: AND WHEREAS His Majesty King Edward the Seventh is now the registered proprietor of Boulder Town Lot R378, registered in the Office of Titles in Volume 290, Folio 14: NOW THEREFORE I, the said Governor, with the advice and consent of the Executive Council, do by this Proclamation revest in His Majesty King Edward the Seventh, his heirs and successors, Boulder Town Lot R378 aforesaid, as of his former estate.

WHEREAS by Section 43 of "The Land Act, 1898," it is made lawful for the Governor, by Order in Council, without issuing any deed of grant, to place any Reserve under the control of any Municipality, Road Board, or other person or persons, as a Board of Management, and to empower such Board to make, repeal, and alter by-laws for the control and management of such Reserves, and prescribe fees for depasturing thereon, and for other purposes: AND WHEREAS it is deemed expedient that Reserve 6090 (Port Hedland Common) should be placed under the control of the Port Hedland Road Board as a Board of Management: NOW, THEREFORE, His Excellency the Governor, by and with the advice and consent of the Executive Council, do hereby place the before-mentioned Reserve under the control of Port Hedland Road Board as a Board of Management, and doth empower such Board to make, repeal, or alter by-laws for the control and management of the said Reserve, for prescribing fees for depasturing thereon, for directing the manner in which such fees shall be imposed, paid, collected, and disposed of, and to impose penalties not exceeding in any case £5 for any breach thereof, and £2 a day for a continuing breach, but not more than £20 in the aggregate.

The Order in Council published in the *Government Gazette* of the 16th January, 1903, is hereby cancelled.

With reference to my Circular despatch of the 4th of December, 1903, I have the honour to transmit to you, for the information of your Government, copies of a notice issued by the Nobel Committee of the Norwegian Parliament with regard to the nomination of candidates for the Nobel Peace Prize of 1905.

I have to request that your Government will take such action with reference to this document as may seem calculated to make the conditions of the Prize known to those bodies and persons who are qualified to nominate candidates.

It will be noted that names of candidates should be received by the Committee before the 1st of February next.

NOBEL PEACE PRIZE.

All proposals of candidates for the Nobel Peace Prize, which is to be distributed December 10, 1904, must, in order to be taken into consideration, be laid before the Nobel Committee of the Norwegian Parliament by a duly qualified person before the first of February of the same year.

Any one of the following persons is held to be duly qualified:—(a) Members of the Nobel Committee of the Norwegian Parliament; (b) Members of Parliament and Members of Government of the different States; (c) Members of the Interparliamentary Council; (d) Members of the Commission of the International Peace Bureau; (e) Members of the Institute of International Law; (f) University professors of Political Science and of Law, of History and of Philosophy; and (g) persons who have received the Nobel Peace Prize.

The Nobel Peace Prize may also be accorded to institutions or associations.

According to the Code of Statutes, § 8, the grounds upon which any proposal is made must be stated, and handed in along with such papers and other documents as may therein be referred to.

According to § 3, every written work, to qualify for a prize, must have appeared in print.

For particulars, qualified persons are requested to apply to the office of the Nobel Committee of the Norwegian Parliament, Victoria Terrasse 4, Kristiania.

With reference to my Circular despatch of the 18th ultimo, I have the honour to transmit to you, for the information of your Government, and for publication in the Colony, the accompanying copies of two Orders of the King in Council, revoking the Orders in Council dated 5th May, 1873, and 29th January, 1904, relating to the measurement of French ships in this country, and exempting from re-measurement in His Majesty's Dominions French ships having Certificates of Registry or other National papers dated on or after 1st July, 1904.

PRESENT:

The King's Most Excellent Majesty in Council.

WHEREAS by an Order in Council dated the 5th day of May, 1873, after reciting that by "The Merchant Shipping Act Amendment Act, 1862," it was enacted that, whenever it was made to appear to Her late Majesty that the rules concerning the measurement of tonnage of merchant ships for the time being in force under the principal Act had been adopted by the Government of any foreign country and were in force in that country, it should be lawful for Her Majesty by Order in Council to direct that the ships of such foreign country should be deemed to be of the tonnage denoted in their certificates of registry or other national papers, and thereupon it should no longer be necessary for such ships to be re-measured in any port or place in Her Majesty's dominions, but such ships should be deemed to be of the tonnage denoted in the certificates of registry or other papers in the same manner to the same extent and for the same purposes in, to, and for which the tonnage denoted in the certificates of registry of British ships was to be deemed the tonnage of such ships, and reciting that it had been made to appear to Her Majesty that the rules concerning the measurement of tonnage of merchant ships then in force under "The Merchant Shipping Act, 1854," had been adopted by the President of the French Republic, and were in force in the French dominions: Her Majesty was thereby pleased, by and with the advice of Her Privy Council, to direct that the ships of France, the certificates of French nationality and registry of which were dated on or after the first day of June, 1873, should be deemed to be of the tonnage denoted in the said certificates of French nationality and registry:

And whereas "The Merchant Shipping Act Amendment Act, 1862," was repealed by "The Merchant Shipping Act, 1894," but by Section 745 of the latter Act it is, amongst other things, provided that any Order in Council made under any enactment thereby repealed should continue in force as if it had been made under the said Act of 1862:

And whereas by another Order in Council dated the 29th day of January, 1904, after reciting that by Section 84 (3) of "The Merchant Shipping Act, 1894," it was enacted that if it was made to appear to Her late Majesty that the tonnage of any foreign ship as measured by the rules of the country to which she belonged, materially differed from that which would be her tonnage if measured under that Act, Her Majesty in Council might order that, notwithstanding any Order in Council for the time being in force, any of the ships of that country might be re-measured in accordance with that Act, and reciting that it had been made to appear to His present Majesty that the tonnage of French ships, as measured by the rules concerning the measurement of tonnage of merchant ships of France, materially differed from that which would be the tonnage of such ships if measured under "The Merchant Shipping Act, 1894," His Majesty in Council ordered that, notwithstanding the hereinbefore recited Order in Council, dated the 5th day of May, 1873, any of the Ships of France might, for all or any of the purposes of "The Merchant Shipping Act, 1894," be re-measured in accordance with the said Act:

And whereas by Section 738 of the same Act it is provided that where Her late Majesty had power under that Act to make an Order in Council, Her Majesty might by Order in Council revoke, alter, or add to any Order so made:

And whereas by Section 30 of "The Interpretation Act, 1889," it is enacted that in that Act and in every other Act, whether passed before or after the commencement of that Act, references to the Sovereign reigning at the time of the passing of the Act or to the Crown shall, unless the contrary intention appears, be construed as references to the Sovereign for the time being and that Act shall be binding on the Crown:

And whereas it has been made to appear desirable to His present Majesty that the provisions of the said recited Orders in Council, dated respectively the 5th day of May, 1873, and the 29th day of January, 1904, should be revoked and a new Order in Council made and substituted in lieu thereof:

Now, THEREFORE, His Majesty, in virtue of the powers vested in Him by the said recited Acts, and by and with the advice of His Privy Council, is pleased to direct that the said recited Orders, dated respectively the 5th day of May, 1873, and the 29th day of January, 1904, shall be and the same are hereby revoked.

THE attention of the Public is specially drawn to the provisions of "The Stamp Act Amendment Act, 1902," which provides that adhesive stamps shall be affixed to instruments not being Bills of Exchange or Promissory Notes, within twenty-eight days from the first execution thereof if executed in Western Australia, or if executed out of Western Australia within twenty-eight days after the instrument is first received in Western Australia, and that the stamps so affixed be cancelled by the Colonial Treasurer, the Under Treasurer, the Registrar of Titles, or other person appointed by the Governor to cancel stamps.

For non-compliance with the said provisions of the Stamp Act, the undermentioned fines will be enforced except in those cases in which the Governor in Council determines that an injustice will be done by inflicting a penalty.

When the Stamps are cancelled.	Amount of fine.
After twenty-eight days from the first execution of the instrument, or from the date on which it is first received in Western Australia	One pound, or double the amount of proper stamp duty if that amount does not exceed One pound.
After six weeks but within eight weeks	Two pounds, or three times the amount of proper stamp duty if that amount does not exceed Two pounds.
After eight weeks but within four months	Four pounds, or four times the amount of proper stamp duty if that amount does not exceed Four pounds.
After four months ...	Eight pounds, or ten times the amount of stamp duty if that amount does not exceed Eight pounds.

7. All trees felled shall have the limbs as well as the bole stripped to a diameter of three (3) inches.
8. No mallet tree shall be stripped of bark except during the months from July to December, inclusive, in each year.
9. Bark stripped upon Crown lands and not removed during the currency of the license shall become, should the Minister so decide, the property of the State.
10. The officers of the Woods and Forests Department may seize and dispose of any bark stripped or removed contrary to these Regulations.
11. Any person committing a breach of these Regulations shall be liable, on conviction, to a penalty not exceeding £20 for any single offence, nor £2 per day for a continuing offence, and not exceeding £100 in the aggregate.
12. The fee for a Mallet Bark License shall be 5s. per month for each person employed in stripping, and for each person engaged only in carting.

LOITERING ON RAILWAY PREMISES.

34. No person having travelled on the railway shall be entitled to remain on any railway station or premises for more than thirty minutes after the arrival at such station or premises of the train by which he travelled; and no person intending to travel on the railway shall be entitled to remain on any railway station or premises for more than one hour prior to the advertised time of departure of the train next proceeding to the station to which such person has booked to travel.

At junction stations passengers travelling from one line to another may remain on such stations until the departure of the next connecting train, provided such train is timed to depart within two hours of the time of arrival of such passengers at the junction station.

Platform tickets shall entitle persons to remain on the railway for thirty minutes only.
