WHEREAS by "The Land Act Amendment Act, 1902" (1 and 2 Edward VII., No. 20), and "The Land Act Amendment Act, 1905" (5 Edward VII., No. 22), the Governor may, by Proclamation in the *Government Gazette*, after the opinion of the Road Board of the District has been requested, close any road or reservation for a road which may have been surveyed or shown as a road on any plan published by the Department of Lands and Surveys: Provided such road is not within the limit of a Municipality, and has not been declared a Government road or a road under "The Roads Act," or any Act amending the same: AND WHEREAS the roads hereinafter described have been surveyed and shown as roads on the under-mentioned plans, as published by the Department of Lands and Surveys: AND it is desirable to close such roads: AND WHEREAS the opinion of the undermentioned Road Boards has been requested: NOW THEREFORE I, Sir Edward Albert Stone, Knight, Lieutenant-Governor as aforesaid, by and with the advice and consent of the Executive Council, do hereby declare the said surveyed roads to be closed.

WHEREAS by Sections 222 and 227 of "The Municipal Corporations Act, 1906" (6 Edward, No. 32), it shall be lawful for the Governor, on request of the Council, by notice in the *Government Gazette*, to declare any land reserved, used, or by purchase or exchange acquired for a street or way, or any place, bridge, or thoroughfare, to be a public highway, and such land

shall thereupon and thenceforth, from the date of such Proclamation, become and be absolutely dedicated to the public as a public highway within the meaning of any law now or hereafter in force.

And whereas the Guildford Municipal Council has requested that certain lands named and described in the Schedule hereunder, which have been used for streets or ways within the Municipality of Guildford, be declared public highways: Now therefore I, the said Governor, by and with the advice and consent of the Executive Council, do by this my Proclamation declare the said lands to be public highways, and such lands shall from the date of this Proclamation, be absolutely dedicated to the public as highways within the meaning of any law now or hereafter in force.

WHEREAS by "The Registration of Births, Deaths, and Marriages Amendment Act, 1907," it is enacted that the Governor may make Regulations for carrying the principal Act and its amendments into effect: And whereas it is also enacted by the said Act that it shall not be lawful to register the death of any person after the expiration of twelve months following the death of such person in Western Australia, except in accordance with the Regulations under the said Act: Now, therefore, His Excellency the Lieutenant-Governor, with the advice of the Executive Council, doth hereby make the following Regulations.

*Regulations.*

1. Before the Registrar General shall authorise the registration of the death of any person after the expiration of twelve months following the death of such person in Western Australia—

- (a.) Application shall be made to the District Registrar of the District in which the death took place by the informant or person desirous of registering the death.
- (b.) The application shall be in the form of the schedule hereto, or to the like effect, with a statutory declaration stating that a search has

been made in the registers of deaths in the Office of the Registrar General, and that no entry has been found of the death of the person, and stating why the death was not previously registered, and giving the information required by the Schedule.

- (c.) If the deceased was attended at the time of death by a medical practitioner, the date of death shall be verified by a statement from such medical practitioner unless reasons satisfactory to the Registrar General shall be given why such verification cannot be given; in such case the date of death shall be verified by some relative of the deceased, or inmate of the house where the death occurred, or by such other evidence as the Registrar may require.

The Registrar General may require the statement referred to in paragraph (c.) to be by statutory declaration, and may require any further evidence he considers necessary in proof of any of the facts mentioned in the declaration or statement to be furnished.

2. If the Registrar General is of opinion that the death may be registered, he shall authorise the District Registrar, in writing, to register such death, on payment by the applicant of a fee of two pounds; provided that, under special circumstances, the Registrar General may, in his discretion, remit the whole or any part of such fee.

3. The District Registrar shall enter on the register form the words "This registration is made under the written authority of the Registrar General, and in accordance with the regulations made under 'The Registration of Births, Deaths, and Marriages Amendment Act, 1907,'" and shall affix his signature to such entry.

4. Where a Judge of the Supreme Court has authorised the registration of a death, it shall not be necessary for application for the registration of such death to be made in the form and in manner hereinbefore prescribed; but the Registrar General, on receipt of the authority of the Judge, shall authorise the District Registrar in writing, to register such death on paying the fee as prescribed in Regulation 2.

The District Registrar shall enter on the register form the words "This registration is made by the written authority of the Registrar General, under the authority of a Judge of the Supreme Court, and in accordance with the regulations made under 'The Registration of Births, Deaths, and Marriages Amendment Act, 1907.'"

## QUEEN'S PARK MUNICIPAL BY-LAWS.

## BY-LAW No. 1.

The Council shall meet in the Council Chambers, Queen's Park, or at such other place or places as shall be decided upon by such Council, on every alternate Tuesday in every month, at the hour of 8 p.m., or such other time as the said Council shall from time to time appoint.

## BY-LAW No. 2.

*General conduct of business.*

1. In all cases not herein provided for, resort shall be had to the rules, forms, and usages of Parliament, which shall be followed, so far as the same are applicable to the proceedings of the Council.

*Minutes of meeting to be read at next subsequent meeting.*

2. At every meeting of the Council the first business thereof shall be the reading and putting a question for the confirmation of the minutes of the proceedings at the preceding meeting, and no discussion shall be permitted thereon except as to their accuracy as a record of the proceedings, and the said minutes of the proceedings at the preceding meeting shall then be signed as by this Act required.

*Order of business at meetings.*

3. After the signing of the minutes as aforesaid, the order of business of an ordinary meeting shall be as follow, or as near thereto as may be practicable, but for the greater convenience of the Council at any particular meeting thereof it may be altered by resolution to that effect:—

- (1.) Announcements.
- (2.) Reading letters.
- (3.) Reception and reading of petitions and memorials.
- (4.) Reports of committees.
- (5.) Orders of the day.
- (6.) Notices of motion.

And the order of business at a general meeting shall be the order in which such business stands in the notice thereof.

*Divisions.*

4. Whenever a division shall be demanded by any councillor, the councillors voting in the affirmative shall first hold up their hands, and then those voting in the negative shall hold up their hands, and the result be declared by the chairman.

*Addresses to Governor.*

5. All addresses to the Governor shall be presented by the Mayor and the Town Clerk, unless otherwise ordered by the Council.

*Motions.*

6. All notices of motion shall be dated and numbered, and given by the intending mover to the Town Clerk at the close of the meeting of the Council, or if not required by law to be given at a meeting, then three clear days prior to the next meeting of Council; and such clerk shall enter the same in the notice of motion book in the order in which they may be received.

*Notice of motion to be given.*

7. No member shall make any motion initiating a subject for discussion but in pursuance of notice given as prescribed in the last preceding clause.

*Petitions.*

8. No motion except that for receiving the same or to refer same to a committee shall, unless under most urgent circumstances, be made on any petition, memorial, or other like application until the next ordinary meeting of Council after that at which it has been presented.

*Motions to be moved in order in motion book.*

9. Except by leave of the Council, motions shall be moved in the order in which they have been received and recorded by the Town Clerk in the notice of motion book, and if not so moved or postponed shall be struck out.

*Motion to be proceeded with by councillor giving same, except with consent.*

10. No notice entered in the notice of motion book shall be proceeded with in the absence of the councillor who gave notice of the same, unless by some other councillor producing written authority from him to that effect.

*Orders, etc., of debate.*

11. Any councillor desirous of making a motion or amendment or taking part in discussion thereon shall rise and address the mayor, and shall not be interrupted unless called to order, when he shall sit down until the councillor calling to order shall have been heard thereon and the question of order disposed of, when the councillor in possession of the chair may proceed with the subject.

*Nature of motion to be stated.*

12. Any councillor desirous of proposing an original motion or amendment must state the nature of the same before he addresses the Council thereon.

*Motion not to be withdrawn without leave.*

13. No motion or amendment shall be withdrawn without the leave of the council.

*Motion to be seconded.*

14. No motion or amendment shall be discussed or put to the vote of the Council unless it be seconded, but a councillor may, however, require the enforcement of any standing order of the Council by directing the Mayor's or Chairman's attention to the infraction thereof.

*Mover of motion.*

15. A Councillor moving a motion shall be held to have spoken thereon, but a Councillor merely seconding a motion shall not be held to have spoken upon it.

*Designation of Councillors.*

16. The councillors in meeting of Council shall designate each other by their official titles, namely, that of Mayor, Chairman, or Councillor, as the case may require.

*Priority of Councillors.*

17. If two or more Councillors rise to speak at the same time, the Mayor shall decide which is entitled to priority.

*Councillor not to speak a second time on same question.*

18. No Councillor shall speak a second time on the same question, unless entitled to reply, or in explanation when he has been misrepresented or misunderstood.

*Points of order.*

19. The Mayor, when called upon to decide on points of order or practice, shall decide the same, and his decision as to order or explanation in each case shall be final.

*Councillors not to digress, etc.*

20. No councillor shall digress from the subject-matter of the question under discussion, or comment upon the words used by any other Councillor in a previous debate; and all imputations of improper motives, and all personal reflections on Councillors, shall be deemed highly disorderly.

*Councillors to apologise for disorderly, etc., expressions.*

21. Whenever any Councillor shall make use of any expression disorderly or capable of being applied offensively to any other Councillor, the Councillor so offending shall be required by the Mayor to withdraw the expression and to make a satisfactory apology to the Council.

*Councillor called to order to sit down.*

22. A Councillor called to order shall sit down unless permitted to explain.

*Councillor twice offending guilty of an offence.*

23. Any Councillor using offensive or disorderly language, and having been twice called to order or to withdraw and apologise for such conduct, and refusing so to do, shall be guilty of an offence.

*Strangers.*

24. Any person not being a Councillor who shall, having been admitted to any meeting of the Council, be guilty thereof of any improper or disorderly conduct, or who shall not leave when lawfully requested by the Mayor so to do, may be forthwith removed by him, and shall be deemed guilty of an offence.

*Councillor may demand documents.*

25. Any Councillor may of right demand the production of any of the documents of the Council applying to the question under discussion.

*Voting.*

26. The Council shall vote by show of hands, and any Councillor present and not voting, not being disabled by law from so doing, shall be guilty of an offence.

*Questions, how declared.*

27. The Mayor shall, in taking the sense of the Council, put the question first in the affirmative, then in the negative, and the result thereof shall be recorded in the minutes.

*Motions, etc., to be in writing.*

28. At every meeting of the Council all motions, whether original motions or amendments, shall be reduced into writing, signed by the mover, and delivered to the Chairman immediately on their being moved and seconded.

*No second amendment until previous one disposed of.*

29. No second or subsequent amendment, whether upon an original proposition or on an amendment, shall be taken into consideration until the previous amendment is disposed of.

*Effect of rejection of words in original motion.*

30. If any words of an original question be rejected, the insertion of other proposed words shall form the next question, whereupon any further amendment to insert other words may be moved.

*If amendment be negatived, a second one may be moved.*

31. If an amendment be negatived, then a second may be moved to the question to which the first-mentioned amendment was moved, but only one amendment shall be submitted to the Council for discussion at a time.

*Mover of motion to have right of reply.*

32. The mover of every original proposition, but not of any amendment, shall have a right to reply, immediately after which the question shall be put from the chair; but no Councillor shall be allowed to speak more than once on the same question, unless permission be given to explain, or the attention of the chair be called to a point of order.

*Motion for adjournment.*

33. No discussion shall be allowed on any motion for adjournment of the Council; but if on the question being put the motion be negatived, the subject then under consideration, or the next on the notice-paper, shall be discussed, or any other that may be allowed precedence, before any subsequent motion for adjournment be made.

*Protests.*

34. Any Councillor may protest against any resolution of the Council, and notice of intention to protest shall be in every case given forthwith on the adoption of the resolution protested against; and the protest shall specify the reasons for protesting, and shall be entered three days at least before the next ordinary meeting of the Council by the protesting Councillor in a book to be kept for that purpose in the office of the Town Clerk, and signed by such Councillor, and shall be also entered in the minutes of the meeting at which notice of the intention to protest shall have been given previously to the confirmation thereof; but such protest may be expunged from the minutes if declared by a majority of the Council to be not in accordance with truth or in its terms disrespectful to the Council.

*Lapsed questions.*

35. If a debate on any motion moved and seconded be interrupted by the number of the Councillors present becoming insufficient for the transaction of business, such debate may be resumed at the point where it was so interrupted, on motion upon notice.

*Lapsed order of the day may be restored.*

36. If a debate on any order of the day be interrupted by such insufficiency of number as aforesaid happening, such order may be restored to the notice-book for a future day on motion upon notice, and then such debate shall be resumed at the point where it was so interrupted.

*Petitions.*

37. No petitions shall be presented after the Council shall have proceeded to the orders of the day.

*Petitions to be respectful.*

38. It shall be incumbent on every Councillor presenting a petition to acquaint himself with the contents thereof, and to ascertain that it does not contain language disrespectful to the Council, and that the contents do not violate any By-law or any provision thereof.

*Councillors to affix their names.*

39. Every Councillor presenting a petition to the Council shall write his name at the beginning thereof.

*Petitions to be in writing.*

40. Every petition shall be in writing, and shall contain the prayer of the petitioners at the end thereof, and be signed by at least one person on every page on which it is written.

*To be signed by petitioners.*

41. Every petition shall be signed by the person whose names are appended thereto by their names or marks, and by no one else, except in cases of incapacity or sickness.

*No letters, etc., to be attached.*

42. No letters, affidavits, or other documents shall be attached to any petition.

*Councillors confined to statement of certain facts.*

43. Every Councillor presenting a petition to the Council shall confine himself to a statement of the persons from whom it comes, of the number of signatures attached to it, of the material allegations contained in it, and to the reading of the prayer thereof.

*Salaries of officers, etc.*

44. The salary or allowance attached to all offices and places at the disposal of the Council shall in all cases be fixed before they proceed to appoint any person to fill the same before the advertisement inviting applications, and shall be specified in such advertisement.

*No Councillor, etc., to be surety for officer.*

45. No Councillor or officer of the Council, and no assessor or auditor of the Municipality, shall be received as a surety for any officer appointed by the Council or for any work to be done for the Council.

*Suspension of rules.*

46. Any one or more of the rules or regulations contained in this subdivision may be suspended for a special purpose, and shall not otherwise be suspended, except by a two-thirds majority vote of the Councillors present.

*Penalty.*

47. If any person shall be guilty of any offence or misfeasance, or negligent act of commission or omission contrary to any provision contained in this subdivision, he shall forfeit a sum not exceeding Five pounds.

**BY-LAW No. 3.***Custody and use of Corporation Seal.*

1. The Town Clerk shall have charge of the Common Seal of the Corporation and shall be responsible for the safe keeping and proper use of the same.

*Attestation under Corporate Seal.*

2. The Town Clerk shall not affix the Common Seal to any corporate document other than contracts of work to be executed, entered into by and with the Corporation, without the express orders of the Council; but in cases of powers of attorney and other legal instruments not relating to the Corporation, the signatures to which require to be verified by declaration or otherwise before the Mayor, the said seal shall and may be affixed by the Town Clerk to the Mayor's certificate accompanying the same, on receipt of a fee of Five shillings.

*Custody of records, journals, etc.*

3. The custody of the records, journals, and all documents whatsoever laid before the Council shall be in the Town Clerk, who shall neither take nor permit to be taken any such records, journals, or documents from the Corporation offices without the express leave or order of the Council.

*Passing of By-laws.*

4. No By-law shall be finally passed or adopted at the meeting at which it shall have been first proposed, nor until the next or some subsequent meeting of the Council, duly convened.

**BY-LAW No. 4.***For regulating the duties of officers of the Council.*

The Town Clerk is the medium of communication between all the officers of the Council.

*Town Clerk's department.*

The duties of the Town Clerk are as under:

1. To attend all Council meetings.
2. To attend all committees.
3. To take notes of all minutes, such minutes to be written up within 48 hours, and prepare reports of committees.
4. Conduct all correspondence, and give instructions to the other officers, as directed by the minutes.
5. To answer all questions on Corporation business.
6. See that the accounts are audited twice a year, and the balance-sheets prepared.
7. See to the gazetting of all By-laws and the publication of all notices and advertisements.
8. To prepare the rate book and electoral lists, attend all courts of revision or appeal, and make all necessary arrangements for elections.
9. To summon the members of the Council to meetings of both Council and Committees.
10. To keep the cash book, journal, and ledger, as well as any and all other books required to show the receipts and expenditure of the Council: the said books to be kept written up every month ready for the inspection of the finance committee or any member of the Council who may, at any time during the office hours desire to see them.
11. To check all accounts sent in by the Corporation officers, and to see that all accounts for works (exceeding Five pounds in amount) have stated on them the authority under which such works have been done; to check all returns made by the collectors or others of the Corporation officers, and to see that with all returns made the heels of the receipt books accompany the returns; to keep the officers of the Corporation who pay money to the credit of the Corporation up to their time in so paying in; to report to the finance committee at their first meeting thereafter any officer neglecting to make his returns as provided, with the necessary vouchers attached thereto.
12. All moneys received to be entered in the cash book, and paid to the Treasurer within seven days.

*Treasurer.*

It is the duty of the Treasurer—

1. To pay into the bank within twenty-four hours after receipt to the credit of the Corporation any sum or sums of money that may be received by him (amounting in the aggregate to Twenty pounds or upwards) on behalf of the Corporation, and all receipts given by him for moneys received must be signed as Treasurer.
2. To see that the bank pass-book is made up to within twenty-four hours of the time of the finance committee, and produce it at each meeting of that committee; or should any member of the Council desire to see it, at any time during office hours, he must produce it for inspection.
3. No moneys are to be paid into the bank by any officer except by or through the Treasurer, who must sign in the cash book for all amounts received.

**BY-LAW No. 5.***To prescribe the manner in which any fence is to be erected.*

whenever the Council shall require any person to erect a fence, or repair any fence, the same shall be done in the following manner, and to the satisfaction of the supervisor:

1. Ornamental fences or walls fronting public thoroughfares to be of a design approved of by the Council.
2. Fence of post and rails of sawn timber not less than four feet in height, faced with sawn pickets, not more than three inches apart.

**BY-LAW No. 6.***To prohibit the erection of fences with barbed wire abutting on public places.*

1. No owner or occupier of land within the Municipality of Queen's Park shall erect, or cause or permit to be erected, any fence with barbed wire abutting on any public place within the said municipality.
2. Every person offending against this By-law shall, on conviction, forfeit and pay a fine not exceeding £10.

## BY-LAW No. 7.

*For prohibiting openings under footways.*

1. No trap-door or cellar-trap or covering over any stair, vault, or cellar-way or opening shall be so made or fixed so that the covering to such stair, vault, cellar-way or openings shall project on or over any portion of the footway of any street within the Municipality of Queen's Park.

2. Any person offending against the provisions of this By-law shall, for every offence, forfeit and pay a penalty not exceeding £10.

## BY-LAW No. 8.

*To prevent obstructions on the footpaths and streets.*

No person shall permit any boxes, cases, coal, sand, firewood, goods, wares, merchandise, or other articles or effects to remain on any part of any street, or on any of the said footpaths of the said Municipality after sunset, nor in any case for a longer period than shall be necessary for housing or removing the same. Every person so offending shall forfeit and pay for every offence a penalty not exceeding £5.

## BY-LAW No. 9.

*To prohibit the throwing of orange peel or other like dangerous substances on the footpaths, or into, or upon any street or any gutter.*

1. No person shall throw or place any orange peel or any other vegetable substance or any dangerous, offensive, or noxious substance, vegetable or otherwise, or throw any lighted match on the footpath; and

2. No person shall sweep, throw, or place any rubbish, garbage, sweepings, litter, or refuse, of any description on any footpath or street of the said town, or into any gutter or channel thereof, or cause or permit the same to remain therein.

3. No person shall empty, throw, or discharge, or permit to be emptied, thrown, or discharged any foul or offensive water or other offensive liquid, into or upon any street or footpath of the town, or into any gutter or channel thereof. Every person so offending shall forfeit and pay for every offence a penalty not exceeding £5.

## BY-LAW No. 10.

*To prevent damage to footpaths and other Council properties.*

No person, without having first obtained the written sanction of the Council, shall break up, cut down, damage, destroy, injure or deface any footpath, drain, gutter, culvert, bridge, road, public way, tree, tree-guard, plant, gate, fence, post, lantern, lamp-post, implements, materials, buildings, or other properties of the Council of Queen's Park or under the control thereof. Every person so offending shall forfeit and pay for every offence a penalty not exceeding £5.

## BY-LAW No. 11.

*For the preservation of trees in the Municipality of Queen's Park.*

Any person who shall carelessly, wilfully, or wantonly injure, destroy, carry away, or remove from its place any tree, shrub, or plant, planted in any of the streets, enclosures, or public places of, belonging to, or under the care or superintendence of the Corporation of the said Municipality; or shall carelessly, wilfully, or wantonly injure, destroy, carry away, remove out of its place, ride or drive against, or tie any horse or other animal to any of the tree-guards, fences, or other protection, shall be liable for any such offence to a penalty not exceeding £10.

## BY-LAW No. 12.

*Trees, or branches of trees, overlapping footways or public crossings or lands.*

Any branch or branches of trees growing on private property overhanging or overlapping any footway, public crossing, or land, or is in any way dangerous to the public, shall, if considered necessary by the Council, be removed by the owner or occupier of such property, and if not so removed as the Council may order the person offending against this By-law shall, on conviction, be liable to a penalty not exceeding £5 or less than 20s., and for every day such branch or branches remain unremoved after the expiration of time given for removal in such notice from the Council, the person or persons so offending shall forfeit and pay a sum of Five shillings.

## BY-LAW No. 13.

*To prevent danger arising from the driving of vehicles at night without lights.*

No person shall between sunset and sunrise, except three nights before the full moon, the night of full moon, and one night after, in, upon, or along any street within the Municipality drive any vehicle, constructed or used for the conveyance of goods, wares, or merchandise without having a lamp or lantern securely fixed and lighted at the off-side; nor any vehicle constructed or used for the conveyance of persons as well as goods, wares, merchandise, or of persons only, without having a lamp or lantern securely fixed and lighted on each side of the said vehicle. Any person so offending shall be liable to a penalty not exceeding £5.

## BY-LAW No. 14.

*To prevent accidents from the riding or propelling of bicycles, tricycles, and other velocipedes.*

1. Throughout this By-law the expression "Bicycle" means bicycle, tricycle, or other velocipede; the expression "Bicyclist" means a person riding or otherwise using or having the management or control of a bicycle, tricycle, or other velocipede in any street, roadway, or footway within the Municipality of Queen's Park.

2. Every bicyclist within the Municipality of Queen's Park shall observe the rules of the road.

3. A bicyclist shall not ride a bicycle upon any footway, pavement, or causeway made and set apart for the use or accommodation of foot-passengers.

4. Every bicyclist who rides a bicycle during the hours between sunset and sunrise except three nights before the full moon, the night of full moon, and one night after, shall carry, attached to his or her bicycle, a lamp, which shall be so constructed and placed as to exhibit a white light in the direction in which he or she is proceeding, and shall be so lighted, and kept lighted, as to afford adequate means of signalling the approach or position of such bicycle.

5. Every bicyclist while riding, or impelling, or propelling a bicycle shall carry a bell, to be used as a signal to warn foot-passengers and generally used to avert accidents.

6. No person using a bicycle or having charge thereof shall leave the same at any one time in or on any street or footway in the said Municipality so as to become an obstruction: and every person shall remove his or her bicycle immediately upon being requested by a constable or other authorised official. Any person offending against this By-law shall be liable to a penalty not exceeding £5.

## BY-LAW No. 15.

*Obstruction of footpath by placing carriages, etc, thereon.*

No person shall ride, or drive, or place, or cause, permit or suffer to be ridden, driven, or placed upon any footway in the said town any wagon, cart, dray, sledge, bicycle, tricycle, or any other vehicle which may be driven, ridden, or drawn, or any wheel, wheelbarrow, handbarrow, truck, hogshead, cask, barrel, or other article or thing, nor shall lead, drive, or ride any animal or animals whatsoever upon any of the footways aforesaid. Any person so offending shall be liable to a penalty not exceeding £5.

## BY-LAW No. 16.

*Restrictions as to furious driving.*

No person shall ride or drive furiously or carelessly in any street, nor be drunk while driving or riding; and no person shall drive at a rapid pace at or round the intersection of any of the streets. Any person so offending shall be liable to a penalty not exceeding £5.

## BY-LAW No. 17.

*Regulating the passing of advertising vans in the streets.*

No person shall, without the written consent of the Town Clerk, drive or cause to be driven through any street of the said Municipality any cart, carriage, van, or other articles with advertisements posted thereon, used or intended solely for advertising purposes. Any person so offending shall be liable to a penalty not exceeding £5.

## BY-LAW No. 18.

*Carriage license.*

Any person using any cart or carriage within the Municipality for a longer period than seven days may be required to take out a license for same.

## BY-LAW No. 19.

*To prevent animals or vehicles being left in the street, or obstructing any portion of the street.*

No person shall leave unattended any vehicle, to which may be attached any animal, for a longer period than necessary for loading or unloading the same: provided that where suitable bridle-posts are erected, the horse or other animal may be securely fastened thereto for a period of not more than sixty minutes, but immediately on the request of any officer of the Council or police constable, such horse or other animal shall be removed; failing the carrying out of such request, the horse or other animal, together with the vehicle, may be seized and removed to the nearest police station, Municipal yard, or pound; and the person so leaving such animal or vehicle shall forfeit and pay a sum not exceeding £10, in addition to any pound fees, which may have become due and payable by such impounding.

## BY-LAW No. 20.

No person shall leave unattended any vehicle to which may be attached any animal without securing the wheel with a chain, or securely fastening the horse or animal to a bridle post. Any person so offending shall be liable to a penalty not exceeding £5.

## BY-LAW No. 21.

*To regulate carriage traffic in the streets.*

The driver of any private vehicle taking up or setting down any person at any public place of public worship, or public amusement, or at any public meeting, or who is waiting for such purpose, shall act under the direction of the officer of the Council or police constable who may be on duty at such place or places, and shall perform his duty in a quiet manner and obey such directions.

## BY-LAW No. 22.

*For prohibiting or regulating processions in the streets.*

No person or persons, with or without vehicles or animals (except for funeral, military, or police purposes), shall parade or pass through any street unless and until the previous consent in writing of the Mayor, or, in his absence, of the Town Clerk, shall be first had and obtained, and then only by the route or at such place or places specified in such consent, nor until the recipient of such consent shall, if required, have paid the cost of giving public notice by advertisement, setting forth the particulars of the route. Any person so offending shall be liable to a penalty not exceeding £10.

## BY-LAW No. 23.

*To regulate the driving of unyoked cattle and unbroken horses through the Municipality.*

1. No unyoked cattle or any sheep or other stock, and no unbroken horse or horses, whether roped or not, shall be driven or ridden into or along any street of the Municipality except between the hours of 10 o'clock at night and 8 o'clock of the mornings of all days during the months of May, June, July, August, and September, and except the hours of 11 o'clock at night and 6 o'clock in the morning on all days during the months of October, November, December, January, February, March, and April; provided that nothing herein contained shall be held to extend to any milch cow going to or returning from her depasturing or watering.

2. No bull or stallion shall be driven, ridden, or led into or along any street of the Municipality, except the same be under the control of a safe keeper, and be secured by proper reins, so that the animal may be well under the control of the said keeper. Any person so offending shall be liable to a penalty not exceeding £5.

## BY-LAW No. 24.

*To restrict the breaking-in of horses in the streets of the Municipality of Queen's Park and for other purposes relating to horses.*

1. No person shall break in any horse, mare, gelding, pony, mule, or ass in any street or thoroughfare of the Municipality of Queen's Park, either by leading, riding, or driving the same.

2. No person or persons, either as owners or otherwise, in charge of any entire horse, bull or ass, shall cause, allow, permit, or suffer any such entire horse, bull or ass to cover any mare or cow within the Municipality, or to cause or permit, or allow or suffer any such entire horse, bull, or ass to be turned loose in any yard or other place with any mare or cow for the purpose of allowing such mare or cow to be covered, except in some yard, building, or other premises as shall be entirely and sufficiently screened from public view; and any person offending against any portion of this By-law shall forfeit and pay for such offence, on conviction, a sum not exceeding £10.

## BY-LAW No. 25.

No camel or camels may be ridden or driven through the Municipality without the written permission of the Town Clerk, the permit to state through which streets such camel or camels may be driven, and that same be done at the owner's responsibility.

Any person who shall offend against the provisions of this By-law shall be liable to a penalty not exceeding £10.

## BY-LAW No. 26.

*Pound regulations.*

The Public Pound for the Municipality shall be on Street, and the following fees shall and may be charged and taken by the Pound-keeper:—

## BY-LAW No. 27.

*Fees for depasturing stock.*

## BY-LAW No. 28.

*To provide restrictions as to hawkers.*

1. No person shall hawk any fruit, fish, or vegetables, or articles of merchandise within any part of the Municipality without having first obtained a license from the Council.

2. Any person who travels and trades on foot, or without any vehicle or animal, or otherwise carrying to sell, or expose, or offer for sale within the limits aforesaid any of the articles or things aforesaid, shall be deemed to hawk the same.

3. No person shall keep, manage, or conduct at any moveable or temporarily fixed stall in or near any street for the sale of any meat, fruit, vegetables, drink, eatables, or articles of merchandise unless such person be licensed.

4. Licenses for "hawkers" shall be in the Form "X" of the Schedule, and for "stalls" in the Form of "Z" in the Schedule.

5. Every hawker, while employed in hawking, shall produce his license upon being required by any constable, or any officer of the Council, and shall at all times have affixed to some conspicuous part of his coat, barrow, basket, vehicle, or dray a board or plate bearing his name and the words "Licensed Hawker" legibly painted thereon in letters not less than one inch in length.

6. No licensed stall shall be placed or allowed to stand in any street or position other than that mentioned in the license or between the hours of 8 p.m. and 2 a.m.

7. The following fees shall be paid for licenses to hawkers or stalls, and shall be paid in advance on the first Monday in every month, and if any payment be not paid when due the license shall be void:—

## HAWKERS' LICENSES.

For every hawker with hand-basket or tray .. .. .	1s. per month.
For every hawker with wheelbarrow or hand-cart .. .. .	1s. per month.
For every hawker with vehicle drawn by a horse or other animal .. .. .	5s. per month or 20s. per annum.

## STALL LICENSES.

For every stall . . . . . 20s. per month.

8. Every licensed hawker and stall-holder shall at all times obey the lawful directions of the Town Clerk or other authorised officer of the Council.

9. No person to whom a hawker's or stall-holder's license is granted shall lend, transfer, or assign his license granted; and no person shall borrow or make use of any such license to a person other than himself, unless by written consent of the Town Clerk.

## FORM X.—HAWKER'S LICENSE.

*Municipality of Queen's Park.*

## BY-LAW No. 29.

*Prohibiting the keeping of swine within the Municipality.*

1. It shall not be lawful for any person to keep or breed any kind of living swine within the Municipality unless he shall have first obtained a license from the Council so to do.

2. Any person who shall offend against the provisions of this By-law shall be liable to a penalty not exceeding £5.

3. Nothing in this By-law shall apply to any swine brought into the Municipality for sale and removed therefrom within 24 hours.

## BY-LAW No. 30.

*To regulate the management of steam, oil, or other engines.*

1. Any steam or other engines in use within the Municipality shall, if required, have affixed to the flue or chimney an improved spark-arrester, and all flues or chimneys shall be carried up to such height above the surrounding buildings as may be directed by the Council from time to time.

2. Any person offending against the provisions of this By-law shall be liable to a penalty not exceeding £20.

## BY-LAW No. 31.

*To prevent danger from inflammable materials.*

1. Any person who shall stack any hay, straw, or other inflammable material within fifty feet of any house or other building, provided that a hay shed shall not be considered a building within the meaning of this By-law, shall, on conviction, forfeit and pay a penalty not exceeding £20 for every such offence.

2. No person shall permit in any yard or way occupied by him any accumulation of straw, paper, shavings, or other inflammable material whatever; and any person offending against this By-law shall, on conviction, forfeit and pay a sum not exceeding £10.

## BY-LAW No. 32.

*Lighting insufficiently guarded fires.*

Any person burning straw, grass, wood, or rubbish within the Municipality without sufficient safeguard shall, on conviction, forfeit and pay a sum not exceeding £5.

## BY-LAW No. 33.

*Fires in chimney flues.*

The occupier of any premises within the Municipality whereof any chimney flues shall take fire, from having become foul, shall forfeit and pay, upon conviction, a penalty not exceeding £10; provided that if any defendant shall plead that such chimney flue did not take fire in consequence of being foul, the onus of proof shall lie on such defendant.

## BY-LAW No. 34.

*To restrain the keeping of houses of ill-fame, within the Municipality of Queen's Park.*

1. Any person acting as the owner or proprietor, and any person having the chief control or management, or being the occupier of any brothel or any house of bad repute, or any disorderly house within the Municipality of Queen's Park shall forfeit and pay, on conviction, a sum not exceeding £10, and a further sum of £1 for every day during which such person shall, after notice from any inspector appointed by the Council to desist, continue to act, control, occupy, or manage any brothel, house of bad repute, or disorderly house as aforesaid.

2. Any person letting any house, knowing that such house is about to be used, or is being used by the tenant thereof as a brothel, shall forfeit and pay, on conviction, a sum not exceeding £10, and a further sum of £1 for every day during which such tenant is in occupation after notice to eject from any inspector appointed by the Council.

## BY-LAW No. 35.

*Regarding bill-posting in the Municipality of Queen's Park.*

Every person who is desirous of posting handbills or other form of advertisement on the walls or other parts of the Municipality where the same is allowed, must make application to the Council for a license for so doing, and the same, if the party is approved of by the Council, shall pay an annual fee of Five shillings for such permission; but in no event shall it be lawful for any bill-poster to post any bills or other form of advertisement on any public fence, trees, or telephone posts, or the walls of any public buildings in the said town, nor upon the walls of any private houses, unless he shall first obtain the consent of the occupier or owner of such house or other premises. Any person offending against this By-law shall be liable to a penalty not exceeding £5.

## BY-LAW No. 36.

*To prevent danger from firearms.*

Any person who shall wantonly and without lawful excuse discharge any firearm in, near to, or across any public street within the Municipality shall forfeit and pay, on conviction, a penalty not exceeding £5 for every such offence.

## BY-LAW No. 37.

*For regulating width of tires of vehicles.*

1. It shall not be lawful for any person engaged in building, constructing, selling, or making vehicles to build, construct, or make, sell or hire, or offer for sale or hire, any vehicle unless the width of the tires of such vehicle shall be in the following proportion to the diameter of the axle-arm of such vehicle, viz.:—

When diameter of the axle-arm is			
2 inches,	the width of the tire shall be 3 inches.		
2¼ "	"	"	3½ "
2½ "	"	"	4 "
2¾ "	"	"	4½ "
3 "	"	"	5 "

2. No person shall import into the Municipality of Queen's Park any vehicle the tires of the wheels of which vehicle are not of the width prescribed or specified by the preceding section of this By-law, and if any such vehicle be imported no person shall use or employ it upon any public road or street within the Municipality.

3. No person shall use or employ any vehicle upon any public road or street of the Municipality unless the tires of the wheels of such vehicle are of the proportion specified in Section No. 1 of this By-law.

4. Every vehicle in use on any public road or street in the Municipality shall have the diameter of the axle-arms painted on some conspicuous part on the off-side thereof; and any owner of any vehicle who neglects to have such measurements painted as aforesaid, or who has the same so painted incorrectly, shall be guilty of an offence against this By-law.

5. Any person offending against any of the provisions of this By-law shall be liable, on conviction before one or more Justices of the Peace, to a penalty not exceeding £5.

6. Vehicle means and includes any wagon, cart, or lorry or dray, but does not include any vehicle intended solely for the conveyance of passengers.

#### BY-LAW No. 38.

##### *Park lands, reserves, and recreation grounds.*

For the management, care, and control of the park lands, commonage, and places of public recreation for the time being vested in the Corporation or under their care, control, and management, pursuant to the powers and provisions contained in "The Municipal Corporations Act, 1906."

##### *Appointment of park rangers and keepers, or servants.*

1. The Municipal Council may from time to time appoint and employ park lands rangers, or keepers of the park land and commonage, and other servants, for maintaining and watching over park lands and places of public recreation and commonage, as they may deem necessary.

##### *Park rangers, keepers, and police may remove offenders.*

2. The park lands rangers, keepers, or other servants appointed as aforesaid, police constables and special constables, shall be at liberty to remove from the park lands all persons offending against any of these By-laws.

##### *Park lands to be opened.*

3. The park lands and places of public recreation shall at all times, except as provided by special Act or otherwise specially hereinafter provided for, be open for the admission of the public.

The Council shall have power to delegate to any committee appointed at any meeting of the Council to manage and make regulations, and do all things that may be done by the Council in the management of park lands, places of public recreation and commonages.

##### *Persons not to ride over the park lands.*

4. No person shall ride in, upon, or over the said park lands, or any part thereof (other than a carriage-way) without permission from the Council be first obtained.

##### *Injuring or destroying trees.*

5. No person shall injure, cut, break, deface, pull up, remove, or destroy any tree, shrub, or plant, growing on the said park lands, or any lands vested in the Council or under their control.

##### *Injuring the soil, or surface, or fence.*

6. No person or persons shall cut up, or damage, or disfigure, or interfere with the soil or turf or surface of any part of the said park lands, recreation grounds, or the roads or footways across, around, or over the same, or with any part of the fences around or upon the same, in any manner whatsoever without the written consent of the Council first obtained.

##### *Persons misconducting themselves.*

7. No person shall misconduct himself in any way by indulging in any riotous or indecent conduct, or make use of any indecent or improper language on the said park lands or recreation grounds.

##### *Lodging on the park lands in the open air.*

8. No person shall camp, lodge, or tarry over night, or frequent for the purpose of camping, lodging, or tarrying over night in the open air on the said park lands, or under the shade or shelter of any tree or trees, or any seat on the said park lands without the written consent of the Council first obtained.

##### *Posting bills.*

9. No person shall post, stick, stamp, stencil, paint, or otherwise affix or cause to be posted, stuck, stamped, stencilled, painted, or otherwise affixed any placard, handbill, notice, or advertisement whatsoever upon any tree, fence, post, gate, wall, flagging, or path on the said park lands or recreation grounds without the written consent of the Council first obtained.

##### *Shooting, etc., on the park lands.*

10. No person or persons shall shoot or discharge any firearms, or throw or discharge any stone or other missile, or set off any fire balloon, or throw or set fire to any fireworks, or kindle or make any fire, on any portion of the park lands or recreation grounds without the written consent of the Council first obtained.

##### *Selling goods on the park lands.*

11. No person shall sell or expose for sale any goods wares, merchandise, or things on any portion of the said park lands or recreation grounds, unless the consent in writing of the said Council shall be previously obtained.

##### *Dangerous games not to be played.*

12. No racing matches with horses, dogs, or otherwise, nor any game of polo, nor any game which may be considered dangerous or may be calculated to interfere with the safety or comfort of the general public, or likely to injure the surface of the ground, shall be allowed on the said park lands or recreation grounds, except on such portions as may be specially set apart for such purposes, and shown thereon by boundary posts, such boundary posts to be fixed and renewed from time to time as the Council may deem necessary.

##### *Waste litter of picnics to be removed.*

13. When any party, company, society, club, or organisation of any kind shall play any game, or picnic on the park lands, they shall, immediately prior to their leaving the ground, collect and remove, or cause to be collected and removed, all waste material, broken glass, scraps, litter, or rubbish of any kind brought or made upon the ground by them. In the event of the non-observance of this Regulation, the actual cost of thoroughly performing the necessary duty by the park rangers or others employed in the work shall be charged, and a bill for the same be presented to any one of the participants in the play, game, or picnic, and the amount so incurred may be recovered by summary process before any one or more Justices of the Peace in the province.

14. No person or organised club shall play cricket, football, baseball, racket, or any game of a like nature, on any portion of the park lands or recreation grounds, except on such portion as shall have been or hereafter may be set apart for their peculiar purposes by the Council; neither shall any such games as aforesaid be played on those portions of the park lands or recreation grounds as are or may be set apart for these peculiar purposes, unless and until the person or club shall have first obtained from the Council a permit in writing so to do.

15. The Council may from time to time issue permits to, and charge and take such fee as they may deem suitable from persons to train horses, dogs, or other animals on the park lands for racing or other purposes, and they may from time to time vary or alter the amount of the fee to be charged for permit so issued.

16. The Council may fix the day or days upon which, and the bounds or limits within which any games or gymnastics may be permitted to take place upon the park lands; or they may prohibit any games or gymnastics from taking place upon the said park lands.

The Council may from time to time vary the fees to be charged the public for admission to any of the park lands or reserves, and the occasions when such fees shall be payable and prohibiting admission therein on such occasions.

17. The Council may set apart any portion of the park lands for the exclusive depasturing of horses and cattle, and may vary, alter, or change such portions when they may deem desirable, and may charge and take such fee as they may deem requisite for horses and cattle so depastured, and may alter or vary the amount of such fee at such times and in such manner as they may deem best.

##### *Park lands may be closed.*

18. The Council may close and reserve for such period of time as to them may seem requisite any portion of the park lands from the depasturing of horses or cattle, or any of them respectively, and any horses or cattle found on such enclosed or reserved portions shall be deemed to be trespassing thereon, and the park lands rangers, keepers, or other servants may impound horses or cattle so trespassing; and it shall be lawful to charge and receive for all horses or cattle so impounded the rates or fees specified in By-law No. 26.

19. The Council may, from time to time, fix the day or days upon which, and the bounds or limits within which, bathing may be permitted from any of the park lands or recreation grounds, and any person bathing therefrom must be habited in proper bathing costume.

##### *Interpretation.*

20. The word "Council" shall mean the Council of the Corporation of the Municipality of Queen's Park.

The words "park lands" shall mean all lands vested in or in the control of the Council.



Penalty.

Every person offending against any of these provisions of this By-law shall forfeit and pay on conviction a penalty not exceeding £5.

BY-LAW No. 39.

Penalties.

For every offence against the provisions of these By-laws to which no penalty is attached, the offender shall, upon conviction, forfeit and pay a penalty not exceeding £10.

BY-LAW No. 40.

Interpretation.

The several words mentioned in Section 6 of "The Municipal Corporations Act, 1906," shall, where used in these By-laws (except where otherwise provided), have the same construction as is provided for by such Section and Act.

# THE ROADS ACT, 1902.

## Kelmescott Special By-laws for Water Supply.

WHEREAS by virtue of the provisions of "The Roads Act, 1902" (2 Edward VII., No. 48), the Road Board of every District is empowered to make, alter, or repeal By-laws for any of the purposes of the said Act mentioned: The Kelmescott Road Board hereby makes and publishes the following By-laws concerning the supply and distribution of water at the well, tank, or place formed for the storage of water under the control of the Board, at all watering places under the control of the Board within the District of the said Board.

(1.) Any resident within the jurisdiction of the said Board may at any time apply to the Board to be supplied with water from the said well, tank, or place of storage upon the following terms and conditions:—

(a.) The Board shall not be held responsible for the non-delivery, short-delivery or delay in delivery of any water to any resident so applying as aforesaid, under any circumstances whatsoever, and the Board may at its discretion at any time whatsoever, without giving any notice to the resident or residents, limit, restrict, or wholly discontinue the supply of such water to any or all of such resident or residents who shall have applied for the supply of same, nor shall the Board be answerable in damages to any such resident or residents for any loss or expenditure he or they may have incurred in consequence of the limitation, restriction, or discontinuance of such supply of water.

(b.) All water supplied to the resident or residents under these By-laws shall be used for domestic purposes only.

(2.) Any resident may, with the consent of the Board and under the supervision and approval of its officers, lay down and connect service pipes to the said well, tank, or place formed for the storage of water, at the expense in all things of the said resident: Provided always, that if the said resident shall desire to remove such service

pipes he may do so at his own expense, provided he makes good and repairs, and he is hereby required to make good and repair any and all roads, bridges, and property within the Board's District affected by such removal, to the satisfaction of the Board or its officers.

(3.) Any resident may obtain water, in quantities of not less than 100 gallons, at the well, tank, or place formed for storage of water as aforesaid, subject to the provisions of these By-laws.

(4.) The charge for water supplied to any resident whose premises are connected by service pipes shall be:—Hotels, £5; Business Houses, £3; Private Houses, £2 per annum payable in advance; and no refund or rebate shall be allowed to any such resident in consequence of the limited, restricted, or wholly discontinued supply of water to such resident from any cause whatsoever.

(5.) Residents obtaining supplies of not less than 100 gallons at the well, tank, or place of storage of water aforesaid, shall pay the sum of 6d. for every 100 gallons or fraction thereof, by cash before delivery.

(6.) Whosoever being supplied with water by the Board, or having access to any such well, tank, or place formed for storage of water as aforesaid for the taking of water therefrom, shall wilfully or negligently suffer any water to run to waste from any pipe or conduit from or by which he shall be so supplied or to which he shall have such access, shall, on conviction, forfeit and pay for every such offence a sum not exceeding Twenty pounds.

(7.) Any person who, in any other respect, commits a breach of any of these By-laws shall be liable, on conviction, to a penalty not exceeding Twenty pounds.

*Land and Income Tax Assessment Act, 1907.*

Section 26.

(1.) It shall not be lawful for any non-resident agent to act as agent, or for any non-resident trader to carry on business in Western Australia, unless he is the holder of a warrant in that behalf under the hand of the Commissioner.

(2.) Every warrant shall be in the prescribed form, and shall be issued without fee by the Commissioner on application to him in that behalf.

(3.) In all proceedings against any person for breach of this section it shall lie on the defendant to prove that he is a warrant holder.

(4.) The Commissioner may from time to time, as he thinks fit, assess any specified non-resident agent or non-resident trader for income tax in respect of any specific transaction, or of all transactions during any specified period, and may fix the amount of the tax at the rate then last in force (if the rate of tax is not then fixed by law), and on the assumption, subject to adjustment within the prescribed time at the instance of the Commissioner or taxpayer, that the specified transaction, or, as the case may be, all the transactions during the specified period, have produced a net profit of five per centum of the gross proceeds resulting therefrom.

(5.) The tax so fixed by the Commissioner shall be payable on demand, and shall be recoverable forthwith in the same manner in all respects as in the case of income-tax in arrear, but subject to adjustment as aforesaid.
