Colonial Secretary's Office, Perth, 4th October, 1910.

HIS Excellency the Governor in Executive Council, under Section 24 of "The Statistics Act, 1907," has been pleased to make the following Regulations providing for the mode in which Statistics shall be collected under the said Act relative to Imports into Western Australia from, or via, other States of the Commonwealth, and Exports from Western Australia to, or via, other States of the Commonwealth; to take effect on and after Monday, the 10th instant.

THE STATISTICS ACT, 1907.

Regulations for the collection of Statistics relative to Imports into Western Australia from, or *via*, other States of the Commonwealth, and Exports from Western Australia to, or *via*, other States of the Commonwealth.

1. The following shall be Statistical Collectors, for their respective ports, under Section 5 of "The Statistics Act, 1907," for the purpose of the collection of Export and Import Returns required to be furnished under these Regulations:—

Fremantle: The Secretary to the Fremantle Harbour Trust.

Bunbury: The Secretary to the Bunbury Harbour Trust.

Albany: The Railway Station-master. Geraldton: The Railway Station-master. Busselton: The Railway Station-master. Hopetoun: The Railway Station-master. Broome: The Wharfinger. Cossack: The Wharfinger. Carnarvon: The Wharfinger. Port Hedland: The Wharfinger. Derby: The Wharfinger. Onslow: The Wharfinger. Other ports: Such persons as shall be subsequently appointed by the Governor in Council. Every owner, or agent for the owner, of goods g exported from any port of Western Australia to port in any one of the other States of the Com-

2. Every owner, or agent for the owner, of goods being exported from any port of Western Australia to any port in any one of the other States of the Commonwealth, whether such goods are intended for export to such State of the Commonwealth or for re-export thence, shall, before the shipment of such goods, furnish, to the duly authorised Statistical Collector appointed for the purpose at such port in the State of Western Australia, a return filled in with all the particulars required in the First Schedule to these Regulations.

3. Every owner, or agent for the owner, of goods being landed at any port of Western Australia, from any port in any one of the other States of the Commonwealth, whether such goods were originally received from outside the Commonwealth or not, shall, before obtaining posses sion of such goods, furnish, to the duly authorised Statistical Collector appointed for the purpose at such port in the State of Western Australia, a return filled in with all the particulars required in the Second Schedule to these Regulations.
