The Water Boards Act, 1904. Pingelly Water Supply.

ORDER IN COUNCIL.

At the Executive Council Chamber, at Perth, the 4th day of June, 1913.

WHEREAS it is provided by "The Water Boards Act, 1904," that for preventing the pollution of water within a catchment area, every Water Board shall within such area have all the power and authority of a Local Board of Health, including the power to make and enforce By-laws under any Act relating to Public Health: And whereas it is desirable that the lands described in the Schedule hereto should be declared the catchment area for the Pingelly Water Supply: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby order and declare the lands described in the Schedule hereto to be a catchment area for the Pingelly Water Supply, and that the Order-in-Council published in the Government Gazette on the 18th day of April, 1913, declaring the Pingelly Catchment Area, is hereby cancelled.

#### The Schedule.

Avon Locations 10421, 10432, 2974, 6424, part of 5595.to North of 2974, 3944, 5441, 4365, 5715, 3861, 4387, 5415, Reserves 8291, 11139, and 11375, and the bed of the North Branch of the Hotham River from the East boundary of Avon Location 3861 to the Western boundary of Reserve 8291.

Williams Locations 4453, 2715, 3262, 2716, 3499, 4052, 6595, 7609, 4353, 4031, 4956, and part of 1732 to the North of 4956, and the bed of the South Branch of the Hotham River from the North boundary of Williams Location 2716 to the Eastern boundary of Reserve 8291.

#### DEPARTMENT OF PUBLIC HEALTH. Food Standards and Regulations.

Regulation 10.—Exemption from Statement of Weight.

The list of exemptions is amended as follows :- Insert : Dried fruits, in packets not exceeding one pound marked with a statement of weight, followed by the words "when packed."

Regulation 13.-Flour, Bread, and Meals.

Paragraph 3, fourth line.--Insert the word "than" after the words "nor more."

Regulation 34.—Vinegar.

a mixture of not less than one-third malt and not a mixture of not less than one-third mait and not more than two-thirds barley. It shall contain not less than two and one-half parts per centum of extractive matters, nor less than eight-hundredths of one part per centum of nitrogen, nor less than eight-hundredths of one part per centum of phos-phorus estimated as phospheric acid, nor less than .35 per centum of ash. The specific gravity shall not be less than 1.017 at a temperature of 60deg. Fabrenheit Fahrenheit.

Paragraph 4, last line.-Insert the word "sources" in lieu of the word "sauces."

Regulation 54.—Summer or Temperance Drinks. Add the following paragraph to stand as paragraph 2.

#### Preservative.

2. The addition of salicylic acid in proportion not exceeding three grains to the gallon is hereby permitted.

#### Regulation 56.-Wine.

#### Allowed Additions.
