PROCLAMATION (Resumption)

WHEREAS by Section 9 of "The Land Act, 1898," the Governor may resume, for any of the purposes specified in Sec. 39 of the said Act, any portion of land held as a Conditional Purchase Lease: And whereas it is deemed expedient that the portion of Conditional Purchase Lease 20/797 (Bolgart Estate Lot 3), as described hereunder, should be resumed for one of the purposes specified in paragraph 8 of Section 39 of the said Act, that is to say for Townsite: Now therefore I, Major General Sir Harry Barron, Governor as aforesaid, with the advice of the Executive Council, do by this my proclamation resume such portion of Conditional Purchase Lease 20/797 (Bolgart Estate Lot 3), for the purpose aforesaid.

Schedule.

That portion of Conditional Purchase 20/797 (Bolgart Estate Lot 3), containing about 77 acres, bounded by lines starting from a point on the North-East boundary of the Bolgart Townsite Reserve, situate 2 chains 70 links from its Northernmost corner and extending 152deg. 43min. 12 chains 3 links; thence 62deg. 43min. about 12 chains; thence 5deg. 44min. about 48 chains 28 links; thence 275deg.

44min. about 9 chains 41 links to a surveyed road, and along it 206deg. 37min. 17 chains 17 links, 189deg. 14min. 26 chains 24 links, and 174deg. 27min. 2 chains 59 links to the starting point. (Plan 32/80.)

HIS Excellency the Governor directs it to be notified as follows:—

That at a Special Meeting of the Executive Council held this day His Excellency announced that he had received the following resignations:

1. The resignation of the Honourable Thomas Henry Bath as Minister for Lands, Agriculture and Industries, and as a Member of the Executive Council;
2. The resignation of the Honourable Philip Collier as Minister for Railways;
3. The resignation of the Honourable William Dartnell Johnson as Minister for Public Works and of Water Supply, Sewerage, and Drainage.

And His Excellency was pleased to make the following appointments:—

1. The Honourable John Scaddan to be Minister for Railways.
2. The Honourable William Dartnell Johnson to be Minister for Lands and Agriculture, in lieu of and in immediate succession to the office previously held by him of Minister for Public Works;
3. The Honourable William Charles Angwin to be Minister for Works and Industries;
4. The Honourable Philip Collier to be Minister of Water Supply, Sewerage, and Drainage.

His Excellency was also pleased to appoint Rufus Henry Underwood, Esquire, M.L.A., to be a member of the Executive Council.

The usual Oaths of Allegiance and Office were administered to the Ministers accepting portfolios; and the Oath of Allegiance and the Oath prescribed for Members of the Executive Council were administered to the Honourable Rufus Henry Underwood by His Excellency the Governor.

NOTICE is hereby given that in pursuance of the provisions of Section 43 of "The Constitution Act Amendment Act, 1899," His Excellency the Governor in Council has been pleased to designate and declare the following to be the six principal Executive Offices of the Government:—

1. The Colonial Treasurer and Minister for Railways.
2. The Minister for Mines and of Water Supply, Sewerage, and Drainage.
3. The Minister for Lands and Agriculture.
4. The Attorney General and Minister for Education.
5. The Colonial Secretary.
6. The Minister for Works and Industries.
