WHEREAS by Section 17 of "The Fisheries Act, 1905-13," it is provided that the Governor may, from time to time, by proclamation in the *Government Gazette*, declare what length and depth of net and size of mesh for the whole or part of a fishing net shall, when used or intended to be used in any specified water or waters, or for catching any specified kind or kinds of fish, be a lawful net: And whereas the 'Prawn'' is a prescribed species of fish within the meaning of this provision: Now therefore I, the said Governor, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid and of every other power enabling me in this behalf, proclaim and declare as follows:

That any net which does not exceed nine feet in length and has a mesh throughout the whole of the net of not less than one half-inch, measured from knot to knot on the inside of the mesh when wetted ready for use, and stretched so that the opposite knots on the alternate corners are in contact, shall be a lawful net when used or intended to be used for the capture of prawns in the Western Australian waters defined in the schedule hereto.

#### By-law 42.

(a) The Board may, by advertisement in a newspaper circulating in the district, from time to time restrict the consumpion of water to domestic purposes only.

(b) A supply of water for domestic purposes shall include a supply for baths, but shall not include a supply for eattle or for horses, or for any steam engine, or for washing carriages or motor cars, where such horses or carriages or motors are kept for hire or are the property of any dealer, or for any factory, trade, or business whatsoever, or for watering gardens or for fountains, or for any ornamental purpose.

(c) Any person supplied with water by the Board, (d) Any person supplied with water by the board, whether by meter or otherwise, who shall allow the same to run to waste, shall be liable for each offence to a penalty not exceeding £20, and in the event of continu-ing the offence, to a further penalty of five pounds for each day after notice of the offence from the Board, and shall have the supply cut off.

(d) The Board may, by notice to a consumer, from time to time restrict the quantity of water to be used and the hours in which it may be supplied to him on any one day or in any one week, either for domestic or any other purpose; and such notice shall be deemed to be continuous until a fresh notice is given to the consumer.

#### COURT OF ARB ITRATION, WESTERN AUSTRALIA.

#### No. 1 of 1916.

Between the Master Bakers' Union of Employers of Western Australia, Perth, Applicant: and Perth and Fremantle Operative Bakers' Industrial Union of Workers, Respondent.

The Court of Arbitration of Western Australia doth hereby make the following award in connection with the industrial dispute between the above-mentioned parties:-

#### AWARD.

Area.-This Award shall apply to the area comprised within a radius of twenty miles from the General Post Office, in the City of Perth.

2. Term.-This Award shall come into operation upon the date hereof, and shall continue in force for a period of three years.

- Definitions.—In this Award—

   (a) "Baker" shall mean a person other than an apprentice employed in mixing, handling, moulding, or baking of dough in a bakehouse;
   All persons other than apprentices employed in the mixing, handling, mould
  - ing, or baking of dough shall be deemed to be bakers, and shall be employed
  - at the rates and on the conditions set out herein; (b) "Jobber" shall mean a baker who is but casually employed, and whose employ-
  - ment may be terminated without notice on either side; "Jobbing dough maker" shall mean a baker employed to make one or more (c)doughs as a casual employee; (d) "Single hand baker" shall mean a baker in charge of a bakehouse where there
  - are no other persons employed in mixing, handling, moulding, or baking dough.

4. Hours.-Twenty-eight hours shall constitute the week's work in the case of a half-time man.

In the case of a full-time man forty-eight hours shall constitute a week's work provided that forty-two hours shall be considered a week's work in a week when one holiday occurs and thirty-six hours shall be the minimum number of hours to entitle the worker to a full week's pay in any week in which two holidays occur.

5. Overtime.--Overtime at the rate of sixpence for every twenty minutes or part thereof shall be paid to a baker for all time worked in excess of the hours herein prescribed or in excess of ten hours in any day : Provided, however, that in the case of a half-time man overtime at the rate aforesaid shall be paid for all time worked beyond four hours on five shifts in the week and for all time beyond eight hours on the long Friday shift in each week.

Any apprentice shall be paid at the rate of one and a third of his ordinary wage for all time worked in excess of the hours herein prescribed or ten hours in any one day.

The time for starting work shall be such as shall be agreed upon for any period between the employer and the secretary of the union : Provided, however, that should the exigencies of the trade demand, it shall be permissible for the employer to commence work at any time not more than thirty minutes before or after the time so agreed upon.

The working time shall be calculated continuously from the time of starting work until the time for leaving work for the day or night. A baker required to make a dough prior to the ordinary starting time shall be allowed

two hours out of a day's or night's work therefor; where, however, there is no break in the employment the time shall be reduced to one and a-half hours.

6. Holidays.-All time worked on New Year's Day, Eight Hours' Day, Good Friday, and Christmas Day shall be paid for at the rate of time and a-half.

- 7. The minimum rate of wages payable shall be as follows :-
  - (a.) Baker-Three pounds seven shillings and sixpence per week ;

    - (b.) Single hand baker—Three pounds eight shillings per week;
      (c.) Baker required to do oven work—Three pounds eight shillings per week;
      (d.) Jobber—One shilling and sixpence per hour;
      (e.) Half-time man—Two pounds per week;
      (f.) Jobber travelling one mile from Trades Hall, Perth or Fremantle, shall be paid travelling expenses not exceeding one shilling; Jobber acting as foreman—Three shillings extra per day or night;
    - (g.)
    - (h.) Jobbing dough maker shall be paid three shillings for each dough of three bags (600lbs.) or under; and for each bag over and above three bags two shillings and sixpence.

8. Lower Rate Workers.—A worker who is unable to earn the minimum rate of wage hereby prescribed may be employed at a lesser rate of wage, which shall be agreed in writing between the worker and the secretary of the workers' union.

If within seven days after being notified in writing of the worker's desire to work at a lower rate of wage than that prescribed, the said secretary and the worker are unable to agree upon a lower rate, then the worker may apply\_in writing to the nearest Resident or Police Magistrate to fix such lower rate of wage.

The worker shall give such secretary two days' notice in writing of his intention to apply to the magistrate, and the said secretary or his agent may attend and oppose the application. The magistrate may fix the rate of wage, and his decision shall be final.

Any worker whose wage shall have been so fixed may work for and be employed by an employer for such less wage for the period of six calendar months thereafter, and after the expiration of the said period until fourteen days' notice in writing shall have been given him by the secretary of the union requiring his wage to be again fixed in the manner prescribed by this clause : · Provided always, that the employer shall not employ more than one such incompetent worker to every four fully paid workers or fraction of the first four. • • •

9. Record.-A time and wages book shall be kept in each bakehouse which shall show the name of each employee, the time he starts and finishes work each day, total hours, amount of overtime, wages, and signature for same. The employer and employee shall be jointly responsible for the proper posting of the book

daily. The book shall be supplied by the Union and shall be open to the inspection of the representatives of the worker's union during working hours.

10. Apprentices.-(i.) When used in this clause the term "permanently employed" shall be construed to mean three months' continuous employment either as full-time or halftime man.

(ii.) Apprentices to the baking trade shall, unless bound by indenture, be engaged under the terms hereinafter set forth. All indentures shall be forthwith registered in the manner hereinafter provided (Form 1 in Appendix hereto) with the Clerk of the Court of Arbitration. Except as aforesaid no legal agreement in existence at the date of issue of this award shall be interfered with.

(iii.) Apprentices shall not exceed in number one to every four or fraction of four journeymen permanently employed.

(iv.) The term of apprenticeship shall be four years. A probationary period of three months previous to being bound shall be lawful; such probationary period shall be deemed portion of the term of apprenticeship.

(v.) Should any employer from unforeseen circumstances be unable to carry out his obligations to his apprentice, he shall be allowed to transfer the apprentice to complete his term with another employer; but it shall be incumbent upon such former employer to notify the Clerk of the Court of Arbitration of the date of such transfer, and when such apprenticeship commenced. (Form 2 in Appendix hereto.)

(vi.) In the absence of indentures, apprentices shall be bound for the term and on the conditions herein provided, and subject to the following provisions :---

- (a.) Any employer taking an apprentice shall give notice thereof to the Clerk of the Court of Arbitration in the Form hereinafter provided (Form 1 in the Appendix hereto), and shall be deemed to undertake the duty which he agrees to perform as a duty enforceable under this Award, and shall, subject to the pro-visions of Subclause (xiii.) hereof, pay the apprentice the rate of wages herein provided :
- (b.) At the end of the period of apprenticeship the employer shall give the apprentice a certificate (Form 6 in Appendix hereto) to show that he has served his apprenticeship. Should the employer at any time before the termination of the term of apprenticeship desire to dispense with the services of the apprentice he may, with the consent of the apprentice, transfer him to another employer carrying on business within a reasonable distance of the original employer's place of business, willing to continue to teach the appendice, and to pay the wages prescribed by this Award according to the total length of time served, and generally to perform the obligations of the original employer. He shall also give to the apprentice a certificate of the time served and of the rate of wages paid, and shall give notice to the Clerk of the Court of Arbitration of such transfer in the form hereinafter provided (Form 2 in Appendix hereto). It shall not be obligatory upon the employer to find the apprentice another employer if he shall so misconduct himself as to entitle the employer to discharge him, but he shall, nevertheless, give him a certificate for the time actually served;
- (c.) An employer shall be deemed to fail in his duty towards his apprentice if he neglects to keep him constantly at work, but slackness of work may form a proper ground for transferring him to a master willing to undertake the responsibility of teaching him;
- (d.) When an apprentice is discharged for cause, the employer shall send notice in writing of the discharge and the cause thereof to the said Clerk of the Court of Arbitration. (Form 3 in Appendix hereto).

(vii.) Wages.—The minimum wage payable to an apprentice shall be :— During the first year of his apprenticeship—12s. 6d. per week; During the second year of his apprenticeship—£1 per week; During the third year of his apprenticeship—£1 7s. 6d. per week; During the fourth year of his apprenticeship—£1 15s. per week;
(viii.) Every apprentice shall be bound to submit himself for examination by a Board of the period the contributed of the contributed Examiners hereinafter constituted at the expiration of each period of one year of his service. Notice of his intention to submit himself for examination shall be given by the apprentice to the Clerk of the Court of Arbitration at least fourteen days before the termination of each yearly period, and may be given in the form numbered four of the Appendix hereto.

(ix.) Upon the receipt of such notice the Clerk of the Court of Arbitration will furnish the

apprentice with an examination certificate in the Form 5 of the Appendix hereto. (x.) The Clerk of the Court will notify the Board of Examiners of the names and addresses of all candidates desirous of submitting themselves to examination. The examination will The examination will be held at the place where the apprentice is employed, and it shall be the duty of each employer to provide such necessary material and machinery as may be required and in all ways to facilitate the conduct of the examination.

(xi.) The examination will be held in the month of February each year. The Board of Examiners will consist of the secretary of the workers' union, or such other person as may be nominated by the union in his stead, and a person skilled in the trade to be nominated by the employers carrying on business within the area to which this Award applies; or failing such of a disagreement between the members of the Board the matter in dispute shall be referred to a third person agreed to by them, or nominated by the Court or the President thereof at the request of either member, and the decision of such third person shall be final and conclusive. The Board of Examiners will examine the work of and inquire into the diligence of each appren-tice and as to the opportunities provided by the employer to each apprentice to learn.

(xii.) The Board will report to the Court in writing as to the result of the examination. Every apprentice shall be bound to produce to the Board of Examiners his examination certificate hereinbefore referred to, and the same shall be kept by the examiners, and returned to the apprentice with the necessary endorsement at the conclusion of the examination.

(xiii.) It shall be lawful for the employer to withhold the increase in wages accruing to the apprentice in accordance with the scale set forth in Clause 10, Subclause (vii.) hereof, from any apprentice who fails to satisfy the examiners. (xiv.) If the Board of Examiners reports to the Court that any employer has not provided sufficient opportunity for the apprentice to learn, the employer shall be deemed *prima facie* guilty of a breach of this Award under Section 90 of the Act, and may be summoned before the Court.

Upon any such proceeding the report may be received in evidence. (xv.) Such fees shall be paid by the Clerk to the examiners as the Court shall allow.

11. This Award is binding upon each of the above-named Industrial Unions and each of the above-named employers who carries on business within the area covered by the Award.
