WHEREAS by "The Land Act Amendment Act, 1904," it is provided that any Crown Lands may be declared to be a State Forest within the meaning and for the purpose of that Act, and that any Proclamation declaring any Crown Lands a State Forest may be rescinded, amended or annulled in part or in whole: Now, therefore, I the said Governor, acting with the advice of the Executive Council, and in exercise of the powers in this behalf conferred by the said Act, do hereby declare the land described in the schedule hereto a State Forest within the meaning and for the purpose of "The Land Act Amendment Act, 1904."

SCHEDULE.

Broad Arrow State Forest.

Bounded by lines starting from the 40-mile post on the East boundary of the Coolgardie Goldfield, and extending Westerly to an angle in the Kunnanalling-Black Flag telegraph Westerly to an angle in the Kunnanalling-Black Flag telegraph line; thence North-North-Westerly to a point one mile West of an angle, in the said Eastern boundary of the Coolgardie Goldfield, situate near the 31-mile post; thence North to a point one mile West of the 23-mile post on said East boundary of Coolgardie Goldfield; thence East one mile to said boundary, and along it North to the 9-mile post; thence East about three mile 30 chains to the Eastern side of the Kalgoorlie-Menzies Railway and along it North-Westerly and Northerly to the 59-mile post on the Coolgardie-Menzies telegraph line; thence East about 20 miles 50 chains Menzies telegraph line; thence East about 20 miles 50 chains to the West side of the Bardoc-Yerilla Road near the 19-mile post; thence South Westerly along said side of road for a distance of about 12½ miles; thence in a South-Easterly direction parallel to and at a distance of about six miles from the Kalgoorlie-Menzies Railway line to the Bardoc-Mulgarrie Road; thence South-Easterly about 31 miles to the 7-mile post on the Broad Arrow-Mulgarrie Road; thence South about 10 miles; West about 9½ miles, and South to the starting point.

The Roads Act, 1911. Yilgarn Road District. ORDER IN COUNCIL.

At the Executive Council Chamber, Perth, the 13th day of March, 1918.

WHEREAS by virtue of the powers conferred by the provisions of "The Roads Act, 1911," the Governor may by Order in Council abolish all or any of the Wards of a Road District, redivide any such district into Wards, define the boundaries of Wards and assign names to the same, and determine the number of members for each Ward: And whereas it is desirable to abolish the present Wards of the Yilgarn Road Board, redivide the same into Wards, define the boundaries of such Wards, and assign names to the same and determine the number of members for each Ward as in manner hereunder appearing: And whereas notice of intention so to do has been duly published and served in accordance with the terms of the said Act and no sufficient cause has been shown why the power proposed to be exercised should not be so exercised: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, and in exercise of the powers conferred on him by "The Roads Act, 1911," and of every other power enabling him in this behalf, doth hereby abolish the present Wards of the Yilgarn Road District, also declare the number of members for the district to be nine; and all members of the district shall go out of office on the 19th of April, 1918. The district shall be redivided into four Wards with the names and boundaries for each as set forth and described in Schedule A hereto. Also determine that the number of members for each Ward shall be as set forth in Schedule B hereto, and that an election shall be held on the 27th day of April,

Schedule A.

North Ward.—Bounded on the Westward, Northward, and Eastward by part of the District boundaries.

On the Southward by lines commencing at the inter-section of the Eastern boundary of the District with the Eastern Railway Reserve, and extending Westward along the Northern side of said Railway Reserve to the Eastern boundary of Southern Cross Townsite; thence following the Northern and part of the South-Western boundaries of said Townsite to again join the Eastern Railway Reserve, and Westward along said reserve, to the Western boundary of the District.

Southern Cross Ward .- Bounded by lines being the present boundaries of the Southern Cross Townsite.

Marvel Loch Ward .- Bounded on the Northward by lines commencing at the intersection of the Western boundary of the District with the Eastern Railway Reserve, and following the Northern side of said Railway Reserve to the South-Western boundaries of Southern Cross Townsite; thence along part of the South-Western, the Southern, and an Eastern boundary of said Townsite to again join the Railway Reserve, and along same to the Eastern boundary of the District.

On the Eastward by part of the District boundary.

On the Southward by an East and West line passing through to 18 M.P. on the surveyed line from Southern Cross to Tamarin from its intersection with the Eastern boundary of the District to the said 18 M.P.; thence along said surveyed line to about 16½ M.P. thereon; thence Westward to the Western boundary of the District.

On the Westward by part of the Western boundary of the District.

South Ward.—Bounded on the Northward by the Southern boundary of the Marvel Loch Ward.

On the Eastward, Southward, and Westward by part of the District boundaries.

Schedule B.

North Ward to be represented by three members. Southern Cross Ward to be represented by four members.

Marvel Loch Ward to be represented by one member. South Ward to be represented by one member.

The Vermin Boards Act, 1909. ORDER IN COUNCIL.

WHEREAS it is enacted by "The Vermin Boards Act, 1909," that the Governor may by Order in Council constitute any defined portion of the State a Vermin District for the purposes of the said Act, and may specify the boundaries of and assign a name to such

district: And whereas by the said Act it is further enacted that for every district there shall be a Board, which shall consist of so many members as may from time to time be prescribed by the Governor, and that until the first elections of the members of a Board the members shall be appointed by the Governor: Now therefore His Excellency the Governor, in exercise of the powers conferred by the said Act, doth hereby by and with the advice and consent of the Executive Council, constitute the Beverley Road District a Vermin District for the purposes of the said Act, under the name of the Beverley Vermin District, and with boundaries in every respect identical with the boundaries of the said road district: And in further exercise of the said powers His Excellency the Governor doth, with the advice and consent aforesaid prescribe eleven as the number of members which shall constitute the Board of the said vermin district, and doth appoint Frank Tyndall Broun, Francis McDonald, William Henry Bateman, James William Broun, Robert Charles Doncon, Frederick Rogers, Thomas Hick, Kenneth McLean, Frank Harrison Blechynden, James Davidson Weaver, and John William McGrath to be members of the Board of the said vermin district.

FREMANTLE HARBOUR TRUST.

Amendment of Regulations.

Colonial Secretary's Office,

HIS Excellency the Governor in Council has been pleased to approve of the following amendment of regulations made by the Fremantle Harbour Trust Commissioners on the 8th February, 1918.

S. BENNETT, Acting Under Secretary.

The Regulations made by the Fremantle Harbour Trust Commissioners and dated the tenth day of August, 1917, are hereby amended as follows, viz:-

1. By repealing Regulation No. 99, and enacting the following new Regulation in lieu thereof:-

No. 99.

General Dues.-All vessels except where otherwise specially provided for by these Regulations visiting the port of Fremantle shall pay in respect of each entry into the port, port dues as follows, viz:-

- (a) In respect of each complete hour calculated as laid down in Regulation No. 98, one twentyfourth of a penny for each ton of the gross registered tonnage of the vessel, and subject to a minimum charge equal to the charge for twelve hours.
- 2. By repealing Regulation No. 100.
- By repealing Regulation No. 101 and enacting the following new Regulation in lieu thereof:-

No. 101.

Vessels Anchored in Outer Harbour.—Vessels other than those included in Regulation No. 104 occupying a berth in the Outer Harbour other than at Owen Anchorage Jetty, shall pay the same rate of port dues as vessels included in Regulation No. 99, but only for such time as they may be actually engaged discharging or shipping cargo.

This provision shall include vessels discharging explosives or other cargo for their own convenience or otherwise and reshipping same.

By repealing Regulation No. 102 and enacting the following new Regulation in lieu thereof:-

No. 102.

Vessels berthed at Owen Anchorage Stock Jettv. -Vessels berthed at Owen Anchorage Jettv shall pay the same port dues as vessels berthed at a wharf in the Inner Harbour.

5. By repealing Regulation No. 103 and enacting the following new Regulation in lieu thereof:—

No. 103.

Coasting Vessels.—Coasting vessels in commission not exceeding 750 tons gross register shall pay half the rates of port dues provided for other vessels in like circumstances or like positions. Vessels shall be deemed to be in commission until such time as the owners thereof notify the Trust in writing that Vessels so laid they intend to lay their vessels up. up shall pay to the Trust a special lay-up fee of 10s. per week.

6. By repealing Regulation No. 104 and enacting the following new Regulation in lieu thereof:-

No. 104.

Vessels calling in distress for Orders, Supplies, etc.-Vessels arriving at the Port of Fremantle in

the circumstances, and for the purpose set out hereunder in this Regulation, shall pay as follows:

- (a) In distress, in duress, or for the purpose of being refitted or repaired, or employed solely in mission work in connection with some religious body, or as a pleasure yacht, and not engaged in trade or plying for hire: 25 per cent. of the amount of port dues set out in Regulations Nos. 99, 101, 102 and/or 103, whichever applies.
- (b) For orders or supplies, including bunker coal for the vessel's own use: 50 per cent. of the amount of port dues set out in Regulations Nos. 99, 101, 102 and/or 103, whichever applies.

Should it be found necessary in the case of a vessel arriving in the circumstances indicated in Subsection (a) hereinabove to discharge temporarily or otherwise eargo not originally intended to be discharged at the port, to enable repairs to be effected or to save loss, this will be permitted without payment of any additional rate of port dues.

Similarly, should it be found necessary in the case of a vessel arriving in the circumstances indicated in Subsection (b) hereinabove to discharge and reship cargo in order to comply with any Regulation of the Port, such will be permitted without payment of any additional rate of port dues.

HIS Excellency the Governor has been pleased to approve of the following amendments of the Food and Drug Regulations, 1913-15, recommended by the Advisory Committee under the provisions of "The Health Act, 1911-15."

Amendment of Food and Drug Regulations, 1913-15.

Whereas under the provisions of "the Health Act. 1911-15," His Excellency the Governor may make regulations, and may repeal, alter, or amend any regulations so made: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, and on the advice of the Advisory Committee, doth hereby make the following amendments of the Food and Drug Regulations, 1913-15:-

Regulations 44 to 49.

Wherever in Regulations numbered 44 to 49 the use of preservative is permitted, it shall be permissible for the preservatising substance benzoate of soda to be used as a substitute for either of the preservatising substances specified in such regulations, and in the proportion specified therein.

Schedule A.

Paragraph 12 to be deleted. Paragraph 15: Delete all words after "page 146," in the third line.

Paragraph 18:

Sub-paragraph (b): For the word "Saponifi-

able," in the first line, read "saponification."
