WHEREAS by Section 9 of "The Land Act, 1898," the Governor may resume, for any of the purposes specified in Section 39 of the said Act, any portion of land held as a Grazing Lease: And whereas it is deemed expedient that the portions of Kojonup Location 5042 (Grazing Lease 3244/68), as described hereunder, should be resumed for one of the purposes specified in paragraph 8 of Section 39 of the said Act, that is to say, for Townsite: Now therefore I, Sir William Grey Ellison-Macartney, Governor as aforesaid, with the advice of the Executive Council, do by this my proclamation resume portions of Kojonup Location 5042 (Grazing Lease 3244/68) for the purpose aforesaid.

WHEREAS it is enacted by "The Vermin Boards Act, 1909," that the Governor may by Order in Council constitute any defined portion of the State a Vermin District for the purpose of the said Act, and may specify the boundaries of and assign a name to such District: And whereas by the said Act it is further enacted that for every district there shall be a Board which shall consist of so many members as may from time to time be prescribed by the Governor, and that until the first elections of the members of a Board the members shall be appointed by the Governor: Now, therefore, His Excellency the Governor, in exercise of the powers conferred by the said Act, doth hereby, by and with the advice and consent of the Executive Council, constitute the Armadale-Kelmscott Road District a Vermin District for the purposes of the said Act under the name of the Armadale-Kelmscott Vermin District and with boundaries in every respect identical with the boundaries of the said Road District: And in further exercise of the said powers His Excellency the Governor doth, with the advice and consent aforesaid, prescribe nine as the number of members which shall constitute the Board of the said Vermin District, and doth appoint James Butcher, Anham Briggs, Frederick Barnes, Joseph Henry Champion, Albert Cornish, Henry Pancote, Walter Rowland Hand, Burnett Saltner Jobson, and William Henry Lockard to be members of the Board of the said Vermin District.

## POLICE BENEFIT FUND REGULATIONS.

Colonial Secretary's Office,  
Perth, 31st May, 1918.

HIS Excellency the Governor in Council has been pleased to approve the repeal of existing Police Benefit Fund Regulations and the substitution of the following therefor.

S. BENNETT,

1. These Regulations shall not apply to the Commissioner of Police nor to any person who prior to or since his appointment as a commissioned officer was paid a gratuity from the Western Australian Police Benefit Fund, but, subject as aforesaid, shall apply to every member of the Police Force.

2. The Fund shall be constituted as follows:—

- (a.) Such annual grant as may be voted by Parliament.  
(b.) A monthly deduction at the rate of three per cent. per annum from the pay of members of the Force, in accordance with the following scale:—

Members in receipt of 8/6 per day, a monthly deduction of	7/9

Inspectors and Chief Inspector, three per cent. per annum on their respective annual rates of pay.

- (c.) All fines imposed on the members of the Force.  
(d.) Proceeds of unclaimed stolen goods sold under Section 75 of "The Police Act, 1892."  
(e.) Fees and mileage received by members of the Police Force in serving process of a Local Court under "The Local Courts Act, 1904," or a Court of Petty Sessions under "The Justices Act, 1902," except such fees as are allowed to members of the Police Force duly appointed as Bailiffs under Police Regulation 410.  
(f.) Fees, mileage, and other expenses received by members of the Police Force in the service of a writ of execution of a warrant of the Supreme Court.

3. The Board shall consist of five members to be appointed from time to time by the Governor. One of such members shall be a member of the Executive Council, who shall be the Chairman of the Board; and two of such members shall be appointed on the nomination of the contributors to the Fund.

4. The nomination of members of the Board by the contributors to the Fund shall be by ballot to be taken by the Chairman of the Board.

5. The members of the Board (except the Chairman) shall hold office during the pleasure of the Governor, provided that a nominated member shall

not hold office without re-nomination and re-appointment for a longer period than three years.

6. Any member of the Force who entered the Service prior to the 14th day of December, 1917, and who may have served therein for twelve consecutive years or over shall be permitted to claim his discharge therefrom, and a gratuity of one month's pay for each year's service.

7. Any member of the Force who entered the Service on or after the 14th day of December, 1917, and who may have served therein for twelve consecutive years or over, shall be permitted to claim his discharge therefrom, and a gratuity on the following basis:—

Period of Service, and No. of Weeks' Salary for each Year of Service.
Over 12 and under 15 years—Two.
Over 15 and under 20 years—Two and two-thirds.
Over 20 and under 25 years—Three.
Over 25 years—Four.

8. Any member of the Force who may have served therein for seven consecutive years, and who may be reported on medical authority as unfit for further service, may claim a gratuity of one month's pay for each year's service; except members referred to in Regulation 7, who may claim a gratuity on the scale therein prescribed.

9. Any member of the Force compelled to leave the service from injuries received, or ill-health contracted in the execution of his duty, may claim a gratuity not exceeding one year's pay, in addition to any further claim he may have under these Regulations, provided that the Board may refuse any gratuity under this rule unless notice of the injuries or ill-health has been given by or on behalf of such member to the Commissioner of Police as soon as practicable after such injuries were received or such ill-health contracted and recorded on the personal file of such member.

10. The widow, or if there be no widow then the orphan (or orphans), or if there be neither widow nor orphan then the next of kin of any member of the Force who may have served therein for a period of seven years or over, may claim a gratuity not exceeding one month's pay for each year's service of the deceased; except in respect of members referred to in Regulation 7, the dependents of whom may claim a gratuity on the scale therein prescribed, provided the deceased member had served for a period of seven years or over.

11. The widow, or if there be no widow then the orphan (or orphans), or if there be neither widow nor orphan then the next of kin of any member of the Force who shall have lost his life in the discharge of his duty may claim a gratuity equal to one year's pay of the deceased, in addition to any further claim he might have had under these Regulations.

12. For the purposes of the foregoing Regulations, a gratuity based on one month's pay for each year of service shall be calculated on the basis of the average monthly rate of pay received for the last three years of service.

13. The widow, or if there be no widow, then the orphan (or orphans), or if there be neither widow nor orphan then the next of kin of any member of the Force who has served for a period of more than one year and less than seven years therein, may claim a gratuity of not more than £50.

14. The character and pecuniary position of the widow, and the number and pecuniary position of the children or next of kin, as the case may be, of the deceased member of the Force, will invariably be taken into consideration by the Board when recommending gratuities from this Fund, and it shall be lawful for the Board to apply the gratuity granted to such widow or orphans or next of kin for their benefit in such manner as the Board may deem fit.

15. It shall be competent for the Board to recommend the payment of gratuities in any deserving cases not comprised in the foregoing Regulations.

16. All claims for gratuities must be supported by such certificates, vouchers, or testimonials as may be reasonably required by the Board.

17. In calculating the amount of gratuity awarded in any case, the period of service shall count from the date at which a member of the Force commenced to contribute to the Fund; except in respect of members who were contributors prior to 20th May, 1908. In such cases the period of service shall count from the date of appointment to the Force.

18. The moneys described in Regulation 2 shall be paid by the Ministerial Accountant to the credit of an account in the Treasury to be called "Western Australian Police Benefit Fund Account," and moneys shall be drawn therefrom only on the approval of the Governor-in-Council.

19. The Board shall cause a proper record of receipts and disbursements made under these Regulations to be included in the books of the Ministerial Department, and such shall be audited every twelve months by the Auditor General, who shall affix his signature to the yearly statement, and every four years the condition of the Fund shall be examined by the Government Actuary, who shall report on such to the Board.

20. Of the amount to the credit of the Fund such sums as may be recommended by the Board shall be invested in Government Inscribed Stock or other approved security, and the balance, with all other moneys paid into the Treasury from time to time on account of the Fund, shall be payable to an account in the Government Savings Bank.

HIS Excellency the Governor in Executive Council has been pleased to make the following Regulations, under the provisions of "The Land Act, 1898," for the granting of leases for the collection and manufacture of Salt, as set out hereunder.

*Regulations.*

1. Leases may be granted under Section 152 of "The Land Act, 1898," for the collection and manufacture of salt of more than 500 acres in any one lease for a term of five years at a rental of Two pounds per annum for every 100 acres or portion thereof, and subject to the payment by the lessee of a royalty of Sixpence per ton on all salt marketed. The lease shall be in the form or to the effect of the Schedule of these Regulations.

2. Every application shall be accompanied by a deposit of rent as proscribed by Section 136 of the Act, together with the lease fee and registration fees. The cost of survey must, if so required by the Surveyor General, be paid by the applicant within 30 days of demand.

3. The lessee shall keep at least one man for every 100 acres constantly employed during the months of December, January, February, March, and April in each year, in gathering salt on the leased land.

4. No person or association of persons or company shall hold or be beneficially interested in more than 1,000 acres leased under these Regulations.

5. Adjoining leases granted under these Regulations, the aggregate area of which does not exceed 1,000 acres and held by the same person or association of persons or company may, with the approval of the Minister for Lands be deemed one lease in respect to the labour conditions, for such time as the Minister may think fit.

6. The Minister for Lands, may in his discretion, grant exemption from working the lease for any portion of the period referred to in Clause 3.

7. The lessee will be required to furnish returns half-yearly or otherwise as the Minister may direct of all salt collected and marketed, such returns to be verified by statutory declaration, and to produce his books of account for inspection on behalf of the Minister.

8. Every lease shall be granted on the condition that the Minister may authorise the construction of railways and tramways or the opening up of roads on the leased area on the application of any person or persons, and may grant permission to construct and use the same without compensation to the lessee, except so far as any improvements may be affected.

9. The lease will be liable to forfeiture if any of the prescribed conditions are not complied with to the satisfaction of the said Minister for Lands.

10. The lease will be open to renewal to the lessee at such rental and on such working conditions as may be prescribed at the termination of the period referred to in Regulation 1.

- (a.) IN pursuance of the powers in that behalf contained in Part VIII. of "The Municipal Corporations Act, 1906," the Municipal Council of the Town of Albany doth hereby make the following By-law:—

*Repeal.*

1. All By-laws hitherto made by the Municipal Council of the Town of Albany with reference to the matters herein contained are hereby repealed.

*Interpretation Clause.*

2. In the construction of this By-law:—
- The word "hoarding" shall mean a hoarding erected on private property for advertising purposes.
  - The word "occupier" shall mean the person having the use and control of a hoarding.
  - The word "owner" shall mean the owner of the land on which a hoarding is erected.
  - "Building Committee" shall mean the committee appointed by the Albany Municipal Council.
  - The word "Council" shall mean the Municipal Council of the Town of Albany.
  - The word "Municipality" shall mean the Municipal District of the Town of Albany.
  - The word "advertisement" shall mean and include, papers, bills, or posters, and all other advertisements of any nature, stencilled, painted, or embossed and affixed or placed in any way on walls, fences, or windows.

3. No person shall erect or cause to be erected a hoarding unless and until a plan and specification, showing clearly the position and size and the method of and materials to be used in the construction of, and the manner of fixing same, shall have been deposited with and approved by the Building Committee, and except in accordance with such plan and specification, and a license in the form of Part 1 of the schedule attached hereto has been issued by the Town Clerk.



4. No license shall be granted in respect of any hoarding erected either before or after the passing of this By-law, unless the distance from the face of the hoarding to the alignment of the nearest street or way shall be at least equal to the distance from the level of such street or way to the highest point of such hoarding, provided that in no case shall the height of any hoarding exceed twenty-one feet. The top of the hoarding shall be finished level and, save as provided in the succeeding section, in a straight line. The name of the owner of the hoarding may, however, be fixed immediately on the top of the hoarding near the centre of the length.

5. Every person erecting a hoarding, or the occupier or owner of a hoarding already erected at the corner of two streets, shall cause such hoarding to be rounded off or splayed off to its full height, as may be required by the Building Committee.

6. No person shall make any alteration or addition to any hoarding, unless and until the proposed alteration or addition shall have been approved in writing by the Building Committee through the Town Clerk.

7. If any hoarding is at any time, in the opinion of the Building Committee, in a dangerous or neglected condition, and the owner or occupier shall, upon receipt of a written notice to that effect, fail to forthwith remove or re-fix the same to the satisfaction of the Building Committee, the Council may remove the same and recover the cost of so doing from the owner or occupier.

8. The occupier of a hoarding shall maintain such hoarding to the satisfaction in all things of the Building Committee, and if any paper or other material affixed thereto becomes detached shall forthwith remove and clear away such paper or other material.

9. If in the opinion of the Council any bill, placard, or advertisement attached to or painted on any hoarding be objectionable, and the occupier or owner shall, upon receipt of a written notice to that effect, fail to at once remove or cause to be removed such bill, placard, or advertisement, the Building Committee or other person or persons authorised by the Council may remove the same and recover the cost of such removal from the occupier or owner.

10. All notices required under this By-law to be served on the owner or occupier shall in the first place be given by the Council to the occupier, but if he cannot be found then any such notice may be served upon the owner.

11. If the occupier or owner of any hoarding fails to comply with a written order of the Council within the time named in such order, the Building Committee or other person or persons authorised by the Council may carry out the requirements of the said order, and any costs incurred may be recovered by the Council from the occupier or from the owner.

12. No person shall attach, paste, or paint any bill, or other form of advertisement upon any hoarding in any part of the Municipality without having a valid and subsisting monthly or yearly license therefor from the Town Clerk in the form of Part 2 of the schedule hereto attached.

13. Every license issued by the Town Clerk under Sections 3 and 12 of this By-law shall terminate on the 31st day of October in each year.

14. The fee for a license under Section 3 shall be one shilling per superficial yard per annum. The fee payable for a monthly license under Section 12 of this By-law shall be seven shillings and sixpence (7s. 6d.), and the fee payable for a yearly license under Section 12 shall be Four pounds (£4). Full fees shall be charged for all licenses issued before the thirteenth day of April in each year, but for all licenses other than monthly licenses, issued between the first day of May and the thirty-first day of October in each year, half fees shall be charged, provided that in no case shall the charge be less than ten shillings (10s.).

15. Every hoarding shall at all times have the name of the occupier clearly shown in a conspicuous place on the front of the hoarding.

16. No person shall post, paint, stencil, place, or affix any advertisement on any fence or wall, footpath, or on any fence or wall, window, or other portion of any building facing or abutting on any street or way or public place within the Municipality.

17. The Council may permit the display of advertisements at theatres or other places of public amusement, and may permit the advertising of meetings or objects of national or general importance, under such

terms and conditions as the Council may in each case decide.

18. Applications for such permission shall be made in the form specified in Part 3 of the schedule hereto attached.

19. Any permission granted by the Council hereunder may be in the form specified in Part 4 of the said schedule.

20. The provisions of Section 16 of this By-law shall not apply to bills or advertisements posted on or affixed to signboards to the erection or maintenance of which the Council has consented, or to the advertisement by the occupier of any shop or dwelling on the windows thereof in respect of the business carried on by him therein, or to advertisements as allowed for and provided by the standard verandah specifications.

21. The use of any advertisement within the Municipality, otherwise than in accordance with this By-law, is hereby prohibited.

22. The occupier or owner of any premises within the Municipality on the walls, windows, or fences of which any bills are posted or any advertisements are painted, stencilled, placed, or fixed contrary to the provisions of this By-law shall, on receiving written notice from the Council so to do, remove same, and if the same are not removed within seven days from the giving of such notice then the Council may by its officers remove the same and recover from the owner or occupier in a court of summary jurisdiction the cost of so doing.

*Penalties for Breaches of By-laws.*

23. Where anything in this By-law is directed to be done or forbidden to be done, or where any authority is given to any officer to direct anything to be done or to forbid anything to be done and such act forbidden to be done is done, in every such case the person making default as to such direction and prohibition respectively shall be deemed guilty of a breach of this By-law, and every person guilty of a breach of this By-law shall be liable, for every offence, besides any costs or expenses which may be incurred in the taking of proceedings against such person guilty of such offence, to a penalty of Ten shillings (10s.) for the first breach of this By-law, and to a penalty not exceeding Twenty pounds for every succeeding breach of such By-law, or to a penalty not exceeding Two pounds (£2) for each day during which such breach shall be committed or continued, and in addition to such penalty shall be liable to pay to the Council any expense incurred by the Council in consequence of any breach or non-observance of any By-law, or in the execution of any work directed to be executed and not so executed. Provided that the minimum pecuniary penalty for any offence against this By-law other than the first offence shall be one-tenth of the maximum penalty hereby provided.

MUNICIPALITY OF ALBANY.

In pursuance of the powers in that behalf contained in Part VIII. of "The Municipal Corporations Act, 1906," the Municipal Council of the Town of Albany doth hereby make the following By-law:—

1. All By-laws heretofore made by the Municipal Council of the Town of Albany, with reference to the matters hereafter contained, are hereby repealed.

2. No person shall erect or maintain any sign, signboard, awning, blind, overhanging lamp, or other thing over or near any footway or roadway within the Municipality, without a written license from the Council or except in accordance with and upon the terms and conditions of such license.

3. A license to erect or maintain a sign or signboard (other than an illuminated sign), in connection with any building shall be granted only on and shall be subject to the following conditions:—

- (1.) In case where there is a verandah, the sign or signboard—
  - (a.) Shall be fixed on the outer plate or fascia of the verandah parallel with the kerb and shall be of maximum width of two feet; or
  - (b.) Shall be under the roof of the verandah securely and rigidly fixed to the T iron or rafter and following absolutely the contour of the verandah at right angles to the building line, and of a maximum width of 12 inches. Signs under the verandah may be fixed to each rib, provided that the minimum distance between any two signs shall be 12 feet.
- (2.) In cases where there is no verandah, the sign or signboard shall be of a maximum width of two feet, and
  - (a.) shall be securely bolted and attached to the wall without any intervening space and parallel with the building line; or
  - (b.) shall be securely bolted to the wall forming the building line with an inclination outwards from the base not exceeding six inches.
- (3.) In no case shall glass be permitted in the construction of the sign.
- (4.) Signs and signboards shall be so placed as to allow in all cases a headway of not less than nine feet from the lowest portion thereof to the surface of the footway, and where practicable not less than 10 feet.

4. A license to erect and maintain an illuminated sign shall be granted only on and shall be subject to the following conditions:—

- (1.) It shall be moved at any time when the Council shall so direct.
- (2.) It shall be lighted with an approved "illuminant" showing light on both sides.
- (3.) Details of the construction of the proposed sign shall be submitted to the Council, and when approved the sign shall be fixed to the approval of the Building Committee.
- (4.) It shall be kept in good order to the satisfaction of the Building Committee and the Town Clerk.

- (5.) The lettering or device on the sign shall be only such as is approved by the Council.
- (6.) The illumination shall not be sufficiently intense to cause annoyance to pedestrians.
- (7.) If the sign be of the flashing or "in and out" type, at least one-half of each side thereof shall be illuminated at all times whilst the same is in use.

5. All electrically lighted signs must be protected by ample single pole fuses and a double pole switch.

6. The sign may be removed by the Building Committee at the cost of the licensee in the event of any of the conditions of the license not being complied with.

7. Any sign fixed under a verandah shall not exceed the following dimensions: Depth, one foot four inches; width at top, one foot six inches, and at bottom twelve inches. If over four feet in length it shall be fixed close up to and follow the contour of the roof of the verandah, and must be securely and rigidly fixed in position. If not more than four feet in length, it may be fixed on the level, one end being close up to the roof of the verandah.

8. If the sign is over the verandah, or on a building having no verandah, it shall not project from the building line more than four feet, and shall be securely stayed and braced to render it rigid and immovable.

9. Chemists and doctors shall be allowed to exhibit an approved lamp—colour red—so fixed as to be seen up and down a street.

10. Sun-blinds shall be white or of a light colour, and no advertisement or writing of any kind shall be permitted thereon. They shall be so constructed that the lowest part thereof cannot hang lower than seven feet six inches above the level of the footpath.

11. All signs and signboards or other similar attachments erected at the time of enactment of this By-law, which do not comply with the conditions thereby prescribed, shall be removed within fourteen days after notice is given by the Council to remove the said signboard or other attachment. Provided that no existing sign or signboard shall be altered or repainted except in such manner as will cause it to conform with the foregoing conditions.

12. Applications and licenses for signboards and sun-blinds shall be in the form of Schedules Nos. 1, 2, 3, and 4 respectively.

13. The scale of fees more particularly specified in Schedule 5 to this By-law shall be the scale of fees to be paid by the person obtaining any license under this By-law.

14. Where anything by this By-law is directed to be done or forbidden to be done, or where authority is given to any officer to direct anything to be done or to forbid anything to be done, and such act so directed to be done remains undone or such act forbidden to be done is done, in every such case the person making such default as to such direction and prohibition respectively shall be deemed guilty of a breach of this By-law. And every person guilty of a breach of this By-law shall be liable for every such offence, besides any costs which may be incurred in the taking of proceedings against such persons guilty of such offence, as well as any costs or expenses which may be incurred in the execution of the work directed to be so executed and not so executed, to a penalty not exceeding Twenty pounds for every breach of any such By-law or to a penalty not exceeding Two pounds for each day during which such breach shall be committed or continued.

MUNICIPALITY OF WAGIN.

A BY-LAW of the Municipality of Wagin, made under Subsection (r), Section 181, of "The Municipal Corporations Act, 1906," and numbered 39.

In pursuance of the powers conferred by the said Act, the Mayor and Councillors of the Municipality of Wagin order as follows:—

By-law No. 39.

1. No person shall act as town herdsman until he is licensed for such purpose by the Council.
2. No person shall engage an unlicensed person to drive and depasture cattle over and upon park lands and public reserves within the municipality.
3. The licensing fee for a town herdsman shall be five shillings per annum, payable in advance.
4. The fee to be charged by the herdsman for minding cows shall be one shilling per week for each cow, payable by the owner to the herdsman.
5. The Council may, without giving any reason, cancel a herdsman's license by the giving of one fortnight's notice to that effect.
6. Any person offending against this By-law shall, upon conviction, forfeit and pay a sum not exceeding Five pounds.

#### GUILDFORD MUNICIPAL COUNCIL.

##### Resolution.

Whereas by Section 267 of "The Health Act, 1911-15," it is provided that the Governor may cause to be prepared Model By-laws for all or any of the purposes for which By-laws may be made by a Local Authority under any of the provisions of the said Act, and that a Local Authority may, of its own motion, by resolution adopt the whole or any part of such By-laws: And whereas Model By-laws have been prepared in accordance with the provisions of the said Section, and published in the *Government Gazette* on the 20th day of November, 1914: Now, therefore, it is resolved and determined by the Guildford Municipal Council, being a Local Health Authority within the meaning of the said Act, that the whole of such Model By-laws be adopted for the District of Guildford, with the following exceptions and amendments:—

##### PART I.—BY-LAWS.

By-law 1.—Delete the whole, and insert in lieu the following:—

##### Privies.

1. Every privy hereafter to be built must have a door and be properly enclosed, screened, and fenced from public view, and every house or other building hereafter to be erected shall have attached to it a privy of the following construction to the satisfaction of the Local Authority:—

The size above the floor internally not to be less than 3ft. 9in. by 4ft. 6in., and not less than 6ft. 6in. high, in clear height on the lowest side. It must also be sufficiently ventilated; the walls to be constructed of 4½in.

brickwork, lime-washed or plastered, jarrah or galvanised corrugated iron, and not to be erected closer than 3ft. to the boundary of the adjoining allotment, nor nearer than 20 feet to any business place or dwelling, unless with the express permission of the Local Authority, and must have proper provision for the removal and replacing of pans. The pan must be the regulation pattern, and if the floor of the privy is of wood, a metal tray at least two inches deep, with sufficient flushing apertures, must be fitted behind the riser for the reception of the pan. If the floor is not of wood it may be composed of concrete, slate, or some non-absorbent material, having a proper fall towards the door. Every privy seat shall be fitted with a closely fitting hinged aperture cover.

The levels of the seat and the floor shall be such that the top of the pan shall be within one inch of the underside of the seat.

By-law 2.—In subsection (a), after the word "walls," insert the words "and floor."

Subsection (b) to be deleted.

Subsection (d).—In the sixth line, delete the words "to a sewer or," and in the sixth and seventh lines, delete the words "of the pattern described by By-law 7."

Subsection (g).—In the last line, delete the words "to the satisfaction of," and insert in lieu thereof the words "when required by."

By-law 6.—Subsection (c) to be deleted; add new subsection, to read:—"All urinals to which the public have access after dark, whether situated on private property or otherwise, must during such time be kept lighted to the satisfaction of the Local Authority."

By-law 7.—In the second and third lines, delete the words "two pans, and such pans shall conform to the following specification," and insert in lieu thereof the words "one pan, and such pan and lid shall be obtained from and be in accordance with the specification of the Local Authority."

Subsections (a) to (f) to be deleted.

By-law 8 to be deleted.

By-law 12 to be deleted, and the following substituted therefor:—"Removals of nightsoil shall only be made by the Local Authority."

By-law 13, Subsection (a).—In the third line, delete the words "an inspector," and insert in lieu thereof the words "the Local Authority."

Delete all words after "receptacle," in the fourth line, and insert in lieu thereof the words "and lid to be in accordance with the specification of the Local Authority."

By-law 15.—Delete all words after the word "emptied," in the fifth line, and insert in lieu thereof "as frequently as the Local Authority may direct."

By-laws 16 and 20 to be deleted.

By-law 21.—Insert after the word "sides," in the second line, "if required by the Local Authority."

By-laws 22 and 22 (a) to be deleted.

By-law 24.—Add at the end the words, "This By-law will not apply in any case where liquid wastes are disposed of without nuisance on a cultivated area."

By-law 25.—Delete all words after the word "by," in the second line, and insert in lieu thereof "such means as are approved by the Local Authority."

By-law 25 (a).—Delete the whole.

By-law 26.—Delete the whole of subsections (a) and (d).

By-laws 29, 30, 33, and 34 to be deleted.

By-law 35 to be deleted, and the following inserted in lieu thereof:—

*Regulating and keeping of cattle or other animals.*

(1.) Every occupier or owner of a building wherein or whereon any horses, cattle, or other animals may be kept shall provide, in connection with such building or other premises, a suitable receptacle for dung, soil, filth, or other offensive or noxious matter which may be produced from time to time in the keeping of such animals.

(2.) Such receptacle shall be constructed in such a manner and of such material, and shall be maintained in such a manner so as to prevent the escape of any of the contents thereof or any leakage therefrom, and shall be properly covered.

(3.) The owner or occupier of such premises shall daily collect and put manure into receptacle, and at least once a week remove or cause to be removed all dung or other offensive matter from such receptacle.

By-law 37.—Subsection (a) to be deleted.

Subsection (b) to read—"No person shall keep any pigeons or poultry within 20 feet of any dwelling-house."

By-law 38.—All words after the words "purpose," in the fifth line, to be deleted.

By-laws 44, 45, 46, and 48 to be deleted.

Part IV., By-law 20.—Subsection (b) to be deleted.

Part VI. to be deleted.

Part X., Section A.—By-law 5 to be deleted.

Schedule "D."—Add at the end the words "Laundries nil."

Section "C."—By-law 2 to read as follows:—"No premises shall be registered as a piggery unless every portion of such piggery is at least two chains distant from any dwelling, street, or thoroughfare."

Section "C," By-law 3.—Delete all words after the word "enclosures," in the third line, and insert in lieu thereof the words "shall be of sufficient area and kept in a clean and satisfactory condition."

Subsection 3 (a) to be deleted.

By-laws 4 and 7 to be deleted.

Section "O," By-law 1.—Strike out the word "inspector," in the seventh line, and insert in lieu thereof the words "Local Authority."

#### *Morgues.*

Whereas under the provisions of "The Health Act, 1911-15," a Local Health Authority may make By-laws: Now, therefore, the Guildford Municipal Council, being the Local Health Authority for the Municipal District of Guildford, do hereby make the following By-law:—

1. The annual fee for a license for a place for the temporary reception of the bodies of the dead, and for keeping such bodies for the purpose of view, examination, identification, or other lawful purpose before burial or cremation, shall be £1.

2. Every license shall expire on the 31st day of October next after the day of its issue.

3. No such license shall be granted in respect of any premises unless—

(a) The walls thereof are constructed of stone or brickwork; and

(b) The interior surface of all walls is covered with glazed tiles or is rendered with some impervious material to be approved by the Board, so as to be non-absorbent and washable; and

(c) All floors are constructed of some impervious material to be approved by the Board, such as granolithic, or glazed tiles, laid upon a bed of 4in. concrete, having a fall to an outlet discharging over a trapped gully; and

(d) The premises are adequately ventilated by direct communication with the open air.

4. No such license shall be granted in respect of any room, the dimensions of which are less than 10ft. by 9ft. by 9ft. in height.

5. No such license shall be granted in respect of private premises unless the site thereof is approved by the Board, or if the same are within 20 feet of any dwelling-house.

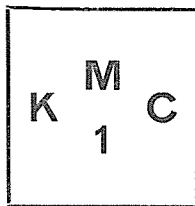
## MUNICIPALITY OF KALGOORLIE.

WHEREAS by "The Health Act, 1911," the Municipality of Kalgoorlie has power to make By-laws prescribing some place or places at which all fish, meat, or perishable food must be produced for inspection before being sold or offered or exposed for sale within the district: Now, therefore, in pursuance thereof the following By-law has been made by the said Municipality and shall come into operation from the date of publication in the *Government Gazette*:—

By-law No. 38.

*Inspection of meat before sale.*

1. No person shall sell, offer, or expose for sale within the Municipality of Kalgoorlie any meat unless such meat has been either inspected by the Government or other Meat Inspector appointed by the Commissioner of Public Health and marked with such brand or marks as may from time to time be prescribed by the said Commissioner, or inspected by the Health Inspector of the Municipality of Kalgoorlie and marked or branded with the following brand, that is to say, a brand consisting of a device in the shape of a square containing the letters "K.M.C." and a numeral in the centre, a *facsimile* of such being appended hereto:—



2. The following places are appointed at which all meat not already inspected by the Government or other Meat Inspector appointed by the Commissioner of Public Health and marked with such brand or marks as may from time to time be prescribed by the said Commissioner shall be exhibited for inspection:—

The Auction Mart of Peter Hansen, Hannan Street, Kalgoorlie.

The Auction Mart of the Associated Fruitgrowers, Hannan Street, Kalgoorlie.

The Kalgoorlie Municipal Markets, Hannan Street, Kalgoorlie.

The Kalgoorlie Railway Station, Forrest Street, Kalgoorlie.

3. All meat exhibited for inspection shall be exposed and hung for inspection in such positions in the appointed places as the Health Inspector of the Municipality of Kalgoorlie shall direct.

4. In this By-law the term "meat" shall mean all meat except ham, bacon, smoked, cured, or tinned meats, or game or poultry.

5. Any person who commits a breach of the above By-law shall be liable to a penalty not exceeding £20.

*Additions and Amendments to By-law No. 35.*

ADDITIONS and Amendments to By-law No. 35 of the Health By-laws of the Municipality of Kalgoorlie, made under Section 167 of "The Health Act, 1911," for prescribing precautions to be taken for the transport, storage, or carriage of meat and for the protection of meat from flies and dust when exhibited for sale.

In pursuance of the powers conferred by "The Health Act, 1911," the following alterations and amendments to By-law No. 35 have been made by the Mayor and Councillors of the Municipality of Kalgoorlie, and shall come into operation from the date of publication in the *Government Gazette*:—

1. In Clause 29 after the figures "29" insert in brackets the numeral "(i)."

2. In the same clause add another subclause numbered "(ii)" as follows:—

(ii.) Every person transporting meat to or storing or exhibiting meat for sale in any auction mart shall comply with the following conditions:—

(a.) The meat shall be effectively protected from dust and flies.

(b.) No meat so stored or exhibited for sale in any auction mart as aforesaid shall be deposited on the floor but all such meat shall be hung on hooks and clear of the floor.
