The Fisheries Act, 1905-13.

WHEREAS by Section 9 of "The Fisheries Act, 1905-13," it is provided that the Governor may, by Proclamation, prohibit all persons from taking any fish whatsoever, in every or any specified portion of Western Australian waters, by means of fishing nets and fishing lines, or either of such means of capture or by any other specified means of capture, for any specified term: Now therefore I, the said Governor, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid and of every other power enabling me in this behalf, proclaim and declare as follows:

That all that portion of Western Australian waters defined in the Schedule hereto shall be closed against the use of fishing nets and fishing lines for a period of twelve (12) months as from the date of the pulication of this Proclamation in the Government Gazette.

All that portion of the Avon River (near the townsite of York) lying between Gwambygine and the road which crosses the said river near Burges' Siding.

## Dedication of Public Highway. North Fremantle Municipality.

WHEREAS by Section 42 of "The Pearling Act, 1912," it is made lawful for the Governor to close any portion of a pearl-shell area and to prohibit the gatherregister of the parts and the promotion the gather-ing, collection, or removal of any pearls or pearl-shell within or from the portion so closed, for a specific period: And whereas it is deemed expedient that the whole of that portion of the Sharks Bay Pearl-shell Area known as South Passage Section, other than those portions held under Exclusive License, shall be closed, and that the gathering, collection, or removal of pearls or pearl-shells within or from the portion so closed shall be prohibited: Now, therefore, His Excellency the Gov-ernor, by and with the advice and consent of the Executive Council, hereby directs that the above-mentioned portion of the said Pearl-shell Area shall be closed, and that the gathering, collection, or removal of pearls or pearl-shells within or from the portion so closed shall be prohibited for a period of twelve (12) months from the date of the publication of this Order in the Government Gazette.

#### FIRE BRIGADES ACT. 1916.

Regulations providing for the Control and Attendance of Firemen on Duty on Public Buildings, and pre-scribing the Fecs to be paid by the Owner or Occu-pier of any such Building for such service, and for recovery thereof.

1. For the services of each fireman encloyed in accordance with regulations made under "The Fire Brigades Act, 1916," and published in the *Government Gazette* of the 16th day of November, 1917, a fee of 5s. per performance for each fireman shall be payable by the owner or occu; ier of the premises on which such f. eman shall have been employed.

2. In the event of any person failing to pay any fees due under Regulation 1 hereof, such fees may be re-covered summarily by complaint made by the fireman to whom such fees are due before any Justice of the Peace, in manner provided by "The Justices Act, 1902."

3. The Chief Officer of Fire Brigades may, in writing, grant permission for the owner or occupier of any public building to dispense with the services of a fireman during any exhibition of animated pictures held between the hours of sunrise and sunset.

4. All firemen approved by the Chief Officer under these regulations shall be subject to the direction and control of the Chief Officer of Fire Brigades.

5. Any person guilty of a breach of any of these regulations whether by act or omission or of any regu-lations heretofore made under "The Fire Brigades Act, 1916," shall be liable to a penalty not exceeding Twenty pounds.
