*The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909.*

## ORDER IN COUNCIL.

M.W.S. 458/20.  
WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister of Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend Water Works, Sewerage Works, and Stormwater Drainage Works; and whereas the preliminary requirements of the said Act have been complied with, and plans, sections, and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, does hereby empower the Minister of Water Supply, Sewerage, and Drainage to undertake the construction of the following works under the said Act, namely:—

### *Maylands Stormwater Drainage.*

Proposed extension to Seventh Avenue from Eighth Avenue through private property to Seventh Avenue, and along Seventh Avenue towards Guildford Road, as shown on Plan W.S., S., & D.D. No. 3710.

This Order in Council shall take effect from the 24th day of September, 1920.

#### GENERAL ORDER.

##### *The Legal Practitioners Act, 1893.*

WE, the Honourable Sir Robert Furse McMillan, Knight, Chief Justice of Western Australia, the Honourable Robert Bruce Burnside, the Honourable John Rooth, and the Honourable John Alfred Northmore, Puisne Judges of the Supreme Court of Western Australia, and we being a majority of the members of the Barristers' Board constituted and appointed under and in pursuance of "The Legal Practitioners Act, 1893," and of every other power us enabling, hereby make the following General Order, that is to say:—

That from and after this General Order has been published in the *Government Gazette* for a period of one calendar month, the total of any bill of costs for the remuneration of Practitioners of the Supreme Court of Western Australia, including Counsels' fees in respect of any business connected with sales, purchases, leases, mortgages, settlements, and other matters of conveyancing, and other business not being business in any action, suit, or proceeding, or transacted in any Court and not being otherwise contentious business, shall be increased by twenty-five per centum, and such increase shall be allowed upon the total of any amount allowed upon taxation of costs in respect of such business, in addition to the usual remuneration heretofore allowed on the taxation of costs in respect of such business.

THE following Amendment of the Supreme Court Rules is published for general information.

The Honourable Sir Robert Furse McMillan, Knight, Chief Justice of Western Australia, the Honourable Robert Bruce Burnside, the Honourable John Rooth, and the Honourable John Alfred Northmore, Puisne Judges of the Supreme Court of Western Australia, do hereby, in pursuance of the powers contained in "The Supreme Court Act, 1880," and of every other power them in this behalf enabling, make the following Rules, which shall come into operation one month after the

publication thereof in the *Government Gazette*, and may be cited as the Supreme Court Rules of 1920:—

#### ORDER LXV.

1. The following new Rules shall be inserted after Order LXV., Rule 8:—

##### *Order LXV., Rule 8a.*

The total of any bills of costs of the fees, including Counsels' fees prescribed by or allowed under this Order (as distinct from other payments) shall, in respect of business done in any cause or matter in the Supreme Court after this date, be increased by twenty-five per centum, and such increase shall be allowed upon any taxation of costs, in respect of any such business, as well between Party and Party as between Solicitor and Client, and in taxations under or pursuant to "The Legal Practitioners Act, 1893."

This Rule shall apply to all references to arbitration and to all Matrimonial, Divorce, and Probate proceedings, and to all criminal proceedings in the Supreme Court.

The increase hereby authorised shall not affect the question whether a bill of costs, when taxed, is or is not less by one-sixth part than the bill delivered, sent, or left.

Provided that this Rule shall not (a) affect the power to direct payment of a sum in lieu of costs under Order LXV., Rule 32, or the power to allow a fixed sum for costs under Order LXV., Rule 35 (39), or a gross sum under Order LXV., Rule 35 (40), or (b) apply to bills of costs which have, at the date on which this Rule comes into operation, already been delivered to the client sought to be charged therewith or to the person chargeable therewith or liable therefor or to bills then already taxed and certified or allowed.

4. Redivide the Geraldton-Chapman Road District when so united into Wards with the boundaries and names, also number of members allotted, as described in Schedule "D" hereto.
5. Dissolve the Geraldton Road Board.
