## Dedication of Public Highway.

### Claremont Municipality.

#### PROCLAMATION

WHEREAS by Sections 222 and 227 of "The Municipal Corporations Act, 1906" (6 Edwardi, No. 32), it shall be lawful for the Governor, on request of the Council, by notice in the *Government Gazette*, to declare any land reserved, used, or by purchase or exchange acquired for a street or way, or any place, bridge, or thoroughfare, to be a public highway, and such land shall thereupon and thenceforth, from the date of such Proclamation, become and be absolutely dedicated to the public as a public highway within the meaning of any law now or hereafter in force: And whereas the Claremont Municipal Council has requested that certain land named and described in the Schedule hereunder, which has been used for a street or way within the Municipality of Claremont, be declared a public highway: Now therefore I, the said Governor, by and with the advice and consent of the Executive Council, do by this my Proclamation declare the said land to be a public highway, and such land shall, from the date of this Proclamation, be absolutely dedicated to the public as a highway within the meaning of any law now or hereafter in force.

WHEREAS it is desirable to partially revoke the Proclamation published in the *Government Gazette* on the 11th day of November, 1910, declaring certain Goldfields State Forests: Now therefore I, the said Governor, with the advice and consent of the Executive Council, do hereby revoke the Proclamation published in the *Government Gazette* on the 11th day of November, 1910, whereby certain Goldfields State Forests were proclaimed, so far as such Proclamation extends to the following area, namely:—

An area bounded by lines starting from Mt. Korong trigonometrical survey station J.R. 34; thence East about 1,600 chains; thence South about 1,000 chains; thence West about 1,600 chains, passing through Mt. Margaret trigonometrical survey station; thence North about 1,000 chains to the starting point.

Road Board, or other person or persons to be named in the order, in trust for any of the purposes set forth in Section 39 of the said Act, or for the like or other public purposes to be specified in such order: And whereas it is deemed expedient that Reserve No. 17533 should vest in and be held by the Municipality of Narrogin, in trust for the purpose of Recreation: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the before-mentioned Reserve shall vest in and be held by the Municipality of Narrogin, in trust for the purpose aforesaid; subject, nevertheless, to the powers reserved to him by Section 41 of the said Act.

ORDER IN COUNCIL.

*The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909.*

ORDER IN COUNCIL.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister of Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend Water Works, Sewerage Works, and Stormwater Drainage Works: And whereas it is further provided that the Governor may exempt reticulation works from certain sections of this Act: Now, therefore, His Excellency the Governor, with the advice of the Executive Council, hereby approves of the construction and extension by the Minister of Water Supply, Sewerage, and Drainage of the following works under the said Act, and does hereby exempt such works from the operations of Sections 20, 21, 22, and 23 of the said Act:—

*Description and Location of Reticulation Works approved and exempted.*

METROPOLITAN WATER SUPPLY.

Extension of Mains in Congdon and Railway Streets, Cottesloe Municipality.

(a.) 3 inches diameter cast-iron water main along Railway Street, from Lot 1, Barnfield Road, to Congdon Street; length, about 14 chains.

(b.) 1½ inches diameter wrought iron water main along Railway Street, from Congdon Street Westward to end of existing main; length, about 2½ chains.

(c.) 1½ inches diameter wrought iron water main along Congdon Street, from Hillside Avenue Southward to end of existing main; length, about one chain.

(d.) 1½ inch valve to be fixed on 1½ inch wrought iron water main in Sea View Terrace, at junction of high level and low level water mains.

All mains provided with valves, hydrants, and necessary apparatus as indicated in red on Plan W.S., S., & D.D. No. 3745.

The Order in Council dated 1st September, 1920, and gazetted on 3rd September, 1920, dealing with these proposals as indicated on Plan W.S., S., & D.D. No. 3724, is hereby cancelled.

This Order in Council shall take effect from the 1st day of October, 1920.

HIS Excellency the Governor in Council has been pleased to approve the following amendment of Regulations made by the Bunbury Harbour Board on the 31st August, 1920, and 21st September, respectively.

*Regulation No. 61.*

Regulation No. 61 made by the Bunbury Harbour Board on the 1st October, 1909, and subsequent amendments made to same are hereby repealed, and the following Regulation enacted in lieu thereof:—

"Pilotage Charges.—Pilotage charges, except where otherwise provided for by these Regulations, shall be at the rate of twopence per ton on the net registered tonnage of each vessel, to cover both inward and outward pilotage.

The minimum charge shall be £4, and the maximum £20."

*Regulation No. 92.*

Regulation No. 92 made by the Bunbury Harbour Board on the 1st October, 1909, is hereby repealed, and the following Regulation enacted in lieu thereof:—

"Vessels calling for bunker coal, orders, passengers, or in distress, etc.—Vessels arriving at the Port of Bunbury for bunker coal, supplies, or orders, and not broaching or shipping cargo or landing and (or) embarking passengers not exceeding ten (10) in number shall not pay the harbour dues calculated as for ordinary traders, but shall in lieu thereof pay a consolidated rate to embrace all harbour dues, but not including pilotage and berthing dues, of £5 per entry into the port.

Vessels calling at the Port of Bunbury in distress and not broaching or shipping cargo or landing or embarking passengers shall be exempt from the payment of port dues and tonnage dues."

*Watermen's Fares.*

Schedule "B" to the Regulations made by the Bunbury Harbour Board on 1st October, 1909, is hereby repealed, and the following enacted in lieu thereof:—

1. Bringing Captain or other person from Bay to Jetty and taking same back again, if service is completed within one hour, 5s.
2. Ballast Ground, 10s. per trip to and from starting point.
3. Other services 5s. per hour, with a minimum of 5s. for one person; two persons, 2s. 6d. each per hour, minimum 5s.; three persons or more, 2s. each per hour, minimum 6s.
4. Fares from 7 p.m. to 7 a.m., double the foregoing rates.
5. Running lines and attending over-sea ships (steam and sail)—Inwards, 30s.; outwards, 15s.  
Running lines and attending coastal steamers—Inwards, 15s.; outwards, 15s.

All the above services are subject to the weather conditions being satisfactory, of which the Harbour Master shall be sole judge.

Harbour Master's orders are always to be obeyed.

Part I.—By-law 34.  
Part IV.—Schedule "C."

And whereas under the provisions of "The Health Act, 1911-19," a Local Authority may make By-laws: Now, therefore, the Melville Road Board, being the Local Health Authority within the meaning of the said

Act, doth hereby make the following By-laws to stand as By-law 34, and Schedule "C," By-law 4, respectively:—

Part I.—By-law 34. *Keeping of Swine.*

No person shall keep swine within the area of C.S. Location 8, known as Palmyra, Swan Location 70, known as Bicton, Swan Location 69, known as Haggood Estate, and the sub-divided area of Swan Location 73, known as Attadale and Melville Heights, and the sub-divided area of Swan Location 61, known as Applecross and Canning Bridge.

Part IV.—By-law 4. *Schedule "C."*

Fees to be paid for License and Registration in respect of the trade of a Dairyman, or Vendor of Milk, to be as follows:—

(a) In respect of the trade of a Dairyman, any person keeping cows to the number of:—

- (1) Not more than one, a fee of—5s. per year.
- (2) More than one, and not more than five—10s. per year.
- (3) Over five—20s. per year.

(b) In respect to the trade of Vendors of Milk—10s. per year.

(c) If the applicant is already licensed and his premises registered in another district—2s. 6d. per year.
