Redivision into Wards.

ORDER IN COUNCIL.

WHEREAS under the provisions of Section 8 of "The Road Districts Act, 1919," the Governor may, by Order in Council, re-divide a Road District into Wards; and whereas it is desirable to re-divide the Dowerin Road District into six Wards: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, under the provisions of the said Act, and all other powers enabling him in this behalf, doth hereby re-divide the Dowerin Road District into six Wards, with the names and boundaries and the number of members allocated to each Ward as described and defined in Schedule A hereto; and doth hereby appoint Mr. S. Griffiths as Returning Officer, and appoint the dates for the various events leading up to the Election as shown in Schedule B hereto.

SCHEDULE A.

Dowerin Road District.

Description of Ward Boundaries.

North Ward.—Bounded on the Northward and South-Eastward by part of the District boundaries, from the North-West corner of Avon Location 6114 (Reserve 9228) to the intersection of the Southern side of the Dowerin-Merredin Railway Reserve with the East boundary of Location 17186, and thence by the said side of the Railway Reserve to intersect the West boundary of Location 9617.

South-West Ward.—Bounded on the Northward by part of the South boundary of the North-West Ward, from the North-West corner of Location 20074 to the North-West corner of Location 12870.

On the Southward by lines commencing at the aforesaid South-West corner and extending Westward along the South boundary of Location 8905, part of the East, the South, and part of the West boundary of Location 13308, the South-West boundaries of Locations 10778 and 10780, the North boundary of Location 20910, the West boundary of Location 18407, a North and a West boundary of Location 16041, part of the North boundary of Location 14850, the North boundaries of Locations 7469, 7884, 16671, and 16670, part of the West boundary of Location 16670, a North boundary of Location 17153, the North and part of the West boundary of Location 10591, a North boundary of Location 19070, the West boundaries of Locations 8000 and 7814, part of the South boundary of Location 17142, the South and South-West boundaries of Location 20474, the South-West boundary of Location 17141, the North and part of the West boundary of Dowerin A.A. Lot 52 (Reserve 4240), the South boundary of Location 10595 to its South-West corner.

On the Westward by part of the District boundary, from the aforesaid South-West corner to the starting point. Exclusive of Dowerin Ward.—1 member.

South Ward.—Bounded on Northward by part of the North boundary of the South-West Ward, from the North-West corner of Location 20058 to the North-East corner of Location 20910.

PUBLIC CEMETERY RESERVE.

By-laws.

HIS Excellency the Governor in Executive Council has been pleased to approve of the following By-laws under the provisions of "The Cemeteries Act, 1897," and amending Acts for the management of the South Carolina Public Cemetery (Reserve 17263).

PUBLIC CEMETERY, SOUTH CAROLING.

By-Laws.

BY virtue of all powers in that behalf vested in the Trustees of the Public Cemetery, South Caroling, the said Trustees make the following By-laws:—

1. All fees and charges payable to the Trustees, as set forth in the Schedule A, shall be paid at the times and manner therein mentioned.

2. Any person desiring to inter any dead body in the cemetery shall make an application to the Trustees. Upon such application being approved by the Trustees, and upon payment of the prescribed fees, they shall cause to be issued to the person so applying an order for burial.

3. All applications for interment shall be made at least five working hours prior to the time fixed for burial. An extra charge shall be made for applications within such time. No free interment shall be allowed unless the application, together with the Justice's order therefor, be handed in in such time as to allow of at least five working hours as above.

4. The Trustees shall cause all graves to be dug, and vaults, brick graves, or graves to be re-opened as and when required.

5. Before any interment is allowed the "Order for burial" shall be handed to and retained by the grave-digger.

6. Every grave shall be at least six feet deep, and no interment shall be allowed in any grave with a less depth than four feet six inches from the top of the coffin to the original surface of the surrounding ground.

7. In the case of an application for interment in any private grave or vault to which the deceased had no claim during life, the written and verified consent of the grantee shall be handed in with the application.

8. No burial shall be allowed to take place in the cemetery unless a certificate from a District Registrar of Deaths that the death has been registered, or a Coroner's order for burial is handed to the Trustees.

9. The hours for burial shall be as follows:—

1st September to 30th April—Week days, from 8 a.m. to 6 p.m.; Sundays, from 2 p.m. to 6 p.m.

1st May to 31st August—Week days, from 8 a.m. to 5 p.m.; Sundays, from 2 p.m. to 5 p.m.;

and no burial shall be allowed to take place, nor any coffin allowed to enter the cemetery at any other hour except by written permission of the Trustees.

10. The time fixed for any burial shall be the time at which the funeral is to arrive at the cemetery gates, and such time shall be rigidly and punctually observed.

11. No hearse, mourning coach, or other vehicle shall enter the cemetery, or proceed except at and by such roads as directed by the officer of the Trustees from time to time. Any driver or other person failing or neglecting to observe such directions commits an offence against these By-laws.

12. Children under the age of ten years entering the cemetery must be in charge of some responsible person.

13. It shall be unlawful for any person to smoke within the cemetery, or to discharge any fireworks therein.

14. No dogs shall be allowed within the cemetery, and any person taking a dog into the cemetery commits an offence against these By-laws.

15. Any person violating the rules of propriety and decorum, or committing any nuisance or trespass, or injuring any tree, shrub, flower, border, or any erection, commits an offence against these By-laws.

16. No person shall promote, or advertise, or carry on within the cemetery any trade, business, or calling, either by solicitation, distribution of circulars, by cards, or otherwise, or by any other system of advertisement whatsoever.

17. No person employed by or under the Trustees shall accept any gratuity whatever, nor shall he be pecuniarily interested in any work in the cemetery other than the remuneration he receives from the Trustees; and any such person proved guilty of accepting any gratuity or being pecuniarily interested in any such work shall be liable to summary dismissal.

18. Any person requiring an "Exclusive right of burial" in any part of the cemetery shall apply to the Trustees, in writing, specifying the location of the grave, and whether it is proposed to erect a brick grave or vault, and in such case submitting plans and specifications of the proposed work. Such application shall also state the names of any already deceased persons whose remains it is proposed to inter therein.

19. Subject to the By-laws, the Superintendent shall exercise a general supervision and control over all matters pertaining to the cemetery, including the conduct of all funerals and interments within the cemetery.

20. Upon being satisfied of the matters aforesaid, and of the suitability of the said work, plans and specifications, the Trustees may authorise the construction and erection thereof; or, if no work is to be done, may issue a "Grant" in the Form "E" in the Schedule.

21. Upon the completion of the work aforesaid, the Trustees may, if and when such work is done to their complete satisfaction, issue a "Grant" in the Form "E" in the Schedule.

22. Every "Grant" shall be subject to the By-laws for the time being, and no interment in any such grave or vault shall be allowed unless upon production of the "Order for burial" aforesaid, nor shall any such grave or vault be opened, unless with the written consent of the Trustees.

23. Every coffin placed in any such bricked grave or vault shall be bricked in, cemented, and covered with a slab of stone, slate, or iron, unless special written exemption be obtained from the Trustees.

24. If application be made for an "Order for burial" in any grave or vault of the remains of any person other than the person to whom grant was issued, or his registered assign, the written and verified consent of such grantee or assignee shall be produced.

25. Any person desiring to place or erect any monument, tombstone, or enclosure in any part of the cemetery must first obtain the written consent and approval of the Trustees, and otherwise comply with Section 23 of "The Cemeteries Act, 1897."

26. Every tombstone, monument, or enclosure shall be placed on proper and substantial foundations, which if required by the Trustees shall extend to the bottom of the grave.

27. The materials used in every such erection shall be subject to the approval of the Trustees, and any material rejected shall be immediately removed from the cemetery by the contractor for the erection.

28. All refuse and other rubbish remaining after any work is completed shall be immediately removed from the cemetery by the person causing the same.

29. Monumental masons and other tradesmen shall, before commencing any work within the cemetery, deposit with the Secretary to the Trustees the sum of ten shillings, which shall be forfeited if either of the two last preceding By-laws are not complied with to the satisfaction of the Trustees.

30. All materials required in the erection and completion of any work shall, as far as possible, be prepared before being taken to the cemetery, and all materials required by tradesmen shall be admitted at such entrance as the Trustees shall direct; and no vehicle conveying any such material with wheels less than 4in. broad shall be permitted to enter the cemetery.

31. No catacomb shall be allowed.

32. All workmen, whether employed by the Trustees or by any other person, shall at all times, whilst within the boundaries of the cemetery, be subject to the supervision of the Trustees, and shall obey such directions as they may find it necessary to give; and any workman permitting any breach of these Regulations and By-laws or refusing or neglecting to comply with any directions of the Trustees commits an offence against these By-laws.

33. Any person taking part in dressing or attending to any grave shall comply with the following rules:—

- (a.) No rubbish, soil, sand, or other material removed in dressing a grave shall be placed on any other grave, and, if placed on any adjoining ground, shall be removed immediately the work is completed.

- (b.) No sand, soil, or loam shall be taken from any portion of the cemetery for the purpose of dressing any grave, except with the permission of the Trustees.

- (c.) The dressing of all graves and the wheeling and carting of all material shall be subject to the supervision of the Trustees.

- (d.) Work in all cases shall be carried on with due despatch, and only during regulation hours.

34. Any person who commits a breach of or an offence against these By-laws shall be liable to a penalty not exceeding Five pounds.

35. Any person who commits a breach of or an offence against any By-law may be expelled from the cemetery.

The foregoing By-laws, with the accompanying schedules, were duly framed and presented to a meeting of the Board of Trustees, held at their office at South Caroling on the 4th of December, 1920.

HIS Excellency the Governor in Executive Council has been pleased to make the following additional regulations under "The Mining Act, 1904," hereinafter referred to as the principal Act, as amended by "The Mining Act Amendment Act, 1920"; and to amend Regulations 80, 81, and 166; also to repeal Regulations 189 to 192 inclusive made under the provisions of the principal Act.

25a. (1.) A license to occupy Crown lands for the purposes of prospecting for mineral oil may, subject to the provisions of Part II. of "The Mining Act Amendment Act, 1920," be granted by the Minister and shall be in Form No. 71 in the Schedule.

(2.) Every such license granted shall be in force for a period to be fixed by the Minister, but not exceeding ten years, and shall, subject to these regulations, confer on the licensee the exclusive right to bore and search for mineral oil on the land thereon defined.

(3.) The said right shall extend only to prospecting for mineral oil, and shall be no bar to any prospector desiring to acquire a claim or lease for gold or mineral, other than mineral oil, or to any person desiring to

acquire a holding under "The Land Act, 1898," and its amendments: Provided that the land applied for does not include any of the licensee's workings which in the opinion of the Minister should be secured to the licensee.

25b. The right conferred by a licensee under Regulation 25a shall be subject—

- (a.) to the excision from the land authorised to be occupied of any land alienated or in the course of alienation, and of reserves or any land acquired or to be acquired and held under the provisions of the principal Act and its amendments, or of "The Land Act, 1898," and its amendments;
- (b.) to any amendments of the principal Act or Regulations thereunder;
- (c.) to cancellation by the Minister, or to amendment of the description of the occupied land by reduction of the area thereof by the Minister upon application by any person for a license to occupy any portion of the land occupied by a licensee if prospecting thereon by the licensee is not being carried out to the satisfaction of the Minister;
- (d.) to such further conditions as may, in the opinion of the Minister, from time to time be deemed necessary.

25c. The licensee shall comply with the provisions of Regulation 196a under the principal Act, and in addition, within seven days of the expiration of each month, furnish a statement of work done during the preceding month.

25d. The licensee shall carry out *bona fide* prospecting operations during the period of occupancy to the satisfaction of the Minister.

25e. No license shall be transferred without the approval in writing of the Minister first obtained.

25f. Before issue of an approved license the licensee shall enter into a bond to the amount of fifty pounds with a surety or sureties (if any) as the Minister may require, as security for the due performance or observance by the licensee or his transferee of the conditions of the license.

25g. The fee payable for a license shall be Five pounds per annum payable in advance. In default of payment of any such fee within one month after it becomes due the Minister may by notice in the *Government Gazette* cancel the license, and on publication of such notice the license shall be void.

25h. (1.) An application for a license to prospect Crown land for mineral oil shall be in or to the effect of Form No. 72 in the Schedule, and shall be delivered to the Principal Registrar, Department of Mines, Perth, and shall give the particulars required in the said form.

(2.) Application for a license shall be accompanied by a description and plan sufficient to identify the land the subject of the license.

25i. A monthly progress report, required under the provisions of Subsection 4 of Section 7 of "The Mining Act Amendment Act, 1920," shall disclose the amount and nature of all work done in searching for mineral oil by the licensee.

25j. Upon proof of the discovery of mineral oil in payable quantities by a licensee and such discovery being duly reported by him to the Minister, the licensee may within thirty days, or such further time as the Minister may in his discretion allow, apply for and obtain a mineral reward lease of six hundred and forty acres and two ordinary mineral oil leases of forty-eight acres each.

102a. The holder, owner, or manager of a mineral oil lease shall, within the first seven days of every month, furnish the Minister with a statement in duplicate in the Form No. 73 in the Schedule showing, with other particulars required thereon, the quantity of mineral oil obtained from the land during the last preceding month and the value or estimated value thereof.

102b. The royalty payable by the lessee under the provisions of Section 13 of "The Mining Act Amendment Act, 1920," shall be at the rate of not exceeding ten per centum of the gross value of all crude oil obtained from the land and shall be paid monthly.

Regulation 80 under the principal Act is amended by the addition thereto of the following:—

- (h.) For Mineral Oil—48 acres.
- (i.) For Mineral Oil (Reward) under Section 10 of "The Mining Act Amendment Act, 1920"—640 acres.

Regulation 81 under the principal Act is amended by the addition thereto of the following:—

"When the application is one for a mineral oil lease under "The Mining Act Amendment Act, 1920," the land may be "marked off" within twenty days, or such further time as the Minister allows after the application has been lodged."

Regulation 166 under the principal Act is amended by addition after the word "sufficient" of the words:—"or such hours as may be fixed by any arbitration award covering the district in which the mining tenement is situated."

Regulations 189 to 192 inclusive in Division 10 of the Regulations under the principal Act are hereby repealed, and the following Regulations are inserted in such Division:—

Division 10.—Tribute Agreements.

189. The provisions contained in Part III. of "The Mining Act Amendment Act, 1920," are hereby extended to claims.

190. The time within which a complaint by a tributer to the Warden under Section 32 of "The Mining Act Amendment Act, 1920," is to be lodged, may be extended by the Warden from seven to fourteen days if it is proved to his satisfaction that the complaint was not lodged within seven days by reason of illness of the tributer or other circumstance beyond his control.

191. (1.) Whenever assessors are required under the provisions of Section 36 of "The Mining Act Amendment Act, 1920," each party to the application or proceeding shall appoint a person to act as an assessor.

(2.) The appointment of an assessor shall be in the form or to the effect of Form No. 74 in the Schedule and shall be filed at the Warden's office at least seven clear days before the date of the hearing of the application or proceeding.

(3.) The Warden or the Mining Registrar shall notify the other party to the application or proceeding of the said appointment of an assessor, and such other party shall, three clear days before the date of the hearing, file notice of appointment of a person to act as an assessor.

(4.) Should the other party to the application or proceeding fail or neglect to so appoint an assessor the Warden may appoint an assessor.

(5.) The Warden or the Mining Registrar shall cause to be given to each assessor notice of the time and place appointed for the hearing.

(6.) Every assessor shall by writing under his hand signify his consent to act as an assessor.

192. If any assessor dies or resigns or declines to act, the party appointing him or the Warden, as the case may be, may forthwith appoint another assessor in his place, and the proceedings shall not abate or be thereby affected, but if the proceedings have been partly heard and either party so desires, the hearing shall be commenced *de novo*.

NOTES.

1. Cargo landed on wharves or jetties from a vessel in distress or for convenience of a vessel and reshipped by same vessel, 1s. per ton wharfage. Handling charges will be made according as said cargo is dealt with, on the same scale as other cargo.
2. Transhipment cargo is cargo appearing as such upon a vessel's manifest, or declared in writing to the Board before being transhipped direct ship to ship or being landed as being intended for transhipment into a vessel.
3. No wharfage dues will be charged in respect of ballast in the shape of stone, sand, shingle, or such like material transhipped overside vessel to vessel.
4. The Board will not supply labour to handle cargo transhipped overside vessel to vessel.
5. Cargo is allowed 48 hours' free storage in sheds, except transhipment cargo, which is allowed 72 hours.
6. Grain (as defined above), flour, agricultural and horticultural produce (including fruit), and coal, any of which being the product of the State of Western Australia, when brought into the Port of Bunbury for the purpose of transhipment for export beyond the State, shall be free of transhipping dues, but must pay handling charges incurred.
7. Cargo discharged (under Regulation 107) direct into trucks for consignment off the wharf will be charged at half handling rates, provided the Board receive only into trucks.
8. Goods from Foreign ports landed at Bunbury without transhipment in the Commonwealth (excepting rails, railway accessories, coal, coke, and kerosene) shall be charged wharfage at a reduced rate of 25 per cent.
9. Wool landed for reclassing, scouring, marking, dumping, etc., and reshipped, will be regarded as transhipment cargo on a certificate from the shipper that it was the same wool as originally landed.
10. Wharfage dues on bulk kerosene and other like oils will be per ton of 250 gallons. Handling charges will be subject to arrangement according as the oils are dealt with.
11. For extra handling and other charges on goods, see Regulations Nos. 109, 122, 123, 124, 125, 133, 134.
