Greeting:

KNOW Ye that I, the said Governor, acting with the advice of the Executive Council, do hereby appoint you to be Commissioners to inquire into and report upon the system of Public Elementary Education followed in the State of Western Australia, and the administration of the Acts relating thereto, and particularly, but without limiting the general scope of the inquiry, to deal with the following questions:—

- (1.) Is the State obtaining adequate value for its expenditure on education?
- (2.) Can the system be improved upon, and if so in what way, to make the system more fitting to the requirements of the State?
- (3.) Can the schools in the rural districts be made more useful to the settlers?
- (4.) Are there extravagancies, defects, or deficiencies in the system followed that can be remedied?
- (5.) Is the administration defective, and if so, in what particulars?

And I appoint you, the said Peter Board to be Chairman of the said Commission, and declare this to be a Royal Commission within the meaning of "The Royal Commissioners' Powers Act, 1902."

And I do hereby desire and request you, with as little delay as possible, to report to me in writing the result of your inquiries by virtue of this Commission.

The Boat Licensing Act, 1878.

ORDER IN COUNCIL.

WHEREAS it is enacted by "The Boat Licensing Act, 1878," that it shall be lawful for the Governor from time to time, with the advice of the Executive Council, to frame, regulate, and fix by a table or tables for that purpose to be made lists of fares and rates to be taken by the owners of all licensed boats, vessels, or steamers for conveying passengers in the different ports, harbours, rivers, and other waters within Western Australia, or any one or more of them: And whereas it is desirable to exercise the powers aforesaid, to the extent hereinafter indicated, in respect of the Port of Onslow: Now, therefore, His Excellency the Governor, acting with the advice of the Executive Council, doth hereby regulate and fix the fares and rates to be taken by the owners of licensed boats, vessels, or steamers for taking and conveying passengers from the Jetty at Onslow to any steamship, or to the Jetty from any such steamship, within the Port of Onslow, at the amounts mentioned and set out in the table hereunder appearing, that is to say:—

Table of Fares for conveying passengers from and to the Jetty at Onslow, to and from any steamship in the Port.

Fare for persons, except children not exceeding 12 years of age—4s. single; 6s. return.

Children not exceeding 12 years of age (except as hereinafter set out)—2s. single; 3s. return.

Children two years and under when carried in arms of person who has paid a fare—To be covered by the fare of the person carrying such child.

The Land Act, 1898.

ORDER IN COUNCIL.

Corr. No. 5392/11.

WHEREAS by Section 43 of "The Land Act, 1898," it is made lawful for the Governor, by Order in Council, without issuing any deed of grant, to place any Reserve under the control of any Municipality, Road Board, or other person or persons, as a Board of Management, and to empower such Board to make, repeal, and alter by-laws for the control and management of such Reserves, and prescribe fees for depasturing thereon, and for other purposes, such by-laws to be approved by the Governor and published in the *Government Gazette*: And whereas it is deemed expedient that Reserve 13862 for Common near Albany should be placed under the control of the Albany Road Board as a Board of Management: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby place the before-mentioned Reserve under the control of the Albany Road Board as a Board of Management, and doth empower such Board to make, repeal, or alter by-laws for the control and management of the said Reserve; for prescribing fees for depasturing thereon; for directing the manner in which such fees shall be imposed, paid, collected, and disposed of, and to impose penalties not exceeding in any case £5 for any breach thereof, and £2 a day for a continuing breach, but not more than £20 in the aggregate.

Coolgardie Road District.

Dissolution of Coolgardie Municipality and inclusion of the District thereof in the Coolgardie Road District; also the Division of the said Road District into Wards.

ORDER IN COUNCIL.

P.W. 6323/19.

WHEREAS under the provisions of "The Municipal Corporations Act, 1906," and "The Road Districts Act, 1919," the Governor may by Order in Council dissolve any Municipality and include the District thereof in any adjoining Road District: And whereas it is desirable to dissolve the Coolgardie Municipality and include the District thereof in the Coolgardie Road District, and to divide the Coolgardie Road District into Wards; and whereas notices of intention to do so have been duly given and published in accordance with the respective requirements of "The Municipal Corporations Act, 1906," and "The Road Districts Act, 1919": Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby dissolve the Coolgardie Municipality as from the 30th day of June, 1921, and include the District thereof in the Coolgardie Road District, and doth hereby divide the Coolgardie Road District into two Wards, with the names and boundaries, and the number of members to represent such Wards as set forth in the Schedule hereto.

Also that all assets and liabilities of the said Municipality shall continue with the Coolgardie Road Board.

To come into force on the 1st day of July, 1921.

ORDER IN COUNCIL.

WHEREAS the enactment contained in Section 74 of "The Constitution Act, 1889," by which the appointment of all public officers under the Government of the State is vested in the Governor in Council, does not apply to minor appointments which by Order in Council are vested in Heads of Departments or other officers or persons within the State: And whereas it is desirable that the minor appointments of all persons who are exempt from the provisions of "The Public Service Act, 1904," employed in the Colonial Secretary's Department should be vested in the several officers whose names or offices are set out in the schedule hereto: Now, therefore, His Excellency the Governor in Council, by and with the advice of the Executive Council, hereby cancels the Orders in Council of the 1st July, 1914, 13th September, 1916, and 5th November, 1919, vesting such appointments in the several officers whose names or whose offices are set out in the schedule to the Order, and ordains and declares that the power of making minor appointments to all positions which are exempt from "The Public Service Act, 1904," in each of the Sub-Departments mentioned in the first column of the schedule hereto shall be vested, and the same is hereby vested in the officer or each of the officers mentioned opposite thereto in the second column of the said schedule and in the person for the time being acting in the place of any such officer, with effect from 1st May, 1921.

REGULATIONS.

No. 122 of the Regulations made under "The Industrial Arbitration Act, 1912," on the 29th day of September, 1913, is hereby repealed, and the following Regulation shall stand in lieu thereof, that is to say:—

Compulsory Conference.

122. (1) A summons to a conference issued by the President under Section 120 of the Act may be according to the Form 76 in the Schedule hereto.

(2) A Special Commissioner appointed under Section 120A of the Act may require the attendance of any person at a conference under that section by requisition according to the Form 77 in the said Schedule.

(3) When the President or a Special Commissioner desires to refer to the Court all matters in dispute between the parties summoned to attend a conference under the said Section 120 or 120A, as to which no agreement has been arrived at, he may do so by transmitting to the Clerk of the Court a notice according to the Form No. 78 in the said Schedule. When such notice is sent by a Commissioner, he shall transmit therewith a copy of the requisition whereby he convened the conference.

(4) As soon as may be after the receipt of the said notice the clerk shall, if the President so directs, require by notice all or any of the parties concerned to file statements of their respective claims with him within a time to be limited in the notice; but failure of all or any of the parties to file claims or a claim shall not prevent the Court from dealing with the reference.

(5) Any party may forthwith after the filing of the claim of such party, apply to the President to fix a date for the hearing of the reference, and the President may fix a date accordingly.

(6) In case no party shall file any claim within the time limited for that purpose, or if no party shall, within a reasonable time, apply under this Regulation to the President to fix a date of hearing, the President may fix a date for the hearing, and the clerk shall thereupon send notice thereof to the parties.

(7) No reference shall be heard and dealt with by the Court unless such public notice as shall be directed by the President shall be given by the clerk of the date fixed for the hearing, and every such notice shall

require all persons desirous of intervening to give the clerk written notice of such desire before the date fixed for the hearing, and the Court may allow the intervention of any person giving such notice or of any other person if it shall appear to the Court to be just so to do.

(8) If any party fails to appear or be represented at the hearing, the Court may proceed in the absence of such party.

(9) The Court may require any notes of the proceedings at any conference held before the President or Commissioner to be produced to the Court, and may make such use of them as shall seem just.
