# REGULATIONS GOVERNING THE ADMISSION OF CADET DRAFTSMEN (ENGINEERING) AND CADET DRAFTSMEN (ARCHITECTURAL) IN THE PUBLIC WORKS AND WATER SUPPLY DEPARTMENT.

#### Conditions:

1. An applicant for appointment must not be more than twenty nor less than sixteen years of age. He will be required to produce a medical certificate to the effect that he is of sound constitution, and not affected with any physical infirmity which would interfere with the proper exercise of his profession. He shall produce satisfactory evidence as to his character.

Qualifications:

2. An applicant shall produce evidence of having passed :---

- (a) The Junior Certificate examination of the University of Western Australia in English, Mathematics, Physics, and any two other subjects; or
- (b) The Leaving Certificate examination of the University of Western Australia in English, Mathematics, Physics, and Applied Mathematics; or
- (c) Such other examination as shall in the opinion of the Engineer-in-Chief be equivalent thereto.

He shall produce a specimen of his plan drawing.

Competitive Examinations:

3. Applications will be invited by the Public Service Commissioner by advertisement, and in the event of more applications being received than the number of vacancies, a competitive examination may be held by the Department in trigonometrical computations, plotting, and plan drawing for Cadet Engineering Drafts-men, and in free-hand drawing, elements of perspective, and scale drawing for Cadet Architectural Draftsmen. **Probation:**

Examinations shall be conducted by a Board appointed by the Public Service Commissioner.

#### Studies:

9. During the term of service cadets will be expected to attend classes, whenever possible, at the University or Technical School or other approved institution, in their own time, for the study of subjects necessary to enable them to pass the qualifying examination preseribed in Section 8.

# Extension of Cadetship:

10. Should a cadet fail to pass the qualifying examination his term of service may, on the recommenda-tion of the Public Service Commissioner, be extended for a further period not exceeding two years, at the same re-muneration as that received for his fourth year of service.

#### Permanent Appointment:

11. A callet who has satisfactorily completed his cadetship and obtained his certificate of qualification shall (should be be so required) serve in the Public Service of the State for a period of three years, at a salary in accordance with the Public Service Commissince 's classification of the work upon which he is en-gaged but at not less than the rate of  $\pounds 204$  per annum.

Manual Training Assistants who have taken the two years' course in the Training College, and have passed the final examination satisfactorily, shall receive for the first two years the salary provided for ex-students with the 'B2,'' with an addition of £10, and in the third year the salary provided for 'B2'' Assistants, with the addition of £15.

If they have passed the examinations required for the 2nd Class Certificate, they will, after three years' good service, receive the salary provided for "B1" Assistants, with the addition of £15.

The same Goldfields Allowances will be given to Manual Training teachers as to other teachers (see Reg. 37).

Teachers of Manual Training may be required to take evening work in lieu of day work, without additional remuneration, for two evenings in the week; provided that two hours' work in the evening shall be considered equivalent to three hours in the day.

Head Teachers of country schools who teach Manual Training in fully equipped rooms shall receive the following additions to their salaries:—

Subsequent years, £20, if first year's work is thoroughly satisfactory.

Teachers who have duly qualified and who take a course of light woodwork in their schools will receive an addition of £5 to their salary.

#### REGULATIONS RELATING TO GOVERNMENT ASSAYS.

ASSAYS, Analyses, and Determinations of any Western Australian Ore or Rock will be made by the Staff of the Geological Survey, when not unduly interfering with official work, subject to the following conditions:—

1. Each sample must weigh at least 6ozs., but not more than 10lbs.

2. Each sample must be enclosed in a separate canvas bag or strong paper wrapper, with a slip of paper bearing the name and address of the sender; together with a private mark by which it may be readily identified.

3. The parcel must be forwarded prepaid addressed to-

#### The Government Geologist, Geological Survey Office, Perth.

4. A letter must be sent at the same time to the same address, stating for what metals the samples are to be assayed, or containing other instructions, as the case may be.

(N.B.-It is always advisable to keep duplicate samples of those submitted.)

5. Before any assay is made, the prescribed fee must be paid to the Government Geologist, or sufficient reasons, in accordance with Section 7 below, be furnished for having the samples treated free of cost.

6. The following Fees will be charged:-

  (b) Prospecting assay for Silver, Iron, Lead, Manganese, Copper, Graphite,

A reduction of 20 per cent. on the above amounts will be made in favour of any person submitting, in one parcel, five or more samples for identical treatment.

7. With the object of encouraging bona fide prospecting, free assays will be made under the following circumstances:---

- (a) The sample must have been obtained within the State, either from land not held under lease for mining purposes, or, if from land so held, it must be accompanied by a certificate from an Inspector of Mines, Mining Registrar, or other responsible Government officer, setting forth the circumstances which justify a free assay.
- (b) The exact locality where the sample was found must be disclosed.
- (c) The sample must be of sufficient promise to warrant an assay being made at the expense of the State.
- (d) Free assays will not be made of samples showing free gold, or of tailings or other metallurgical products, or of umpire samples.

8. With the object of encouraging the establishment of secondary industries, investigations will be made in the Laboratory free of charge under the following conditions, provided that evidence is submitted that such action is in the interests of the State:-

(a) Any samples submitted must have been found naturally occurring within the State or have been manufactured wholly or for the most part from raw materials so found.

- (b) The source of supply of the raw materials must be disclosed, and such details supplied regarding the materials and method of manufacture as are considered essential for the proper conduct of the investigations required.
- (c) No free examination will be made of manufactured articles or raw materials of foreign origin or connected with a process already firmly established in the State.

9. The Department reserves to itself the right of refusing to make any particular assay, and also the right of publishing the results of an assay made at the public expense, after the expiry of twelve months.

10. Specimens will be dealt with in the order of their arrival, at such times as do not interfere with regular departmental work.

#### WESTERN AUSTRALIAN GOVERNMENT RAILWAYS.

#### By-law No. 76.

#### Office of the Railway Commissioner, Perth, 18th June, 1921.

THE Commissioner of Railways, in pursuance of the powers conferred by "The Government Railways Act, 1904," hereby makes the following By-law for providing for the grant of licenses to porters plying for hire within the precincts of a railway, and for prescribing the conditions of such licenses (including the payment of a license fee), and also of the transfer or forfeiture thereof, and for the exclusion from Railway premises of all unlicensed porters plying for hire:---

#### 76. Licensed Luggage Porters.

1. No person shall ply for hire as a porter, at or in connection with any station vested in the Commissioner, unless duly licensed by the Chief Traffic Manager for that purpose.

2. No licensed porter shall be deemed to be in the employ of the Commissioner, and the Commissioner shall not be in any way liable for the acts or defaults of any porter to any person whether an employer of such porter or not.

3. Applications for a porter's license shall be in the handwriting of, and signed by, the applicant, and addressed to the Chief Traffic Manager, and shall give particulars of the candidate's age and previous employment, with any references or copies of testimonials as to character and fitness that the applicant may think fit to supply or submit.

4. Applicants for a license shall not be under the age of eighteen years nor more than fifty years of age, and shall be persons of sober habits and good moral character and address, and shall be able to read and write with facility.

5. If the Chief Traffic Manager approves of any candidate's application he may issue to him, upon payment of a fee of 10s., a license or renewal license (as the case may be) in the form, or to the effect, of that in the Schedule hereto, to be available for a period of twelve calendar months from the date thereof (unless sooner determined or revoked as hereinafter provided), at the station therein mentioned.

6. Before, or at the time of, the issue of any license or renewed license the applicant for the same shall, in addition to the payment of the prescribed fee, deposit with the Chief Traffic Manager a sum of ten shillings (10s.) as a security for the due and faithful performance by him of the duties of his calling.

7. Every porter shall, during the time he is on duty in connection with his calling, wear the cap, with the badge as lettered and numbered, supplied to him by the Commissioner, and shall be clean in his person, and tidily and suitably dressed.

8. Every porter shall observe, obey, and be bound by all general by-laws for the time being in force applicable to the conduct of persons while on railway premises not inconsistent with this present by-law, as well as any instructions for the time being in force issued generally to porters by the Station Master, and any instruction given to him specially by the Station Master, and shall observe, obey, and be bound by any directions that he may from time to time receive from the officers of the Commissioner authorised to give same.

9. Every porter for a single payment in respect of each trip or article carried, on being engaged by the person having control of luggage intended to be despatched by train or placed in the Parcels Office, shall torthwith take such luggage from the vehicle by which it was brought to the station, or from the person engaging him, as the case may require, and place the same in the railway carriage or on such part of the station as his employer may indicate, or take such luggage to the luggage office or cloak room if so directed by such employer, subject, nevertheless, so far as regards luggage intended to be despatched by train, to the following proviso—that is to say, if the luggage is intended to be carried in the luggage van of any train, or if the luggage is not of a kind, or is in quantity in excess of that permitted to be carried free by the passenger or passengers concerned, having regard to the class and train by which such passenger or passengers propose to travel, the porter shall take such luggage into the place appointed and hand the same over to the proper officer of the Commissioner to be dealt with by such officer. If any such luggage, after being weighed or checked and the charges or excess fare (if any) paid, is intended to be carried in the carriage with a passenger, the porter, if the proper officer sanction his doing so, shall without claim for further fee or payment, at the request of his employer, place the same in the carriage selected, or on such part of the station indicated by the employer.

Save as in this clause expressly provided, no porter shall further or otherwise interfere with or handle any luggage that may be intended to be conveyed in a luggage van.

10. Every porter for a single payment in respect of each trip or article carried, on being engaged by the person having the control of luggage arriving by passenger train, shall take charge of all such luggage entrusted to his care carried in the carriage with a passenger, or handed to him by his employer, or for which checks have been handed to him to claim at the van or elsewhere on the station, and shall forthwith convey and place such luggage in the vehicle indicated by his employer, or, if so directed, in the cloak room, or place it on such part of the station as the employer may direct.

11. Each porter shall be entitled to claim and be paid by the person employing him, in respect of his services, at the following rates and no more:---

- (a.) When a single article of luggage only has to be transported, 6d.
- (b.) When there are more articles than one to be transported, a charge of 9d. for two articles, and 1s. for three articles, will be made. In the event of the number of articles exceeding three but not more than one barrow-load, the maximum charge shall be 1s. 6d., and for each extra barrow-load, or trip necessarily undertaken by the porter in transporting such articles to or from the cab, tram, vehicle, railway carriage, parcels office, or part of station directed or appointed, as the case may be, the minimum or maximum charge shall apply, as the case may be.

12. Any porter into whose hands any luggage or other property may come which is not duly claimed, or any porter finding or noticing any luggage in a railway carriage or on the station apparently overlooked by the owner, shall forthwith convey the same to the Lost Property Office, and hand it over to the officer there in charge.

13. Upon the suspension of a porter, or at any time while such suspension remains in force, the porter, if required by the Chief Traffic Manager or Station Master, shall hand to the officer requiring the same his license and the cap with the badge supplied to him by the Commissioner, to be retained until such suspension ceases to be in force or license revoked. 14. Any porter may surrender or the Chief Traffic Manager may withdraw any license issued under this by-law by giving one calendar month's written notice, and after the expiration of one calendar month from the receipt of such notice by the person for whom it was intended the license to which it applies shall cease to be in force.

15. Upon the expiry or other sooner determination of a license otherwise than by revocation for misconduct the person named in the license, or his executors, administrators, or assigns, shall be entitled on demand to have returned the deposit money lodged by such person in connection with the issue of the license to him, or if the same has been reduced by any adjudication or suspension as hereinbefore provided, any balance thereof in the hands of the Commissioner.

16. In this By-law the following words and expressions, unless repugnant or inconsistent with the context, shall include the meanings thereby assigned to them:—

- "Luggage" includes any goods, articles, or things belonging to or over which any passenger or intending passenger by such train has any control, carried or intended to be carried by a passenger train.
- "Porter" means a luggage porter duly licensed under this By-law.
- "Station Master," when used without words of limitation, includes, in addition to the officer appointed Station Master or Acting Station Master, the officer for the time being on duty in charge of the station in the absence of the Station Master or Acting Station Master.
- "Chief Traffic Manager" shall mean the Chief Traffic Manager of the Western Australian Government Railways, or such other officer as may be nominated from time to time by the Railway Commissioner for Western Australia as the officer for the time being to issue or deal with the case of porters licensed under this By-law.
