THE following Order in Council was published by order of His Excellency the Governor in Executive Council on the 27th day of August, 1909, and is now re-issued in view of the fact that copies of the Government Gazette of that date are not available.

WHEREAS by an Act passed in a Session of Parliament held in the seventh and eighth years of Her late Majesty's reign (shortly entitled "The Judicial Com-mittee Act, 1844") it was enacted that it should be competent to Her Majesty by any Order or Orders in Council to provide for the admission of Appeals to Her Majesty in Council from any judgments, sentences, decrees or orders of any Court of Justice within any British Colony or Possession abroad, although such Court should not be a Court of Errors or Appeal within such Colony or Possession, and to make provision for the instituting and prosecuting of such Appeals, and for carrying into effect any such decisions or sentences as Her Majesty in Council should pronounce thereon:

And whereas by an Order in Council, dated the 11th of October, 1861, provision was made for Appeals from the Supreme Court of the Colony of Western Australia to Her Majesty in Council: And whereas the Colony of Western Australia is

now a State of the Commonwealth of Australia constituted by an Act passed in a Session of Parliament held in the sixty-third and sixty-fourth years of Her late Majesty's reign and entitled "An Act to con-stitute the Commonwealth of Australia":

And whereas it is expedient, with a view to equalising as far as may be the conditions under which His Majesty's subjects in the British Dominions beyond the Seas shall have a right of Appeal to His Majesty in Council and to promoting uniformity in the practice and procedure in all such Appeals, that the said Order in Council, dated 11th of October, 1861, should be revoked and new provision made for Appeals from the said Supreme Court to His Majesty in Council:

It is hereby ordered by the King's Most Excellent Majesty, by and with the advice of His Privy Council, that the said Order in Council be and the same is hereby revoked, and that instead thereof the Rules hereunder set out shall regulate all Appeals to His Majesty in Council from the said State of Western Australia.

1. In these Rules, unless the context otherwise requires :-

- Appeal" means Appeal to His Majesty in Council; "His Majesty" includes His Majesty's heirs and successors; "Judgment" includes decree, order, sentence, or de-
- cision;
- "Court" means either the Full Court or a single Judge of the Supreme Court of Western Australia according as the matter in question is one which, under the Rules and Practice of the Supreme Court, properly appertains to the Full Court or to a single Judge; "Record" means the aggregate of papers relating to
- an Appeal (including the pleadings, proceedings, evidence, and judgments) proper to be laid be-fore His Majesty in Council on the hearing of
- the Appeal; "Registrar" means the Registrar or other proper officer having the custody of the Records in the Court appealed from; "Month" means calendar month;

Words in the singular include the plural, and words in the plural include the singular.

2. Subject to the provisions of these Rules, an Appeal shall lie-

- (a) as of right, from any final judgment of the Court, where the matter in dispute on the Appeal amounts to or is of the value of £500 sterling or upwards, or where the Appeal involves, directly or indirectly, some claim or question to or respecting property or some civil right amounting to or of the value of £500 sterling or upwards; and
- (b) at the discretion of the Court, from any other judgment of the Court, whether final or interlocutory, if in the opinion of the Court the question involved in the Appeal is one which, by reason of its great general or public importance, or otherwise, ought to be submitted to His Majesty in Council for decision.

3. Where, in any action or other proceeding, no final judgment can be duly given in consequence of a difference of opinion between the Judges, the final judgment may be entered *pro jormâ* on the application of any party to such action or other proceeding according to the opinion of the Chief Justice, or, in his absence, of the senior pulse Judge of the Court, but such judgment shall only be deemed final for purposes of an Appeal therefrom, and not for any other purpose.

4. Applications to the Court for leave to appeal shall be made by motion or petition within twenty-one days from the date of the judgment to be appealed from, and the Applicant shall give the opposite party notice of his intended application.

5. Leave to appeal under Rule 2 shall only be granted by the Court in the first instance:---

- (a) upon condition of the Appellant, within a period to be fixed by the Court, but not exceeding three months from the date of the hearing of the application for leave to appeal, entering into good and sufficient security, to the satisfaction of the Court, in a sum not exceeding £500, for the due prosecution of the Appeal, and the payment of all such costs as may become payable to the Respondent in the event of the Appeallant's not obtaining an order granting him final leave to appeal, or of the Appeal being dismissed for non-prosecution, or of His Majesty in Council ordering the Appellant to pay the Respondent's costs of the Appeal (as the case may be); and
 (b) upon such other conditions (if any) as to the
- (b) upon such other conditions (if any) as to the time or times within which the Appellant shall take the necessary steps for the purpose of procuring the preparation of the Record and the dispatch thereof to England as the Court, having regard to all the circumstance of the case, may think it reasonable to impose.

case, may think it reasonable to impose. 6. Where the judgment appealed from requires the Appellant to pay money or perform a duty, the Court shall have power, when granting leave to appeal, either to direct that the said judgment shall be carried into execution or that the execution thereof shall be suspended pending the Appeal, as to the Court shall seem just, and in case the Court shall direct the said judgment to be carried into execution, the person in whose favour it was given shall, before the execution thereof, enter into good and sufficient security, to the satisfaction of the Court, for the due performance of such Order as His Majesty in Council shall think fit to make thereon.

7. The preparation of the Record shall be subject to the supervision of the Court, and the parties may submit any disputed question arising in connection therewith to the decision of the Court, and the Court shall give such directions thereon as the justice of the case may require.

8. The Registrar, as well as the parties and their legal Agents, shall endeavour to exclude from the Record all documents (more particularly such as are merely formal) that are not relevant to the subject-matter of the Appeal, and generally to reduce the bulk of the Record as far as practicable, taking special care to avoid the duplication of documents and the unnecessary repetition of headings and other merely formal parts of documents; but the documents omitted to be copied or printed shall be enumerated in a list to be placed after the index or at the end of the Record, 9. Where in the course of the preparation of a Record one party objects to the inclusion of a doc.ment on the ground that it is unnecessary or irrelevant, and the other party nevertheless insists upon its being included, the Record, as finally printed (whether in Western Australia or in England), shall, with a view to the subsequent adjustment of the costs of and incidental to such document, indicate in the index of papers, or otherwise, the fact that, and the party by whom, the inclusion of the document was objected to.

10. The Record shall be printed in accordance with the Rules set forth in the Schedule hereto. It may be so printed either in Western Australia or in England.

11. Where the Record is printed in Western Australia, the Registrar shall, at the expense of the Appellant, transmit to the Registrar of the Privy Council 40 copies of such Record, one of which copies he shall certify to be correct by signing his name on, or initialling, every eighth page thereof and by affixing thereto the seal, if any, of the Court.

12. Where the Record is to be printed in England, the Registrar shall, at the expense of the Appellant, transmit to the Registrar of the Privy Council one certified copy of such Record, together with an index of all the papers and exhibits in the case. No other certified copies of the Record shall be transmitted to the Agents in England by or on behalf of the parties to the Appeal.

13. Where part of the Record is printed in Western Anstralia and part is to be printed in England, Rules 11 and 12 shall, as far as practicable, apply to such parts as are printed in Western Australia and such as are to be printed in England respectively.

14. The reasons given by the Judge, or any of the Judges, for or against any judgment pronounced in the course of the proceedings out of which the Appeal arises shall by such Judge or Judges be communicated in writing to the Registrar, and shall by him be transmitted to the Registrar of the Privy Council at the same time when the Record is transmitted.

15. Where there are two or more applications for leave to appeal arising out of the same matter, and the Court is of opinion that it would be for the convenience of the Lords of the Judicial Committee and all parties concerned that the Appeals should be consolidated, the Court may direct the Appeals to be consolidated and grant leave to appeal by a single order. 16. An Appellant who has obtained an order granting him conditional leave to appeal may at any time prior to the making of an order granting him leave to the making of an order granting him final leave

16. An Appellant who has obtained an order granting him conditional leave to appeal may at any timprior to the making of an order granting him final leavto appeal withdraw his Appeal on such terms as to cost, and otherwise as the Court may direct.

and otherwise as the bourt may interact 17. Where an Appellant, having obtained an orde, granting him conditional leave to appeal, and having complied with the conditions imposed on him by such order, fails thereafter to apply with due diligence to the Court for an order granting him final leave to appeal, the Court may, on an application in that behalf made by the Respondent, rescind the order granting couditional leave to appeal, notwithstanding the Appellant's compliance with the conditions imposed by such order, and may give such directions as to the costs of the Appeal and the security entered into by the Appellant as the Court shall think fit, or make such further or other order in the premises as, in the opinion of the Court, the justice of the case requires. 18. On an application for final leave to appeal, the

18. On an application for final leave to appeal, the Court may inquire whether notice, or sufficient notice, of the application has been given by the Appellant to all parties concerned, and, if not satisfied as to the notice given, may defer the granting of the final leave to appeal, or may give such other directions in the matter as in the opinion of the Court the justice of the case requires.

19. An Appellant who has obtained final leave to appeal shall prosecute his Appeal in accordance with the Rules for the time being regulating the general practice and procedure in Appeals to His Majesty in Council.

20. Where an Appellant, having obtained final leave to appeal, desires, prior to the dispatch of the Record to England, to withdraw his Appeal, the Court may, upon an application in that behalf made by the Appellant, grant him a certificate to the effect that the Appeal has been withdrawn, and the Appeal shall thereupon be deemed, as from the date of such certificate, to stand dismissed without express Order of His Majesty in Council, and the costs of the Appeal and the security entered into by the Appellant shall be dealt with in such manner as the Court may think fit to direct.

21. Where an Appellant, having obtained final leave to appeal, fails to show due diligence in taking all necessary steps for the purpose of procuring the dispatch of the Record to England, the Respondent may, after giving the Appellant due notice of his intended application, apply to the Court for a certificate that the Appeal has not been effectually prosecuted by the Appellant, and if the Court sees fit to grant such a certificate, the Appeal shall be deemed, as from the date of such certificate, to stand dismissed for nonprosecution without express Order of His Majesty in Council, and the costs of the Appeal and the security entered into by the Appellant shall be dealt with in such manner as the Court may think fit to direct. 22. Where at any time between the order granting

22. Where at any time between the order granting final leave to appeal and the dispatch of the Record to England the Record becomes defective by reason of the death, or change of status, of a party to the Appeal, the Court may, notwithstanding the order granting final leave to appeal, on an application in that behalf made by any person interested, grant a certificate showing who, in the opinion of the Court, is the proper person to be substituted or entered on the Record in place of, or in addition to, the party who has died or undergone a change of status, and the name of such person shall thereupon be deemed to be so substituted or entered on the Record as aforesaid without express Order of His Majesty in Council.

23. Where the Record subsequently to its dispatch to England becomes defective by reason of the death, or change of status, of a party to the Appeal, the Court shall, upon an application in that behalf made by any person interested, cause a certificate to be transmitted to the Registrar of the Privy Council showing who, in the opinion of the Court, is the proper person to be substituted, or entered, on the Record, in place of, or in addition to, the party who has died or undergone a change of status.

24. The Case of each party to the Appeal may be printed either in Western Australia or in England, and shall, in either event, be printed in accordance with the Rules set forth in the Schedule hereto, every tenth line thereof being numbered in the margin, and shall be signed by at least one of the Counsel who attends at the hearing of the Appeal, or by the party himself if he conducts his Appeal in person.

25. The Case shall consist of paragraphs numbered consecutively, and shall state, as concisely as possible, the circumstances out of which the Appeal arises, the contentions to be urged by the party lodging the same, and the reasons of Appeal. References by page and line to the relevant portions of the Record as printed shall, as far as practicable, be printed in the margin, and care shall be taken to avoid, as far as possible, the reprinting in the Case of long extracts from the Record. The taxing officer, in taxing the costs of the Appeal, shall, either of his own motion or at the instance of the opposite party, inquire into any unnecessary prolixity in the Case, and shall disallow the costs occasioned thereby.

thereby. 26. Where the Judicial Committee directs a party to bear the costs of an Appeal incurred in Western Australia, such costs shall be taxed by the proper officer of the Court in accordance with the Rules for the time being regulating taxation in the Court.

27. The Court shall conform with, and execute, any Order which His Majesty in Council may think fit to make on an Appeal from a judgment of the Court in like manner as any original judgment of the Court should or might have been executed.

· 28. Nothing in these Rules contained shall be deemed to interfere with the right of His Majesty, upon the humble Petition of any person aggrieved by any judgment of the Court, to admit his Appeal therefrom upon such conditions as His Majesty in Council shall think fit to impose.

WHEREAS His late Majesty was pleased by His Order in Council dated the 21st day of December, 1908, and made on a representation from the Judicial Committee of the Privy Council, to approve certain Rules entitled 'The Judicial Committee Rules, 1908,' for regulating the Practice and Procedure in Appeals and other matters before the said Judicial Committee:*

"The Lords of the Judicial Committee having taken into consideration the List of Fees allowed to Agents conducting Appeals and other matters before Their Lordships contained in Schedule C.I. to the Judicial Committee Rules, 1908, and being of opinion that the total in all Bills of Costs brought in for taxation from the date of Your Majesty's Order herein of the fees prescribed by the said Schedule ought to be increased by thirty-three and a third per centum, and that such increase ought to be allowed upon all taxations of costs in respect of such Appeals and other matters as well between Party and Party as between Solicitor and Client, Their Lordships do this day agree humbly to represent to Your Majesty accordingly."

And whereas there was this day read at the Board a representation from the said Judicial Committee, dated

the 7th day of March, 1921, in the words following:-"The Lords of the Judicial Committee, having taken into consideration the List of Council Office Fees, chargeable to parties to appeals and other matters before Their Lordships, contained in Schedule C. II., to the Judicial Committee Rules. 1908, and being of opinion that the said Schedule ought to be amended as follows:--(1) By inserting after the words 'Lodging Petition of Appeal $\pounds 2$ ' the words 'Lodging Petition for special leave to appeal $\pounds 2$,' (2) By inserting after the words 'Set-ting down Appeal (chargeable to Appellant only) $\pounds 2$ ' the words 'Setting down Petition for special leave to appeal (chargeable to Petitioner only) $\pounds 2$,' (3) By deleting the words 'Setting down Petition (chargeable to Petitioner only) $\pounds 1$ ' and sub-stituting therefor the words 'Setting down any other Petition, (chargeable to Petitioner only) $\pounds 1$ other Petition (chargeable to Petitioner only) $\pounds 1$, and (4) By deleting the item 'Summons 10s.' and substituting therefor 'Summons $\pounds 1$.'

Their Lordships do this day agree humbly to represent to Your Majesty that it is expedient that the said Schedule C. II. should be amended as set out in the Schedule to this Order accordingly, and that, as so amended, the same should come into operation on the 1st day of April, 1921."

PURSUANT to the powers conferred upon me by "The Government Railways Act, 1904," I hereby make the By-law set forth hereunder, to come into operation on the first day of July, 1921, and do hereby repeal all Regulations and Instructions in force at the coming into operation of this By-law, in so far as they are in conflict with any of its provisions.

BY-LAW No. 66.

This By-law may be cited and known as the "West Australian Government Railways Salaried Staff By-law," and will have application to all Officers who are engaged for the working and maintenance of the West Australian Government Railways.

2. Interpretation.

(a) "Head of Branch" shall mean the Secretary for Railways, Chief Traffic Manager, Chief Mechanical Engineer, Chief Engineer Way and Works, Chief Ac-countant, Auditor of Receipts, and Comptroller of Stores, or such other Head as may hereafter be appointed.

(b) "Officer" shall mean any person who is in receipt of an annual salary.

(c) "Permanent" shall mean an Officer who has served the full period of probation and whose appoint-ment has been confirmed by the Commissioner.

(d) "Temporary" shall mean a person who is en-(a) Temporary shall head a person who is en-gaged upon probation or upon work which, in the opinion of the Head of the Branch, is not likely to necessitate a permanent appointment, whose term of employment shall in all cases be at the discretion of the Head of the Branch.

Appointment to the Service. 3.

(a) Applications for admission to the Service must be made on the usual Departmental form.

(b) When Junior Clerks are required, applications will be invited by public advertisement.

(c) The form must be filled in in the applicant's own handwriting, and addressed to the Chairman of Selection Board.

(d) Each application must be supported with the fol-

- of such not being obtainable, a duly sworn statutory declaration of date of birth from a parent, guardian, person of good repute, or from the candidate should he be over the age of 21 years.
- (2) Educational certificate to the standard determined by the Commissioner for the position applied for.
- Three satisfactory testimonials of character, one of which must be from the last employer (3)or, in the event of a candidate just leaving school, from the head master of the school he or she last attended, or should neither of these be obtainable, a satisfactory reason must be forthcoming.

(e) The age of admission shall be :---

- Minimum. Maximum. (1) For Junior Clerks .. 15 yrs. 17 yrs.
- (2) For Engineering 16 yrs. 18 yrs.

Cadets (3) For other positions

35 yrs.

(f) Provided always that in special cases to neet the requirements of the Service the Commissioner may admit any person whose age may be beyond the maximum. 4. Junior Clerks.

(a) Applicants for the position of Junior Clerk who have complied with the provisions of paragraph 3 will be called upon to present themselves before a Selection Board appointed by the Commissioner, which Board may make such tests and arrange for such examinations as (b) The Board will decide which applicants are suit-

able for employment and in what order they shall be offered positions.

(c) In making their selection the Board will be governed by the examinations which the applicants have passed, their physical appearance, apparent general capabilities to discharge the duties which they will be required to perform, and such other considerations as they may think it necessary to take into account in influencing their choice.

(d) The approved applicants will be offered positions in the order in which they are placed by the Selection Board, and any applicant who does not accept a position when it is offered will have his or her name removed from the list of approved candidates, unless the Commissioner approves of the name being retained on the list.

(e) An approved applicant residing outside the Metropolitan Suburban Area may be offered a vacancy at a station adjacent to his place of residence, notwithstanding that he or she may not be the first on the list.

(f) If approved applicants are not employed within six months of their appearance before the Selection Board their applications lapse.

5. Appointment of Engineering Cadets.

(a) An applicant for appointment as an Engineering Cadet must not be more than eighteen nor less than sixteen years of age. He will be required to produce a medical certificate from the Railway Medical Officer to the effect that he is of sound constitution, and not affected with any physical infirmity which would interfere with the proper exercise of his profession. He shall also produce satisfactory evidence as to his character.

(b) Qualifications.—An applicant will be required to produce evidence of the examinations passed by him. All other things being equal, preference will be given to a candidate who has passed the Matriculation Examination of the University of Western Australia in subjects set down for engineering cadets, viz., English and an-

other modern language, Mathematics and Applied Mathe-matics, Chemistry, and Geology or Physics. (e) Competitive Examination.—Applications will be invited by the Commissioner of Railways by advertise-ment, and in the event of more applications being received than the number of vacancies a competitive ex-amination may be held by the Department in trigonometrical computations, plotting and plan drawing. (d) Probation.—Every cadet shall, in the first in-

(d) Probaton.—Every cadet shall, in the first in-stance, be appointed on probation for a period of not more than three months. Before the expiration of the period of probation the Permanent Head shall report to the Commissioner on the manner in which the proba-tioner has performed his duties and upon his general conduct. Upon receipt of such report the Commissioner will confirm or annul the cadetchip. Upon confirmation will confirm or annul the cadetship. Upon confirmation of a Cadet's appointment he will be articled to the Head of the Branch for the prescribed term of service.

(e) Term of Service.--A Cadet who possesses the qualifications as prescribed in Section (b) will be required to serve for a term of four years, a part of which will be spent in the office where he will receive instruction in general engineering drafting, computations, specifications, office methods, etc. The balance of the term will be in the field on engineering surveys and the construction of works in the case of Civil Engineering Cadets, in the Workshops and Running Sheds in the case of Mechanical Engineering Cadets, and in the Workshops or on general outside work in the case of Electrical Engineering Cadets.

(f) General .- During the term of service a Cadet eers, London, and will be expected to attend classes, whenever possible, at the University or Technical School, in his own time, for the further study of subjects neces-sary to enable him to pass the examination qualifying for a candidate as Associate Member of the Institution of Civil Engineers, Mechanical Engineers, or Electrical Engineers, London.

(g) Should a Cadet desire to obtain an engineering degree at the University of Western Australia, section (f) will not apply. Time will be allowed him to attend the requisite lectures, such time to be without pay.

(h) When a Cadet has completed one-half of the prescribed term of service, if in the opinion of the permanent head of the Department his progress and general conduct have not been satisfactory, his services may be dispensed with, on the approval of the Commissioner of Railways.

(i) On the completion of the prescribed term of service a Cadet will required to apply to the Institution of Civil Engineers, the Institution of Mechanical Engineers, or the Institution of Electrical Engineers, London, for the admission to the examination qualifying for candidature as an Associate member. The Cadet's term of service shall be extended to cover the period between the completion of his service and the holding of the examination by the Institution at the same remuneration as that received for his last year of service.

(j) When a Cadet takes advantage of Section (g) he must, on completion of the prescribed term of service,

obtain the degree of Bachelor of Engineering of the University of Western Australia.

(k) Should a Cadet fail to pass in either of these examinations set forth in Sections (i) and (j) his term of service may be extended for a further period not exceeding two years, at the same remuneration as that received for his last year of service.

(1) Permanent Appointment.—A Cadet who has satis-factorily completed his cadetship and passed the ex-aminations required in Sections (i) and (j) shall (should he be so required) serve in the Railway Service of the State for a period of three (3) years at a salary in accordance with the Commissioner's classification of the work upon which he is engaged.

6. Probation.

(a) Every person appointed under this By-law shall serve a probation of one year, except where otherwise provided.

(b) After the period of probation and upon production of a certificate of fitness from the Head of the Branch in which the probationer has been employed, his or her appointment may be confirmed by the Commissioner.

(c) Exemption may be granted by the Commissioner in regard to a term of probation in the case of officers of known ability and skill.

Examinations. 7.

(a) All Officers shall present themselves for medical examination and vision and hearing tests when instructed so to do.

(b) All Officers shall qualify and pass examinations in such subjects as the Commissioner may decide, and the retention of any Officer in the Service will be contingent upon his passing such examinations.

Duties and Discipline.

(a) All persons employed by the Commissioner must devote themselves exclusively to his service, and conform to all the Rules and Regulations of the Commissioner; they must reside at whatever place may be appointed, attend at such hours as may be required, and pay prompt obedience to all persons placed in authority over them.

(b) No employee shall trade, either directly or indirectly, for himself or others. (c) Provided that nothing herein contained shall be

deemed to prevent an Officer holding a paid position in a registered Friendly or Co-operative Society, or in any Society or Union of Railway Officers. (d) Any Officer shall not use for any other purpose than the discharge of his official duties information

gained by or conveyed to him through his connection with the Railway Service.

(e) If the estate of an Officer shall become seques-trated, either voluntarily or compulsorily, for the benefit of his creditors, such Officer shall report the full cir-cumstances, through the Head of his Branch, to the Commissioner, and shall apply, as soon as he may legally do so, to the Court for a certificate of discharge. If such Officer does not so report or apply for such certifi-cate of discharge, or if he applies, and it appears from the report that such officer has been guilty of fraud, dishonourable conduct, or extravagance, such Officer may be dismissed or otherwise dealt with by the Commissioner.

(f) If an Officer is, on an indictment, convicted of any offence, he shall be dismissed the service. 9. Retirements.

An Officer who has reached the age of sixty years may be called upon to retire, and the Commissioner shall decide whether any Officer having reached this age shall continue in the Department.

Reductions in Staff.

(a) The Commissioner may, if he thinks it desirable, abolish any office or reduce the number of staff, and in such cases may dispense with the services of any officers or offer them positions in lower classes as he may deem fit.

(b) Whenever the Commissioner considers it neces-sary to reduce the number of staff, the following shall be the course adopted with regard to the re-employment of retrenched Officers, viz .:

(1) The name and address of each Officer shall be registered. As vacancies occur each shall, in order of seniority of service, all other things being equal, have the offer of re-employment in any position in the Department for which he is qualified.

JULY 15, 1921.

(2) An Officer having left the Department on account of retrenchment and being re-employed within twelve months may, with the approval of the Commissioner, be credited with the period of former service, but the salary at which the re-employment is made shall be the starting factor for future advancement.

11. Uniforms. The following uniforms will be supplied to Station-masters. Relief masters, Assistant and Night Station-masters, Relief Officers, and Traffic Inspectors :-

1 Summer and 1 Winter suit each year,

Cap each alternate year,

1 Helmet each alternate year,

except that Night Station-masters will not receive a Helmet but a Cap every year.

12.General.

(a) Should an Officer be transferred from another Branch of the Government Service to the Railway Department, such transfer shall not carry with it any rights or privileges contrary to, or in conflict with, any By-law, Award or Agreement which may be in force at the time of such transfer.

(b) No Officer, unless authorised, shall incur liability or enter into any contract on behalf of the Department, or alter the terms or conditions of any contract.

(c) In the matter of accounts and the collection and remittance and payment of Public Moneys, each Officer is enjoined to conform strictly to "The Audit Act, 1904,", and such regulations and instructions as may be issued from time to time.

(d) A son of an Officer shall not, without the consent of the Commissioner, be engaged in any office or at any station under his father after he attains the age of 21.

(e) In the event of any questions arising as to the meaning of this By-law or any part thereof, or as to anything done or alleged to have been done thereunto, or contrary thereto, it shall be referred to the Commissioner, whose decision shall be final.

(f) Every Officer will hold his appointment conditionally upon his being subject to and strictly observing the By-laws, Rules and Regulations established from time to time for his or her guidance.
