WHEREAS by Crown Grant under "The Land Act, 1898," registered in the books of the Office of Land Titles in Vol. 747, Folio 154, Avon Location 21394, containing 160 acres, was granted to Francis John Winch Dawe, subject to the reservation to His Majesty the King, his heirs and successors, of the right to resume and enter upon possession of any part of the said land which it might at any time be deemed necessary to resume for roads, tramways, railways, railway stations, bridges, canals, towing paths, harbour or river improvements works, drainage or irrigation works or quarries, and generally for any other works or purposes of public use, utility, or convenience, and such land so resumed to hold to His Majesty, his heirs and successors, as of his or their former estate, without making to the said grantee any compensation in respect thereof, so that the land so resumed should not exceed one-twentieth part of the whole of the land aforesaid, and that no such resumption should be made of any land upon which any buildings should be erected or should be in use as gardens or otherwise for the more convenient occupation of any such building without compensation; and whereas it is desirable to resume the land hereinafter described (being portion of the land granted as aforesaid not exceeding one-twentieth thereof) for the purpose of School Site: Now know ye that I, the Administrator of this State, by and with the advice and consent of the Executive Council, do hereby proclaim that in exercise of the power contained in the Crown Grant as aforesaid, the land described in the Schedule hereto, being portion not exceeding one-twentieth of the whole of the land comprised in the said Grant, was on the fifth day of July, 1922, resumed on behalf of His Majesty for the purpose of School Site.

### Stock Diseases Act, 1895. ORDER IN COUNCIL.

AT a meeting of the Executive Council, held in the Executive Council Chamber this 28th day of June, 1922, the following Order in Council was authorised to be issued; such Order to take effect as from 14th July, 1922:—

WHEREAS there is reason to believe that the introduction or importation of cattle into Western Australia from the States of New South Wales, Victoria, South Australia, and Queensland would cause the disease of pleuro-pneumonia to extend to the State of Western Australia, and it is desirable that steps should be taken for its prevention: Now, therefore, His Excellency the Lieutenant-Governor and Administrator, by and with the advice and consent of the Executive Council, doth hereby prohibit for a period of twelve months the introduction or importation into Western Australia from the States of New South Wales, Victoria, South Australia, and Queensland of any cattle, except stud stock accompanied by a certificate from the Chief Veterinary Officer of the State that such stud stock are from clean herds and have not been in contact with diseased stock for a period of at least six months.

# STALLIONS ACT, 1921.

Department of Agriculture, Perth, 20th July, 1922.

HIS Excellency the Governor in Executive Council has been pleased to make the following Regulations under the "Stallions Act, 1921."

> GEO. L. SUTTON. Director of Agriculture.

#### Regulations.

- 1. In the interpretation of these Regulations, unless inconsistent with the context or subject-matter,-

  - "'Act'" means "The Stallions Act, 1921."
    "'Applicant" means an applicant for a certificate under the Act, and "Application" has a corresponding meaning.
  - "Certificate" means a certificate for the time being
  - in force of registration under the Act.
    "Registered" means entered pursuant to this Act
  - in the register.

    "Registration" means registration for the time
  - being in force under this Act.

    "Sound" means free from unsoundness, a
    "Soundness" has a corresponding meaning.
- 2. Every application shall be according to Form "A" of the Schedule hereto, with such modifications, if any, as the circumstances of the case require.
- 3. Every applicant shall submit his stallion for examination by the Examining Authority at an inspection parade arranged by the Inspector.
- 4. The fee to be paid by an owner for a special parade of his stallion shall be one pound and the return first-class railway fares and expenses of the Examining Authority; and for each additional stallion, the property of the same owner, an additional fee of ten shillings shall be paid.
- 5. An owner shall furnish the Examining Authority with such particulars concerning a stallion as such Examining Authority may require, namely, the name, breeder, pedigree, age, prior ownership, etc., and if the Examining Authority deems it necessary the owner shall supply a statutory declaration in support of such particulars.
- 6. The Inspector shall, in writing, notify the owner of any stallion in respect of which a certificate is refused within fourteen days of such refusal, and shall state in such notification the reason for refusal.
- 7. The Register to be kept under the Act shall be in accordance with Form "B" of the Schedule hereto.
- 8. The publication of lists required by Section 9 of the Act shall be made in the month of August in each vear ..
- 9. Until the issue of a certificate or the publication of the Register, the result of an examination of a stallion by an Examining Authority shall not be communicated to any person except as herein provided or under circumstances as follows:-

The Inspector may, in his discretion, communicate to an owner or to an owner's agent duly authorised in writing to inquire, the result of examination of such owner's stallion;

The reason for refusal of a certificate shall not be communicated to any person except the owner concerned or his agent duly authorised in writing, save under the direction of the Court in legal proceedings.

- 10. The certificate of registration shall be in accordance with Form "C'' of the Schedule hereto.

- 17. The stud-book prescribed for the purpose of the Act is the Commonwealth Stud-book.
- 18. Any breach of these Regulations by act or omission on the part of any person shall render such person liable on summary conviction to a penalty not exceeding Five pounds.

- 19. The appointment of an Examining Authority by an Inspector shall be made in writing according to the Form "F" in the Schedule hereto, and shall be published in the Gazette.
- 20. Every person appointed to a position of an Examining Authority shall hold office for one year unless sooner removed by the Inspector.
- 21. An Examining Authority may act in such part of the State as is mentioned in the appointment of such authority but not elsewhere.
