## THE STAMP ACT, 1921.

The commission to be paid as remuneration to licensed vendors of stamps, under Section 12 of "The Stamp Act, 1921," shall not exceed one and a-half per cent.; and such commission shall be payable only when adhesive stamps are purchased and paid for by such vendors to the value of not less than £1, at one time, and such stamps so purchased do not exceed the value of 2s. 6d. each.

2. No licensed vendor of stamps shall share his commission with any other person, and for breach of this regulation his license shall be cancelled.
