The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 745/22.

WHEREAS by "The Metropolitan Water Supply, Sew-erage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister of Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend Water Works, Sewerage Works, and Stormwater Drainage Works; and whereas it is further provided that the Governor may exempt reticulation works from certain sections of this Act: Now, therefore, His Ex-cellency the Governor, with the advice of the Executive Council, hereby approves of the construction by the Minister of Water Supply, Sewerage, and Drainage of the following works under the said Act, and does hereby exempt such works from the operations of Sections 20, 21, 22, and 23 of the said Act -

Description and Location of Reticulation Works approved and exempted:

Fremantle Municipality.

Proposed 6in. diameter stoneware pipe sewer, com-mencing at a point on existing sewer in Beach Street, opposite Lot No. 265; thence in a South-Easterly direc-tion through private property for a distance of about 170 feet; thence in a Southerly direction for a distance of about 70 feet to a point on existing sewer, as shown on Plan M.W.S., S., & D.D. No. 4083.

This Order in Council shall take effect from the 13th day of October, 1922.
