*The Land Act, 1898.*

ORDER IN COUNCIL.

Corr. No. 5494/13.

WHEREAS by Section 43 of "The Land Act, 1898," it is made lawful for the Governor, by Order in Council, without issuing any deed of grant, to place any Reserve under the control of any Municipality, Road Board, or other person or persons, as a Board of Management, and to empower such Board to make, repeal, and alter by-laws for the control and management of such Reserves, and prescribe fees for depasturing thereon, and for other purposes, such by-laws to be approved by the Deputy Governor and published in the *Government Gazette*: And whereas it is deemed expedient that Reserve 15291 for a Race Course and Recreation at Trayning should be placed under the control of the Ninghan Road Board as a Board of Management: Now, therefore, His Excellency the Deputy Governor, by and with the advice and consent of the Executive Council, doth hereby place the before-mentioned Reserve under the control of the Ninghan Road Board as a Board of Management, and doth empower such Board to make, repeal, or alter by-laws for the control and management of the said Reserve; for prescribing fees for depasturing thereon; for directing the manner in which such fees shall be imposed, paid, collected, and disposed of, and to impose penalties not exceeding in any case £5 for any breach thereof, and £2 a day for a continuing breach, but not more than £20 in the aggregate.

*The Metropolitan Water Supply, Sewerage, and  
Drainage Act, 1909.*

ORDER IN COUNCIL.

M.W.S. 980/22.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that the Governor may, by Order in Council, alter or extend the boundaries of the Metropolitan Water Supply, Sewerage, and Drainage Area or any District; and whereas it is desirable that the boundaries of Metropolitan Stormwater Districts Nos. 2 and 1 should be altered: Now therefore I, the said Governor, acting by and with the advice of the Executive Council, do hereby alter the boundaries of Metropolitan Stormwater Districts Nos. 2 and 1, and declare that the said boundaries, as shown on Plan M.W.S.S. and D.D. No. 3449, and as described in Order in Council of 2nd May, 1923, shall be altered in the following manner, by deleting the area described hereunder from Metropolitan Stormwater District No. 1 and including it in Metropolitan Stormwater District No. 2.

*Schedule.*

Commencing at the intersection of Albert and Anzaco Streets; thence Westerly along the North side of Albert Street to the West side of Charles Street; thence Northerly along the West side of Charles Street to its intersection with North Beach Road; thence North-Westerly along the South side of North Beach Road to Hardy Street; thence Southerly along the East side of Hardy Street to Howlett Street; thence Westerly along the North side of Howlett Street crossing Hardy Street to right-of-way; thence Southerly along the East side of right-of-way crossing Howlett and Kadina Streets to the South side of Kadina Street; thence Westerly along the South side of Kadina Street through private property to a point on the East side of Loftus Street, 350 feet South of the South side of Chamberlain Street; thence Southerly along the East side of Loftus Street to Thompson Street; thence Easterly along the North side of Thompson Street and through private property to Barnett Street; thence Northerly along the West side of Barnett Street to and across Bourke Street; thence Easterly along the North side of Bourke Street and the Northern boundary of Lot 29 to and across right-of-way; thence Southerly along the East side of right-of-way and Eastern boundary of Lot 15 to Richmond Street; thence Westerly along the North boundary of Richmond Street across Campsie Street to a point opposite the West boundary of Lot 3; thence Southerly along the West boundaries of Lots 3 and 7 to Hart Avenue; thence Westerly along the North side of Hart Avenue to Morrison Street; thence Westerly across Morrison Street and along the North side of Emmerson Street to Loftus Street; thence Northerly along the East side of Loftus Street to and across Richmond Street; thence Westerly along the North side of Richmond Street across Fleet Street to Lot 12; thence Northerly along the East boundary of Lot 12; thence Westerly along the North boundaries of Lots 12 to 9 to Scott Street; thence Northerly along the East side of Scott Street to a point opposite the North boundary of Lot 11; thence Westerly along the said boundary of Lot 11 to the East boundary of Lot 8; thence Northerly along the said boundary of Lot 8 to Bourke Street; thence Westerly along the South side of Bourke Street to a point opposite the East boundary of Lot 12; thence Northerly across Bourke Street along the East boundaries of Lots 12 and 15 to Schafer Street; thence Easterly along the South side of Schafer Street to a point opposite the East boundary of Lot 5; thence Northerly along the East boundary of Lot 5 across Tennyson Street and along the East side of Byron Street to a point opposite the North boundary of Lot 38; thence Westerly along the said boundary of Lot 38 to the East boundary of Lot 20; thence Northerly along the East boundaries of Lots 20 to 24; thence Westerly along the North boundary of Lot 24 to the East boundary of Lot 26; thence Northerly along said boundary of Lot 26 to Marian Street; thence Westerly along the South side of Marian Street to and across Shakespeare Street; thence Northerly along the West side of Shakespeare Street across Shaftesbury Street to right-of-way; thence Westerly along the South side of right-of-way to the East boundary of Lot 71; thence Northerly along the said boundary of Lot 71 to Salisbury Street; thence Westerly along the South side of Salisbury Street to a point opposite the

East boundary of Lot 52; thence Northerly along the East boundaries of Lots 52 and 90 to and across Anzac Road; thence Westerly along the North side of Anzac Road to a point opposite the East boundary of Lot 70; thence Northerly along the said boundary of Lot 70 to right-of-way; thence Westerly along the South side of right-of-way to a point opposite the East boundary of Lot 62; thence Northerly along the said boundary of Lot 62 to and across Wilberforce Street; thence Westerly along the North side of Wilberforce Street to right-of-way; thence Northerly along the East side of right-of-way to a point opposite the North boundary of Lot 14; thence Westerly along said boundary of Lot 14 to Oxford Street; thence Northerly along the East side of Oxford Street to North Beach Road; thence North-Westerly along the South side of North Beach Road to the centre of Fairfield Street; thence Northerly across North Beach Road and along the West side of Fairfield Street to Woodstock Street; thence Westerly along the South side of Woodstock Street to the West side of right-of-way; thence Northerly across Woodstock Street and along the said side of right-of-way to the North boundary of Lot 98; thence Westerly along the said boundary of Lot 98 to Flinders Street; thence Northerly along the East side of Flinders Street to a point opposite the North boundary of Lot 164; thence Westerly along the North boundary of Lot 164 to right-of-way; thence Northerly along the East side of right-of-way to and across Ellesmere Street; thence Northerly along the right-of-way to the North-West corner of Lot 175, Flinders Street; thence Easterly along the North boundary of Lot 175, Flinders Street; across Flinders Street and along the North boundary of Lot 85, Flinders Street to the right-of-way; thence Northerly along the said right-of-way to the North boundary of Lot 53, Fairfield Street; thence Easterly along the said boundary of the said Lot to and across Fairfield Street and along the North boundary of Lot 31, Fairfield Street, to the right-of-way; thence Northerly along the said right-of-way to the North boundary of Lot 55, Edinburgh Street; thence Easterly along the said boundary of the said Lot to and across Edinburgh Street; thence Northerly along the East side of Edinburgh Street to the North boundary of Lot 125, Edinburgh Street; thence Easterly along the said boundary of the said Lot to and across the right-of-way and along the North boundary of Lot 136, Shakespeare Street to Shakespeare Street; thence Southerly along the West side of Shakespeare Street to the South-East corner of Lot 141, Shakespeare Street; thence Easterly across Shakespeare Street and along the North boundary of Lot 207, Shakespeare Street, and the North boundary of Lot 228, Dunedin Street, across Dunedin Street and along the North boundary of Lot 292, Dunedin Street and the North boundary of Lot 316 Girton Street; thence Southerly along the East side of Girton Street to the South-East corner of Lot 319, Girton Street; thence Easterly across Girton Street and Location 690 to the North-West corner of Lot 212, Charles Street; thence Southerly along the East side of Charles Street to the South-West corner of Elma Street; thence Easterly along the South side of Elma Street to Doris Street; thence North-Easterly along the South side of Elma Street to and across Lawler Street to the right-of-way; thence South-Easterly along the East side of right-of-way to a point opposite the North-West boundary of Lot 174; thence South-Westerly along the said boundary of Lot 174 to the centre of Lawler Street; thence South-Easterly along the centre of Lawler Street to a point opposite the North-West boundary of Lot 191; thence South-Westerly along the said boundary of Lot 191 to the centre of right-of-way; thence South-Easterly along the centre of right-of-way to the centre of intersecting right-of-way; thence along centre of said right-of-way to and across Bedford Street; thence Easterly along the centre of right-of-way to the West boundary of Lot 76; thence Southerly along the said boundary of Lot 76 to the centre of Selkirk Street; thence Easterly along Selkirk Street to the centre of Union Street; thence Southerly along Union Street to the centre of right-of-way; thence Easterly along right-of-way to a point opposite the West boundary of Lot 21; thence Southerly along said boundary of Lot 21 to the centre of Clieveden Street; thence Easterly along Clieveden Street to the centre of Walcott Street; thence South-Easterly along Walcott Street to the centre of Paddington Road; thence Westerly along Paddington Road to a point opposite the East

boundary of Lot 44; thence Southerly along the East boundaries of Lots 44 and 55 to the centre of Redfern Street; thence Westerly along Redfern Street to the centre of Norham Street; thence Southerly along Norham Street to right-of-way; thence Easterly along right-of-way to Bay View Road; thence Southerly along the West side of Bay View Road to Namur Street; thence Southerly along the West boundary of Lot 88 to and across Farmer Street; thence Easterly along the South side of Farmer Street to Daphne Street; thence Southerly along the West side of Daphne Street across Angove Street to the point of commencement, as shown in yellow on Plan M.W.S.S. and D.D. No. 3449.

This Order in Council shall take effect from the 22nd day of June, 1923.

*Procedure re Preparation of Wages Sheets and Payment of Wages for Construction Works where Timekeepers are employed and Wages Sheets are made up on Works.*

1. *Preparation of Time-book.*—Timekeeper shall enter in time-book name of each man employed, classification and rate of pay and the time worked by such employee, whether employed full or part time. The foreman shall initial the last entry in each day's record as a certification that the entries *re* men and time worked shown on that day are correct. At the close of the pay period, the timekeeper shall extend the time of each man, and set out in the column provided the amount earned by each employee and shall show the total wages earned.

2. *Preparation of Wages Sheets.*—From the time-book the timekeeper shall enter on wages sheet the name of each employee, total time worked and wages earned by him, and the aggregate of the wages sheet, and shall show on foot of pay sheet the number of men employed. Such sheet shall be signed by the foreman or officer immediately in charge, after comparison with the time-book.

3. *Costing.*—The timekeeper shall keep a record of the wages expended on the several authorised works authorities, under the prescribed costing subdivisions. The total of these cost segregations should agree with the total of the wages sheets for the period involved.

4. *Submission of Wages Sheets and Cost Analyses to Accountant.*—Wages sheets, signed by foreman, shall be submitted to Accountant with analyses of wages under costing subdivisions, at the close of the pay period. Checking officer (Accounts Staff) shall check—

- That rates of pay are those authorised under award or other approval.
- That extensions have been correctly made.
- That total of sheet is correct.
- That the items in the analysis sheet are approved, costing items for the work, and that the total of such analysis sheet agrees with the total on the accompanying wages sheet.
- That approval has been sighted for any leave or accumulated leave shown on wages sheets and that leave is in accordance with awards, agreements, etc.

5. The checking officer shall sign sheets if in order as per paragraph 4, and pass to officer empowered to appoint for his certification as provided for on wages sheets.

The latter will, after signature, pass sheets to officer incurring expense for certification.

After signature by officer incurring expense, sheets shall be passed to certifying officer, who shall sign, after seeing that the necessary certifications have been inserted, and has satisfied himself from a perusal of the wages analysis the expenditure has been charged against the proper authority.

Sheet shall then be submitted to Treasury for payment.

6. *Interim Pays.*—Wages employees paid off before close of wages period shall be included in regular wages sheets, and the pay off order number inserted against name of payee concerned. When it is necessary to pay off an employee between regular pay periods the time-keeper shall prepare a "pay off" docket which shall be signed by authorised officer showing thereon the name of the employee, time worked and wages earned. No "pay off" orders to be issued in head office by Accounts Officers.

The pay-off order shall be handed to the employees concerned after a specimen signature of the latter, witnessed by the foreman, has been inscribed thereon.

The pay-off order shall be submitted to the Sub-Accountant, who shall arrange for the checking officer to check in accordance with paragraph 4 and initial if correct. Particular attention shall be paid by checking officer to the matter of holiday pay to employees going on leave, or payments in lieu of leave.

After receiving checking officer's certification, the Sub-Accountant shall sign docket and pass to the cashier to pay employee direct from his advance.

Cashier, before paying, shall satisfy himself employee's acquittance agrees with specimen signature on docket and shall personally pay over to the payee and initial the docket as evidence of having done so.

Before wages sheets are passed by certifying officer to Treasury for payment, he shall arrange for the checking officer to check off the pay-off dockets with the notations *re* interim pays as shown by the timekeepers on wages sheets; and see that all wages covered by pay-off orders are included in the regular pay sheets for the period involved.

METROPOLITAN WATER SUPPLY, SEWERAGE,  
AND DRAINAGE DEPARTMENT.

*Procedure re Preparation of Wages Sheets and Payment of Wages for Maintenance and other Works where no Timekeeper is employed and Wages Sheets are prepared at Head Office.*

1. *Preparation of Time-book.*—From daily or weekly time dockets, signed by foremen or officer immediately in charge, the wages clerk shall enter into a time-book the name of each man employed, classification and rate of pay, and the time worked by such employee.

2. *Preparation of Wages Sheets.*—From the time-book the wages clerk shall enter on wages sheet the name of each employee, total time worked, and wages earned by him, the aggregate of the wages earned and the number of men employed.

3. Wages clerk shall certify that "The certification of foreman, that men shown on wages sheet have been employed during the periods set out, has been sighted on the supporting time dockets."

4. *Note.*—It is impracticable to get the signature of each foreman concerned on wages sheet even if a separate sheet were made up for each set of men.

5. *Submission of Wages Sheets to Accountant.*—Wages sheets, certified as above, together with time-books and analysis of wages under costing segregations, shall be submitted to Accountant at the close of each pay period.

6. Checking officer (Accounts Staff) shall check entries on wages sheets with entries in the time-book. He (checking officer) shall check—

- (a) That the rates of pay are those authorised under awards, agreements, or other approvals.
- (b) That individual amounts set against each name agree with those in the time-book.

(c) That extensions have been correctly made.

(d) That total of sheet is correct and agrees with total in time-book.

(e) That the items in the analysis sheet are the approved costing subdivisions and that the total of such analysis sheet agrees with the total on the accompanying wages sheet.

(f) That approval has been sighted for any leave or accumulated leave shown on wages sheets, and that leave is in accordance with awards, agreements, etc.

(g) That name of payees are correct as to initials and surname.

(h) That employees have been properly and actually employed by the Metropolitan Water Supply, Sewerage, and Drainage Department on work specified on wages sheet to be certified.

7. The checking clerk shall sign sheets if in order as per paragraph 6 and pass, together with dockets, to "Officer Empowered to Appoint" for his certification as provided for on wages sheet.

The latter will, after signature, pass sheets to officer incurring expense for his certification.

After signature by officer incurring expenses, sheets shall be passed to certifying officer, who shall sign after seeing that the necessary certificates have been inserted and has satisfied himself from a perusal of the wages analysis that the expenditure has been charged against the proper authorities in accordance with Section 33 of "The Audit Act, 1904."

Sheet shall then be submitted to Treasury for payment.

8. *Interim Pays.*—Wages employees paid off before close of wages period shall be included in regular wages sheets. When it is necessary to pay off an employee between regular pay periods, the officer authorised shall hand the employee concerned a pay-off order (after obtaining and witnessing such employee's specimen signature thereon), together with a pay docket showing any time worked which has not been advised to the wages clerk.

No pay-off orders to be issued in head office by Accounts Staff.

Pay-off order shall be handed by employee to wages clerk who shall enter thereon time worked and wages earned, sign docket, and pass same to Sub-Accountant, who shall arrange for the checking officer to check in accordance with paragraph 6, compare with time dockets, and initial if correct.

After receiving checking officer's certification, the Sub-Accountant shall initial docket and pass to cashier to pay employee direct from his advance.

Cashier, before paying, shall satisfy himself that employee's acquittance agrees with specimen signature on docket and shall personally pay out to payee and initial docket as evidence of having done so.

9. Before wages sheets are passed to Treasury for payment the certifying officer shall arrange for the checking clerk to check off the pay-off dockets with the notations *re* interim pays as shown by the wages clerk on regular wages sheets, and see that all such wages covered by pay-off orders are included in the regular wages sheets for the period involved.

## WESTERN AUSTRALIAN GOVERNMENT ELECTRICITY SUPPLY.

IT is hereby notified, for general information, that the following By-laws in connection with the Western Australian Government Electricity Supply will become effective on and from 1st July, 1923.

*The Government Electric Works Act, 1914 (No. 29 of 1915) and Amendment Act (No. 42 of 1915).*

*By-laws.*

1. These By-laws may be cited as "The Electric Works By-laws, 1923," and shall become effective on and from 1st July, 1923.

2. *Applications for Connections.*—Applications for service connections must be made on the Department's application form and filed at the Office of the Department for approval at least five clear days before the connection is required.

The Department will not be bound to give the supply unless and until the application is approved, nor be bound to any particular date.

3. *System.*—Electric current will be supplied, except where special arrangements may be made, from the Department's alternating current system at a frequency of 40 cycles. All lighting will be, and motors up to 2 h.p. may be supplied at 250 volts, single phase. All motors over 2 h.p., except with special written permission of the Department, must be connected to the 440 volt, 3 phase circuits.

4. *Wiring of Installations.*—All wiring of installations shall be in accordance with the standard wiring rules of the Institution of Engineers, Australia, and the rules of the Fire Underwriters' Association of Western Australia, for the time being in force, and no connection will be made without a certificate that the installation is in order and on such form as may be from time to time prescribed by the Department.

5. *Position of Service Leads, Fuses, etc.*—The Department will decide as to the most suitable position for its fuses, circuit breakers, indicators, meters, and termination of service leads.

Where service fuses are within a building, they will be placed within 10ft. of the point of entrance of the supply leads.

The consumer or contractor shall consult the Department as to the position of the meter-board, which must be fixed in a position approved by the Department, protected from the weather, out-of-doors, or elsewhere accessible to the Department at all reasonable times.

6. *Consumer's Main Switch and Fuses.*—The Department will provide and fix the meter-board and meter at the position agreed upon, to which point the contractor must bring the consumer's mains and provide:—

- (a) Double pole linked switch for single phase circuits.
- (b) Three pole switch for three phase circuits.

In cases where the consumer's main switches and fuses are, with the Department's consent, fixed on the supply side of the meter, they will be ironclad and suitable for sealing with the Department's seal.

7. *Service Connection.*—The Department will run the overhead service wires to insulators attached to the outside of the consumer's premises, when the distance from the street in which the mains are located does not exceed 66ft. Above that distance the cost will be charged to the consumer.

The mains between the Swan Neck Insulators and the Department's meter shall be provided by the consumer.

8. *Capacity Main Switches.*—The foregoing switches shall be of ample capacity and design approved by the Department. Sufficient length of wire shall be left by the contractor to connect to the Department's meter. In all cases the line wires are at the left and the consumer's wires at the right of the meter.

9. *Consumer's Terminals and Leads.*—The point of termination of the Department's service leads shall be deemed to be the position of the consumer's terminals, which position in the case of an overhead supply shall be on the outside of the building, and is hereinafter designated "the point of entry."

The consumer's leads shall be of sufficient length to allow of their ends being properly connected to the service conductors at the consumer's terminals. Loops shall be left in the leads for the insertion by the Department of its meters, service cut-outs, or other apparatus.

At the point of entrance to buildings the consumer's leads shall be provided with a suitable bell-mouthed bend or other approved terminal fitting of the water-shed type.

10. *Meters and Meter-boards.*—(a) These must be placed in the position determined by the Department as provided under the Department's regulations respectively.

(b) In buildings having several tenants the consumers' meters must all be placed at one or more points, approved by the Department, as the Department will not instal meters in different positions in the same building.

(c) In large buildings all circuits must be brought to one or more central points, as may be arranged with the Department, where the Department's circuits will enter and the necessary meter or meters be placed.

11. *Fixing of Leads in Fuses, Meters, etc.*—No person not being an employee of the Department shall insert the ends of a consumer's leads into any service fuse, meter, indicator, current limiter, or other device the property of the Department.

12. *Department's Property.*—The service mains, meters, and other apparatus fixed by the Department on the consumer's premises shall remain the property of the Department.

13. *Nature and Protection of Consumer's Leads.*—The consumer's main switchboard may be placed in any convenient position on his premises. The conductors between the point of entry and the consumer's main switch shall be closed in steel conduit, shall be stranded, and of adequate sectional area, which in no case shall be less than that of a 7/0.036in. cable.

14. *Department's Fuses.*—The fuses fixed by the Department above the meter may or may not be sealed by the Department, but they shall not in any case be interfered with by the consumer, who must provide suitable fuses on the load side of the consumer's main switch.

15. *Testing Insulation.*—The insulation resistance of new installations may be tested by the Department, and if such test is not satisfactory, connection will not be made. The second test will be subject to a charge of 5s.; any subsequent tests 10s. each, and such charges will be payable by the consumer.

16. *Conductors not to be Earthed.*—No conductor in a consumer's installation shall be connected to earth, and all conductors shall be equally insulated as provided in the Wiring Rules of the Institution of Engineers, Australia.

No supply will be given to premises wired on the concentric system using an uninsulated "outer" conductor.

17. *Wall Plugs for Lighting and Power.*—Where it is required to provide for the separate metering of current supplied at different rates, the installation shall be divided into separate and distinct circuits, which must not be bunched, and all wall plugs, connectors, and the like shall be of such different types that it shall not be possible to connect apparatus chargeable at a certain rate to any part of the installation conveying current chargeable at a lower rate.

No lamp holder shall be connected to any circuit the supply to which is given at power or heating rates, except as provided in the Wiring Rules in the case of pilot lamps, which, however, shall be so installed as to render it impossible to use them for general illuminating purposes.

18. *Switches to be on Conductors.*—The ends of conductors to which all single phase switches must be connected in accordance with the standard Wiring Rules of the Institution of Engineers, Australia, shall be labelled "Switchwire" in order that the Department may correctly connect the consumer's leads to the service leads.

19. *Balancing Circuits.*—Circuits must be arranged as follows:—

- (a) Circuits taking less than 15 (fifteen) amps may be taken off one phase.
- (b) Circuits taking more than 15 (fifteen) amps must be divided into two equal circuits and taken off two phases.
- (c) Circuits taking more than 30 (thirty) amps must be divided into three equal parts and taken off three phases.

In all cases a separate double pole linked switch must be provided on each circuit.

#### Motors.

20. Motors up to 2 h.p. may be single phase, and with special permission from the Department larger single phase motors of approved type may be installed, but the Department reserves the right not to connect any single phase motor larger than 2 h.p.

All motors over 2 h.p., unless approved as above, must be three-phase.

21. *Starting Current of A.C. Motors.*—Motors up to 10 h.p. may be squirrel cage and must be provided with an approved method of starting such that the maximum starting current shall not exceed 30 amperes.

Motors above 10 h.p., unless specially approved by the Department for special purposes, shall have wound rotors and shall be provided with such starting gear that the starting current will be put on gradually and will not at any time exceed double the full load current for motors up to 30 h.p. and  $1\frac{1}{2}$  times the full load current for motors over 30 h.p.

22. *Power Factor of Motors.*—The power factor of A.C. motors shall at full load be not less than the following:—

	3 Phase.	Single Phase.
Motors not exceeding 2 b.h.p.	75%	70%
2 b.h.p. to 8 b.h.p. . .	80%	—
8 b.h.p. to 25 b.h.p. . .	84%	—
Exceeding 25 b.h.p. . .	86%	—

23. *Domestic Supplies.*—All installations and apparatus for use in heating and cooking, including water heating, must be approved by the Department before installation and will not be connected unless so approved, and if connected without such approval the consumer will be disconnected.

24. *Special Lighting.*—Proposals for special lighting, such as outdoor display, illuminations, lighting of a temporary nature, or where the conditions are unusual, must be submitted to the Department before the installation is made and the Department's approval obtained before the work is connected.

25. *Additions to Installations.*—When first connected the consumer shall supply the Department with full details of all apparatus connected to the circuits. No additions of lamps, motors, cookers, or other apparatus shall be made until the Department has been notified of such intended addition and the consent of the Department has been obtained, and the consumer shall be fully responsible for any damage to meters or other apparatus which may occur through failure to comply with this By-law, in addition to being liable to disconnection.

26. *Meter Readings.*—The reading of the meter or other measuring device provided by the Department shall be taken as *prima facie* evidence of the quantity of electricity consumed. If the meter or other measuring device fails to register, or is found to be inaccurate, the account for the period since the last account was rendered shall be adjusted, at the option of the Department, upon the basis of—

- (a) The account rendered to the consumer for the corresponding period of the previous year.
- (b) The account for the last preceding period, a reasonable allowance being made for any known variations in the demand.

27. *Testing of Meters.*—The Department shall have the right to test meters at any time, and adjust the consumption for the current period of such test. The cost of testing such meter shall be borne by the Department, unless the meter is tested on the complaint or at the request of the consumer, in which case a testing fee of 5s. shall be paid by the consumer before the meter is tested. If it is found on testing that the meter is more than two per cent. fast, a refund of the testing fee above will be made to the consumer. Meters will be considered correct if on testing they are found to register within two per cent. of the Department's standards, and no adjustments of accounts will be made.

28. *Department's Apparatus, Interruptions, Responsibility.*—The Department—

- (a) shall have the right at all reasonable times to enter the premises of the consumer to inspect and test the installation and the Department's meter and to remove any of the Department's property;
- (b) may at any time interrupt the supply to make tests, alterations, or repairs to the Department's system, or for any other purpose;
- (c) shall not be responsible or liable for any injury, damage, or loss of any kind to the person, property, or business of the consumer, or to the consumer's lamps or apparatus, resulting from fire or otherwise, through the supply of electricity or through interruptions or defects of supply due to storm, accident, or breakdown of plant or mains or *force majeure*.

29. *Disconnection.*—The Department shall have the right to disconnect the consumer without notice if—

- (a) The consumer is in arrears in payment of accounts.
- (b) The consumer's installation is faulty.
- (c) The consumer uses the service in a way that interferes with the general supply to other consumers.
- (d) The consumer uses apparatus not authorised by the Department.
- (e) The consumer connects increased load without first obtaining the consent of the Department.
- (f) The consumer interferes with the seals, fuses, meters, or other apparatus, the property of the Department.
- (g) The consumer becomes bankrupt or assigns his estate for the benefit of his creditors, or in the case of a company, is in process of winding up.
- (h) The consumer fails to conform to the By-laws or the Department's Regulations in any way.

30. *Charge for Re-connection.*—Should it be necessary to disconnect a consumer for any of the foregoing reasons, re-connection will not be made until a fee of 5s. has been paid by him.

31. *Termination of Connection.*—The consumer shall give the Department at least three days' notice in writing of desire to terminate and shall be responsible for all current used until the expiration of such notice.

32. *Consumer's Liability for Loss.*—The consumer will be held responsible for loss by fire, damage, or theft of the meters or other apparatus hired from or loaned by the Department on the consumer's premises.

33. *Complaints.*—All complaints as to defective service or accounts must be made in writing to the Department's office.

Where complaints are received and it is found that the fault is not due to the Department and is on the consumer's side of the meter, attention thereto may be charged to the consumer, the minimum for any such service being 5s.

34. *Metering of Current.*—All electricity shall be measured by means of a meter or meters. No connection shall be made by any person so as to prevent the meter registering the total quantity of electricity used.

35. *Power Rates.*—Electricity taken and charged at power rates shall not be used for lighting purposes except where special contracts are in force.

36. *Interfering with Commissioner's Property.*—No person or persons shall interfere with any lines, poles, cables, sub-stations, switch gear, transformers, or apparatus or property of the Commissioner.



37. *Inspecting Meters, etc.*—The Commissioner's duly authorised representative shall have access, at all reasonable times, to the property of the Commissioner for the purpose of reading meters, making inspections, alterations, or anything necessary for maintaining a proper and efficient service.

38. *Commissioner's Right of Refusal.*—The Commissioner may, if he so desires, refuse to give a supply unless the installations, wiring, meters, or any electricity consuming device complies with the requirements as stated in the "Conditions of Supply."

39. *Scale of Charges—*

*Lighting.*

First 300 Board of Trade Units per month—5d. per unit.

All units in excess of 300 in any one month—4d. per unit.

*Domestic Power—Heating, Cooking, etc.*

First 50 Board of Trade Units per month—1½d. per unit.

All in excess of 50 units in any one month—1d. per unit.

*Industrial Power.*

Power for large industrial purposes is supplied under contract for which special rates are quoted according to demand and load factor.

Where mains already exist, small industrial power consumers will be supplied at a flat rate of 1½d. per unit.

*Minimum Charge.*

The following minimum monthly charges will be made:—

- (a) Domestic supplies (Lighting and Power)—5s.
- (b) Industrial power (Small consumers)—5s.

*Deposit.*

The following deposits must be paid before connection is made:—

- (a) Lighting consumers—15s.
- (b) Industrial power consumers—£1.

Any power consumer having a meter installed and wishing it to be disconnected during a portion of the year may have such meter disconnected, but it will not be re-connected until a fee amounting to the minimum charge for the number of months the supply has been disconnected has been paid.

The Department will supply one Power Meter, Industrial or Domestic, and one Lighting Meter per consumer only.

A Power Meter will not be fixed for one iron only.

Any additional meters will be subject to a rental of 1s. per meter per month.

40. *Consumer Connections.*—The Department will, as stated in By-law 7, connect a consumer's premises up to a distance of 66ft., but all over this distance will be charged to the consumer who should pay the cost for the additional length of connecting mains at the time of lodging the application form.

41. For a breach of any of the foregoing By-laws a penalty of not exceeding Twenty pounds is hereby imposed.
